

Mother Nature lashes north portion of Yoakum County

Rainfall for the year rapidly approaching 26 inches!

Last Tuesday evening, October 5, dark and ominous clouds began forming in Eastern New Mexico, approaching the Texas stateline. Residents of neighboring Tatum, New Mexico heard the community storm warning whistle sound as the storm cell neared, and a confirmed tornado sighting was made, but no damage was reported as the storm moved into the Bronco, Texas area, and about 9:30 PM whipped into Plains.

A number of area residents reported a deluge of water proured from the skies - many recorded over four inches in an hour or less, with resulting serious flooding in several areas of town. Accompanying hail was confined mainly to the norhtern most sections of town.

Sulfur Draw, the depression which meanders diagonally across the county and through Plains and then on to form the headwaters of the Colorado River, became a torrent, pouring across U.S. Highway 380 and into Stanford Park. There the flood waters rose rapidly, and actually reached most of the residences on the north side of the park. Gentry did say he estimated there were at least 25 irrigated circles of crops, mostly cotton, but with some peanut acreage, that appeared to be lost. "There will probably be more than that when we can take a closer look." Gentry has not had an opportunity to fully explore the northeast portion of the county, but knows a substantial amount of cotton, peanuts and milo have been destroyed. 

Yoakum County Hospital awarded hefty grant

Hospital officials, staff and supporters were eleated when the prestigious Meadows Foundation announced it had awarded the hospital \$107,000 in grant funds. The hospital only recently completed a year long renovation and expansion of facilities program, enabled by Yoakum County voters approving a \$2.95 million bond issue in 2002 for the extensive project.

The Meadows Foundation is a private philanthropic institution founded in 1948 by Algur and Virginia Meadows. Algur Meadows built General American Oil Company into one of the nation's most successful independent oil and gas production companies. The Meadows Foundation's assets have now grown to over \$800 million, and it has dispersed over \$430 million in grants and charitable expenditures to more than 2,000 Texas institutions.

The hospital's efforts to improve and expand patient facilities and programs for its patients undoubtedly played a significant role in the Meadows Foundation awarding the generous grant. Included in the hospital enhancement plans were a new, state of the art dialysis

are collected in January and February. Our savings account (fund balance) must be of adequate size to pay salaries and operating expenses from August until January when we start receiving income (taxes) to pay those expenses. Some of the tax money collected also goes toward replenishing our savings account (fund balance) for the next year.

The district must operate based on the information we have under the current funding system for Texas schools. Should the legislature develop a new funding system during the regular session in the Spring of 2005, everything

could change, but nothing is known about the future at this

Because of the uncertainty of the future, it is critical Plains ISD provide an adequate level of funding so we can maintain the outstanding programs we currently have. Supporting the board's decision to tax a \$1.50 per \$100 will help tremendously. Plains ISD will host a Question and Answer session before the election. Please watch this paper for an announcement of the time and location. I will also be glad to speak to any group interested in the election.

treatment center, a multi-faceted rehab and fitness center, expansion of birthing rooms and delivery room improvements, and improvements of the hospital's emergency room and a new pre-op and recovery room. The hospital's Dialysis Services of West Texas is a state of the art treatment center for dialysis patients. Its service area enables many patients to receive the vital and life sustaining treatments without traveling excessive miles. It will attract many new area patients, who prior to its opening were forced to make the three times per week trip to Midland/ Odessa or lubbock. The dialysis center features six patient treatment stations, with one required stand-by station, all featuring the very latest in equipment and monitoring systems.

The hospital's fitness center, West Texas Lifestyle and Rehab opened in September. The fitness center, Lifestyle, is crowded with virtually every fitness machine available, including weight machines, free weihts, elipticals, treadmills, bicycles, and much more. Rehabilitation therapy in the center includes a therapy swimming pool, vital to many recovering patients, two racquetball courts and a large assembly room. The public can have access to the facility's classes and equipment thru a membership program.

The renovation of the hospital's birthing rooms allows a family to stay with the mother as the baby is being born, and the larger rooms and updated equipment make the delivery a more enjoyable experience.

TheFoundation searches for programs and services employing imaginative, innovative ways to solve community problems through

projects leading to organizational self-sufficiency and in capital plans enabling agencies to flourish. It seeks to support projects to alleviate pain, enhance social skills, and promote better human relations. Their review of the Hospital's grant search indicated achieving these pre-requisites.


We Get Letters

CAPITOL COMMENT U.S. SENATOR KAY BAILEY HUTCHISON

In a recent column, I recalled our state's rich Native American history in light of opening the National Museum of American Indians. This week I want to tell you about another significant aspect of our past - the early Hispanic history in Texas in conjunction with another development in Washington.

After years of work, Congress enacted my legislation granting El Camino Real de los Tejas the status of a U.S. National Historic Trail - a privilige so rare onlt 15 other trails throughout the entire nation have been given that status by Congress.

In October, 2000, El Camino Real de Tierra Adentro was the first trail to be nationally recognized in Texas. Extending from Mexico City to San Juan Pueblo, New Mexico, this route once served as the sole artery for news, supplies, and travel to the far flung Spanish Colony of New Mexico.


Now, we take another step in enriching our heritage and education by recognizing El Camino Real de Tejas. For nearly 300 years, "The Royal Road" operated as a corridor for settlers, immigrants, Indians and the military. Its various trails assisted victories during both the American Revolutionary War and the Texas War of Independence, particularly during the infamous battle of the Alamo. Davy Crockett used a section of the trail to reach the Alamo while General Santa Anna launched a quick surprise attack on the Texans in San Antonio utilizing an adjacent trail. As the first major highway into Texas and Louisiana, El Camino Real opened the pathways to trade and cultural ex-

El Camino Real de los Tejas is more than a road, it's a 2,600 mile path embedded with footprints and tracks that narrate longstanding tales about Texas and all who settled here or simply passed through. As visitors travel down this winding route, they'll follow in the footsteps of Spanish Missionaries of 1691, Mexican and Texan armies of 1836, Anglo-American settlers and personages such as Jim Bowie and Sam Houston, all while observing Spanish missions in San Antonio, Caddo Indian mounds in Alto and a dozen historical small towns helping make Texas unique. Preserving this landmark enhances our heritage and culture, which is why I first proposed this important measure designating El Camino Real de los Tejas as a National Historic Trail. Under this legislation, the path will be recognized nation-wide on maps as a significant landmark. The law authorizes the National Park System, working under the Department of the Interior, to establish and maintain the trail. The designation gives landowners the right to opt in or opt out of those portions of the trail that are not public property, helping to protect private property owners. In addition the bill will allow our state agencies, such as the Texas Historical Commission, to participate in the establishment and designation of the trailt to boost tourism and economic development.

One reason for this law is to promote education for current and future Texans, as well as the many tourists who will visit each year. My bill allows the Secretary of the Interior to coordinate activities with the United States and Mexican public and nongovernmental organizations. By collaborating with Mexiacn institutions, academic programs will help enrich our knowledge of the trail's history, geography and cultures.

This legendary trail forged the way for early development of Texas into a Spanish colony, an independent Republic and finally, our nation's 28th state. It is not just a highway; it is the foundation of an inspirational past, and with this designation, will become an even more imprtant academic and economic aspect of Texas as our second national historical trail.


