

Sandy Land Observes 10th Anniversary

Water District has impressive record of service and achievements

Any definitive historical work on the State of Texas will contain extensive material about a natural resource Texans simply cannot exist without - water. Here in West Texas, a vast area under-blessed with precipitation common in other parts of the state, the role of ground water is absolutely critical for our ability to remain West Texans'.

In November, 1989, the voters of Yoakum County declared their awareness of the need to conserve, preserve and protect the underlying Ogallala Aquifer, the source for the entire South Plains groundwater. They voted approval to form the Sandy Land Underground Water Conservation District. Purposes and goals of the district included monitoring both water quality and quantity; service the county's two communities with water management plans; establish distancing rules for new agricultural irrigation wells; develop more efficient means of applying agricultural water; provide on farm assistance to producers for individual problems, and exercise self government through local control and regulation of the resource through local elections.

Following the election, a temporary Board of Directors were seated. An initial Board was later formed, consisting of David Turnbough, Presi-

loans to modify or replace irrigation systems. These improvements saved some 1,250 gallons of water per minute, or 75,000 gallons an hour. Assuming an irrigation season of 60 days, water savings totalled 108,000,000 gallons.

Sandy Land has been a generous contributor to county youth. Since 1991, the district has contributed equal amounts of scholarship funds to Denver City and Plains High School Seniors winning their annual water conservation essay contest. Through 1999, \$22,000 in scholarships have been awarded. Additionally, this year the district awarded two \$2,500 scholarships to two Tech graduate students who are working on advanced degrees involving water conservation or agriculture.

Since 1996, Sandy Land has assisted city governments of both Plains and Denver City with grant funds used in improving their water systems. Plains has received \$10,605, and Denver City \$36,500.

One of the major accomplishments of the district occurred in 1993, when it's board and the Yoakum County Commissioners Court approved the start up of the County Landfill, located on county land about half way between Plains and Denver City. There, waste from the cities is dumped, packed and covered, with each town paying a fee for the operation of the landfill. County residents may also dispose of waste on a fee basis. The landfill has saved every county

pared to other area cities contracting for hauling their refuse to distant landfills.

The water district manges the landfill operation. Sandy Land has annually received approval from the IRS to accept the water district's water depletion levels. Producers with wells showing depletion levels may claim healthy deductions for this loss on their annual tax returns. Almost seventy producers have taken advantage of these deductions. Exact figures for the deductions are impossible to calculate because of the individuals tax returns, but the tax benefits are very significant.



The biggest chunk of payments - \$3.3 billion - comes up front, and the Legislature was responsible for deciding what to do with most of it. 

NOTICE OF PETITION

Texas ALLTEL, Inc. (Texas ALLTEL) has filed a petition with the Public Utility Commission of Texas (Commission) to establish a surcharge to recover lost revenues and increased costs associated with Expanded Local Calling Service (ELCS) for several Texas ALLTEL exchanges. The submission of this petition is in accordance with the Commission's Substantive Rule 23.49 (c)(12), a measure established as a result of Senate Bill 632 in the 73rd session of the Texas State Legislature.

ELCS permits an exchange to expand its local calling scope to include one or more exchanges if customers approve by ballot the payment of an ELCS fee in lieu of long distance charges. The costs and lost revenues associated with this petition are those not recoverable through the ELCS fee.

If the Texas ALLTEL petition is approved, the company's basic local exchange customers will be assessed an additional monthly surcharge of \$2.30 for business, \$1.15 for residential and \$0.40 for Tel-Assist customers per access line. If approved by the Commission, the additional monthly surcharge will begin, on an interim basis, with the March 25, 2000 billing cycle, with an agreement to refund all or part of the charge if the Commission does not finally approve the rate.

The net annual effect on the revenues of Texas ALLTEL will be zero since the requested surcharge replaces lost revenues and reimburses Texas ALLTEL for the increased direct cost of service associated with all ELCS petitions placed in service since September 1, 1996. The estimated total lost revenues and increased costs Texas ALLTEL seeks to recover through this proceeding is \$41,027 monthly.

Are You Ready To Vote?

County residents planning to vote in the March 14 primary elections are reminded to make sure they are legally prepared to do so. Problems at the polls on election day can be avoided if your voter registration card contains all correct information. If any of the information on the card is incorrect, it must be corrected by the February 14 deadline. A visit to one of the two County Tax Assessor/Collector offices before the February 14 deadline to correct any errors will ensure a voter's eligibility.

Some of the more common errors on registration cards is incorrect addresses, or wrong voting precincts resulting when a voter moves. The deadline also applies to those residents who do not have a voter registration card, and first time voters.

In the March 14 primary elections, voters will be asked if they wish to vote in the Democrat or Republican primary. They will be allowed to vote either, but not both elections. Voters will be allowed to vote for either party candidates in the November general election.

Early voting for the primary elections starts here February 28, and ends March 10, and all voters are urged to take advantage of this opportunity, and avoid last minute problems which may arise on the March 14 date.




