

Spring Time Is..... Planting Time




While spring planting is not fully up to speed in Yoakum County, there is evidence of the eternal optimism of ag producers, with peanuts, watermelons and some cotton planting going on. The scene at left shows a crew on one of Larry Morrow's farms busy replenishing planter seed boxes with peanut seed. A number of peanut brokerage firms have again cash leased several thousand acres of land from local producers for peanut production.

The photo to the right shows watermelon transplanting taking place west of town. The four women riding the mechanical transplanter were getting a little relief from the heat and bright sun with the tarp over the machine. Not shown in the photo were two other women walking behind the planter, checking each plant. If a plant was not properly bedded in the ground, they would hand correct the problem.

Soil and water conservation districts are sponsoring Soil and Water Stewardship Week as a commitment to protecting our renewable resource."

PHS Sophs triumph over TAAS test again

For the fourth consecutive year, Sophomores at Plains High demolished the dreaded TAAS exit level exams. Their combined scores in reading, mathematics and writing averaged well over 90 percent passing grades, one of the requirements for a school campus to achieve the coveted Exemplary rating. Other factors, including school attendance records, are considered by the Texas Education Agency, but administrators here are confident Plains High School will be rated exemplary when all data is tabulated by TEA.

The TAAS tests, including the Sophomore exit level test, were mandated by the Texas Legislature several years ago. Starting in 2004, the exit level exams will be given to Junior class members. Currently, the law allows a Sophomore student seven chances to pass the exit level exam before the end of their Senior year to qualify for graduation certification.

High School Principal Steven O'Quinn told CCN, "I am extremely pleased with this great performance by our Sophomores. This is the first year our students have achieved 100 percent passing test scores in math. Twelve of these students scored high enough to qualify for exemption from the TASP college entrance exam, which is a great achievement."

PISD Superintendent Jim Haynes said he and all the administrators were excited over the repeat performance this year. "I think these excellent results are not only an indicator of how hard our students prepared for the TAAS test, but are a good indicator of how effectively our teaching staff is preparing them. The Board of Trustees and I are very well pleased with these test scores."

Boll Weevil Eradication Stresses Importance Of Accessibility To Fields

Planting has begun in the Western High Plains boll weevil eradication zone, and Texas Boll Weevil Eradication Foundation officials want to remind cotton producers that access to all sides of their fields is vital to the success of the eradication effort.

Traps are being placed as fields are planted and will be checked on a weekly basis during the growing season. Trapping all sides of the field and having access to those traps is especially important at the beginning of the season, said Zone Manager Darrell Dusek.

Trapping of fields during the seasonlong phase of eradication differs from the diapause phase the zone experienced last year. During diapause fields are trapped at a rate of one trap per 40 acres. The information gathered is used to

establish a baseline that data gathered in subsequent years can be compared with. The comparison aids in monitoring the progress of eradication in the zone.

During the seasonlong phase all treatment decisions are based on trap captures, so the information must be gathered in a timely fashion and must be accurate. The trapping rate increases to one trap each one, twentieth mile.

The information from these traps provides a picture of weevil activity in the fields, so if fields are not trapped on all sides, the picture is incomplete and treatment decisions are affected, Dusek said.



form a sort of barrier to detect weevils as they move into the fields."

Weevils entering through an untrapped side of a field will not be detected, and the field may not be treated until the weevil population has increased to a level detectable by the other traps, he said. Trapping and checking all sides of the field enables program personnel to target portions of the field, helping to preserve beneficial insects and lowering the cost of the program to producers.

Catching the weevils early reduces both damage in the field and the need to spray later in the season, which also helps preserve beneficials and keeps program costs down, Dusek said.

Foundation personnel will


work with growers, within established guidelines, to place traps where they will be effective and cause the least amount of disruption to operations, according to a newsletter sent to growers.

Producers who have questions about trapping should contact their district supervisor. 

NOTICE OF RECEIPT OF APPLICATION AND INTENT TO OBTAIN A WATER QUALITY PERMIT

PERMIT NO. 10114-001

APPLICATION. City of Plains, P.O. Box 550, Plains, Texas 79355, a domestic wastewater treatment operation, has applied to the Texas Natural Resources Conservation Commission (TNRCC) to amend wastewater disposal Permit No. 10114-001 to authorize the reduction of the monitoring frequency for biochemical oxygen demand and pH. The domestic wastewater treatment facility is located approximately one mile east of State Highway 214 and 1.5 miles north of U.S. Highway 380 in Yoakum County, Texas. This application was submitted to the TNRCC on June 9, 1999. The permit application is available for viewing and copying at the Plains City Hall, 601 11th Street, Plains, Texas 79355

The TNRCC executive director has determined the application is administratively complete and will conduct a technical review of the application. After completion of the technical review, the TNRCC will issue a Notice of Application and Preliminary Decision.

MAILING LISTS. You may ask to be placed on a mailing list to obtain additional information on this application by sending a request to the Office of the Chief Clerk at the address below. You may also ask to be on a county-wide mailing list to receive public notice for TNRCC permits in the county.

PUBLIC COMMENT/PUBLIC MEETING. You may submit public comments or request a public meeting about this application. The purpose of a public meeting is to provide the opportunity to submit comments or to ask questions about the application. The TNRCC will hold a public meeting if the executive director determines that there is significant degree of public interest in the application or if requested by a local legislator. A public meeting is not a contested case hearing.

Written public comments should be submitted to the Office of the Chief Clerk, MC 105, TNRCC, P.O. Box 13087, Austin, TX 78711-3087.


ADDITIONAL NOTICE. After technical review of the application is complete, the executive director may prepare a draft permit and will issue a preliminary decision of the application. **Notice of the Application and Preliminary Decision will be published and mailed to those who are on the county-wide mailing list or the mailing list for this application. That notice will contain the final deadline for submitting public comments.**

OPPORTUNITY FOR A CONTESTED CASE HEARING. After the deadline for public comments, the executive director will consider the comments and prepare a response to all relevant and material, or significant public comments. **The response to comments, along with the executive director's decision on the application, will be mailed to everyone who submitted public comments or who requested to be on a mailing list for this application. The mailing will also provide instructions for requesting reconsideration of the executive director's decision and for requesting a contested case hearing.** A contested case hearing is a legal proceeding similar to a civil trial in a state district court.


A contested case hearing will only be granted based on disputed issues of fact that are relevant and material to the Commission's decision on the application. Further, the Commission will only grant a hearing on issues that were raised during the public comment period and not withdrawn.

The Texas Economy: Older And Wiser

The decade of the 1990's was a period of remarkable growth in the Texas economy, according to economists at the Texas Comptroller of Public Accounts.

- Consider;
- * Texas had no recessions
 - * 2.35 million jobs were created, more than any other state.
 - * Average annual job growth was 3 percent statewide.
 - * Job growth in rural counties was more than 2.5% per year.
 - * Real gross state product growth, net of inflation, was 4.5 % per year on average.

Such sustained growth was welcomed after the 1980's when Texas had multiple recessions.

In the next decade, Comptroller economists expect a more mature Texas economy. Annual rate of growth is estimated at 2.2% and gross state product will grow 3.6%.

Here is a sector-by-sector look at the state of the Texas economy in the new decade:

AGRICULTURE

The gross state product from agriculture grew an average

4.5% a year in the 90's, despite droughts and price instability. Agriculture employment grew to 268,000 in 1998 from 227,000 in 1990.

MINING

The oil and gas industry, where employment declined by an average of 1.5% in the 1990's, has more struggles ahead. Through 2010, the industry will lose 1,300 jobs.

CONSTRUCTION

In 1998, Texas housing construction reached its highest level in over a dozen years with 170,000 units built. In the new decade, migration and a healthy economy should keep housing starts between 150,000 and 190,000, and job growth should be about 1.8% a year.

MANUFACTURING

Highest manufacturing growth rate over the next decade is expected to be in miscellaneous non-durable goods, mostly plastics. Texas is set to capitalize on abundant raw material sources from its petrochemical industry. Computer and electronics employment

will grow at a slower pace. Job growth for these industries is expected to slow to 1.5% annually, compared to 2.3% in the 90's.

TRANSPORTATION, COMMUNICATIONS, PUBLIC UTILITIES

Communications, mostly cellular and standard phones and modem services will see jobs growth at 3.9%, third fastest of any sector. Transportation jobs will grow at 3.4%, while jobs in utilities sector, with increased competition from deregulation, will grow at only 0.3%

FINANCE, INSURANCE, REAL ESTATE

These industries that revolve around money are expected to add far fewer jobs in the new decade, with the real estate sec-

tor especially flat.

SERVICES

The services industry is expected to account for 47% of the state's non-farm jobs growth, about 108,000 jobs annually.

RETAIL

Retail employment will gain jobs at a 2% rate annually, while wholesale trade jobs will grow by 1.3%. Proficiency in more than one language will be a great plus for job hunters.

GOVERNMENT

Employment in local government will increase, with virtually no new jobs in the federal sector. School jobs will grow at 2.2%, and state jobs at 1.3%







Plains Independent School District Trustee Election Information

The two maps accompanying this article show the boundaries for Plains ISD Trustee District 1 and Plains ISD Trustee-District 5. District 1 is highlighted on the city map at the top of the page, and District 5 is highlighted on the larger map at the bottom of the page. These maps are provided for your information to help you determine if you live in the area described by these two districts. You must be a resident of Dist. 1 to vote for the trustee in Dist. 1 and you must be a resident of Dist. 5 to vote for the trustee in Dist. 5. The other trustee position open is Dist. 6 at-large. As long as you are residing within the boundaries of Plains Independent School District you are eligible to vote for the Dist. 6 at-large position. If you are unable to determine the trustee district in which you reside, help will be available at the polling place.

Early voting for school district trustee positions can be accomplished at the Plains ISD administration building beginning April 19 and ending May 2. The election will be held May 6 at the Plains ISD auditorium foyer.

The candidates for District 1 are Anna Gonzalez and Ramon Diaz. The candidates for District 5 are Brad Crump and John Gray. Brad Palmer is running unopposed for the trustee position of District 6 at-large.
