EEOC Settles Sexual Harassment Suit Against Ron-Bar, Inc.

EEOC Claims Female Employee Subjected to Full Body Strip Search and Forced to Quit

EL PASO, Texas - The U.S. **Equal Employment Opportunity** Commission ("EEOC"), today announced that it settled an employment discrimination lawsuit it had filed against Ron-Bar, Inc. ("Ron-Bar") a corporation which owas a Burger King franchise in Odessa, Texas. The EEOC's suit, filed under Title VII of the Civil Rights Act of 1964, asserts unlawful employment practices on the basis of gender, and seeks to provide relief to a female charging party, who alleges that she was subjected to a hostile work environment, and constructively discharged, in violation of Title VII, because of her gender.

More specifically, the EEOC alleges in its lawsuit, that the female charging party was sexually harassed and forced to quit when she was required to submit to a full body strip search at work.

Defendant denies all allega-

tions of wrongdoing as alleged by the EEOC and female charging party.

Under the terms of the Consent Decree, Ron-Bar will pay charging party the sum total of \$35,563.00 Additionally, Ron-Bar has agreed, among other things, not to discriminate against its female employees, because of their gender and to provide a workplace which is free of gender discrimination.

"The sexual harassment to which the female charging party claims she was subjected, in this case, was egregious. The EEOC is hopeful that, as a result of this lawsuit, no other female employee will have such an experience in the future," said Leticia Dominguez, Trial Attorney at the EEOC.

The EEOC filed suit after exhausting its conciliation efforts to reach a voluntary pre-Effgation settlement. The lawsuit. Civil Action No. MO-02-CA-157, was

filed on August 8, 2002, in the United States District Court for the Western District of Texas, El Paso Division, and then transferred to the Midland-Odessa Division.

The EEOC enforces Title VII of the Civil Rights Act of 1964, which prohibits employment discrimination based on race, color, religion, sex, or national origin; the Age Discrimination in Employment Act, the Equal Pay Act, Title I of the Americans with Disabilities Act, which prohibits employment discrimination against people with disabilities in the private sector and states and local governments; Rehabilitation Act of 1973 's prohibitions against discrimination affecting dividuals with disabilities in State Meral government; and sections, the Civil Rights Act of 1991. Children in Extreme Poverty Need Nation's Attention

Child poverty is at shameful, epidemic levels in the United States, especially for black and Latino kids.

The Children's Defense Fund recently released a study that revealed that the number of black children under 18 in extreme poverty was at a record high. The organization, using current U.S. Census figures, found that the number is the highest it has been in the 23 years since the statistics have been kept.

"Extreme poverty" is denned as a family whose after-tax income is less than half of what the federal government defines as the poverty line. In this study, the "extreme poverty" line for a family of three was a mere \$7,064 of disposable income.

Although the study also showed that overall poverty is down in this country, that is not the case for extreme poverty of black.

Latino and white children. There were nearly 932,000 black children in extreme poverty in 2001, the latest year the statistics are available. That is up 50 percent from 622,000 in 1999. Latino children in extreme poverty numbered at 733,000, an increase of 13 percent from 1999. And white children in the same group numbered at 1.8 million, up 2 percent since 1999.

We may like to think that

poverty is something that exists only in some so-called Third World country. But these statistics should force us to focus on extreme poverty right here in the United States. Too many of us are ignorant of, or indifferent to, the plight of poor and minority kids.

As Congress debates proposed tax cuts and whether to renew the 1996 welfare legislation — including cuts of Head Start programs and child health programs - policymakers should consider the study carefully before enacting laws that could have detrimental consequences on the well-being of millions of children.

The startling rigures should force us all to take action. We can no longer afford to sit idly by as large tax cuts for the wealthy few supersede the day-today needs of those in extreme poverty.

Congress should increase the childcare supplements/ and the welfare reauthorization bill should specifically direct more money to job training. Additionally, states should offer wage supplements to women in minimum-wage jobs. Filling these holes in the "welfare-to-work safety net" would benefit parents as well as to their children. In the richest nation in the world, we should not measure our success in economic wealth, but in the social condition of our downtrodden — especially our children.

Upward Bound Students Teach Blind Adults to Build Computers

Stucents enrolled in the Texas
Tech Upward Bound CLEAR
Scholars Visions class have been
providing instruction to blind and
low vision individuals related to
building computers and the usage
of accessibility software. As the
close of the class the blind participants will receive the computers
they've learn to build.

As part of the five-week course, Upward Bound students attended sensitivity workshops led by the South Plains Council of the Blind, the Life Run Independent Living Center and the Virginia Sowell Center for the Visually Impaired. These workshops helped the Upward Bounders to become more aware of various concepts related to working with visually impaired individuals. In addition, the students in the class had to eventually demonstrate their ability to assemble a computer blindfolded and to operate the accessibility software by keystroke and with the monitors turned off. The accessibil-

ity software installed on the computers came with voice synthesizers that read emails and web pages out loud.

According to Dr. Dean Fontenot, Managing Director of the SBC CLEAR Project, the TTU College of Engineering Program that joined with the Lubbock Area Foundation in funding the course said "We typically do not think of high school students from backgrounds similar to those represented in Upward Bound as being able teach others to build computes; nor do we think of blind individuals as being able to build their own computers or even knowing how to use a computer. This class will go a long way in dispelling these two antiquated myths,"

Jim Gatteys, the course's instructor and himself a blind individual, explained. "For a blind person a computer mouse might as well be a paperweight. The blindfold and the fact that the monitors

were turned off helped students to understand this. These computers and the software they've installed will allow the blind participants to enter the computer age and experience the cyber world for the first time"

George Olivas, one of the class' blind participants said, "Before I took this class I had never even touched a computer, let alone turned one on. Today, I'm learning to type an email to my grand kids."

The Jobs Access with Speech software or JAWS that was installed with the computers is manufactured by the Freedom Scientific Company. The company donated one

version of the software to the class.

A demonstration of the class project will be presented to the

American Council of the Blind in the spring.

The Upward Bound students and the visually impaired adults all signed E-Mentoring Pacts, whereby the students will mentor the adults on the usage their new technology and the visually impaired adults will mentor the Upward Bounders on issues related to life skills.



born again, or "born from above," means a transformation of a person so that he is able to enter another world and adapt to its condition Plainly put, "To belong to the heavenly kingdom, one must be born. The question posed by Nicodemus next in verse 4 shows his interest and ignorance in the matter, for he wanted to know "How is this possible? Can a man enter the second time into his mother's womb, and be born"? Jesus replied with a verily, verily (meant to really get his attention) except a man be born of water and of the spirit, he cannot enter the kingdom. Jesus ministry coming shortly after the ministry of John the Baptist leads us to believe that the "water" spoken of here would relate to water baptism which signifies "repentance" and the coming messenger of God who would endow men with the Holy Spirit. Jesus words are paralleled with the promise in Ezekiel 36: 25-28, "I will sprinkle clean water on you, and you will be clean; I will cleanse you from all your impurities and from all your idols. I will give you a new heart and put a new spirit in you; I will remove from you your heart of stone and give you a new heart of flesh. I will put my Spirit in you and move you to follow my decrees and he careful to keep my laws. The spiritual principle of these verses accords with that of the new birth that Jesus taught.



Public Release for Free and Reduced-Price Meals

Texas Tech University Early Head Start Program today announced its policy for free and reduced-price meals served under the Child and Adult Care Food Program. Each facility and Texas Tech University Early Head Start has a copy of the policy, which anyone may review. "The following household size and income criteria will be used to determine eligibility:

For family units with more than 8 members, add \$3,140 for each additional member.

"Children from households whose income is at or below the levels shown are eligible for free or reduced-price meals. Application forms and a letter to

parents or guardians are being sent to all homes. To apply for free or reduced-price meals, households should fill out the application and return it to the contractor. Additional copies are available at the contractor's office. The information provided on the application will be used to determine eligibility, it may be verified any time during the contract year by the contractor or other program officials. Households must provide the following information on the application: all household memb'as' names, the Social Security number of the head of the household (or other responsible adult), and all household members' incomes by source, OR the household's food stamp or AFDC case number, if appropriate and the signature of an adult household member certifying that the information is correct. Applications may be submitted any time during the year. According to the free and reduced-price policy, La Nelle Ethridge will review applications and determine eligibility. Parents or guardians dissatisfied with the ruling of the official may discuss the decision with La Nelle Ethridge. Parents may request a formal appeal either

Someone

brought in the idea of a spectacle such as the one in Sandy, Utah—a suburb of Salt Lake City—where a flag was planted in a grassy field as the name of each 9-11 victim was read aloud.

The planners quickly dedicated themselves to recreating the scene in Lubbock. A similar display has been scheduled in Florida at the urging of Governor Jeb Bush. The Lubbock event will be the first in Texas.

Back to the question of volunteers: it will take hundreds of people helping with assembly of the flags and poles and with various other aspects of the two-day spectacular.
