MY BROTHER'S KEEPER

LESTER C. MEANS

"We don't want to be involved"

The seventeenth century post-preacher John Dunn gave to the world these now widely quoted words: "No man is an island, entire of itself every man is a piece of the continent, a part of the main." If a clod be wasted or washed away by the sea, Europe is less, as well as if a promontory were, as well as if a manor of thy friends or of thine own were; any man's death diminishes me, because I am involved in man kind, and therefore never send to know for whom the bell tolls; the bell tolls for thee." Sure enough, each of us is deeply involved in all mankind and there is nothing that happens anywhere in the world that affects people that is not a matter of our concern.

This has been true since the very beginning of time, though me u have not always realized it. For example, at the very dawn of man's history Cain answered the question of the Lord by saying, "AM I MY BROTHER'S KEEPER?" It was not until later that he realized that the answer was "YES". And in the meantime, he had disregarded the rights of his brother and had even murdered him. As a result of this lack of concern for his brother, Cain received a curse and became a fugitive and a wonderer. I am convinced that after all these centuries there are still the decendants of Cain as it were in the world then. They are cursed by their own lack of concern for their fellowmen.

I don't know how many of you who take time to read your Bible, but if you do then you know that Jesus had some rather harsh words to say about those who were NOT concerned about their brethern. In Matthew 25 is the great scene of the Judgement, and toward the end of that chapter those who were sent away asked, saying, "Lord, when saw we thee hungry, or athirst, or a stranger, or naked, or sick, or in prison, and did not minister unto thee? His answer: "Verily I say unto you, inasmuch as ye did it NOT unto one of these least, ye did it NOT unto me." It is in Luke 16 that we read the story of the famed rich man who is often called by the name Dives. He is not described a liar or a thief; there is no indication in the story that he committed murder or adultery, or that he had sown seeds to discord and stirred up strife. None of these things is mentioned. Rather, he is described as a man who lived sumptuously, dressed in purple, and had a fine table. His sin was that he disregarded the beggar Lazarus, who lay at his gate

It is in the Tenth chapter of this same Gospel of Luke that we read about a man whose name is never mentioned, going down a dangerous road which leads from Jerusalem to Jericho. On either side there are hills that are enfested with cut-throats and thieves. Immediately, you recognize this as the story of the good Samaritan. Jesus told the story in answer to a question, "Who is my neighbor?"

Now some would say that this Samaritan really was a rather irrational man. He should have had the sense to see that this was a dangerous spot and if he remained there he likewise might be robbed and beaten. He should have had the insight to realize that the man he was helping was a man of a race that looked down upon his own race and that he would likely get no thanks for his efforts. After all, he was a Samaritan, despised by the Jews, and looked down upon as if he were a dog. I do not know what it was that caused him to stop. But stop he did. I guess it was his conscience, his sense of honor, and his sense of integrity. Certainly, it did involve unselfishness and love.

Today we live in an age when more and more people are running away from danger. They are resisting responsibility and saying, "I am not going to have anything to do with it"..."I don't want to get involved." In our day there is a disturbing tendency away from being involved in the needs of other people. A little 12 year-old boy needed someone to get involved the 10th day of August for getting involved may have saved this little boy's life. This little 12 year-old boy was murdered by another 14 year-old boy in Green-Fair Manor, on Weber

There are several apartments in this area--with several tenants-and yet not a one of them took time to stop the argument between these two small boys? Why? You may ask--THEY DID NOT WANT TO BECOME INVOLVED.

What are the reasons why we as a people do not become involved? Well, there are THREE. The first is FEAR, paralyzing FEAR, which leads people to think, "I don't know how, I can't." WE NEED TO RISE ABOVE OUR FEARS.

The second, and this is bigger, is SELFISHNESS, some say "Why should I get involved? Why should I risk my reputation, or my time, for somebody else?"

Beyond FEAR and SELFISHNESS, there is INDIFFERENCE. People are so busy, so preoccupied that they just do not even see the world's

Adults, you ought to stop and think. Just put yourself in this boy's mother's place -- that could have been your child, you know -- then you would have wanted everyone in Lubbock to feel sorry for you. YES, you would have wanted everyone to become involved, then why not do unto others as you would have them do unto you? You hollow about how you want to be intergrated and yet you don't think enough of your own race to even try to prevent your own children from being murdered!! Who wants that kind of a neighbor? Why not even another legro if he is self-respecting


It is a shame when so-called parents can't control a child which is little more than a baby. (Oh, I know that some of you are afraid of your own children -- after all you wean them). And some are so busy doing things that they should not do themselves that they just don't have the time to rear their children. TRAIN A CHILD IN THE WAY IT SHOULD GO AND WHEN HE IS OLD HE WILL NOT DEPART FROM IT

..... Listen, YOU, train a child by EXAMPLE. What kind of an example are you setting before your children? Many children want to be like father and mother (remember that). There ought to be a law where the parents of children be punished for the crimes committed by their children, and you would see quite a difference in the behavior of the children --- you know, they claim that they can't handle their children now, but if there was such a lawthey would handle them.

Victim Here

Final rites were held Monday afternoon for Clayton Wallace, Jr., 13, son of Mr. and Mrs. Clayton Wallace, Sr., 2609-D Weber Drive, who was fatally stabbed last Thursday night.

Services were held in the Mount Gilead Baptist Church with Rev. S.R. Roberts, pastor, officiating. The South Plains Funeral Home directed the burial in the Peaceful Gardens Cemetery.

According to authorities, a 13 year-old youth is being held in regard to the incident. The youth was transferred to custody of juvenile probation officers the following morning. A delinquency petition was expected to be filed this week.

According to police, the victim, Clayton, died at Methodist Hospital soon after he had named his assailant to his mother.

The stabbing took place about 7:30 p.m. Thursday behind a laundromat in 2700-block Weber Drive following an argument.

It was learned later that there were three other boys who witnessed the affair.

The suspect was arrested at his

home on Avenue B. Juvenile officers said last Friday morning that a knife had been recovered, but that another one one also was sought.

Young Wallace suffered a wound below his right shoulder blade and a small cut on his arm.



Texan Offers Guidelines For "Effective Intergroup Relations"

lations" were advanced last week by Community Council Director Russell Rine, as preventive measures for racial disorders which have plagued the nation.

The guidelines proposed were part of an overall look at the riots around the nation and specifically as they would apply to Texas communities, as viewed by Rine, Texas Congressman Jim Wright, state Senator Don Kennard and Legislator Don Gladden.

Noting that Negroes and many other races become disgusted when they "are living in the midst of this land of plenty and are not sharing in it," Rine pointed out that "Negro unemployment was in the depths of the depression.

"Racial unrest has been caused because promise after promise that the total community has made handles heavy sacks weighing up has fallen short of fulfillment."

He suggested that: -- Inter-religious under standing flourishes when people of different religions are working for a common cause.

-- Positive, constructive leadership by elected officials help to maintain community harmony. -- An official human relations commission and a program of

Fort Worth--(NPI)--Four guide police and community relations lines for "effective intergroup re- | are necessary to aid community leaders.

-- Establishment of lines of communication and an attitude of open-mindness from the "power pyramid" in a city into all sections of the community.

Wright, Kennard and Gladden, speaking before labor groups, urged organized labor to expand its program and activities, to take up the slack in Negro job placement and union membership.


