Panthers Track And Field Team Reach For New Marks

Those fighting Dunbar Panthers ripped off a blazing 41.8 in the 440 yard relay last Saturday in the Brownfield Invitational to highlight area prep school track and field activity last week.

According to the clockingposted by the quartet of Claudell Morgan, Sidney Hall, Roy Davis, and Robert "Rocket" Medlock, it is the fastest in the state to date. This clocking came in the prelimenaries. Dunbar ran a mere 42 flat in the finals.

Medlock remained undefeated as he won the 100 yard dash in a record-tying 9.8, outstepping his teammate Morgan and then came back to win the 220 in 22.7 after having established a new meet record of 22.3 in the prelimenaries.

Coach Prenis Williams' chargers won the meet easily as they rolled up 162 points to Herefords'

Aside from this, the Panthers cracked the mile relay record with a 3:24.3 clocking for the only new mark of the day.

Urban Renewal: Items You Should Know

An American's home is supposed to be his castle. A substantial portion of the Constitution of the United States of America is devoted to the specific aim of protecting citizens in their right to own property and to be secure in the ownership and use of it.

But there is a certain organization at work in the United States and right here in the city of Lubbock which seems to ignore all of those very Constitutional protections. If you just happen to live in a pleasant well kept residental neighborhood, which city planners think should be wiped out and rebuilt, then brother you're out of luck, because the city government can condemn the whole neighborhood if they want to and convert it into a public park, or sell it to some out-of-town developer who promises to put up buildings which the official planners

When city planners decide that they would like to tear down everything in a whole section of the city and redesign it to suit their taste, (remember, their taste not yours), they can get tax money, (your tax money out of the federal treasury for the scheme. At this point it must be pointed out that these planners do have certain formalities that they

First of all, the planners must present the federal Urban Renewal Administration plans for a Workable Program, meaning an Urban Renewal project which meets all specifications of the federal agencies, and is pleasing in the sight of the agency officials.

Of course this could be a big hurdle. How can lesser planners in small country towns draw up something to satisfy the Great Planners in Washington? Where will they get the money for working out their plans? The Urban Renewal Administration will advance funds to pay for surveys and planning work necessary to draw up the Workable Program. Nice of them, eh? But did you know that some of the federal advances for this initial survey-and-planning job runs into hundreds of thousands of dollars?

After the Workable Program has been presented to Washington officials and approved, the city government gets tax money from the federal treasury to buy all property in the project area. If any citizen refuses to sell, the city government condemns their property and forces

The wholesale eviction of people from an Urban Renewal area often leaves many families without a place to live, and business firms without a place of business. The city government can get, from the federal treasury, \$100.00 to pay the moving expenses of each displaced person, and \$2,500.00 for the moving expenses of each displaced business firm.

If there is no housing available for persons evicted from an Urban Renewal area, the city can get tax money from the national treasury to build "low-rent" public housing. It si called "low-rent", because the persons living in it do not pay much rent for the privilege of living there. The federal government provides an annual subsidy to operate "low-rent" public housing projects. The projects could accurately be called "very high rent" housing, if the rent which tenents pay were added to the "rent" which ALL taxpayers pay on each public housing project—in the form of federal subsidies to meet the cost of operation. A business firm evicted from an Urban Renewal project can usually get loans through some federal agency to acquire new quarters elsewhere.

Once human beings are removed from an Urban Renewal project, the city uses United States tax money to demolish and remove everything else—leaving the project area naked and ready for a fresh start.

The city can sell the entire profect area to private developers who promise to build in compliance with specifications of the Workable Program. Often, the area is sold in one piece to one buyer. This generally means that only big real estate operators or syndicates can buy. It follows that many, if not most, major Urban Renewal projects are developed by big firms or syndicates which specialize in buying and developing "Urban Renewed" land.

The private firms which buy the cleared Urban Renewal project land can get tax money, from federal lending agencies, to do the developing. But the land and the developments are THEIRS—to be used for their own private profit, under certain provisions. Here are controls imposed on private developers of Urban Renewal projects:

(1) They must build something that conforms with the planners'

dreams as revealed in the Workable Program.

(2) They must abide by whatever federal requirements may be made under the terms of Section 106 (c) (7) of the Housing Act of 1949, as amended, which provides that the Urban Renewal Administrator; "notwithstanding the provisions of any other law, may ... include in any contract or instrument made pursuant to this title such other covenants,



TWO CHURCHES' MACHINES LOOTED

Now it's the churches of the community, not the schools, that are being robbed by unknown peo-

The first church to be robbed was the Mount Gilead Baptist. Rev. S. R. Roberts, pastor, reported the burgalry to the Lubbock Police Department last Friday evening. It was learned that someone had

conditions, or provisions...as he may deem necessary."

(3) They must comply with Section 109 (a) of the Federal Housing Law, which contains the Davis-Bacon Act provision that the Secretary of Labor has absolute power to set wage scales for all work connected with a federally-financed Urban Renewal project. This is a law which union bosses lobbied through Congress. Its purpose is to force private contractors, when using federal tax money, to hire union labor, or, at least, to pay whatever wages union bosses want paid-regardless of local conditions and wage scales.

(4) Private developers of federally financed Urban Renewal projects must comply with "no racial discrimination."

Apart from these political restrictions, the private developers who buy land confiscated from private owners in an Urban Renewal area, and develop the land with Federal Tax Money, enjoy ownership of the development.

The major burden to the taxpayers, in an Urban Renewal project, is the net cost of acquiring and clearing the land.

While the major burden to the citizens living in a Project Area is the moving, relocation, and heartbreak with leaving their homes at their personal expense for the benefit of a chosen few.

Another family incident happened here which led to the husband shooting his wife. It was learned that a bullet did graze her eyebrow and temple. She was also shot in the left thigh.


