## Brownwood Files **Protest Against WF**

The aftermath of a game at Wichita Falls, Texas, between the teams of Washington High and Brownwood High Schools, led to a letter of protest which was drafted over the actions of high school football fans during the contest.

The letter was written by Brownwood Independent School District Superintendent Guy T. Smith, after receiving several telephone calls complaining about the treatment the Brownwood team allegedly received at Wichita Falls.

However, the athletic director of Wichita Falls High Schools rejected the complaint by Brownwood school officials. He said that he had no evidence that would warrant a protest by Brownwood. Washington won the contest 20-

Guy Smith said that Washington fans used vulgar language, threatened bodily harm, started numerous fights, touched members of the Brownwood drill team and ran up and down the sidelines when seats were available in the stands. He also made it known that Washington coaches interferred with game officials.

#### Lubbock Youth Receives **Gunshot Wound**

Last week Lubbock police were investigating a shooting incident which left a teenager in extremely critical condition at Methodist Hospital.

According to officers, the 18year old youth, Stanley Smith, suffered a gunshot wound between the eyes. Witnesses told police that the shooting occurred shortly before 10:00 p.m. in the 200 block of Avenue R.

Some teenage friends of Smith, who were at the scene when the shooting occurred, flagged a passing motorist at the intersection of after their car broke down enroute to the hospital.

The game of the year in District 3-AAA play will probably be reeled off here in Lubbock Saturday night, the 12th, at Lowery Field, when undefeated Estacado takes on the defending district champions, Dunbar in a district tilt.

The Panthers hold a 1-1-1 record for the season. Their tie came about when they played the Mustangs of Sweetwater. The score ended 6-6.

On the other hand, the fighting Matadors of Estacado have not been defeated this year, nor has any team in District 3-AAA scored on them.

The contest should decide the leader in district play, and help determine Lubbock's chances of sending a team to state play in 3-AAA.

#### Estacado Downs Levelland

A crowd of more than 3,000 fans were on hand last Thursday night at Lowery field to see the Estacado Matadors pulverize those eleven from Levelland, 69-0.

This was not a record by any means, since the record goes back as far as 1921, when Lubbock defeated Post City, 93-0, and Dunbar High School did score 69 points agains Big Spring in 1960.

However, those Matadors played as much defense if not more, as their explosive offense.

The Matadors scored two touchdowns in the first quarter when James Mosley snagged an 18 yard aerial from Kenneth Wallace. Another came when Frank Judie scampered twenty yards for pay dirt. In the second quarter, the Matadors equaled the first when Larry Miller ran for 15 yards and Kenneth Wallace scored on a 59 yard punt return.

In the second half, Mosley, Joe Benson, Jesse Bozeman and Lethridge added to the scoring fete.

#### **Dunbar Defeats Slaton**

Those defending 3-AAA District Champions, the Dunbar Panthers, outlasted the Tigers of Slaton last Friday night at Slaton, to the score of 41-19.

A 70-yard scoring jaunt by Ernie Davis and a pass interception by A. G. Perryman put the victory away for Dunbar.

Dunbar scored 20 points in the fourth quarter and the other 21 points came in the first and second quarters. Slaton was able to score in the first, second and fourth quarters.

In looking at the statistics; Dunbar collected 15 first downs with Slaton leading with 18. However, the Panthers were able to capture honors in yards gained in rushing when they came up with 326 against the Tiger's 218. In the passing department, Slaton had 69 yards against Dunbar's 44.

Mrs. E. C. Struggs has been appointed as local chairman of the Coretta Scott King Memorial Association of University Women.


