EDITORIAL

Lack of understanding in regard to "penny antie" situations can and have caused much trouble between the Negro community and the ruling white community throughout the years in this great country of ours.

Last Saturday night at a regular dance activity sponsored by a local private club, such just a misunderstanding came about again.

This organization, Caprock Lodge of Elks I.B.P.E.O. W. gave a social activity at their lodge hall, at 616 16th Street. During the course of the activity, two uniformed City of Lubbock Police Officers entered the building, without request, and caused an incident which could very well lead to a great deal of misunderstanding between the communities for a long time to come.

To quote the rap sheet, "in checking a 'joint', the two officers discovered a person present who allegedly was drunk and subsequently arrested that person.

The West Texas Times is not concerned with upholding any citizen who has broken the law — regardless of the race of the individual involved. But the Times, without any reservations, is concerned about the "right way" to arrest anyone, or about the conduct portrayed by either of the parties involved, be they citizens or police.

Last Saturday night, a representative of the Times was on hand, and we feel that certain legal technicalities were either bent or completely forgotten in the pursuit of law and order. Granted, the shining of flashlights in people's faces in a private organization attending a dance might not have been illegal, but it certainly was uncouth in regard to manners. It would be interesting to know how it is if you belong to the Elks, Masons, Lions or Odd Fellows in Lubbock, to be presented with this same problem in West Lubbock, since the precedent has been established in East Lubbock.

The whole incident is unfortunate, in that the police entered a private organization — without being summoned — without justification, unless "checking out a joint" is justification — and technically without finding anyone on the premises who wished to testify to the fact that the person involved was anything but drunk.

Several weeks ago, a similar incident occurred in the city, at a local dance in which a Negro patrolman and a Latin-American patrolman had been assigned to "off-duty" work. In this situation, the situation arose where two young "bucks" worked off their vigor on each other, and the patrolmen had to arrest the participants in the altercation. Later when the two arrested citizens were taken outside the building, a group gathered to witness the final stage of the arrest, sending everyone to jail and so-forth. The Latin-American policeman became a little over anxious in the performance of his duty and shoved and pushed several members of the crowd. Without the cool assistance of the Negro policeman on duty, this performance might have turned into a very ugly incident. As it turned out, everything worked out to the better...without the problems involved when a crowd gets unruly and out of hand. The Times would like to take its hat off to Officer Lawrence Fury in his effort that Sunday night, and again to Officer Lawrence Fury and Officer James Price last Saturday night for putting a stop to a situation that had just about gotten out of hand by the time they arrived on the scene. Only through understanding and some concern, can you find policemen who rectify a grave error in judgement when tensions run high and emotions sometimes out of hand.

The time has come when we as citizens should quit sweeping small acts such as these under the rug, and deal with them as they should be. With this type of action on the part of any party involved, local citizen or law enforcement agency, it can only lead to a much more dangerous situation in the future, which can't be handled by anyone.

For almost seven years now, the Times has taken the opportunity whenever possible to cooperate with all involved to keep the Lubbock community, both black and white in a state of limbo, where both of its citizens could live in an atmosphere conducive to the betterment of racial harmony and understanding. The Times will continue to do just this job, with the understanding that the "downtown" establishment will endeavor to do what-so-ever is necessary to play down the emotionalism sweeping the country nationwide about how soon a Negro is going to riot, just because he is a Negro. Understanding rests on communication, and communication rests on the fact that regardless of what may have happened anywhere else in this United States, we the Negro representatives of the Negro community of Lubbock will always be interested in Lubbock, and how we can maintain and make it a better community, regardless of the feeling anywhere else in the country. For this reason, it would be criminal on the part of anyone—black or white—to try to create an incident here because of the feelings that are now running wild across this country. Remember this, just because the Negro in Watts rioted, just because Detroit had troubles, and just because Newark had problems doesn't mean that everyone, white or black in this nation, and especially in Lubbock — East or West — would like to see a misunderstanding turn into a situation that would give the citizens of this city a black eye in regard to how we feel.

Those fighting Dunbar Panthers got off to a tremendous start this year by blanking the eleven from Snyder last Friday night there by a high counting 21 - 0.

This win, which was the first game of the season for the Maroon and White, built their stand to 1-0 in defense of its 3-AAA title.

According to Coach James Hill-yer, "The defense was responsible for this."

Dunbar's A. G. Perryman, an all-state lineman last season, carried in for Dunbar's two first half touchdowns and was the only offensive spark during the contest. He attributed 51 yards on 16 carries for the Panthers.

In looking at the Panther defense early in the season, they held Snyder to only 33 yards on the ground and got the final touchdown on a blocked punt when nese-guard Clifton Mason fell on a blocked punt in the end zone for Dunbar's third tally. Actually, Snyder could only account for 50 yards on offense.

Dunbar had 12 first downs in the contest with 102 yards gained rushing and only 41 on the ground.

The club members are now planning a welcome party for the members that have been away for the summer. There will be a host of members returning from a long summer absence, and we want to let them know how much we have missed them.

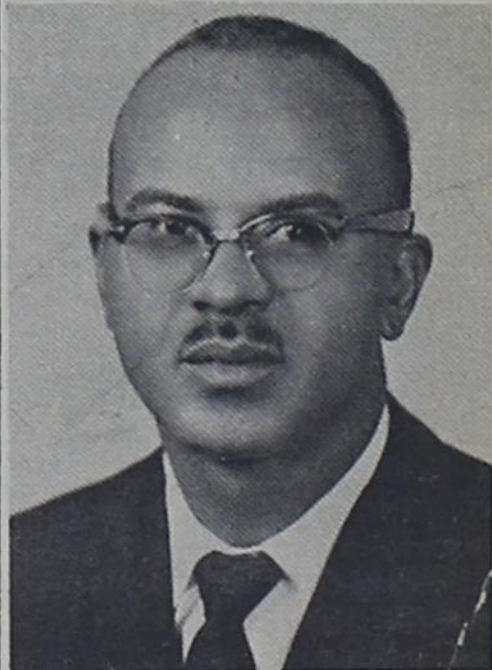
Mrs. Ben Wilson will sponsor a luncheon for the club members on a future date in her home. She will also give important points on setting the table and good eating etiquette.
