One of our projects coming up very shortly is the Mom's part of the club playing basketball. We hope to raise funds with this project to help the teams. Please pitch in and help us all you can.

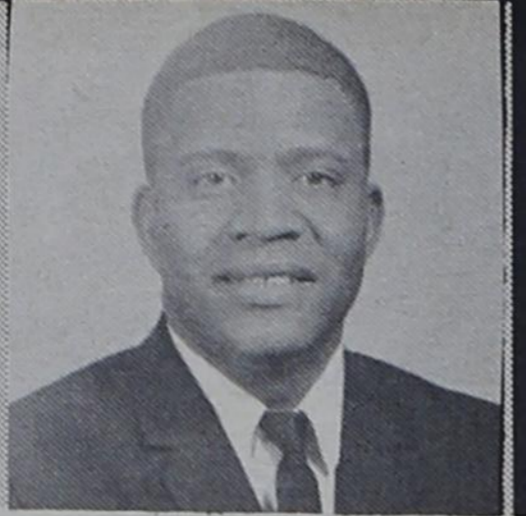
### V.I.C.A. Chapter 403 Goes to Estacado High

## Judge Robert H. Bean Seeks Re-election to 140th Court

Judge Robert H. Bean has announced for re-election as Judge of the 140th District Court of Lubbock County, Texas, subject to the Democratic Primary on May 4, 1968.

Judge Bean has served as Judge of the 140th District Court since its creation in 1955. During the more than twelve years that he has been on the bench, he has tried approximately 100 criminal felony cases before juries, and nearly 500 civil jury cases.

In addition, he has tried thousands of non-jury cases, including hundreds of pleas of guilty in criminal cases, thousands of divorce cases, and during the last several years, has heard practically

all of the dependency and neglect cases involving dependent or neglected children in Lubbock County. An average of about 75 cases of this type are filed each year, involving custody of an average of 125 or more children each year.
