## Health Officials to Inspect County Jail

A U.S. Public Health Service officer will inspect the Lubbock County Jail next week as officials prepare to file their first report to U.S. Dist. Judge Halbert Woodward Aug. 8.

The county jail has been operated in the shadow of a court order since Woodward ruled in an inmate right lawsuit earlier this year.

County officials have been conferring with Woodward informally they developed plans for an inmate recreation center on the north end of the existing jail, but the Aug. 8 report is the first of the changes commissioners have made and will have to comply with Woodward's order.

Dist. Atty. Alton Griffin, in informing county commissioners at their Monday meeting of the inspection, said that the county will ask for some variances in the broad mandates the county must comply with.

Commissioners also approved a management plan for the present jail and for a new facility commissioners hope to build in the future. One highlight of the plan, prepared by security consultant Bob Frisby and County Architect Arnold Maeker, is the use of closed circuit television cameras in the old and new jails.

"We don't plan for extensive use in the old jail," Maeker told the Times, "probably just one or two cameras that can be relocated (to the new jail) later."

In urging adoption of the plan which was circulated to commissioners last week, Maeker said that the plan should be

implemented slowly and practically, with the possibility of changes as the new jail took shape.

"If it becomes antiquated, somebody's going to put it on the shelf and we're going to lose it," the structural engineer said.

In other action Monday, commissioners approved changes in the Lubbock County Hospital District Budget.

LCHD chairman J.C. Rickman explained that the changes were necessary because opening of the teaching hospital that the district is building in conjunction with the Texas Tech school of medicine has been delayed until Feb. 1, 1978. The hospital was earlier set to open in September.

One of the big items in the new budget was a \$87,540 increase in emergency outpatient services. Presently, LCHD is stuck with the bill for emergency room treatment if the two hospitals—St. Mary's and Methodist—can't collect from the patient after six months.

Questioned by Pct. 2 Commissioner Coy Biggs, Rickman admitted that the district may be paying for some bill run up by people who are not classified as "indigent" because there is no screening of the patients.

But Rickman noted that much of the rise is due to round-the-clock emergency rooms, something LCHD budgeters hadn't anticipated.

Rickman said a board of managers committee was negotiating with the hospitals for a solution to the jump in expenditures.

## Nation's Only Minority Industrial Chemical Company Expands to Texas

HUNTSVILLE, Texas, (Special)—Ascension Chemical of America Corp., (the only black-owned industrial chemical manufacturing company in the U.S.) opened a new plant here in the Houston area today for the production of aluminum chloride anhydrous (A1 C13).

The new Texas facility initially will have three A1 C13 furnaces in 7,200 square feet with an annual capacity of 35 million pounds. Lewis Jackson, vice president of Ascension, will assume the duties of general manager.

Based in Tonawanda, New York, Ascension was founded in 1972 by Jesse Jackson, president, and

presently has six furnaces in operation in 12,000 feet of leased space. Its annual production of 75 million pounds is used by major producers, including Dow, Conoco, Union Carbide, DuPont, American Oil, Sun Oil and Amoco.

Aluminum chloride, the only product of Ascension Chemical, is the catalyst of choice in most Friedel-Crafts reactions. It is used in the manufacture of Ethylbenzene for styrene, anthraquinone dyestuffs, phenylethyl alcohol, detergent alkylate and other specialty chemicals and intermediates.

Attending the ribbon-cutting ceremonies and luncheon were

several hundred dignitaries, including representatives of major chemical suppliers and customers, among them Dow Chemical U.S.A.; the mayor of Huntsville and representatives of the Chamber of Commerce, and a delegation from the local Sam Houston University. Highlight of the proceedings was induction of the Jackson brothers into the Huntsville Chamber of Commerce.

In his remarks, General Manager Lewis Jackson said he is pleased and proud to be coming "home to Walker County."

## Who's Who Honors Rev. Tieucl

Rev. Robert "Bob" Tieucl Jr., of 914 S. Dal Paso, St. Hobbs, New Mexico, pastor of Carter Chapel C.M.E. Church of Spur, Texas, is a native son of Boley.

He is one of a select group of Oklahomans included in the first volume of Bill Matney's *Who's Who Among Black Americans*, recently published.

The veteran minister is also director of the Christian Call News Service, a voluntary non-sectarian, non-profit organization and does a regular for a great number of daily and weekly newspapers in Texas and the Southwest. He is also secretary-treasurer of the United Clearing Systems, Inc., of Hobbs, New Mexico, a group that promotes church finance programs throughout the Southwest.

Tieucl keeps himself well occupied. He maintains his ties with his native Boley and is an active member of a number of civic and social organizations in his adopted state of New Mexico.

He has, recently, proposed to the Boley Chamber of Commerce that they secure at least one hundred leading Blacks, and whites in the nation to explore the possibilities of securing a "National Black Park" designation (Federal) in the vicinity of Boley to insure its

future growth and prosperity as the "leading Black town in America."

"There are other vast opportunities awaiting Boley with the new Carter administration in power and the National Park idea is one of many. I hope we will go to work on some of these possibilities and not go to sleep at the switch," Tieucl said recently.

Tieucl is the son of Mr. N.E. Tieucl, the oldest active business woman in Boley and a brother of Mrs. Theresa Tieucl Span, public school teacher in Boley.

## August is Immunization Action Month

A gift that lasts a lifetime—and perhaps may save the life of the receiver—will be offered all Texans during August.

The gift is immunizations against the serious, even life-threatening diseases which continue to plague mankind. Remember polio, diphtheria, measles, rubella (German measles), tetanus (lockjaw), whooping cough (pertussis), mumps? They're still with us and are always looking for a susceptible person—someone who hasn't been immunized against them.

August will be observed as Immunization Action Month in Texas as part of a nationwide campaign this year to immunize all those in need of protection. The Texas Department of Health is spearheading the Immunization Action Month, aided by Mrs. Dolph Briscoe's First Lady's

Volunteer Program.

While all immunizations will be stressed during the campaign, the theme of this year's program will be, "Immunization Isn't Just Kid Stuff".

Texans other than just children do need immunizations, and emphasis will be given to these other groups. Special attention will be given to:

—Older persons who should be protected against disease, particularly tetanus;

—Youngsters and young adults who need measles immunizations before reaching their first birthdays; and

—Prospective mothers who need protection against rubella to safeguard possible birth defects of their future children.

During the past few months, more red measles cases have been occurring across Texas than

have been experienced in several years. Much of this is in young adults-teenagers.

Health scientists feel that children who were immunized against measles before their first birthdays have only limited protection unless they receive a booster vaccination. When exposed to the disease, they have come down with an infection, although symptoms of the disease may be less severe.

Adults need booster vaccinations against diphtheria and tetanus every 10 years throughout their lives, since these diseases can be as devastating to an adult as a child.

Rubella is another disease which can be dangerous to some adults, specifically pregnant women. Although the mother recovers, the fetus can be

and many places, it's always a pleasure to come home," Jackson said. "I was reared here near Huntsville, but I left home when I was a youngster to go North. I thought the streets there were paved with gold. But I soon found out that you make your own breaks.

"In America, whether you're white, black, brown or yellow, if you won't take no for an answer, you can make it. You can."

His brother, Jesse, explained how he came to call his company "Ascension Chemical."

"In the early seventies, I was on the floor," he said, "and anywhere I went, I had to be rising. The only direction I could go was up, and that's why I picked the name 'Ascension'."

President Jackson explained that he met and soon hired Rausto Mazzuto, an Italian immigrant who had been making aluminum chloride for a decade, and together they built their first furnace.

"It wasn't easy at first," Jackson said, "but the important thing is, it was possible. Today, I'm the richest man in the world, because I have an abundance of friends here today. I couldn't have made it without their encouragement and support.

"I'm here to stay, and nobody can run me off!"

Ascension is the first industrial company to locate in rural Huntsville, best-known for Sam Houston University and a state correctional facility, which pre-

viously had been the major source of local employment. Ascension initially will employ about 12 persons, with more to follow as additional furnaces, already under construction, are started up.

severely affected. A blood test is available to determine whether a woman of child-bearing age is susceptible to rubella and should be vaccinated before pregnancy occurs. Special efforts will be made during Immunization Action Month, as well as September and October, to test young females.

During August, special efforts will be made in child care institutions across Texas to bring immunization levels up among children attending these centers. Department of Public Welfare personnel will be instrumental in getting information to child care centers and in notifying welfare recipients of the need for immunization.

All of the immunizations against these dangerous diseases are available, free of charge, from public health clinics operated by local health departments and Texas Public Health Regions. Immunizations also may be obtained from most private physicians for their standard fees.

The Department of Health wants all children, teenagers and adults to be properly and completely immunized. During August, the Department asks you to remember that "Immunization Isn't Just Kid Stuff".

Survivors include two sons, William Nathan of Winkler, Texas, Lee Roy Giddings of Lubbock, Cornelius Giddings, who preceded her in death; two daughters, Mrs. Bernice Baxter, and Mrs. Mineola Armstrong, both of Dallas; seventeen grandchildren; thirty-six great-children; fifty-two great-great-grandchildren, several great-great-great-grandchildren; a host of other relatives and friends.

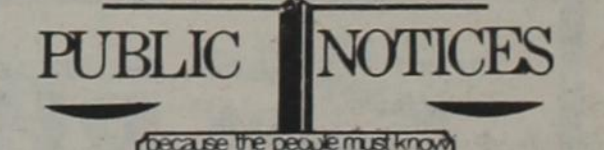
