# **New Book: School Resegregation Is Detrimental To Black Students**

Nationwide -- A new book, Schooling Poor Minority Children: New Segregation in the Post-Brown Era, authored by Martha R. Bireda, Ph.D., chronicles the process of desegregation to a return to post-Brown resegregated schools. The author describes this "new" segregation as a "redesign of pre-Brown segregation" and details the devastating impact upon poor minority students.

The return to segregated neighborhood schools, most often populated by poor black and brown students, unequally

funded, and labeled "low performing" or "failing" should be taken very by seriously by the black community. The "new" segregation that has evolved in the post-Brown era is even more insidious than that of pre-Brown segregation. The deeply rooted problems that plagued pre-Brown segregated schools persist; while a new set of problems inherent in the "new" segregation have emerged. # LISD School Board Meeting Synopsos

At their recent meeting, Lubbock ISD trustees approved the elimination of positions at Central Office as the first step in meeting an anticipated \$10 million reduction in state funding for 2011-12. Bills currently under consideration by the Legislature would reduce LISD's annual state funding between \$10 million and \$27 million below current funding levels.

While the Legislature has not finalized the extent of cuts to public education, state law requires school districts to notify contract personnel 45 days before the last day of instruction if their contract will not be renewed. As a result, April 12 is the deadline for LISD to notify employees if their jobs will be eliminated.

Dr. Karen Garza, superintendent said, "We consulted our legislative delegation and they advised us that planning for a \$10 million reduction was prudent. We owe it to our dedicated employees to give them as much notice as possible of this inevitable reduction in force so they can plan accordingly and have the best chance of finding other employment." LISD Board President James Arnold added, "The board and administration did not enter into this decision lightly. These employees are our neighbors, friends and tax payers. We simply have no other option with the level of cuts we expect from the state." In remarks to the board, Garza reiterated that the positions being eliminated at central office were important jobs that contributed to the academic gains and smooth operation of schools. "Our schools will feel the impact of these central office jobs being lost and the good work being done by these fine employees. In reacting to these anticipated revenue reductions, our priority is to protect our classrooms to the extent possible," Garza said. Contractual employees affected by the reduction in force will receive a \$10,000 payment in consideration for entering into a separation agreement with the district. Full-time non-contractual employees impacted by the reduction in force will receive \$5,000 and part-time, non-contractual employees will receive \$2,000 for entering into a separation agreement. "People experienced and actively engaged in the legislative process did not anticipate these dramatic cuts to public education when the Legislature convened," Garza said. "We certainly did not expect that we would be in a position to do a reduction in force when the board considered my contract in early January. For that reason, I have requested and the board has agreed to remove the increase they made to my base salary for 2011-12." In other action, the board approved the first expenditure of funds from the 2010 bond election with \$7.7 million approved for infrastructure to support wireless internet access in all of the district's 57 school buildings and build a reliable, resilient network. Through a government erate rebate program, \$2.9 million of the expenditure is expected to be reimbursed. Bonds funds are designated for capital expenditures such as technology, construction and renovation. State law does not allow bond money to be used for salaries and other operating expenses.

responsibility for student learning; and secondly, a stigmatizing school climate that focuses on control of students rather than creating rigorous and challenging learning environments. The combination of these factors results in the failure of these students to develop an academic identity, a lack of achievement

motivation, the development of low self-expectations, disengagement from the learning process, academic failure, and in far too many instances non-completion.

This is a critical period in the future education of black children. As solutions are being proposed to close the achievement gap, none address the destructive effects of resegregation and the stigmatizing environments in which poor black and brown children are forced to learn. It is imperative that black parents and the black community become involved in all discussions about educational reform. The author suggests that the black community must re-commit itself to the education of black children, exercising the same fervor as during the initial stages of desegregation. She recommends that we must engage in yet another crusade, a "fourth crusade" to ensure equal educational opportunities for our children.



Section 5304 Planning Funds – This program cost is estimated at \$23,253, which will be provided by the Federal Transit Administration (FTA) Section 5304 funds through the Texas Department of Transportation (TxDOT); the Texas Transportation Commission has awarded Citibus Transportation Development Credits to serve as the local match. These funds will be used regional coordination meetings and activities.

Section 5307 Formula Grant Funds – The federal program cost is estimated at \$4,338,963, \$2,889,343 of which will be provided by FTA Section 5307 funds and \$1,449,620 as local match. TxDOT will contribute \$622,763 for operating assistance only, with \$622,763 as local match. This funding will be used for preventive maintenance, non-fixed route ADA services, operating, planning, and miscellaneous capital improvements including passenger amenities and security upgrades.

Section 5309 Discretionary Earmark Funds – This program cost is \$750,000, and the local match has been provided through 153,614 Transportation Development Credits, which were awarded by the Texas Transportation Commission. The funds will be used to purchase a hybrid-electric bus, which will replace an outdated route bus. The remainder of the funding will be utilized for a future vehicle or vehicle-related purchase.

Section 5310 Elderly & Disabled Funds – This program cost is estimated at \$109,152, \$87,322 of which will be provided by the FTA and \$21,830 as local match. These funds will be used for preventive maintenance activities.

Section 5311 Intercity Bus Funds – All phases of the program cost is estimated at \$1,842,892, which will be provided by the FTA Section 5311 funds; the Texas Transportation Commission has awarded Citibus Transportation Development Credits to serve as the local match. The funds will be used for the following phases of the Downtown Transfer Plaza renovation: Greyhound freight addition (1), vending/training additions, restroom renov (2), lobby renov (3), and site repair (4).

# **Chris Rock Adds Broadway To His Funny Resume**




