

would wear to school.

Council to approve the memorial. "The theme of the memorial is about lessons learned and moving forward with a spirit of forgiveness," he said. "Let's do everything we can to prevent it from happening again."

Cole was the first person in the United States to be posthumously exonerated for a crime he didn't commit. He was convicted in 1985 of raping a fellow Texas Tech student and was sentenced to 25 years in prison. In 1999, he died from complications from asthma while still incarcerated. Cole's exoneration was based on DNA testing that revealed Jerry Johnson, a man already serving a prison sentence for an unrelated crime, was the attacker in Cole's case.

Dixon said he used Cole's mug shots to capture Cole's image, but the statue's facial expression of determination came from the stories of Cole's perseverance and faith that he would be proven innocent.

Session was moved to tears when he saw the statue of his brother a few weeks ago. He stated that I caused him to think of his mother who passed away in October, and wished that she could be around to see the work

The statue will be positioned so its gaze falls on the Texas Tech law school, with its body directed to the church parking lot where the crime he was wrongly accused of committing took place.

SPC to Offer New Concealed Handgun Lcense Course

Texas feel University CUBBOCK TEXAS 79409

LEVELLAND - South Plains College will offer the new, shorter Concealed Handgun License course on Jan. 11 (Saturday) in the Law Enforcement Technology building in Room 115 on the Levelland

Class will begin at 8 a.m., and will include breaks every hour and a one-hour break for lunch. The classroom portion will be completed by 3 p.m. and the length of the range portion will depend on the number of students. The cost is \$70 for students seeking their first license, and \$25 for students wanting a refresher course before renewing their license. Although renewals are now handled strictly online, the 15 or more changes in Texas firearms law last summer make a refresher course a good investment.

The course covers the laws pertaining to concealed carry and to the use of force or deadly force. Safe gun handling and storage, including storage with children in the home, are covered, as is non-violent dispute resolution.







Dixon says that he is honored to work on Cole's statue. Dixon is using the principle that Cole





#### Charter Schools in Wisconsin Great Alternative



Across the nation our public schools are not performing as they should or as they used to. There is so much attention given to improving our public schools but the successes are far and too few. According to the National Assessment of Adult Literacy, American literacy rates have not changed in over ten years. With all the attention we are giving to public education there is just no improvement by using the traditional methods. Just reading alone is a factor in national security, economic attainment, access to health care and the chance of full participation as a 1st class citizen. According to the US Department of Justice, "The link between academic failure and delinquency, violence, and crime is welded to reading failure". Yes, 85 percent of all juveniles in our juvenile court system are functionally illiterate. Over 70 percent of inmates in our prisons cannot read

above a fourth grade level. As the great Booker T. Washington stated, "We cannot be truly free without an education." We as a nation must come up with new direction as the same old methods are failing us while education levels and literacy in many rival nations are improving and pulling away from the achievement of US schools. Alas, the state of Wisconsin has stepped up and created an alternative. The state legislature of this progressive state has authorized a comprehensive Charter School Program. The state has three types of charter schools.

The first is a basic Charter School. Here is the definition: "Charter schools are public, nonsectarian schools created through a businesslike contract or "charter" between the charter governance board and the sponsoring school board or other chartering authority. The Wisconsin charter school law gives charter schools freedom from most state rules and regulations in exchange for greater accountability for results. The charter defines the missions and methods of the charter school. The chartering authority holds the school accountable to its charter. The charter school motto is Autonomy for Accountability."

The Wisconsin Department of Public Instruction justifies the above via this explanation: "Wisconsin established charter schools to foster an environment for innovation and parental choice. They can exist as living laboratories that influence the larger public school system and introduce an element of competition within that system. Charter schools are created with the best elements of regular public schools in mind. Their leaders may experiment with different instructional theories, site-based management techniques, and other innovations. They learn, sometimes by trial and error, what works best for their student population. Regular schools can observe and learn from what happens in the charter school and make similar improvements. Through this process, the entire public school system is continually challenged to improve itself."

They also demand parental involvement. Parents can participate in choosing upcoming curriculum changes, technology methods and encouraging the entire community to stay involved with all school programs and give input for new direction.





We Must Never Give Up!

The United States Senate's failure to pass common sense gun safety measures - the Manchin-Toomey Amendment to expand background checks to keep guns away from underage or dangerous people, and amendments to ban assault weapons and high capacity magazines designed only to kill as many human beings as possible - is a moral failure of great magnitude. Once again the safety of children has been sacrificed by political leaders in service to the gun lobby. As Americans do we value guns more than the lives of children? Do we really want to continue to have political leaders who kowtow to the threats and money and half-truths of the gun lobby and who think their political jobs are more important than the right of children to live and learn and grow up in safety?

The fight to protect children, not guns is not over because:

Ninety percent of Americans want a universal background check. This includes 94 percent of North Dakota voters, 89 percent of Indiana voters, 89 percent of New Hampshire voters, 84 percent of Arkansas voters, and 79 percent of Montana voters-all states where at least one senator went against the will of their constituents and of the American people. Getting 90 percent of Americans to agree on anything is extremely difficult.

It must be working! The greater Milwaukee area has 37 charter schools running with many more on the "books". As typical public schools are closing and/or consolidating, charter school expansion is there to fill the void.

Now the state has come up with another version of a charter school. That is a 2R Charter School. They are identical to a regular charter school except their authorizers can be the city of Milwaukee, University of Wisconsin - Milwaukee, University of Wisconsin - Parkside or the Milwaukee area technical college district board.

Wait, they also have one more version of a charter school. There is the Virtual Charter School. "Virtual charter schools are publicly funded, nonsectarian schools that are exempt from many regulations that apply to traditional public schools and that offer some of their classes online. They began operating in Wisconsin during the 2002-3 school year. Pupils typically attend from their homes and communicate with teachers using e-mail, by telephone, or in online discussions. During the 2010-11 school year, 17 virtual charter schools enrolled 4,110 pupils. Most were high schools. Currently there are 25 virtual charter schools."

It is very apparent that the state of Wisconsin has developed a model program for many other states that have urban centers that could use improvement and innovation towards the better product it is putting out through their school system. One thing is clear - there is no room for street gangs, drugs and general violence in a charter school system. It makes a school a place for learning and achievement plus preparation for the future. Oh, if Cleveland, Detroit, Chicago and many other cities with challenging school systems would try to emulate this successful program. It could make a wonderful change. What are we waiting for? We are talking about our children's future.



Or viewers.


This is where Jindal -- as well as those who believe Robertson's suspension violates his constitutional right to free speech -- get it wrong.

And if you don't believe me -- try walking into your boss' office and call him or her a big fat idiot with ugly children.


