

EDITORIALS

"IT OUGHT TO BE A LAV

After what happened to an officer of the court, Gene Gaines -- local attorney here--last Friday, it ought to be a law for elected officials to take advantage of an attorney who is defending the rights of a client.

Justice of the Peace Charles Smith, in our opinion, was out of place when he had Mr. Gaines thrown into the Lubbock County Jail, because he was defending the rights of his client. For several hours, Mr. Gaines was held at the county jail. We disagree with this type of justice because of three reasons.

For one, we learned that all of this came about because Mr. Gaines attemptto post bail for his client, and ed that Mr. Smith refused to accept the bond posted by Mr. Gaines. According to Vernon's Annotated Texas Statue, Article 237p-3, Section 14, the sheriff of the county has the apparent right to see who can serve bond, not the Justice of the Peace as was the apparent case here last week.

The Article says: "The sheriff of any county has the sole responsibility of receiving and approving bail bonds for the purpose of gaining the release of a named principal held in custody by any authority in his county upon accusation of an offense of which the county or district court has jurisdiction.'

Second, after Mr. Gaines was arrested, he should have been given the right to h a v e been released upon his own personal recognizance, and not have been arrested. This is vividly pointed out in Vernon's Annotated Texas Statue also. Article 1911a, Section 2(c) says the following:

Mr. Gaines was reportedly taken to the Lubbock County Jail before a writ of habeas corpus was filed by Lubbock attorney A.W. Salayars in Judge Robert Wright's 137th District Court. Third, since there were no other persons present in the Justice of the Peace's chambers, but Mr. Gaines and Mr. Smith, who is to say who was in contempt. It is our opinion that Mr. Gaines w a. s doing his duty of representing a client who had apparently hired him for the sole purpose of Gefending this situation. There ought to be a law on how an officer of the court is treated in the Justice of the Peace court. Over reacting in this type of a situation is not good for the court system nor the great city and county of Lubbock. We hope, for God's sake, that these kinds of embarassing situations will be curtailed in the future. At the s a m e time, we hope our readers will become aware of these kinds of situations when it comes to taking advantage of anyone's human rights.

It is limited, perhaps, even deliberately, in its conception of both our inherited principles of law and our requirements for promoting or maintaining the public good. One may speculate on many sinister-and possibly

realistic-reasons for such a destructive and distorted approach to so serious an issue in our nation's public policy development. But it should oe more than sufficient to observe that emotive language which results in misdefinitions of issues should be seen as beneath the dignity

public opinion firm. What the Gallup Poll has done to injure the rightful job and educational prospects for black Americans " be enormous. That such behavior is to be expected seen as likely on the part of those largely unfamiliar with our inherited system of lawwhich had a valued place for the principle of equity and restitution. Beyond this, our whole ethical tradition speaks always of the primacy of the larger good, as opposed to the narrowly partisan or the inherited preferential or disproportionate advantage of those possessed of longstanding power.

What black Americans must, therefore, be prepared for in an age when even former friends lear obviously needed change is an unconscious and pervasive assault upon perhaps all black aspirations, especially as they relate to any aspect of change

But for far more than simple vigitance is called for. Black: must, pernaps foremost, be mindful that we are a people under siege and citack. With this in mind, we must do more than defend ourselves; we must aggressively and devastatingly take a positive leadership role in defining our own goals and in setting our own priorities. In this, we must be alert to the clever tactics of subversion by misinterpretation and misrepresentation of our just cause by supposedly "fairminded friends" like those who run and direct the





Baraka peppers his conversation with Marsist cliches and terminology, much in the way a physicist might speak in physicist jargon, but coming from him it sounds odd. For in the past, anti-Marxists utilized much of Baraka's 1960's work to attack communism as detrimental to Bilalians. "Marx's dirty Lenin." a sardonic phrase that poetically denounced Marxism, was a Baraka origi-

nal. He was one of the most fervently anti-marxist Bilalian intellectuals on the scene.

"At the time-the '60s in New York," Baraka explained, "most of the people who were running what was

passing for socialist doctrine we rejected as being outright chauvinist and racist themselves.

"We were not able to see the forest for the trees. Most of the people who professed socialism were strange cats ... most of the blacks too," he recounted.
