Section 3. One fou: th of the revenue derived from the State occupation taxes and a poll tax of \$1 on every male inhabitant of this State between the ages of twenty-one and sixty years shall be set apart annually for the benefit of the pablic free selools, and in addition thereto there shall be levied and colheted an annual ad valorem State tax of such an amount, not to exceed itwenty cents on the \$100 valuation, as with the available school fund arising from all other sources, will be sufficien to mintain and support the public free schools of this State for a period of not less than six months in each year. and the Legis'ature may also provide for the formation of school district: within all or any of the counties of this State by general or special law, withput the local notice required in other cases of special legislation, and may authorize an additional ad valorem tax to be collected, within such school districts for the further maintenance of public free school, and the erection and equipment of school buildings therein, provided that a majority of the qualified pro, erty tax paying voters of the district, voting at an election to be held for that purpose shall vote such tax, not to exceed in any one year 50 cepts on the \$100 valuation of the property subject to taxation in such district, but the limitation upon the amount of district tax herein authorized shall not app'y to incorporated cities or towns constituting separate and independent school districts.




