## Bond Issue Approved

Schleicher County voters gave the board of trustees of the Eldorado School system the go-ahead Saturday for the construction of three new buildings by passing the \$1.2 million bond issue 368 to 77.

This will enable the board to build a new cafeteria, elementary classroom building and learning center. Also, the board is planning to construct an administrative building and make repairs on the track and bleachers at the football field with about \$280,000 in surplus funds.

Elected to the board during the

election were Duwain Sauer and Richard Sterling, with 160 and 155 votes, respectively. Other candidates received the following votes: Dan Griffin, 66; Paul Page, Jr., 71; Raymon Mobley, 108; San Henderson, Jr., 104; Delia Pina, 111; Bill Gentry, 45 and Edwin Jackson, Jr., 39.

### J. Doyle Wins Write-In Race

In the write-in race for mayor, alderman Jimmy Doyle received 176 votes and John D. "Rusty" Meador received 32. Other receiving write-in votes were: Jerry Jones, three; Pat Ragsdale, Raymon Mobley, Jo Ed Hill, D.D. Griffin and Bobby Sykes, two each; Rosa Burrus, Sam Henderson, Jr., John Callison, Bill Hodges, Richard Sterling, Bob Lester, Thomas R. Jones, David Vannett, Clay Porter and Ray Standeford, one vote each.

The write-in contest resulted after no one filed for the mayor's position.

Billy McCravey will return to his seat on the city council after receiving 133 votes. The other spot went to Frank Williams with 129 votes. Other candidates received as follows: Domingo Pina, 86; Bobby Sykes, 124; David Vannett, 32, and Richard Preston, E.M. Jackson, Jr., D.D. Griffin and Jimmy Doyle, one each. The city council will now have to appoint an alderman to fill the vacancy left when Doyle was elected mayor.

## School Board Elects Officers, Continues Plans For Building

Dr. J.B. Brame was elected president of the board of trustees of the Schleicher County Independent School district during a regular meeting Monday night. Other officers are Billy Williams, vice president and Lynn Meador, secretary.

During the business meeting, the board authorized the financial consultant to continue progress in preparation of documents for the sale of bonds which will build three new buildings on the school campus. The bonds were approved during the election Saturday.

The board also authorized architect Gary Donaldson of San Angelo to begin work on improvements of the track, which the board had planned to do if the bond issues were passed.

Along the same lines, the board agreed to do some repair work during the summer such as the plumbing in the science laboratory and painting where needed.

The board agreed to build a building close to the tennis courts for storage and possibly a concession stand.

These youth tour winners were among seven high school juniors from the area served by Southwest Texas Electric Cooperative, Inc., who submitted essays on the subject "Facts About Rural Electric Cooperatives and Their Role in Energy Conservation", A.T. Turner, assistant manager of the cooperative explained.

The winners of this contest will be among many young people from all over the state who will tour the nation's capital city in June.

Board members discussed playground equipment and agreed to place pea gravel around the base of playground equipment to make it more stable and safe.

The student handbook was also discussed for revisions on cheerleaders and exemptions for seniors on finals. The request was discussed, but will be discussed further at a later date.

Superintendent Guy Whitaker presented reports on Title I, a special program for a blind student, the special education program and vocational programs.

The possibility of a different method of purchasing and storing gasoline was also discussed, and a committee was chosen to look into making repairs on the tin roof of the ag barn which has several leaks.

A called meeting for April 17 was set to look into the possibility of creating a position of counselor for the school, review the student handbook and gas procurement for the upcoming year.

Outgoing president Mort Mertz also presented the board with a past president's report on the conditions of the school system, both physically and scholastically.

## Jail Inspector Report Given To Commissioners

Joe Slater of Sweetwater, one of three inspectors for the Texas State Commission on Jail Standards, was in Eldorado at the end of last week to inspect the Schleicher County Jail. The commission makes at least one inspection of all jails in the state during the year.

After his inspection of the jail, Slater met with the four county commissioners and sheriff Orval Edmiston to give them a report. County Judge Johnny Griffin was not present as he was out of town.

Slater said the jail did not meet 61 requirements set by the jail commission and listed all the discrepancies in a written report given to each commissioner.

Following are some of the discrepancies found in the 70 year old jail and included in the report:

- The facility is not all fire resistive and does not contain single cells and dayrooms.

- Adequate segregation of different classifications of inmates. (misdemeanor, juvenile, felony or female) is not always possible.

- Inmate entrance is not constructed so as to allow passage of a loaded ambulance cot between interlocking doors.

- Janitor area is not provided with lockable door.

- Adequate secure storage for drugs and medical supplies is not provided.

- Separate secure storage space for weapons is not provided at entrance to prohibited weapon area.

- The two cells in the jail have six foot ceilings instead of eight foot ceilings.

- Water closets and lavatories are not constructed to resist vandalism.

- Operable windows are not provided with insect and/or security

Temperature control at reasonable 85 degrees or below in summer cannot be kept.

Emergency illumination is not provided.

High velocity smoke and fume removal capability is not provided.

Slater told the commissioners that law suits concerning jails and their conditions were getting "thicker and thicker," and reminded the men that standards are not to create a "Holiday Inn for hoodlums," but also for the jailer's protection from the inmates.

"The worst people in state penitentiaries had to first come from a county jail," he said.

The jail inspector said that if the sheriff's office were moved to the jail, it could serve a double purpose; whereas there could be a jailer on duty 24 hours a day who could also dispatch for the night watchman and receive incoming calls.

"You are talking about efficiency in law enforcement. If you give it up, you'll have to go to another county," he said.

Edmiston agreed, but said, "If we have to take all our prisoners into San Angelo or Sonora, we will spend most of our time on the highway and be more exposed to these criminals than we need to be. Besides, it is not San Angelo's or Sonora's responsibility to take care of our prisoners."

Slater told the group taking prisoners to another town to be jailed would be very expensive and would have to be done by contract.

Most of the items listed on the report concern mandatory regulations on the commission's life safety code, namely they could possibly save the lives of either inmates, law enforcement officials or jailers.

## The Domestic Oil Production Policy Act of 1979

I have introduced a bill, H.R. 3159, entitled the "Domestic Oil Production Policy Act of 1979."

The purpose of this bill is to provide the United States of America with the greatest possible domestic supply of crude oil, at the lowest possible price in the most fiscally responsible manner by stimulating the domestic production of crude oil. In so doing, the bill will effectively decrease the dependency of this country on costly, strategically vulnerable and economically-debilitating imports of crude oil.

The provisions of this bill require that the volumes of crude oil currently classified as upper tier crude oil ("new oil") be immediately decontrolled, and that lower tier crude oil ("old oil") be decontrolled gradually, but completely decontrolled by September 30, 1981.

### Reasons This Bill Is Necessary

- 1) Crude oil production in the lower 48 states has declined from a pre-control level of 9.44 million barrels per day during 1972 to 7.47 million barrels per day during 1978.
- 2) The rate of decline of crude oil production from wells in the lower 48 states is approaching 15% per year.
- 3) The number of crude oil wells drilled during 1978 decreased six percent from 1977 levels. Since November 1978, the number of drilling rigs in operation domestically has declined 16% to fewer than 2,000.
- 4) Since 1972, domestic petroleum reserves have fallen by nearly one fifth.
- 5) Crude oil imports have increased from 2.2 million barrels a day during 1972 to 6.1 million barrels a day during 1978 — a 177 percent increase. Total petroleum imports (crude oil plus refined petroleum products) have increased from 4.7 million barrels a day to 8 million barrels a day.
- 6) The cost of importing oil into the U.S. has increased over 1,000 percent since 1972, from \$4.3 billion to \$45 billion per year.
- 7) An increase in exploration and production activity will positively affect employment and state and Federal revenues.
- 8) A decrease in foreign oil imports will have salutary effects on balance of payment deficits, the stability of the dollar abroad and other economic benefits to this country.

I believe this comprehensive approach to both general and specific incentives provided by immediate and phased decontrol steps will have the most positive effect possible on increased domestic production while offering the most moderate effect possible on the rate of inflation, the Gross National Product and on the Consumer Price Index.

The ultimate result of such a plan will be to assure the consumers of America the greatest possible availability of gasoline and other refined petroleum products at the lowest possible price, and to make this country energy independent, once again.

Instead of trying to implement programs which are costly and which only attempt to try to teach us how to live with shortages, I believe this program — designed to allow this country to grow and prosper — is the proper goal we should be working toward.

## Commissioners Discuss Road Crew, Supplies

A variety of small items were discussed during the regular meeting of the Schleicher County Commissioners Court Monday morning.

Commissioners accepted the resignation of Saragoza Esquivel Jr., who had worked on the county road crew on a monthly basis. Commissioners then discussed the decrease of workers on the county road crew. After a short discussion, they decided to advertise for workers in area newspapers, hoping to attract men from other areas who are working on lower wage scales.

Also discussing road work, the court decided not to trade with an Odessa firm any longer. The firm had been sending a salesman to sell supplies to the county road crew and the commissioners felt these expenses had become considerable in the past few months. Also, consensus of the court is to buy supplies for the county locally whenever possible.

Salaries for election officials were also raised during the meeting. They will now be paid \$2.50 an hour for twelve hours with the election judge being paid for two hours of preparation time also.

County Judge Johnny Griffin was given authority to meet with Joe Lee of Thomas Y. Pickett and Co. which compiles the county's tax roll each year. They are to meet and determine the amount of money needed to operate next year.

County treasurer A.G. McCormack presented the court with a quarterly financial report and a report on the county's medical insurance policy.

The men also held an hour-long discussion on the problem of the injunction they are under prohibiting them from using county-owned equipment on pri-

ivate property. They discussed the definitions of public and private roads and ownership of roads declared public by the court. They also discussed a policy by which they could follow in determining which roads they could and should maintain. However, they took no official action on the issue.

All commissioners were present except Joe Christian who was ill.
