## Local All-Stars Trip In Championship Game

High Plains East All-Stars traveled to Memphis for the seventh and final time Monday night to play Wellington in the championship game. High Plains East would fail to advance to the Area Tournament in Sunray, beginning Tuesday, losing 5-4. Too many bobbled infield plays and not enough hitting would end the season on this night.

Wellington hit the ball off Pitcher Daniel Treadwell; their big inning came in the second when Wellington got three runs added to two runs in the first inning proving to be enough to outscore High Plains East.

High Plains East had a big inning in the third when Chris Ollinger, Daniel Treadwell, and Cael Shields

hit giving High Plains East, the bases loaded. Justin Homen had a good night hitting the ball as he knocked a double scoring Ollinger and Treadwell. Cael would score off a Dean Fields bunt to give High Plains East their scoring of the inning as well as for the night to allow Wellington to advance.

High Plains East All-Stars surprised Childress in the bottom of the sixth inning last Wednesday night by coming from behind to win

four runs.

A "judgement cail" at home plate by the umpire allowed Childress to score a run when the umpire ruled Pitcher Treadwell was blocking home plate and would not allow the runner to score as the runner was on his back and never reached home plate when Treadwell tagged him.





The Sheriff's Department was involved in the search for two runaways. cases were not related and



## **Texas Department Of Public Safety Urges Commercial Motorists To Take Test**

In the nearly 33 months that Texas-based commercial motor vehicle drivers have had to study for and take the tests necessary to receive a commercial driver (CDL), some 412,000 persons required to have the license have done

"We're concerned, though, that some drivers in our state who are required to have a CDL don't yet realize that they are now considered commercial drivers," Inspector John Hall, who administers the

Texas Department of Public Safety's Commercial Driver License program, he said.

"The law requires some drivers who previously did not meet the criteria of a commercial driver to get a CDL," Hall said.

"For instance, a person who drives a vehicle designed to carry 16 or more people (including the than one license. driver) now is considered to be a commercial driver, and that could include drivers of vehicles used by churches and day care facilities," he said.

The Texas Department of Public Safety began issuing commercial driver licenses in September of 1990 and the law mandating that drivers of certain classes of vehicles obtain a commercial driver license went into effect April 1, 1992. The Texas law was implemented to conform to the federal

Commercial Motor Vehicle Safety Act of 1986 that, among other things, makes it illegal for an operator of a commercial motor vehicle (truck or bus) to have more addition, it defines who is categorized as a commercial driver.

The law also makes a CDL mandatory to drive a vehicle that weights more than 26,000 pounds or carries certain hazardous materials. There are exemptions for farm, military, emergency and personal-use recreation vehicles.





• I keep hearing about pyrethrum powder and diatomaceous earth to keep fleas off pets. What are they? Where do you find them? Do they really work?

 Diatomaceous earth and py-rethrum powder are natural products that can be highly effective in controlling fleas. Pyrethrum powder is made by crushing a particular variety of chrysanthemum flowers. Diatomaceous earth was formed from millions of years of deposits from dying one-cell sea plants. The first place to check is with your veterinaran. Your vet will also be able to instruct you on proper use. Other potential sources include lawn and garden supply stores, feed and grain stores, organic or natural food stores, and stores specializing in environ-mentally safe products. Don't expect a quick fix from these products ey achieve the best results when applied consistently over a period of time. But unlike chemical flea-control products, they won't kill beneficial insects that also help control

• Are there safe ways to get • rid of mosquitoes? We've got our annual summer onslaught and it makes going outside miserable.

The first step toward mos-quito control is understand-ing their life cycle. Mosquitoes usually don't travel far from their breed-ing habitat – standing water. Thus, the best way to control them is by removing or managing their water home. Clogged rain gutters, bird baths, flower pots, tree holes, cans, old tires, children's toys and even rain gauges can hold enough water for mosquitoes to breed. If the water source is permanent, like a backyard pond, one choice is to use fish that feed on mosquitoes, including goldfish, gambusia and tilapia. Insect growth regulators with the active ngredient methoprene keep mosquitoes from maturing. Another product to use in your fight against mosquitoes is BTI, or bacillus thuringiensis. These products should be available at most garden supply stores or from a pest control company. Purple martins and bats are natural enemies of mosquitoes, with

one martin or bat capable of consuming thousands of insects daily. Purple martins can be attracted by installing houses made especially for them. For a mosquito repellant, dilute citronella or pennyroyal oil with vegetable oil and apply sparingly, like perfume. You can put several drops of citronella, pennyroyal, eucalyptus or other essential oils in a spray bottle of water, shake well and spray on.

Can you give me a list of easy-to-find, low-wateruse vegetation that's appropriate for Texas?

A mong the commonly available Texas wildflower seeds are bluebonnet. Indian paintbrush. purple coneflower, Mexican hat, poppy, flax, evening primrose and black-eyed Susan. Shrubs include many varieties of sage, holly, boxwood, crepe myrtle, mountain laurel, purple fountain grass and pampas grass. Among the commonly found vines and ground cover are coral honeysuckle, English ivy, Asiatic jasmine, fig ivy, ajuga, mealy sage, verbena, Virginia creeper, periwinkle and mustang grape. Low-water-use trees include live oak, pecan, red bud, mesquite, bald cypress, ash, loquat, red oak, mimosa Chinaberry and Texas persimmon For a complete list, call your county extension agent or a local garden club. Remember that even lowwater-use natives need extra water until they are established in your landscape, which can mean a few weeks for vines, a couple of months or more for shrubs and a year or

Q = Our neighborhood is facing a ticklish situation. The creek that runs through it has poison ivy all over its banks. We'd like the kids to be able to play around the creek, but we're afraid to use chemicals to get rid of the ivy. Suggestions?

A • Your problem is a common one in Texas. Not only could chemicals pollute the soil and water in the creek, their use might kill all of the vegetation on the creek banks, making them susceptible to erosion, which pollutes the creek and makes the area less attractive for neighbor hood use. Sometimes physical labor is the most environmentally sound alternative. Why not organize a neighborhood clean-up day? Outfit several adults with boots, rubber gloves and eye protection. After you're sure of your identification of poison ivy (and not some look-alike, such as Virginia creeper) send your hit squad into the vegetation with machetes and clippers. You can get rid of the unwanted vegetation but leave the desirable plants.

#### Teacher's Retirement System Restores Benefits

The Teacher Retirement System of Texas is looking for former annuitants - widows or widowers of deceased members or retirees - whose survivor benefits stopped when they remarried prior to 1980. A new Texas law has now restored their benefits.

State law previously required that benefits stop when a surviving spouse remarried. That law was changed in September 1980 permitting benefits, in future years, to continue for surviving spouses who remarried; however, those who had already lost benefits before that date were not included.

The 73rd Texas Legislature this spring rectified that inequity and passed the House Bill 2711 restoring payments to those beneficiaries whose benefits stopped when they remarried.

TRS, however, does not have record of these individuals since their names were dropped from the system database when their benefits ended 13 or more years ago. The retirement system is looking for these individuals so that benefits can be restored to them.

Person who believe they qualify to have survivor benefits restored should contact the Claims Department of the Teacher Retirement System for information on how to

apply. The new law will be effective September 1, 1993. Payments can begin after that date and within one month after an application is filed and approved.

## **Social Security** Reporting Requirements

As a Social Security beneficiary, you have a certain responsibility for ensuring that you continue to receive your benefits in the right amount, delivered to the right place, and on time. You probably know that you need to tell Social Security any time you change addresses or if you change direct deposit bank accounts, but do you know that there are events that affect your Social Security checks?

You also must report the following:

· Any change in your estimated earnings.

Changes in marital status.

Name changes.

Births, adoptions, or deaths in the fam ly.

Changes in the circumstances of any child who is receiving benefits under vou care, under 16 or has a disability.

Imprisonment.

· Trips of 30 days or more outside the United

· Pensions from work not covered by Social Security.

If you fail to report these changes the amount of your benefits may be wrong. You may receive money that you are not due, and we will have to ask you to pay it back, or you may receive less than you are due and have to wait until the records are corrected.

If you need more information on what to report or how to make a report on any of these items, visit your nearest Social Security office or call toll-free telephone the number: 1-800-772-1213. The Pampa Social Security office is located at 125 S. Gillespie and the telephone number is 806-669-1019. Office hours are 9 am until 4 pm, Monday through Friday.

and intrastate commercial drivers, who instances had multiple licenses and could spread traffic offenses over different states to circumvent license suspension or revocation," Hall said.

"A driver could use whichever license was most advantageous if stopped by a law enforcement officer or asked to produce one so that a potential employer could check a driving record," he said.

The federal law set up a national registry for commercial driver licenses in order to track in which state a person is licensed. Also, the registry allows driving records from other states to be combined with a driver's home state driving record.

The new law imposes stricter penalties on commercial drivers who violate certain traffic and alcohol/drug laws.

The law also gives Texas the authority to use traffic convictions from other states to suspend a CDL and adopts the federal criteria for disqualification of commercial motor vehicle operators.

Since the law went into effect nearly 15 months ago, DPS and other law enforcement agencies have issued citations to persons who do not have a CDL but were required to. CDL suspensions/disqualifications for various lengths of time have been taken against drivers of commercial vehicles.


