## Deputy Recovers Stolen Highway Signs

This report covers Sheriff's Department activities for the past two weeks. There was no time last week to prepare a report.

The Sheriff's Department investigated the death of a White Deer man. After submitting the results of our investigation and pathology findings, the death was ruled accidental by carbon monoxide poisoning.

Our officers have been investigating several cases of thefts from motor vehicles and one report of a stolen trailer.

One juvenile runaway from Bryan, Texas was taken to O'Brien House in Amarillo pending release to

her parents.

Sheriff's deputies have been called to several reports of domestic violence in the county. In one incident, the deputy was met by a male subject with a shotgun. The subject surrendered the shotgun to the deputy and no injuries were sustained by the deputy or the suspect.

Deputy Larry Mendez was involved in the recovery of twenty-five road signs which had been discovered in a vacant farm building between Panhandle and White Deer. The signs were turned over to the Texas Department of Highways.

Deputy Jeff Oldham

assisted the Texas Rangers in the recovery of stolen oilfield equipment near the Gray County line. The equipment is currently being held pending owner identification.

Chief Deputy Lovell Kennard attended a conference in Amarillo which dealt with the identification of potential gang and cult members. With our county located between larger cities which have gang and cult problems and with the persons we encounter on Interstate 40, the need for proper recognition of gang members and cult-related signs has become a necessity.

## Bobcats Best Groom Two Out With Injuries

The Groom Tigers lost an agonizing game to Sunray's Bobcats last Friday night. Agonizing because the boys played so well but just kept getting bad breaks that essentially defeated them.

Defensively, it took the Tigers awhile to figure out the Bobcat offense but when they did they held them and settled down to play very well.

Bo Burgin was back at the quarterback position and played one of his best games of the season, hitting 8 out of 16 passes and running for 50 yards and also scored a T.D.

Ty Lambert and Collin Downs, both had outstanding nights as linebackers. Ty had 11 solo tackles and 3 assists while Collin had 10 solos and 4 assists.

Bart Britten was also a key player as a safety. Totalling up 9 tackles and 1 assist as well as having several key runs to keep the drive coming down field. He also scored on a 5 yard pass from Burgin, the kick by Tom Lambert was good.

Brandon Crump was a standout playing most of the game as a defensive tackle. He plugged the middle all evening and had 5 excellent tackles that were key.

"Because of injuries, we had some younger and less experienced players on the line," said Coach Lott.

"This cost us at least two T.D.'s"

"Over all, I was very pleased with the effort... It was a much better game than the scoreboard reflected."

Groom had 16 first downs to Sunray's 24, 189 yards rushing to their 306 but out distanced them in passing 116 to 55. Sunray had 8 penalties while

## Quinn Seeks Office

Brian Quinn is running for the 7th Court of Appeals on the Republican ticket.

The 7th Court of appeals consists of four judges that sit in panels of three and review decisions rendered by district and county court judges.

Graduating fourth in his class at the Texas Tech School of Law, Brian Quinn is an appeals attorney with eleven years of experience, as well as admitted to practicing law in the Texas Supreme Court, U.S. Supreme Court, U.S. Court of Appeals, and many others.

He has personally handled over fifty appeals, two hundred civil and criminal appellate matters, and participated in over 95% of all major trial litigation in his law firm.

Quinn is 38 years old, married to Abby Flygare and they have two children. They attend St. Elizabeth's Catholic Church in

Lubbock.

He is a member of fourteen civic groups, including 4th on Broadway Festival, Lights on Broadway Festival, Lubbock Downtown Lions Club, Committee of Churches, and a volunteer for youth basketball programs and local girl scouts.

"I have not been a trial judge though I have trial experience. Furthermore, appeals courts do not try cases. Nor am I on the Appeals Court, but Appeals Judges perform tasks remarkably similar to mine. Unlike them, however, I also have the opportunity to represent clients in appeals and trial courts. Thus I have the qualifications of legal intelligence and experience, integrity, honesty, fairness and respect for the law needed to perform effectively," stated Quinn.

"I will interpret and apply the law, not create or ignore it."

The Fighting Tiger Marching Band went to contest last week at Borger. The band was rated a II in their over-all performance

by three different judges. Each band is judged on three general areas: Musical Competencies, Marching Competencies,

and General Effect.

In the "Musical Competencies" category, such things as music selection, compatibility between the music and marching styles, fullness of sound and balance are what the judges look for. The Groom Band had many compliments on the trombone section. Two of the judges felt that they overpowered the rest of the band slightly but it might be that the band needed a little more self-confidence in order to match their sound.

In Marching Competencies, the judges look at uniformity, posture, execution and precision of

the marching drills. Most of the critique was complimentary. They stated that the band was a little uneven on their step off on spacing coming across the field and needed to work on their carriage. In the General Effect part of the competition, drill difficulty, continuity and flow and attention to detail are considered.

Judges commented that the band had a "good show design" and "attention to details."

The band is directed by Jerry Crowell and is under the field direction of Roni Michelle Fields.



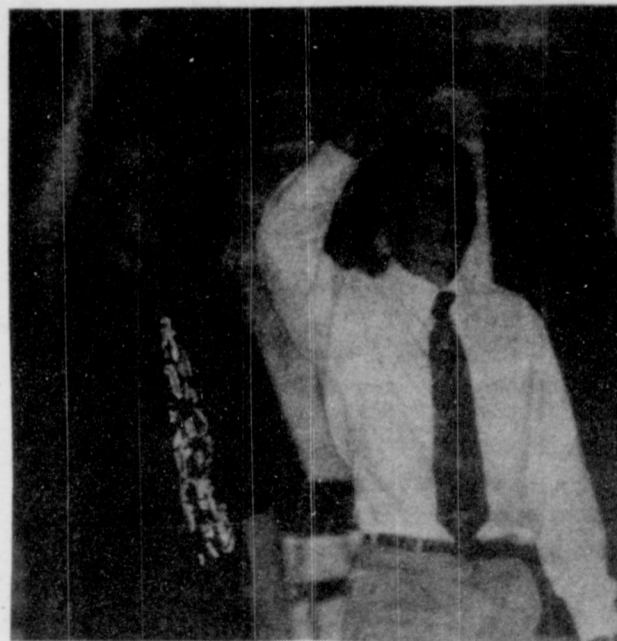

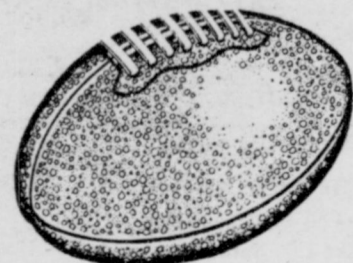

### Public Notice


Southwestern Bell Telephone Company (SWBT) has filed an application with the Public Utility Commission of Texas (PUC) to restructure the current PLEXAR I and II service offerings. This restructure will significantly change PLEXAR I and II services.

The restructuring of PLEXAR I will, among other things: (1) reduce the maximum line size from 30 to 9; (2) obsolete and grandfather certain optional features; (3) eliminate the requirement to subscribe to Feature Package Two in order to subscribe to certain optional features; (4) reduce the nonrecurring and monthly rates of certain features; and (5) increase the nonrecurring charges for the PLEXAR I System Charge (\$2.10 to \$8.00), Call Transfer Disconnect feature (\$3.00 to \$8.00), and Convenience Dialing I feature (\$6.35 to \$8.00). All current PLEXAR I customers will have the option of keeping their current PLEXAR I service, switching to the new restructured PLEXAR I service, or switching to PLEXAR II service with ten or more lines.

The proposed PLEXAR II restructure will, among other things: (1) change the tariffed offering to serve the market segment of 10-74 stations; (2) create two station pricing structures, one for customers with 10-29 stations, and one for customers with 30-74 stations; (3) reduce the sensitivity for the loop portion of the rate to two price bands: 0-2 miles, and beyond 2 miles; (4) offer a PLEXAR II basic station that can be flexibly configured, from a number of standard features, to meet the individual customer requirements; (5) change the way the termination liability is calculated so the customer is responsible for 65% rather than 56% of the present worth of the remaining monthly payments in the contract; (6) create an option that allows month-to-month customers to convert to long term contracts of at least three years and receive a credit or "contract signing bonus"; and (7) establish a System Subsequent Change Charge which applies per serving central office when changes are made that affect the entire system.

Current PLEXAR II customers will also have the option of keeping their current PLEXAR II service, or switching to the new restructured PLEXAR II service. PLEXAR II customers with at least 75 stations also have the option of switching to PLEXAR Custom service in certain situations.
