Tourney champion Wall had three players on the team when you include the most outstanding player James Glass. The other two who won awards were Kenneth Holubec and Kenneth Dierschke.







When The Congress this week received President Eisenhower's 1,02" page budget, weighing in at four and one-fourth pounds and calling for expenditures of \$77 billion, someone with a quick pencil figured that it cost more than \$1 billion an ounce, or approximately \$75 million per page.

A glance at the budget reveals again the high cost of national defense. Some \$45.8 billion is to be spent for major national security. The President recommends a modest increase in ballistic missiles and space exploration equipment as well as the retaining of ready military forces at about their present strength.

It is easy to see that war, and the threat of future wars, accounts for much high Government spending. Of the fiscal year 1960 budget, 59.9 cents of every dollar will go for national defense and security; 10.5 cents for interest on the national debt (increased largely by heavy defense spending over the years) and 6.6 cents for care of and benefits to veteran's participating in past conflicts. In his budget message, the President said it would be necessary to again ask Congress to increase the permanent national debt ceiling to \$285 billion, and to hike it even higher on a temporary basis to cover the \$12.9 billion deficit expected under his current operating budget.

This will be the seventh time Mr. Eisenhower has asked Congress to raise the national debt ceiling during his tenure of office.

Even if the present budget proves to be balanced and shows the \$100 million surplus the President optimistically predicts at the close of fiscal 1960, he will have accrued a net deficit of \$29.1 billion during his Administration to that point. in balance at the close of the fiscal year, the national debt will be
