Veteran of RAF Describes Work of Nuisance Raiders

Thadd Tabb One of Daredevil Americans Who Flew with British

An interesting account of some of his experiences as a "nuisance raider," flying sorties over the coastal area of occupied France in the early stages of the war as one of a group of "crazy Americans" who joined up as pilots with the RAF before America entered the war, was given to members of the Ozona Rotary Club Tuesday by Thadd E. Tabb, RAF fighter pilot in 1941 and a pilot in the U. S. Army Air Forces after American entry into the conflict. Tabb received a medical discharge from the Air Forces as a result of injuries suffered in combat and for the past several months has been acting as civilian instructor of flying cadets at the Ballinger Army Air Field.

Tabb's talk was one of two interesting features on the club's program for the day, Houston Smith, county judge, discussing the two proposed amendments to the Texas constitution to be voted on at the general election November 7.

Tabb went to England as a pilot in the RAF in 1941, with "a bunch of Crazy Americans, as the British called us." England was in desperate need of pilots at the time, Tabb recounted, and he and others of the group of volunteer Americans, although experienced only in civilian aircraft in this country, were readily acceptable to the British.

"We were given a 20-minute check ride, a few landings and take-offs, and we were handed a Hurricane fighter," Tabb said. "After ten hours of flying in the Hurricanes, which were the beaten up survivors of the battle of Britain, we were classified as operational pilots."

After a tour of duty as fighter cover for bomber raids and ship convoys, they were shipped to Southern England, Tabb said, where he was a member of the first group of "nuisance raiders." He was the only American in his squadron, he recalled, the group being composed of Polish, French, Czech, British, Dutch and other nationalities.

"We were told that we were to carry out nuisance raids over occupied France," he said. "We were to fly at an altitude of six feet to not more than fifty feet off the water over the channel and go into France to shoot up whatever was in sight. We were given obsolete Hurricanes with home-made bomb racks under each wing to carry two 500-pound bombs each. In addition we had 12 machine guns in the wings."

"The prospect of such an assignment did not look so hot to us," Tabb said. "But our squadron leader volunteered to make the first mission and see what it was like. He came back with such a vivid account of the fun he had had in just shooting up what ever struck his fancy that all of us were anxious to give it a try. And it was just as much fun as the squadron leader had reported."

"Our first trip over as a group was a mad scramble. We shot up and bombed everything in sight that looked like a Jerry hangout. I may have killed as many French as I did Germans but at that time it didn't make a great deal of difference for the French collaborationists were concentrated in that area. Our raids were calculated to slow down production of German materials in French factories, for workers had to take shelter while we cruised about an hour or more, that was that many man hours lost to the German production."

One of his most vivid memories was in proving the Dieppe raid, which proved disastrous both for the ground and air forces of Britain.

"The raid was supposed to be a deep secret," he said, "but when we approached the coast everything, including the kitchen sink, came up at us. We lost a complete squadron in that raid, and we

Rev. Childers Accepts Pastorate In San Antonio

Baptist Pastor Here 7 Years to New Post November 13

Rev. Clyde Childers, pastor of the First Baptist Church in Ozona for nearly seven years, has resigned his charge here to accept the pastorate of the Riverside Park Baptist Church in San Antonio. Announcement of his decision was made to the membership at prayer meeting services at the church last night.

Rev. Childers and Mrs. Childers will leave Ozona Monday November 13 for their new work. He will succeed the Rev. C. S. Cadwalader, who left the San Antonio church six weeks ago to accept a post in Ruston, La.

The Riverside Park Church has a membership of 943, Rev. Childers said, with an average attendance of 400 in the Sunday School. The church employs a full time assistant pastor and a full time secretary. Last year it operated on a \$27,000 financial program and has an \$80,000 property valuation. The church is located at 3600 South Presa Street. The church was organized in 1907 and in its 37 years of existence has had but ten pastors.

Rev. Childers came to the Ozona church as pastor from Westbrook, Texas, in January of 1938, succeeding the Rev. Ira Garrison. During his years as pastor the church has made steady growth and in that period has wiped out its indebtedness incurred in the construction of the present building. Rev. and Mrs. Childers have won the love not only of the membership of their own church but of the community at large during their stay here.

"We have been happy in Ozona and it is with deep regrets that we leave," Rev. Childers said. "We shall always have a place in our hearts for the people of Ozona and the welcome mat will always be out at our new home in San Antonio."

200,000 Pounds Of Fall Wool Is Appraised Here

First Appraisal Sets An Average Price of 38.72 Cents

In the first appraisal of the current accumulation of fall wool in the Ozona Wool & Mohair Co. warehouse, appraisers for the Commodity Credit Corporation, here last Friday priced approximately 200,000 pounds of the short fleece.

Valuations placed by the appraisers varied from 35 to 42 cents on individual clips, with an average of 38.72 cents per pound on the lots examined.

Melvin Brown, manager of the local warehouse, said that approximately 800,000 pounds of fall wool is stored here. Appraisers were expected back this week to place government purchase price on more of the accumulation.

Lions Triumph Over Eldorado in Spirited Battle

Locals Remain Undeclared in Face of Strong Eagle Threat

In one of the hardest fought battles of the current football season, Coach Sikes' championship-bound Ozona Lions retained their undefeated status here Saturday when they thumped the Eldorado Eagles by a count of 13 to 7. Despite their record of three games lost and only one win, the Eldorado team was judged the best team the Lions have met this season, supporting a speedy and hard-driving backfield sparked by Davidson, Page and Finley and a stubborn line which locals found hard to penetrate.

Perennially a jinx to Ozona teams, whether of championship calibre or not, the invading Eagles served notice on the Lions in the first few seconds of play that they, the visitors, were by means a push-over. Taking the Lion kick-off on their own 35, the Eagles, in three plays had chalked up three first downs and shoved the ball to the Ozona 25, and a few seconds later had hung up a penetration by pushing on to the Ozona 18. There, however, the Lions stiffened and held the Eagles for downs.

From there the Lions started their first touchdown march which paid off early in the second frame. An exchange of kicks left the Lions in possession on their own 30. From there Byrd Phillips took a hand-off which netted 9½ yards and on the next play Bill McWilliams, behind superb blocking by the hard-driving Ozona forwards, slashed to the Eagle 44. Sweeten picked up a yard and a short pass to Phillips was good for 9 more and a first down. Sweeten picked up another first on the Eldorado 30 and Yancy, substitute back, did a bit of fancy stepping around the left end to carry to the 15 as the quarter ended.

Opening the second quarter, Sweeten stepped off 7 yards and McWilliams took it the remaining distance through tackle for the first marker. Coach Sikes, whose lads the previous week against Junction failed to make a point after touchdown in five tries, came up with a fancy drop kicker in Lowell Sweeten, who bounced the ball squarely between the uprights for the point.

It was a see-saw affair the balance of the first half until the fading seconds when the Lions recovered an Eagle fumble on an attempted lateral to take possession just inside the Eagle 20. But time caught up and three plays remaining in the half failed to produce the Lion score.

Ozona fans found their breaths coming in quick jerks at the opening of the second half when the Eagles came back with a slashing running attack which netted a touchdown on the second play of the period. The Lion kick-off slithered out-of-bounds on the 50. Taking advantage of the break Page tossed to Davidson on Ozona's 40 and on the next play, Davidson, a shifty and speedy running back, galloped the remaining distance for the Eagles' only touchdown — and incidentally, the only touchdown so far this season made through the Ozona line. A place-kick for extra point tied up the score—with the two teams at the moment tied on penetrations and the Lions one first down behind.

But the Lions showed their championship calibre by meeting the challenge. Stiffening their defenses, the Lions took the steam out of the Eagle rally and near the end of the third quarter were knocking at the door of another touchdown, only to lose the ball on downs on the Eldorado 3.

The locals were not to be denied that winning touchdown, however. The Eagles early in the final period, had made splendid recovery from their deep set-back, Davidson carrying to the 19 and then launching a splendid kick which put the ball back in local territory, on the Ozona 30. Community Faces School Teacher Housing Problem

Hotel Rate Hike Forces Move; Shortage Poses Serious Problem

A teacher housing shortage, resulting from a sharp raise in rates at the Hotel Ozona which probably will force an even dozen members of the school faculty to move, was presented as the number one community problem this week.

Members of the school board and Superintendent C. S. Denham brought the matter to public attention this week as a problem which may seriously jeopardize the continued smooth operation of the schools unless a prompt solution is found. The rate raise represents an advance of two-thirds over the rate paid by teachers last year, according to reports, and most of the teachers have indicated that they will be unable to pay the new rate under their contract salaries.

Congested housing conditions locally complicate the problem for school officials and an appeal to the community was made by Supt. Denham for help in solving the problem.

"Teachers accepted faculty positions with the expectation of securing rooms at last year's rates," Mr. Denham pointed out. "They, like most other white collar class of workers, have been hardest hit by the rise in living costs since their salaries have not risen in proportion. This additional burden of expense cannot be borne out of present salaries and unless rooms can be found for them at more reasonable rates, the community stands the chance of a serious disruption in the school system."

If there are homes in Ozona where rooms might be made available to one or more of the homeless teachers, school officials would like to know about them. Since all available rent houses, apartments and rooms regularly rented are filled here now, the only apparent solution to the teacher housing problem seems to lie in a response of the citizenship, in the interest of the community welfare, to make available spare rooms in private homes.

Crockett 6th War Loan Quota Set at \$300,000

Drive Starts Officially Nov. 20; Series E Quota \$75,000

Another government War Loan drive is at hand, the Sixth, scheduled to begin officially on November 20 and continue through December 16.

Crockett county has been assigned an overall quota of \$300,000 in government securities to be sold during this period, Scott Peters, County War Finance Committee chairman, announced this week upon receipt of advice from Nathan Adams of Dallas, state chairman. The county's quota is divided into \$75,000 of Series E bonds for small investors and the balance for corporations and other large investors.

"Texas has again received a challenge in this drive which we must meet and exceed" Chairman Adams wrote to Mr. Peters in announcing the Sixth War Loan plans. "The quota for the state is \$414 millions, of which \$105 million has been assigned to us for sales of Series E bonds."

"The primary objective of the Sixth War Loan, like the past several drives, is to reach as many small individual investors as possible, and the success of the drive in your county will depend on the manner in which you organize for personal solicitation in each of your communities."

"The war news is not nearly so optimistic as it was thirty days ago. Germany could last all winter—Japan several years more. Our job is to finance these military operations with sound, legitimate sales to investors that will stay sold."

Sister of Ozonan Dies in California

John R. Bailey of Ozona received word early Tuesday morning of the sudden death of his sister, Mrs. Addie Roberts, 69, in Glendale, Calif.

Mrs. Roberts had made her home in Glendale for a number of years. She is survived by three daughters and one son. Funeral plans were awaiting the arrival of the children one daughter living in Mexico City.

In addition to the children, Mrs. Roberts is survived by three brothers, John Bailey of Ozona, Albert Bailey of Eldorado and Tom Bailey of Fort Worth, and one sister, Mrs. Nora Gee of El Paso.

That he receives a letter from home every week was the welcome word from an Ozona lad in a German prisoner of war camp received this week by his mother. He is Pvt. Evarado Ramoz, captured in Tunisia. In a letter to his sister, Lile Ramoz, dated August 27, Everado wrote, "This leaves me in the best of health. Don't worry about me. I receive letter from you and Mom every week. Have a friend from MacDona, Texas. His name is Raul Garcia. We are both together in the same place."

Ramoz is a son of Tomasa Ramoz of Ozona.

Lt. James H. Joslin Begins Final Phase Of Pilot Training

GULFPORT ARMY AIR FIELD, Gulfport, Miss.—2nd Lt. James H. Joslin, son of Mr. and Mrs. Harry W. Joslin, Ozona, Texas, has reported at this Third Air Force bomber base for an intensive training course as a co-pilot on a B-17 Flying Fortress.

Selected for this important assignment after stringent examinations Lt. Joslin will be a member of a ten-man crew who will live and work together under simulated battle conditions. Upon completion of training the crew will be ready for duty on the fighting fronts.

Taylor Deaton Is Promoted to Rank of Staff Sgt. in England

AN EIGHTH AIR FORCE BOMBER STATION, England—The promotion of Marshall T. Deaton, 25, of Ozona, from sergeant to staff sergeant has been announced at this station.

Sgt. Deaton, son of Mr. and Mrs. Fred Deaton of the same address, is taking part in bomber combat operations over Germany and the occupied areas as a ball turret gunner on a B-17 Flying Fortress. A graduate of Ozona High School, he entered the service in July, 1943. The Fortress group of which he is member, is a veteran unit on the European aerial front, having carried out 200 operations against the enemy.

Ten Absentee Votes Cast for General Election

Only One Federal Soldier Ballot Cast From Overseas

Only ten absentee ballots for the general election, to be held next Tuesday, November 7, had been received in the office of County Clerk George Russell yesterday. Absentee voting deadline is Friday of this week.

Out of a number of applications filed by service men for ballots, only one service man vote has been returned. It is on the official Federal service ballot and came from a soldier in Italy.

The official general election ballot for Texas carries a complete slate of 23 candidates for electors for President and Vice President of the United States for four parties and a partial slate for two other parties. In addition to the Democratic, Republican and Texas Regulars parties, which will attract major interest in the state, the Prohibition party has a complete slate of electors. Partial lists of electors are offered by the Socialist and America First parties.

Only in the case of the Republican party, however, do any of the parties other than the Democratic, offer any candidates other than for presidential electors. The Republican party has a complete slate of candidates for all state officers from Governor down with the exception of that for State Commissioner of Agriculture. Candidates for district, county and precinct offices, nominated in the Democratic primaries, appear at the bottom of the Democratic column.

The spirited presidential campaign and the campaign of the rebel Democratic group calling themselves Texas Regulars in Texas are expected to produce considerable split ticket voting. Voters are being instructed by the campaigning groups on this method of voting, a method which has been declared legal if the voter marks out all candidates for whom he does not wish to vote and leaves unmarked those candidates for whom he wishes to cast his vote. A continuous mark down the party column from top to bottom, or such part of its candidates against whom the vote is cast, is sufficient it being unnecessary to mark out each name separately. But a mark through the candidates of all other parties for a particular office is necessary in order to register a vote for the candidates of your choice.

age against the stubborn Eagle defense, the Lions kicked to the Eldorado 35. There the visitors made their fatal mistake—Page tossed a pass intended for Davidson, but Jimmy Read was at the right spot and intercepted, and then raced to the Eldorado 17 before being brought down. Four plays more and the Lions had sewed up the ball game, McWilliams carrying over for the last couple of yards for the touchdown, after Read had made it a first down almost to the pay line. Sweeten's next drop kick had direction but hit the cross piece squarely and bounced back into the field to be killed by an Eldorado player.

The Eagles came back with a determined passing attack, but alert Lions soon had the situation in hand, Sweeten intercepting on Ozona's 30 near the end of the game.

A near-tragic accident which resulted in the serious injury of two Ozona lads, Jimmy Read and Larry Arledge, marred somewhat the thrill of the day's victory for local fans. It was within two minutes of the end of the game when Read slashed off tackle in a terrific drive. Arledge had cut around to block an Eagle defender and the two lads crashed head-on, literally, their heads crashing together to lay both flat. Both injured lads were carried from the field and Arledge was unconscious for several hours. Both, however, had recovered the first of the week and were back in school, apparently no worse for wear. Arledge and Earl Tillery were co-captains for the day and both played stellar roles in the Eldorado defeat, as did others in that brick-wall line as well as the champion backfield.

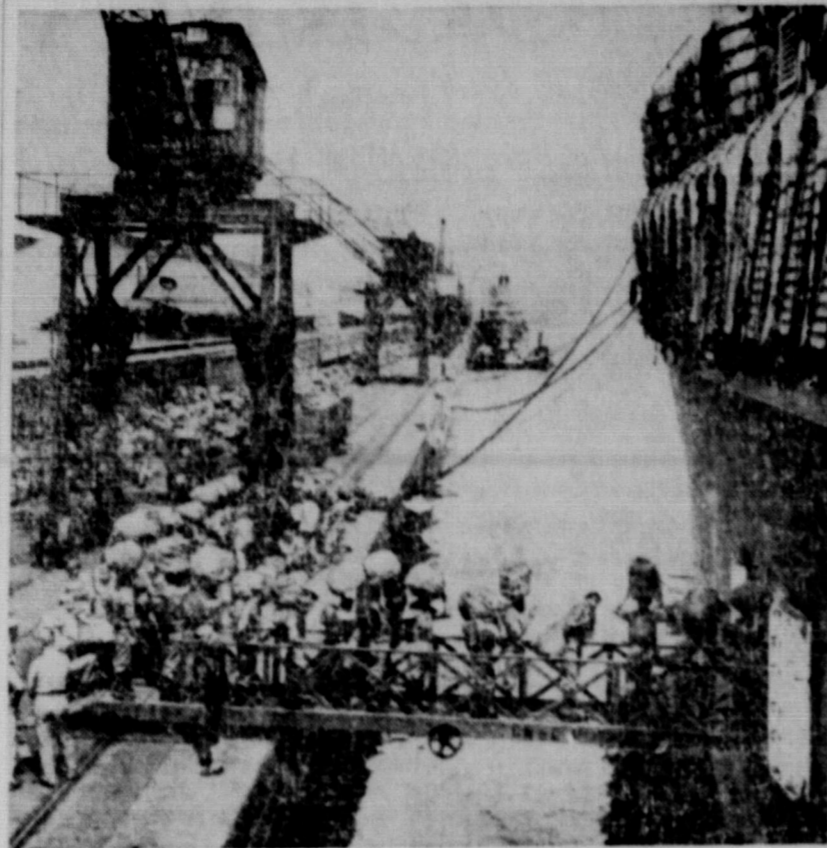

"Far in advance of the time when credit is actually needed for reconversion and postwar activities, the banks have adopted a dynamic and constructive credit program

and are already carrying it into effect," Hanes told the meeting. "Every competent man, firm or corporation that needs bank credit for some constructive purpose that serves the private enterprise economy of this country will get it," he declared.

After Seeing Underground Fortifications Of Germans at Brest, Ozona Sergeant Says He'll Be Lucky if He Gets Home by 1946

An interesting account of his Army medical unit's travels from a Normandy beach landing and on through France, Luxembourg and Belgium close behind the victorious Allied armies is given in a letter written from somewhere in Belgium on October 17 by Sgt. Martin Harvick to his parents, Mr. and Mrs. S. M. Harvick.

That American boys in and near the fighting on the continent are not as optimistic about the early close of the war as some at home are is indicated in a statement made by Sgt. Harvick in connection with an account of his visit to the German underground fortifications after the fall of the port city of Brest, France. "I still say that if I get home by the early part of 1946, we'll be doing darn good," he commented.

"We really do get around in this man's Army," Sgt. Harvick began his letter. "It seems about the time we land in one place we have to move on to another country. Just to give you an idea of where we have been this is more or less the history of our unit since we have been in France.

"When we came from England, we landed at the Ytoh beach in Normandy. From there we went to St. Germaine Du Vanville and spent a couple of days; and from there to Bricquovic, which is only a holding area. Our first set up was at St. Sauveren Le Vicome. When we were at this place, we received patients that were wounded in the battles of LeHaye, St. Lo and Contance. Remember I wrote you about the time I had gone up to the front line and had been in a town where they hadn't had time to remove the dead from the streets? That was St. Lo. The town was completely destroyed.

"From this area, we moved to Sens de Bretagne, which is only a short way from Rennes. While in this area we had casualties from the battles of Avaranches, Rennes St. Mallo and Dinard. When moving to this area we met quite a bit of excitement.

"From there we went to Bregonog, which is near what is left of Brest. That was one of the worst battles I believe our troops have run into since we have been in France. We moved into that area on my birthday and they told us if the Germans didn't surrender within 24 hours, they could take the place in half a day. As you know, it was quite a bit longer than half a day before Brest fell—by the way it was two weeks after all the big papers back home said that Brest had fallen before the real victory came. I believe there is less left of Brest than there was of St. Lo. I was also in Brest only a few hours after it fell and if you could see the underground fortifications they had there you could understand why it takes so long to go into these places. I still say if I get home by the first of 1946, we will be doing darn good.

"From the Brest area we went to a place in Luxembourg called Schillanger, which is near the city of Esch. There we stayed only a few days which was a rest period for us. We moved from there to this place in Belgium. We are only staying here waiting to get some orders telling us where to go and set up next. We may be here three days or three weeks, but I hope it

is only a few days because I had rather be busy than not doing anything."

The English people were friendly and treated them fine, Tabb said. They are a tough people and could never be beaten down, in his opinion.

Mr. Smith, speaking on the two proposed constitutional amendments, outlined the provisions of the amendments and gave the principal arguments for and against their approval. One provides for authority to be given by the voters in any county to the commissioners courts to re-allocate county tax levies for the various purposes. The other outlines a system whereby cities may pension overage employees.
