64th Annual Motley County Junior Livestock Show set for February 28

The 64th Annual Motley County Junior Livestock Show will be held on Saturday, February 28, 2004, at the Motley County Livestock Show Barn. The Livestock Show is sponsored each year by local volunteers to provide an opportunity for 4-H and FFA members to exhibit their livestock projects.

By caring and feeding for their livestock throughout the feeding project, youth have the opportunity to learn responsibilities and increase their knowledge of the livestock industry.

During this year's Show, there will be 4 steers, 23 hogs, 6 lambs, 21 goats and 24 rabbits exhibited. In addition, a Pee Wee Swine Showmanship Show will be held for youth under the age of 9 years and not in the third grade.

Anyone living in Motley County, owning land in Motley County, or youth eligible for the Junior Livestock Show may show heifers. Anyone planning to show a pen of heifers must

notify the Junior Livestock Show Association by Friday, February 20, 2004. Heifers must be 12 to 18 months of age at show time. Heifers will be shown in a pen of three format. Animals will be identified by number and placed in a pen. They will not be shown at halter or weighed. There will be a \$10.00 entry fee per pen of heifers. All heifers must be in place by 10:00 a.m. Heifer classes will include, English, Exotic, and Crossbred.

Pay-N-Save Grocery in Matador will be serving breakfast to exhibitors, donors, and local residents from 6:30 a.m. to 8:30 a.m. at the Livestock Show Barn. The breakfast will be prepared by local volunteers.

There will be a concession stand open throughout the Stock Show.

Roaring Springs graduate appointed to Texas Tech Board

Bob Stafford, a 1955 graduate of Roaring Springs High School, has been appointed to the Texas Tech Board of Regents by Gov. Rick Perry.

Stafford, a retired orthopedic surgeon and a 1959 Tech graduate, said that he is honored to be given the responsibility of representing the Panhandle on the Texas Tech board.

"I hope to represent the best interests of the university and this area because I believe that these mutually benefit each other," Stafford said.

He feels that his love of Tech, his love of medicine, and his love of agriculture give him a unique perspective to bring to the board.

Rural health care is of great interest and concern, and he has said that he would like to see what the university has planned relating to this issue.

He attended Tech on a football scholarship and attended the University of Texas Southwestern Medical School in Dallas. Another interest of Stafford's is boosting attendance at Tech football games.

Stafford retired in 1998, and lives in Amarillo with his wife Diana. He has three children, Greg, Gwen, and Cheryl.

He spends time at his ranch in Roaring Springs where he is a partner in Stafford Cattle Company. He is Co-director of Region II of the Texas Wildlife Association.

Stafford is a member of the board of The Red Raider Club and a member of the Double T

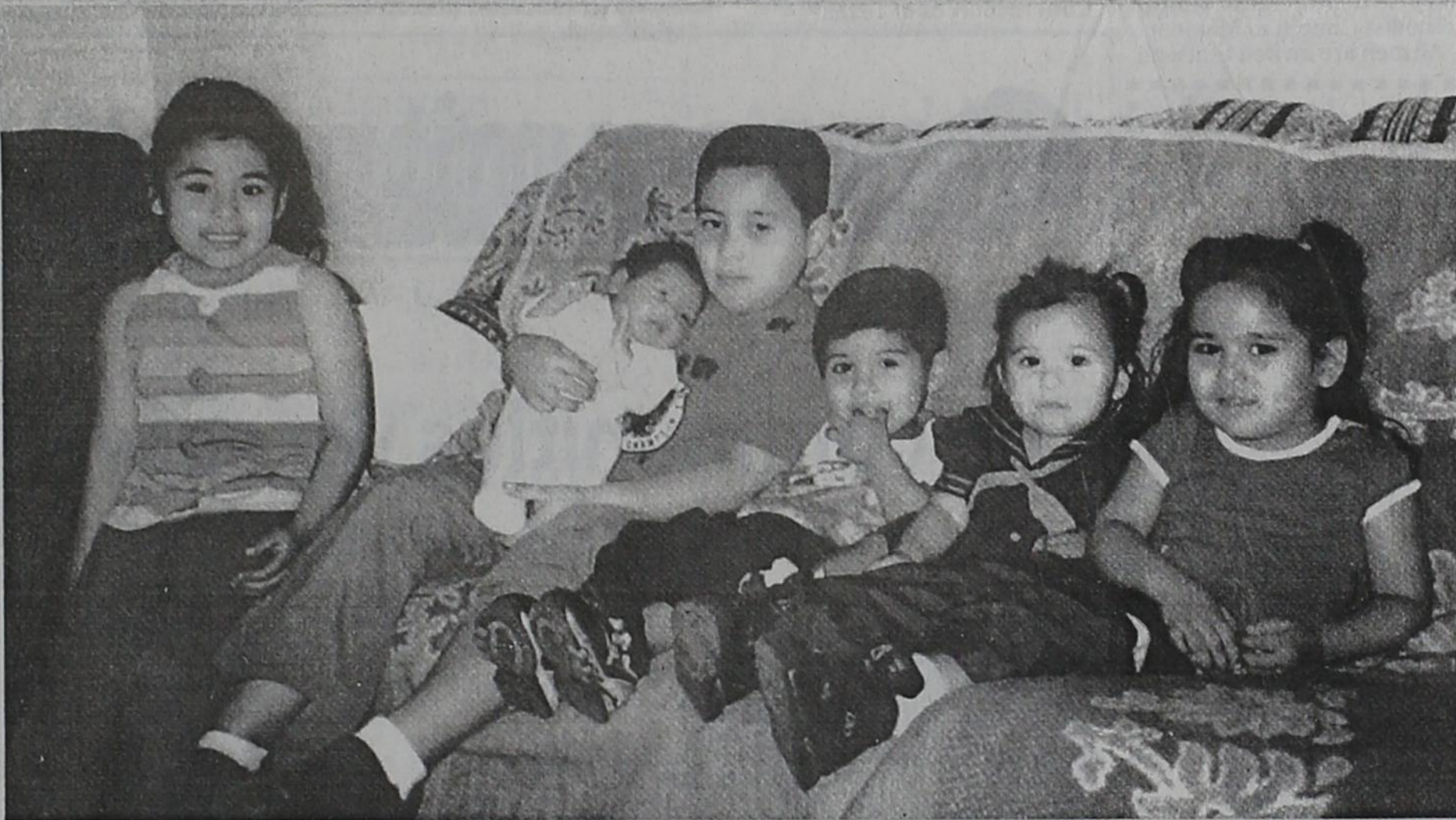

Association. He chairs the Amarillo Area Texas Tech Horizon Campaign. He is a member of the Double T Association and serves on the Baptist Saint Anthony's Foundation board.

Robert Black, Chairman of the Board of Regents, feels that it will be helpful to have new thoughts and ideas from the three new appointees to the board. "These are people with varying experience, but the most important thing I've seen is these people are committed to serving and doing what is right for Texas Tech," Black said.

"I am free to communicate with people here in our area about what they feel Texas Tech can do for us. I would like to be a liaison between us and the Tech community," Stafford said.

Motley County begins year with good precipitation

For the past two months, Motley County had two choices in precipitation, a trace or nothing at all. A network of roads, rail and a dedicated utility zone called the Trans-Texas Corridor will be built to move people, goods, utilities - and even ideas - through the state safely and faster than ever before. Construction will be funded over several decades through tolls, bonds and other innovative financing tools. Likely starting points for this corridor will be high-population areas of the state. Eventual features of the corridor could include separate lanes for cars and trucks, separate passenger, commuter and freight rail lines as well as a dedicated utility zone that includes water, electricity, natural gas, petroleum, fiber optics and telecommunications.

Area trying to gain recognition through region-wide influence

The advantages of a 10-county regional organization in promoting state representation and economic opportunities were discussed during a meeting at Fair Park Auditorium in Childress, Wednesday, January 28.

Childress County Judge Jay Mayden and Childress Mayor Pat Steed emphasized the im-

portance of a group "to pull in population numbers for representation in Austin and implement regional projects beneficial to the entire area."

Motley County Judge Ed D. Smith attended the meeting. Mayors and county judges from Wellington, Memphis, Paducah, Quanah, Clarendon, Hollis, Oklahoma, Matador, Turkey, Quitaque, Silvertown, Crowell and Childress were in attendance.

"It is our belief that if we want our region to prosper and grow it is going to take all of us work-

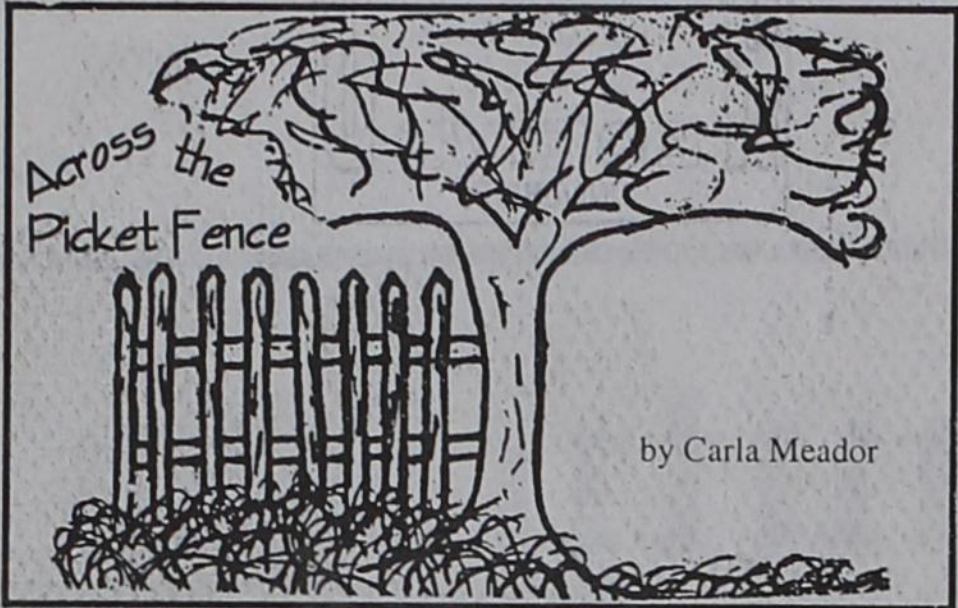
ing together to make it happen," said Childress City manager Jerry Cummins. "Combining our efforts gives us a much stronger voice in expressing to others what we are trying to accomplish."

The 10 counties - Briscoe, Childress, Collingsworth, Cottle, Donley, Foard, Hall, Hardeman, Harmon County, Okla., and Motley - have a combined population of 33,252 - down 1.5 percent from 33,747 in 1990. Individually, population numbers range from 1,426

to 7,688, which shows that no one county has the numbers to impress state and national candidates, but together the numbers are significant.

Only two of the 10 counties - Childress and Donley - show a population increase. Childress County population is now 7,699 - up 29.1 percent over the 1990 census; Donley County is 3,828 - up 3.6 percent.

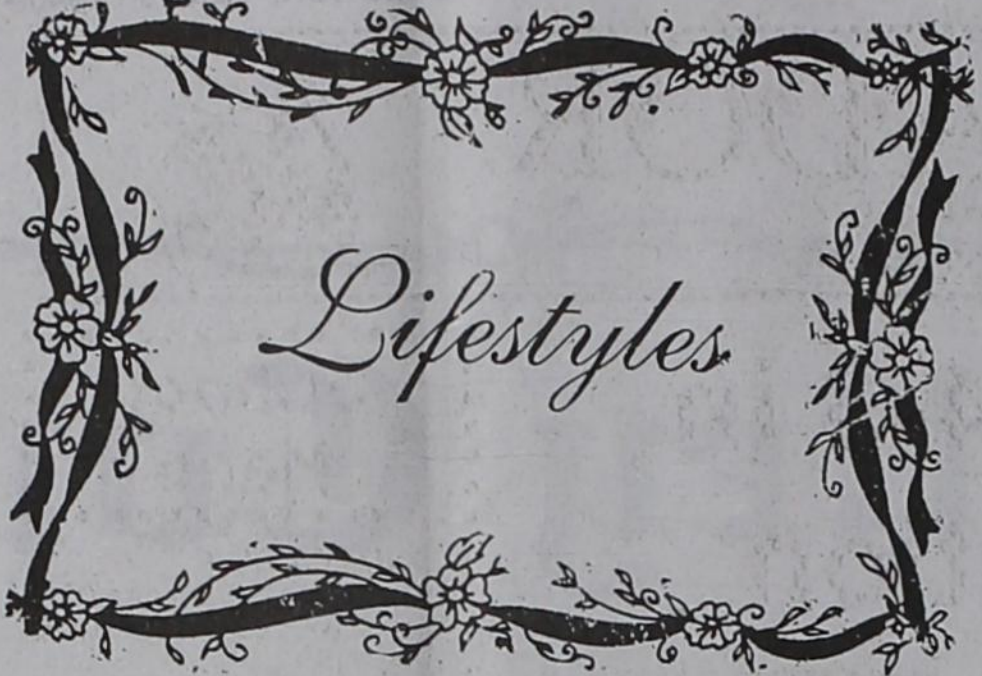

THC commemorates cultural legacy of African Americans during Black History Month

Austin - Celebrate Black History Month by experiencing the contributions of African Americans in Texas. The Texas Historical Commission (THC) is offering a free brochure commemorating the cultural legacies of African American Texans. This colorful booklet guides travelers to statewide heritage attractions and is an educational resource of African American history.

After this proclamation, African Americans flooded into Texas, shaping the history and culture of the state. Buffalo Soldiers protected frontier forts, black churches motivated social change and everyday people struggled for voting rights, improved education and equal treatment.

Part of the THC's heritage tourism initiative, the brochure includes a time-line, photos, narratives and special events honoring the struggles and triumphs of African Americans in Texas.

The guide informs visitors about people, places and events dating from 1528, when the first identified African American explored the region north of the Rio Grande, to the 1973 election of Barbara Jordan to the U.S. House of Representatives. It guides the traveler to historic neighborhoods, black folk art museums and festivals celebrating black culture and heritage.

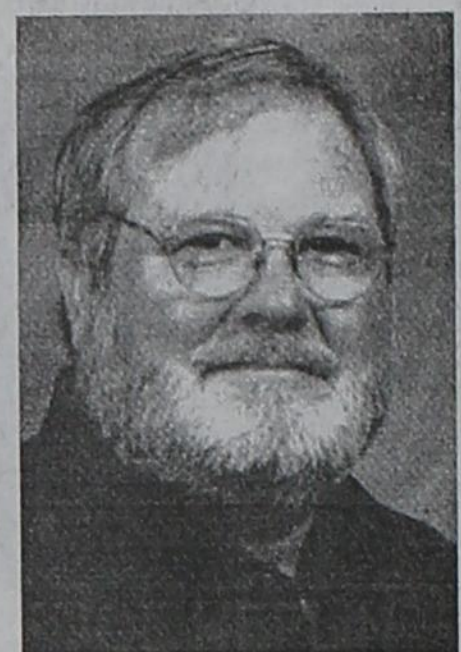
Ken Vance Campbell

Duncan announces plan for new district office

Sen. Robert Duncan, R-Lubbock, is pleased to announce his plan for opening an office in Childress to assist constituents in the northern portion of Senate District 28.

The office will serve residents of the district's 15 northernmost counties: Armstrong, Briscoe, Carson, Childress, Collingsworth, Cottle, Donley, Foard, Gray, Hall, Hardeman, King, Knox, Motley and Wheeler.

"Senate District 28 is wide-ranging expanse of land, with varying interests and economies," Duncan said. "But one thing all 46 counties have in common is that some of the greatest Texans in the state live

there." Many of the communities' leadership had expressed interest in being home to Duncan's northern office, and each featured the progressive, thoughtful local leadership important to moving both the region and the state forward. Childress was selected based on its geographic proximity to the other 14 counties, and sharing the area with other legislators.

"This part of West Texas is well-represented in the Legislature, and I am proud to share a part of this state with lawmakers such as Representative Warren Chisum and Representative Rick Hardcastle," Duncan said. "I look forward to what we can

accomplish together between Chisum's office in Pampa, my office in Childress, and Hardcastle's office in Vernon."

Duncan said many residents in the area have made it plain that they want to be involved in protecting rural interests.

"I will work to see that these communities have the resources necessary to develop and maintain those opportunities, and I believe this office will be key in that effort," he said.

Duncan said he hopes to have an office space this spring.

Initially, Lubbock staffers Brandon Lipps and Katie Yates will work in Childress. However, Duncan intends to hire a local resident as District Director by this fall.

"It's important to me that we have someone in the office who lives and has worked among these communities. My philosophy in hiring district staff is that they must understand Senate District 28 constituents' lives so that we can be certain their needs and concerns are met," Duncan said.

Cummins prepared a list of state boards/committees on which appointments are scheduled and suggested that each county/city look at its people and submit names which could be forwarded by the group to Sen. 

