

### The Consumer Alert

AUSTIN—Deceptive trade practices in the fields of art and antiques? Yes, indeed, say lawyers in our Attorney General's Consumer Protection Division. And recently, we've obtained court orders prohibiting misrepresentation, false advertising, and other violations of the Texas Deceptive Trade Practices-Consumer Protection Act in several cases involving art and antiques.

Generally, the cases our attorneys have worked on have not been the traditional "art forgery" or "fake antique" cases in which an individual has carefully crafted an item to make it appear to be an original by a known master painter or artisan.

Instead, they usually follow this pattern: an advertisement will appear in the local newspaper for a limited-time special sale (usually a one-day or one-weekend only sale) to be held at a local motel or hotel.

In one case, the advertisers claimed to be liquidating the contents of several out-of-state antique shops, plus antiques from the collection of an out-of-state couple.

Although the advertisement implied that the "special auction" was unique, our attorneys discovered that the seller had been traveling from city to city in Texas holding the same "auction."

Contrary to the ad, the merchandise to be auctioned was not all antiques, but included antique reproductions and new merchandise. In addition, our attorneys alleged, and the court agreed, that many of the "bids" at the event were "fake sales" bid at the highest price by employees of the seller in order to mislead persons attending into thinking the auction was valid.

The seller was not certified to do business in Texas, and the employees who were serving as "auctioneers" were not licensed, as required by a new State law. We were able to obtain restitution for some consumers, plus civil penalties for the State, in addition to requiring the defendants to issue retractions of any advertising placed in newspapers across the State.


Several art fraud cases follow the same general pattern. In one, a seller represented that paintings were "registered" by an international art registry, and that their "appraised value" had been determined by experts. Neither claim was true.

In another case currently in the courts, our lawyers have alleged that persons conducting a "special warehouse clearance art sale" did not have on hand the large number of low-priced art and related items advertised.

The "limited time" sale from motel or hotel rooms is a method frequently used by persons selling Oriental rugs, Indian jewelry, and other jewelry and gems. The average consumer may not be able to

Select a television carefully with an eye to crispness and sharpness of picture, pleasing color tones and lack of distortion. Experts at the Electronic Industries Association suggest you don't select by picture alone; turn the sound up to determine whether it is well balanced and pleasing, particularly in musical passages. Watching titles or commercials is a good test. Written matter should be crisp and easily legible.




As an aid to choosing the right sized set, it's a good idea to measure the distance you'will sit from the set at home and stand at about that same distance in the store.

judge the quality of such items, and may learn only later when an expert appraises them that they were greatly overpriced. By then, it's usually too late to trace the seller, since he has moved on to another city or state.

If you're not knowledgeable in such fields, you should trade with a reputable, established merchant who won't leave town after a sale. Such persons may offer authentication of major art or antique purchases, may allow a "trial period" of the goods, or may even offer a money-back guarantee if an independent appraiser evaluates an item at lesser cost.




Deadline for submitting entries will be April 30, 1976. All participants are asked to be signed up withapplication blanks filled out by March 31, 1976.


## Youth Events Planned By FBC Friday, Sunday


