## Statement Shows Local Bank In Good Condition

The Statement of the Condition of the Santa Anna National Bank at the close of business on December 31, 1951, shows the bank to be in excellent condition with total deposits amounting to \$1,736,579.45. Deposits a year ago were \$1,802,632.72. Total assets of the bank at the present time are \$1,937,503.80, while the assets a year ago were \$1,989,035.06. Assets and deposits have decreased slightly during the year, but the country has suffered a drought, with only a few crops being made.

### No Announcements For Car Inspections

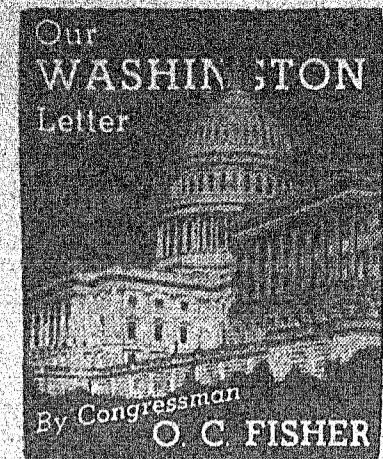
During the past few days we have been asked by a large number of citizens as to what was going to happen concerning the auto inspection that all vehicles must have before license plates can be issued.

Just as soon as news is released of stations where inspections will be handled, these stations will be published. But until some approval is granted, we will just have to sit tight and hope that the approvals are issued in the near future.

With this first Newsletter of 1952, I extend my greetings and best wishes to each of you for the New Year. Though it's too much to hope for, it is my wish that the best day you had in 1951 may be the worst for you in '52. During the past three months I have had the privilege of visiting in most of the counties of our

large 27-county district. I made more than 40 appearances before different groups, including Farm Bureau meetings, Soil Conservation, REA, PMA, livestock producers, Angora Association, School and College assemblies, Chamber of Commerce, Service Clubs, and a multitude of other meetings. As I made the rounds I had a chance to talk personally with hundreds of friends and constituents and to obtain the benefit of their views on many complex problems with which our Nation is faced today.

Everywhere in our area the drought is, of course, taking its toll, and along with this misfortune there is a very serious shortage of labor to carry on ranching and farming operations.

I found the people to be of one mind on most of the basic issues with which we are confronted. They are very properly concerned about high taxes, the magnitude of the public debt

and the present-day cost of government. Most of the people want this nation made strong and powerful during the critical and uncertain times. But they loathe the waste and extravagance by the military as well as all other agencies.

They feel there has been poor judgment used by the Executive branch in hiring many key officials, and that the Congress has acted with wisdom and propriety in exposing crime and corruption wherever it could be found. Many expressed the hope that these investigations be continued so long as they seem to be doing any good.

**THE PRESIDENT'S ACTION** in calling for a complete revamping of the Bureau of Internal Revenue, with the offices of Collectors to be abolished and most key officials to be put under Civil Service, offers a plan patterned after the Hoover-Commission recommendations. The proposals will receive the attention of the Congress early in the session. While coming at a late date, the plan seems to be basically sound. There is no way of preventing dishonesty and corruption if dishonest or corrupt men are employed, whether under Civil Service or not. But the reorganization should discourage a practice of political rewards in making appointments, and through an independent inspection service, should be a very proper step in the right direction.

Commissioner of Internal Revenue, John Dunlap, is said to be about the busiest man in Washington these days. Having taken over the job last Summer after serving ably as Collector of Internal Revenue at Dallas, he has been prying into the caliber of personnel and has removed a lot of them. He has disclosed that a total of 166 employes of the tax agency were fired or forced to resign in 1951, including six Collectors. Dunlap and thousands of other Federal employes are considered to be honest, but it seems that he inherited a good many politically inspired appointees who turned out to be corrupt.

**TIDELANDS** is due to be acted upon by the Senate this Spring. A bill to confirm title to our tidelands in Texas was passed by the House last July by a vote of 265 to 109 — more than enough to override a veto. But the margin may be closer in the Senate despite the valiant efforts of Senator Connally, Senator Johnson and others.

Spearheading the opposition will be Senator O'Mahoney of Wyoming and Senators who are closely aligned with labor union pressure. Both the CIO and the AFL have been very active in supporting the Administration's grab of our tidelands. Last week the magazine LABOR, representing 15 railroad unions, joined in the demand that Uncle Sam gobble up oil reserves under the tidelands along the coasts where ownership in the States was recognized for more than 150 years. In the case of Texas, ownership

was defined in the annexation agreement in 1945. It is believed here that most of the labor unions in Texas are not in sympathy with the attitude of the parent unions in the North with respect to the tidelands issue.

home Monday. Maybe you have forgotten that Anson, in Jones County, was named for Anson Jones, the second president of the Republic of Texas.

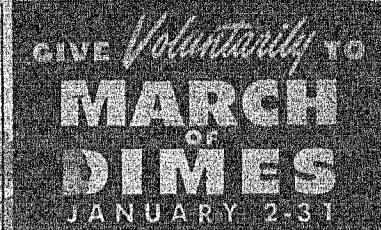
**OUR NEW YEAR RESOLUTIONS**

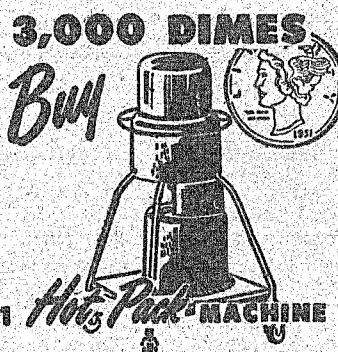

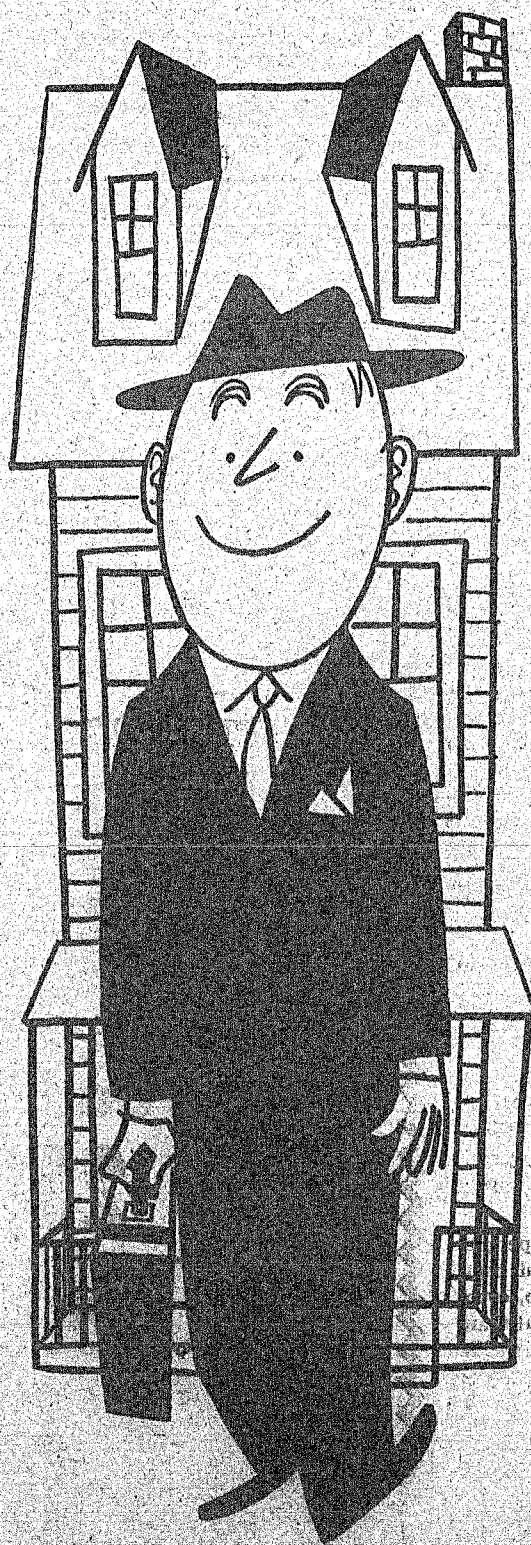

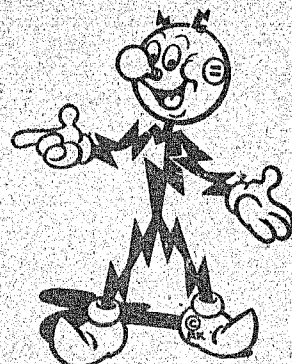

Time To Prune The Orchard

College Station. — This year's fruit crop depends to a large degree on the care given the trees during the dormant season. One of the orchard jobs that shouldn't be neglected, according to J. E. Hutchison, horticulturist for the Texas Agricultural Extension

Service, is the annual pruning and it should be done during the next few weeks.

A lot of equipment isn't needed but essential tools include a pair of hand pruning shears. Be sure the tools are sharp, says the specialist, before starting the job.

Fruit trees, says Hutchison, are pruned to stimulate new growth for next year's fruit to grow on. Pruning also keeps the trees down to handling dimensions. It is much easier to harvest the fruit from properly pruned trees and he points out that fruit needs sunshine to ripen as it should, and pruning allows the sunlight to reach the ripening fruit.

Hutchison also points out that the tops should be cut back to balance with the root system on trees set this winter. This practice of balancing tops and roots will insure better growth and a better tree later.

Pruning, he says, also gives

the orchardist a chance to remove dead or diseased limbs and branches from the trees and to check each tree for insects and diseases that might otherwise go unnoticed.

in several counties of the 50-County Fort Worth District, which includes Coleman County. "We have had several complaints from junk dealers that numerous sellers of used batteries are demanding above the ceiling price for these batteries," Boyd said. He explained that under the Defense Production Act both seller and purchaser can be prosecuted for such illegal transaction.

The ceiling price for junk passenger car batteries is \$2.80 per battery on an as is basis. The ceiling does not apply to the trade-in allowance a retailer may grant the purchaser of a new battery.

Reports list some sales as high as \$3.15 per battery, which is 35 cents above the ceiling, Boyd said.

The demand for junk batteries has increased because the batteries are a source of lead, a critical item in the defense pro-

gram, Boyd said. "Probably there are many businesses who sell new batteries and receive old batteries in exchange that are unaware of the ceiling price," Boyd said. He explained that OPS has a campaign underway to inform battery companies, service stations, auto supply houses, auto parts companies and others who sell junk batteries about the ceiling, as well as those who buy batteries.

**A 'Yes' to Christ**

Lesson for January 13, 1952

JESUS knew some distinguished people. But his first and most intimate friends were not of that kind. Christianity started at the grassroots of humanity. It did not start in the top branches. It is a good thing, too.

It is quite true that Christianity has depths and heights to which most Christians do not attain. A St. Paul has not only mystic raptures but intellectual penetrations which comparatively few Christians have shared or can share; he was a genius, and most of us are not geniuses.

But in Jesus' first group of companions there was no St. Paul. They were the plainest of plain people. The first of them were fishermen. They were not used to lectures; they were extremely doubtful whether any of them would have understood the Epistle to the Ephesians if it had been read to them. But they understood Jesus... at least they understood what he said. He said, "Follow me," and they followed him. It was as simple as that.



**Surrender**

THAT is what Christianity is, at its heart: saying Yes to Jesus. When those fishermen said their "Yes" it meant three things, and those three are always involved whenever any one sincerely begins the Christian life. For this was only the beginning, of course. There was a long road ahead; much they would have to learn and do and suffer; but even the longest road has its beginning. And the Christian's road begins with this first "Yes."

First of all, it means surrender. They took him for their leader, they absorbed his teaching, they obeyed his orders. There is a Christian hymn, "My Jesus, as Thou Wilt"; one hears it most often at funerals, but it is not intended as a funeral hymn. It could well be the hymn sung when young people are confirmed or join the church; it could well be the every-morning song of every real Christian.

What do I want most? Is not a Christian question: Rather it should be, What does Christ want most?

**Separation**

A GAIN, those fishermen's "Yes" meant separation. They left their nets, their old occupation. We must not read too much into this, as if in order to be a Christian one must leave his wage-earning business, whatever it is. On the contrary, the best place to be a Christian may be right where we are.

However, no matter what we may do for a living, it is still true that saying "Yes" to Jesus means saying "No" and "Good-bye" to many other things. It means separation from all that is out of tune with him; separation from selfishness, from sin, from trash and trifles. It means separation from habits that enslave us, from "recreations" that do not re-create but tear down, from places and opportunities of temptation, from hatred and prejudice and pride.

If a man really means "Yes" to Jesus, he cannot mean "Yes" to what is opposite to Jesus. The Christian life is a separated life. It is not that he is separated from people. Isn't it likely that the fishermen who followed Christ had a far wider circle of friends as they went with him than they had ever had before? But they were being shaken loose from what had before seemed to them most important,—yes, even from themselves.

**Service**

BUT that is the negative side of it. The Christian life is not only "no" but it is "for." That is, just as these first fishermen followed Jesus in order to become fishers of men, so the Christian's yes-saying always means enlistment for service.

A Christian's sincerity cannot be measured in what he says, nor even in what he does not do; it is to be measured in what he does.

It is a serious and solemn question: Do you, this is your last day

in life, and all the accounts are in. Looking back on what you have been and what you have done, has your life actually helped what Jesus Christ is undertaking in this world, or have you hindered him?

The Christian life is a surrendered, a separated life, but also a life of service. "Yes" can be said with the lips alone—that was Judas; a "Yes" to Christ can truly be said only with life itself.

## Game Department Consoles Hunters

Austin. — Those Texas sportsmen discouraged by the 1951 hunting season were consoled by the Executive Secretary of the Game and Fish Commission.

He said that while "the luck of many hunters was very bad because of a game shortage, conditions are not so dark that they cannot be improved by two or three years of good weather."

"The ravages of the drought have been particularly severe for the deer and turkey," the Executive Secretary said. He pointed out that the a. s. toll from

the drought will be accentuated by many more winter deaths from starvation.

"One bright spot on the hunting horizon this year," he said, "was the extraordinarily good quail hunting in the Panhandle. And this fine crop of birds will serve to stand as hope for the hunters since the Panhandle situation shows the difference provided by favorable weather conditions.

"While most of the state has been blighted by the dry weather, the Panhandle has had more normal moisture. This is reflected in the splendid quail crop."

In the case of wild turkey which have deteriorated badly in the state, the Executive Director said a change to more favorable weather "should find the turkeys rebounding quickly."

He relayed encouragement for the duck hunters about advance waterfowl prospects, citing that Canadian nesting areas had good fall rains.

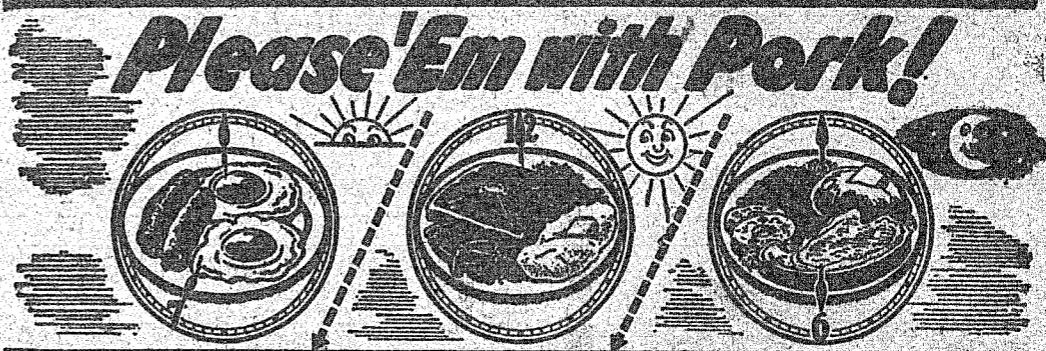
## 50 Graduates To Receive Scholarships
