County Judge Brad Stephenson stated that the county could not act on these requests and explained that this action would make the county a target for a

Gorman Schools Adopt New Dress Codes

We expect students to come to school in clothes that are clean and neat, and we expect students to exhibit basic cleanliness and grooming that will not be a health or safety threat to themselves or to other students or staff. While we respect students' desire to express themselves in their clothing and grooming styles.

Appropriate Attire

Male students must wear clean clothing (shirts, slacks, jeans, trousers) that is ot torn or damaged. Female students must wear clean clothing (dress, blouse, skirt, slack, jeans,) that is not torn or damaged. All students' pants must be worn with the waist at waist level, and shirt or blouses must be buttoned. Dresses, Shorts, and Skirts must be a reasonable length just above the knee. All students must wear shoes and appropriate undergarments. Shorts will not be worn between Thanksgiving Break and Spring Break. Any attire that brings undo attention will not be appropriate.

Appropriate Grooming

All students will exemplify grooming standards that project a positive image for the student, school, and district. Hair must be clean and neatly groomed and worn in a style that does not cover the eyes or eyebrows. Exceptions may apply with proof of religious affiliation, which address this issue.

Male students' hair must be neatly trimmed and worn in a style above the eye brows that exposes the earlobes and has a length above the top of the collard of a button-up shirt or crew-neck tee-shirt. Male students must be clean-shaven. Sideburns may extend no lower than the bottom of the ear and must be trimmed in a straight line without flares at the bottom.

Inappropriate or Unacceptable Attire

The following clothing and accessories are inappropriate attire for any student at school or a school-related or sanctioned activity.

- Skirts/Dresses/Shorts that are short.
- Pants worn below the natural waistline or sagging or extremely loose
- Shirts or blouse that reveal undergarments or cleavage, midriff length tops that leave exposed skin, or halter-tops.
- Exposed undergarments.
- Bedtime attire, pajamas, undershirts, or undergarments worn as outerwear, e.g., boxer shorts.
- Clothing made of any see-through material, fish net or very loosely woven fabric.
- Shirts or blouses that are split up the side such that the vent of split is unfinished and extends above the natural waistline.
- Unhemmed or cut-off clothing of any kind.
- Muscle shirts, shirts with oversized armholes, or backless shirts,
- 10. Any clothing made of spandex or similar body-hugging fabric or ma-
- 11. Flip Flops or house shoes.
- 12. Sunglasses, hats, or caps worn inside a school building.
- 13. Hair rollers, hair curlers, plastic hair bags, and other similar grooming items worn inside a school building.
- 14. Shorts in the school building. Clothing with Words or Pictures

Clothing worn at school or school-related or sanctioned activities may not display printed statements or pictures:

- 1. that are vulgar or obscene 6. that are related to or depict sexual activity
- 7. that promote hate or violence in general or directed at any specific
- person or group of persons that are related to or depict the use of drugs, alcohol, or tobacco.

An Open Letter

Dear Joe:

I have known you for a number of years and have appreciated reading about the people I know in the Gorman area while I was in distant places. As you probably know, over the years, I returned to Gorman several times each year for long visits with my family. As we started building on our ranch in Gorman during recent years, we have spent much more time in Gorman and were enjoying renewing old acquaintances. We continue to work in Tennessee much of the time as we develop our property in Gorman.

Unfortunately, the atmosphere in Gorman recently has not been a pleasant one because of the issue concerning St. Jude's Ranch for Children proposed in the Gorman area. I have been strongly opposed to the St. Jude's facility in a town the size of Gorman because of my personal experiences with such programs. I have helped in the opposition work and will continue to do so because I believe the facility will have a serious detrimental effect on the Gorman community, especially in schools, its police protection, and its economics.

I now feel a need to write a letter because the Texas administrators of St. Jude's have misquoted me in meetings where I was not in attendance and in written materials they have handed out at meetings. Let me assure everyone I did not say "I hate those kids". As a professor of education at the University of Tennessee, I had grants to work with youth very much like the ones who would be housed at the St. Jude's facility in Gorman. I did not have to work on such projects: I chose to do so because I wanted to help those troubled adolescents. My area of work is in literacy and many of these individuals have problems in that area.

I am not the only one who has been misquoted by the St. Jude people. The written materials and television reports have accused those who oppose them as either being "racist", of being members of "hate" groups, of being members of the Klu Klux Klan, or of being "unchristian". To them, everyone must be placed in one of these categories. I seem to have been placed in the "hate" group. Simply saying Gorman is racist will not work. Gorman has approximately 25 per cent of its school population who are Hispanic. These students are part of the community and There have been no "hate groups" as some have accused us. Simply saying Gorman people who oppose the facility are not religious does not make it true. Everyone knows the religious backgrounds of the many people who are opposed to the facility and the many good works they have done in the community. Simply saying the Klu Klux Klan is in Gorman does not mean one exists. It does show a lack of knowledge about Gorman. I do not know anyone who has ever known a KKK member in Gorman. My family has been here for four generations and none of our acquaintances has ever known a KKK member in Gorman. These are wild and unfounded accusations and do not help us look at the facts of the impact of this facility in Gorman, its impact on our schools, our police, and our future economics and safety.

As an educator for 35 years, I know the impact that an influx of troubled adolescents will have on a small school. I wish these adolescents would be the well behaved children which St. Jude's portrays to us. However, well behaved children do not get classified at specified levels by the state. When we look



I cannot even imagine the impact 60 of these additional students. Please be assured that not all money to educate these youth as special education student will be provided by the state. It is asking too much of Gorman to overload its schools with problem children from the large cities of Texas. It is too much for any small town in Texas and the small towns must protest this treatment by the state. Let us all permit our voice to be heard in Gorman, in Eastland, and in Austin to stop this practice of placing an educational and economic burden on our small, rural towns. The problems of troubled youth in Texas must be addressed by the State of Texas; however, sending them to the small communities in Texas is not the solution.

We must all examine the facts in as open, calm, and honest manner as possible. Let us all listen to the small towns which have already experienced problems with these types of facilities. These towns are trying to help us prevent some of the problems they have experienced.

Glickman Announces Additional Payments Under Livestock Assistance Program

Secretary of Agriculture Dan Glickman announced that the U.S. Department of Agriculture is distributing an additional \$70 million to farmers and ranchers under the Livestock Assistance Program (LAP).

LAP payments are made in compensation for 1998 grazing losses because of droughts and other natural disasters. The \$70 million being distributed is in addition to \$200 million already distributed under the program.

"These funds come at a critical time for our livestock producers," said Glickman. "With prices at historic lows, this money may help some farmers

Congress originally made available \$200 million for the LAP under the Fiscal Year 1999 Omnibus Appropriations Bill President Clinton signed October 21, 1998. Those funds were disbursed to more than 167,000 producers in 31 States for 1998 grazing losses. Due to the temendous losses suffered by producers and the number of applications received, the \$200 million only covered 22.1 percent of the total loss an individual producer experienced.

Release of the additional funds from USDA's Farm Service Agency (FSA) county offices began June 28. 
1999 is sure not a repeat of 1998 as cooler temperatures and recent rains





An Open Letter

to Roy A. Jones II, Regional Editor Abilene Reporter News

July 5, 1999 Subj: Response to your article on Saint Judes Ranch for Children

I was surprised by your article on Saint Judes Ranch for Children. You were correct in the reporting of the attack on our Christian Organization by State Rep. Jim Keffer, Democrat from Eastland.

"The PR St. Jude's has done on this thing is just flat miserable," "Coming in here and basically saying to Eastland County and Gorman 'here we are. Take it or leave it' isn't going to win you many friends around here." "They say they wanted to come here so their children 'can learn some small town values'. Well, they better learn some themselves."

"The officials also criticized Brewer for implying Gorman is a rac-

I gave you a "talking paper" on the meeting. In it I stated the threats made to burn us out and to kill us. These included racial components. My statement about "is race an issue" was after these comments. I certainly do not feel that the majority of individuals in Eastland County or Gorman are racist and would not imply this. I only was responding to the threats made to us, and stating fact on the ethnic make up of Gorman.

It surprises me that in 1999 a private not for profit organization cannot purchase property in the United States and build a program that does not rely on State or Federal Monies to help abandoned, abused, and neglected children. You would think we were opening a gambling den or a liquor sales

We are proud of the fact that 92% of the funds we raise privately and from cooperate sponsors goes to the care of the children. We do not, at this time, spend the thousands of dollars necessary to hire a public relations firm. You are perhaps right and we should consider this issue.

When I came to Gorman on the 3rd of April of this year I immediately talked to the Chief of Police and the other members of the Police Force. I immediately attended the City Council meeting and have attended all except the last meeting. I joined the Chamber of Commerce and attended their annual dinner. I have met with the citizens of Gorman on two occasions at City Meetings. I have met with and/or talked to the leaders in the churches in Gorman. I have met with hundreds of Gorman citizens at the site of our program outside of Gorman.



Ranger College Offers Distance Learning

Ranger College will soon be moving into some of the latest communication technology available for educational programs. The Ranger College main campus and the Graham Center have both received video conferencing equipment. The equipment and Internet access have been provided through the TIFB Grant.

With the installation of the video conferencing equipment, the Graham Center and the Ranger College main campus will be able to offer classes through interactive television. Students in Graham will be able to attend classes taught by instructors in Ranger. This will also allow students in Ranger to take courses from instructors in Graham.

The equipment that has been installed is model Venue 50 by PictureTel. This sophisticated interactive equipment includes three television monitors in each classroom--one in Graham, one in Ranger--each run by a computer and connected to the internet by a T1 line. The T1 line will connect Ranger College to the Graham Center. The T1 line allows Graham to be directly connected to the Internet. This internet access will also allow students in Graham to access the library in Ranger.

There is a substantial cost in this process. The initial expense this project has incurred is in the purchase of the direct equipment. The total cost in connecting the Graham center to Ranger College is \$166,963.00. Ranger College is committing to a continuing cost of \$700.00 per month to provide access to Graham. The interactive Internet course equipment was made available through the TIFB Grant.
