




Having farmed, I understand working from a budget, having worked in the construction and custom farm work. I understand the importance of being able to work with all of you, the public.



ity in matters religious. In Jesus' famed Sermon on the Mount, we see that (1) Jesus taught with authority (Matt. 7:28-29). Other individuals when teaching the Old Law would quote other rabbis and scribes and merely repeat what other men had said. But Jesus was different. He never appealed to the teachings that originated with men, but always appealed to God's Word as THE authority. Some 13 times in the Sermon on the Mount Jesus said, "Ye have heard that it was said of them of old time, but I say unto you." Notice the authority that Jesus has been given to take the Old Law to a deeper spiritual level.

standard is the authority of His Son, greater than that of Moses or the prophets (Matt. 17:1-8). Here we see the account when Jesus was transfigured. It is here that the Father tells Jesus's disciples to listen to and obey His Son. Moses represented the authority of the Old Law and Elijah represented the authority of the prophets. The plain implication is that we are no longer to "hear and obey" Moses or the prophets specifically, but we are to hear and obey Jesus the Christ, the only begotten Son of God (Heb. 1:1-2).
