The peanuts, when harvested, will be used for demonstration at the festival on September 11th.

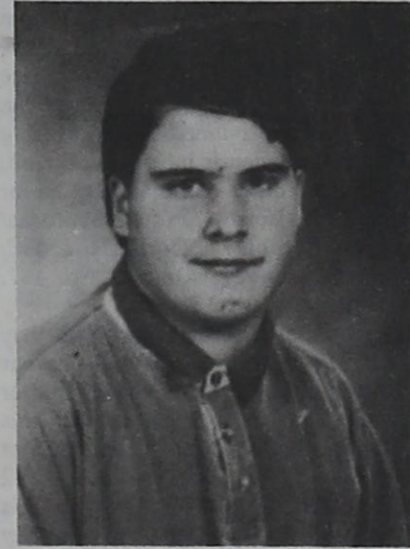
Further plans for the festival are being made. Contacts for various groups have been made.

Nic was one of a select group of 45 high school students who were chosen from a five state region to be a part of the Environmental and Life Science Regional Math-Science Center conference this summer.

Nic went through stiff competition and a rigorous evaluation process to be chosen. The curriculum offered in the summer school session centers around the understanding that math and science are not isolated areas of school work. The Center will provide curriculum for the students which allows them to understand that math science, composition, scientific research, and computer technology are all interrelated.

Nic will be involved in a scientific research project which he will learn to write up using scientific language as is used by scientists. In math class he will observe how math is inter-related with scientific career choices. He will be instructed in computer technology and learn how to use a modem for communicating. Fire Destroys Peanut Warehouse At Comyn



Fire of undetermined origin completely destroyed a cold storage peanut warehouse on Thursday in the Comyn community near De Leon.

The fire, which was reported around 5:15 p. m., completely destroyed a warehouse being leased by Birdsong Peanuts from the Resolution Trust Corp., according to Max Grice, vice president in operations management of Birdsong Peanuts.

There were no injuries reported, and volunteer firefighters from De Leon, Dublin, Gorman and Sipe Springs worked through the night and most of the weekend in keeping the blaze under control.

Because the building collapsed on the peanuts, firefighters couldn't get close enough to attempt to extinguish the fire immediately, Grice stated.

The firefighters were mainly waiting for the fire to burn down and keeping it from spreading, according to one of the firefighters. There is a house in close proximity that the firefighters were trying to keep protected. The building and its

contents were total loss, according to Grice. The fire was reported to have caused several million dollars worth of damage because the warehouse, which was around 45,000 square feet, was full of shelled peanuts, Grice added.

Firefighters have been unable to determine the cause of the fire.

Birdsong Peanuts buys and shells peanuts from producers and then resells them to major manufacturers.

Grice said that the warehouse in Comyn handled up to 1,000 tons of peanuts each year.

On Tuesday Grice stated that the State Fire Marshall would be in the area to help with the preparations for bringing the fire to a completion and releasing the firefighters of the area towns of the duties of keeping the continuing fire under control. It was expected that the fire would be brought to a completion between now and the weekend.

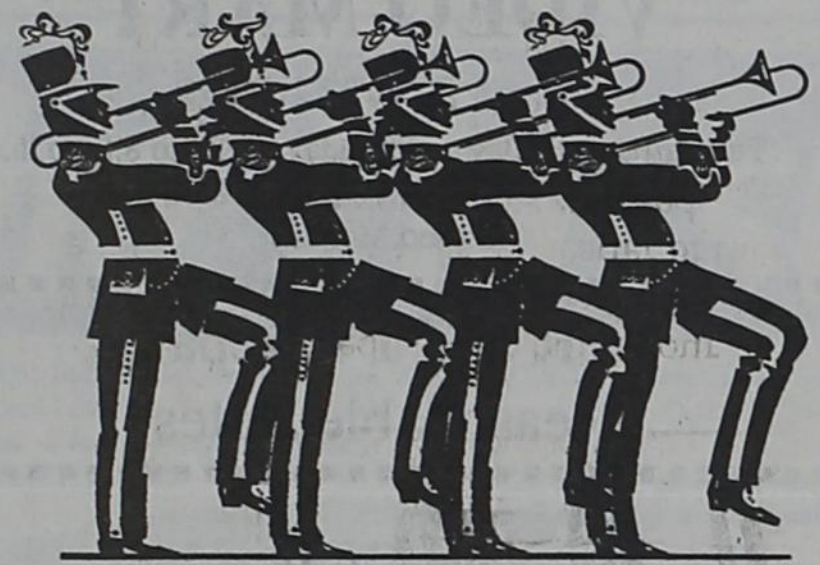
