The Llano Estacado Cotton Conference is set for Jan. 26 in the Bailey

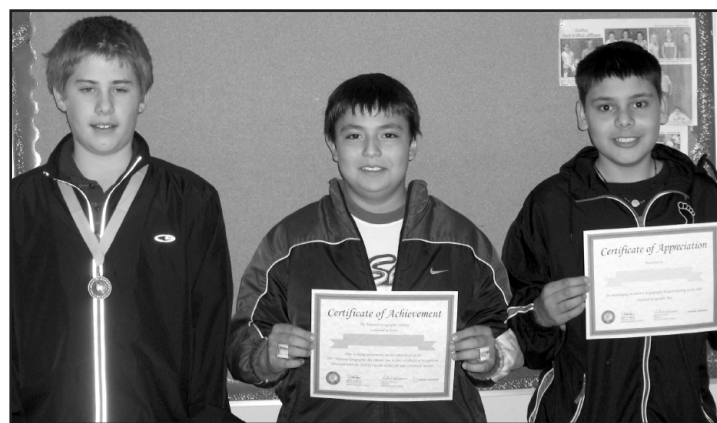
County Coliseum in Muleshoe.

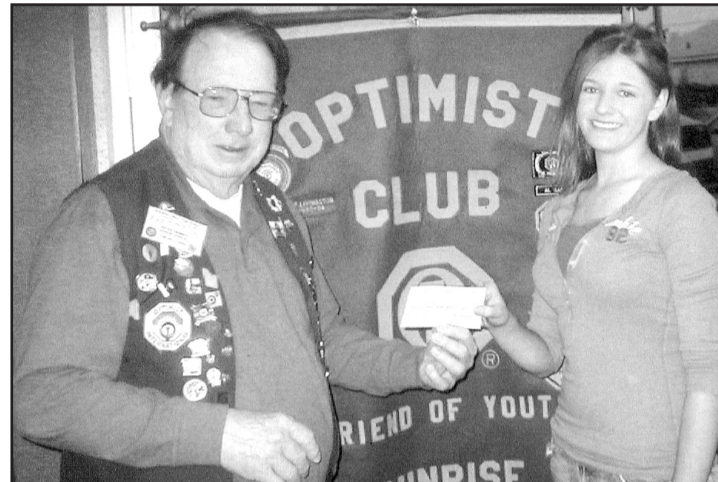

# Texico changes disconnect policy for city water users

The Texico City Council on Tuesday changed the disconnect policy for water in the city.

Until now, if a resident did not pay the water bill, the city would send out a person to deliver a 'disconnect notice' to the house. This is a problem because it involves several people and takes several hours a month to complete. Plus, the city had to wait several days from the date the notice went out before they could legally stop the water.

Starting next month, if a bill isn't paid, than the next bill that goes out will be clearly stamped "Disconnect". If the resident doesn't contact City Hall, the city will then cut the water.

Besides saving Texico several hours of work each month, it will also make it more clear for the residents. There will be no confusion as to when the water will be turned off, it will always be done on the same morning.

In other business, the council:

- Will start looking at grant money from the State Highway Cooperative. With the recent snows, there are likely to be several potholes and the city will try to get grant money to fix them properly.

Councilman Oran Jay Autrey also recommended that they ask for money to seal all of the streets that had been widened recently to keep water from getting in. Councilman Jerry Bradley also brought up South College Street where there is a really bad ditch that needs to be fixed as soon as possible.

- Received a semi-annual report from the Cemetery Board. They are looking at putting up the memorial for unmarked graves in March. They also spoke about a project to put a gazebo out there as well as a possible flagpole, a restroom and a stand to state the by-laws of the cemetery.

Councilman Doug Scioli told Margie Crooks and Marcia Leavell, "We appreciate all the work that you have done. It is outstanding."

- Heard from Fire Chief Lewis Cooper that Yucca Telecom will be starting to wire Texico with under ground fiber optic cable starting this summer.

- Agreed to put a fence with barbed wire around the tall water tank KKR park. This is per a directive from the state environmental department to protect against terrorism.

- Will look at the Police Department door. In freezing weather it seems that the concrete is keeping the door from being opened. Residents can still enter through City Hall.

**LIVE CATTLE:** Cash cattle prices came under pressure for the second week in a row. The most negative aspect of this is cash weakened during a time when the most positive fundamental situation was ignored. Cash beef prices were high, futures prices were high and couple this with a major winter storm and the market looks very weak. Expect to see a major breakdown in prices from early February into the late May/June time frame.

**FEEDER CATTLE:** Although the market has recovered some this week, the long term trends remain down and are expected to continue to move lower into the late May time frame. With higher corn expected to last for several more months, higher cost's of gain will only translate into lower feeder prices. Expect to see the opposite affect in feeders if corn prices move significantly higher.

**CORN:** The market has begun a correction phase after trading the 20 cent limit-up two days in a row after last Friday's USDA dropped production estimates and ending stocks. Short and long term trends remain higher into the April and possibly all the way into Summer. This market remains on a rocket ride and could move higher than anyone would have ever guessed.

**SOYBEANS:** Last weeks USDA report was not as supportive for soybeans, but prices will continue to ride behind corn's coattail's as this market fights to hold acreage. This market also broke out technically to the upside this week and has been able to hold onto gains. Expect to see a continuation of the rally into planting.

**WHEAT:** The market exploded behind higher beans and corn, but at this time, this is about the only reason wheat prices have had any strength. The USDA report was not supportive for higher prices as crop conditions continue to improve and acreage increases worldwide as well. Wheat will continue to ride behind corn, but there will come a day wheat prices will have to stand on their own.

**COTTON:** The market made a fairly good one day rally in attempt to follow the grain complex, but the USDA raised production and ending stocks to levels which may make it difficult if not impossible to continue to move significantly higher behind the grains. It may be a good thing if cotton looses acres this year and possibly deplete some burdensome ending stocks?

## Taking responsibility

Each December, I chat with an old high school chum, John, who has been a longtime music professor at a college in Indiana.

It's always fun to get updated on our families and work. But we also talk about the state of affairs in

our nation and world.

I asked him, since he has been a teacher for nearly 40 years, whether college students had changed at all during that span.

Definitely, John responded. Today's young people tend to not take responsibility for their own actions.

Of course, he was generalizing.

Yes, some youths do take responsibility for what they do. But while that percentage may have been the majority years back, I don't believe it's true today.

Why is that? What has led to this horrifying nega-

tive for our youth? Is there a time we can trace it back to?

Personally, I wonder if it doesn't go back to the emergence of the drug culture in the 1960s and '70s.

I remember being given the assignment as a young reporter in the 1970s to ask youths who their favorite comedian was. Flip Wilson was at the top back then, and he led the pack.

Remember Flip's famous line: "The devil made me do it."

At the time, it was the punch line on a funny joke. Today, a paraphrase of it is used in all seriousness by many youths when something bad happens, such as:

-- The other guy is responsible.

-- My parents are responsible.

-- Society is responsible.

-- Anyone is responsible, as long as it's not me.

Rarely do you hear "I am responsible."

Why is that? Are parents teaching their children that it's the devil's fault when a kid goofs up?

Doesn't it hinder a child from maturing by going that route? Are parents being so overly-protective that they don't understand

that the short-term advantage of saying it's someone else's fault causes their child a real problem in the long run -- that of being unable to accept the slings and misfortunes of life?

Watching the divorce rate skyrocket during my lifetime, and seeing too many kids turn to drugs and alcohol, make me wonder about the possible correlation with youths and adults not accepting responsibility for their own actions.

Often on TV you will see our government run lots of commercials on stuff like obeying seat belt laws, or frying your brain with drugs, or whatever.

Instead, I wish they would go on a major campaign explaining why it's important to accept responsibility for your own actions, and why not doing so will inhibit your chances of becoming an adult.

Just because a person is 50 or 60 years old doesn't make that person an adult. There's a reason for the phrase "good ol' boy."

Sometimes people never grow up. And that percentage is skyrocketing.

Will your child forever be a "good ol' boy or girl"?

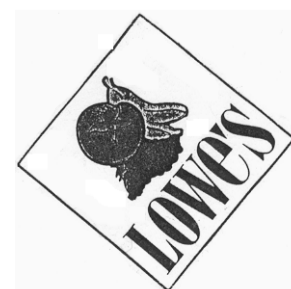
