It just isn't the same any more. Free agency won't kill pro baseball, just like it won't kill pro football. But it will cause quite a hemorrhage.

I predict that the number of fans going to big league games this year will show quite a drop (excluding the normal enthusiasm for the two expansion teams).

As you know, I'm a longtime Chicago Cubs fan.

I used to enjoy rooting for players, watching them grow and mature over the years. I like familiar names. An Ernie Banks. A Ron Santo. A Billy Williams. A Fergy Jenkins. Names to grow up with.

But do you know who the starting pitchers for the Cubs were in their first 3game match with the Atlanta Braves? Morgan, Guzman and

Guzman and Hibbard are new Cubs and Morgan is in his second year.

What are they doing on the Chicago Cubs' roster? And they're not the only new additions. The club's cleanup hitter is named Maldonado. Where did he come from? And the leadoff hitter is Wilson. Who's he?

Sure, some names are familiar: Sandberg and Grace. But this list seems quite short when compared to the comeand-go players.

The Cubs are no longer "the Cubs." They are now a combination of various free agents from both leagues who happened to sign with one club. They're a bunch of strangers - and I would have very little desire, if I lived in the Chicago area, to go see them play.

If any of them have a good year, forget it - they'll hop to another team next year. It almost makes you root for your favorite players to have a bad season.

And what I have to say about the Cubs probably rings true for other teams, too. Forget loyalty and all the other fine aspects that helped make baseball the national pastime - now it's a matter of which club dangles the most dollars in front of you.

I'm afraid that baseball owners aren't much smarter than politicians. They can't see that this free agency will break them in the long run. Baseball already has fallen into 2nd place behind football. It may always be ahead of soccer, but not by much.

The money given players -\$1 million a year for .230 punch - and - judy hitters, for example - is ridiculous. I'm not about to pay as much as \$14 a seat (in Toronto) to see a bunch of strangers pretend they're "my" team. Especially when I know the money I would pay goes toward those exorbitant salaries.

Just by going to a baseball game is like saying "we need to pay these bozos more millions."

If I knew that the players who joined the Cubs would stay as Cubs, I could get somewhat excited. But the fact is they joined the club for a limited engagement and will leave asap. Now, how can you "root" for them?

With free agency as it now stands, baseball has become a revolving door for players. The team no longer means anything. Each player under-

stands that the only thing that counts is his own statistics - helping him get more dollars from another ball club

the following season. The team concept is dead.

Too bad.

Texico employs Vargas, Sain

The Texico School Board voted to re-hire almost all of its current staff members Tuesday.

Contracts will not be offered to staff working in federal programs until after the parent advisory meetings which will be held later this spring.

The Board accepted the resignations of Kate Griffin, Chapter I aide, and Jo Ann Edwards, special education teacher and Elementary School diagnostician. Mrs. Edwards will retain her position as school diagnostician, but she will resign her teaching position.

The board hired new staff members Pat Vargas and

Margaret Sain as Chapter I instructors.

The administration projected that it will need one high school teacher, one junior high school teacher, a 5th grade teacher and one special education teacher next year. They may also need a half time kindergarten aide because so many students enrolled at the Texico Kindergarten registration and Health Fair.

"The kids really turned out for that Health Fair," said Supt. R.L. Richards.

The board also:

- Awarded electrical supplies bids to Beacon Electric.

- Awarded the school bus contractsto Bill Queener.

Two classes?

It was reported at Texico's School Board meeting that the New Mexico Activities Association has recommended that Texico remain in Class A for football but move to Class AA for all other activities.

- Awarded the bid for constructing parking lots to Eastwood Construction. They will be built between the junior high and the cafeteria, and south of the gym.

- Discussed the need to keep an operational cash balance of at least 10 percent of the budget in reserve each year.

- Reviewed federal programs and their costs. Currently the school system has Chapter I, Chapter II, Drug Free Schools and Community and IDEA programs in the Texico Schools.

- Voted to allocate \$500 from the school board, \$100 from the junior high, and \$100 from the high school budgets to help the Odyssey of the Mind team which will compete in the national Odyssey of the Mind Competition. The team will need about \$5,000 total to go to the competition.

Anyone else interested in donating to this group should contact Joel Pate at Texico Elementary School.

- Voted to spend \$75 to help Dara Jenkins attend a premed workshop in Boston. She is one of only 350 students in the nation to be honored with an invitation.

- Heard Brandon Schauf present the itinerary for the Senior Class trip to Amarillo on May 4.

- Tabled a request from Coach Michael Littleighn for financial assistance to attend a conference in Florida. Littlejohn has been named Regional Volleyball Coach of the Year for an 8-state area.

- Reviewed the state Quality of Education Survey. The Texico school board will add some questions of their own and ask parents to respond to them.

Groundwater levels decrease

Parmer County's groundwater levels decreased an average of 1.47 feet in 1992, according to measurements taken at 97 wells by the High Plains Underground Water Conservation District No. 1:

This decline represents a decrease of 127,437 acre-feet of water from storage in the Ogallala Aquifer last year in Parmer County.

Groundwater levels within the Water District's Parmer County service area declined 1.26 feet during the 10-year period from 1983-1993. A decline of 1.71 feet was recorded during the 5-year period from 1988 to 1993.

Groundwater levels in the Ogallala Aguifer within the 6.4 million acre Water District service area had an average rise of 0.14 of a foot from January 1992 to January 1993. This is a net increase of about 135,103 acre- feet of ground water in storage in the Ogallala Aquifer within the Water District service area.

A zero - average annual change in the ground water levels was recorded for the first time in the Water District's history in 1985. Depth - to - water measurements revealed an average ground water level rise of 0.50 of a foot in 1986; an average rise of 0.90 of a foot in 1987; an average decline of 0.51 of a foot in 1988; an average decline of one foot in 1989; an average decline of 1.06 feet in 1990 and an average decline of 0.73 of a foot in 1991.

Construction manager hired

The Farwell School Board held a special meeting Tuesday and hired John Cole, of Lubbock, to be the construction manager on the building project.

Last year, Farwell School District patrons approved a \$1.5 million bond issue. With other available funds, Farwell officials felt they could afford up a \$1.9 million building project - new classrooms at all three campuses plus a new gym.

But when bids were opened from general contractors, the lowest bid was at \$2,193,000. If that bid were accepted, cutbacks would have to be made in what was planned.

School Supt. Richard Boothby said that it's believed that Cole can line up the subcontractors to get the project built without any cutbacks and with the money the school system has to spend.

"The package Cole put together is within the ballpark," said Boothby.

Because Cole needs to check on a couple of subcontractor bids, and for legal purposes, the school system is again running its "notice to

bid" legal ads the next two weeks in the Tribune. Under construction management, Cole is hired by the school system to arrange

for subcontractors to do the work. No general contractor is involved.

Boothby also reported that he's fairly certain that state funds will be available to build two new tennis courts. Application will be made in July.

The old courts were demolished last month to make way for the new gym.

Because the school board held the special meeting Tuesday, it changed the date for its regular monthly meeting to April 15 at 7 p.m. at the administration office.

- Heard Meeks ask if the water department could sell some excessive equipment, and buy some other materials it needs. The council asked for a list of what he proposed selling.

 Heard Tharp report that he has been to two highway meetings. He said improving the highway intersection by the Crossroads Motel "is still in the works" but nothing definitive is planned. State officials are talking about 4-laning the stretch to the state line but realignment is out. Also, a traffic light is being discussed there.

be \$15,296 or a negative 6.11% change in revenues. The Utility also intends to change its service rules and regulations, including rules relating to obtaining service, line extension and line extension charges, the provision of electric service, service fees, and



More than 400 young people signed up for the annual contest, which featured judging in three species - cattle, swine and sheep.




