## In days of yore

From spouse Judy: The girls in sorority had talked so much about Kevin Costner's rear view in the movie "Robin Hood," that I dragged my poor husband out to the movies recently to see for myself. I have to admit that we enjoyed the movie, with or without Kevin Costner's rear view.

This wasn't a perfect movie. There were a few minor details that rubbed me the wrong way - accents that slipped into American English and a statue or two that didn't quite fit the era that the story was set in. But on the whole, I really enjoyed the action and the optimistic tone of the movie.

It gave a little different view of Robin Hood than we usually see on the movie screen. Why not? Robin Hood probably was an imaginary character.

On the other hand, there really was a Richard the Lion Hearted who was king of England from 1189-99. Richard got to be a pretty good soldier because of the family battles. Actually, all the wars in those days seemed to be family battles because most of the royalty was related one way or another.

Shortly after Richard became king of England he set off on the Third Crusade to "save the holy land from the infidels," or liberate the source of spices, jewels, and fabric, I'm not sure which.

On his way to war Richard married the princess of Navarre - a kingdom that included parts of modern Spain and France. That act may have made some of his English subjects a little upset. Some of them were probably hoping that he would form an alliance with their households through marriage.

During the crusade, Richard won some battles, and lost some. At the end, Jerusalem remained in the hands of Saladin, the sultan of Egypt and Syria.

The costs of the war were great. Taxes went up in merry old England to pay them. This was the period of time when legend says that Robin Hood robbed the tax collector to help the poor.

In the historical accounts, Richard was captured on his way home to England by an Austrian duke, who turned him over to the Emperor of the Holy Roman Empire (which historians are quick to note wasn't holy, wasn't Roman, and wasn't an Empire). English taxpayers were supposed to pay extra taxes to exact Richard's ransom. History books say that a heavy ransom was paid so that Richard the Lionhearted could be released.

Some historical accounts say that Richard returned to England where he made peace with his brother John.

The movie didn't actually mention John at all. He was the king who mortgaged his land and borrowed money to pay the debts incurred by the wars that his father and brother had waged, and the ransom of his brother.

By 1215 John's kingdom was on the brink of ruin. And he was forced by his barons to sign the Magna Carta - the first English constitution. It gave the English barons some important freedoms, and by 1776 those freedoms had trickled down to regular folks

## 12% turn out for election

With all 254 Texas counties reporting, the proposed constitutional amendment that would clear the way for property tax exemptions for county educational taxing districts passed by a slim margin statewide - while the proposal to authorize bonds for college loans failed.

On Proposition 1 to allow homestead exemptions and personal property taxation in Texas' new county education taxing districts, the vote was 467,115 or 57.4 percent in favor, and 346,826 or 42.6 percent against.

On Proposition 2, 410,117 voters, or 50.42 percent voted against the measure, and 403,352, or 49.58 percent voted in favor of the proposition which would have authorized \$300 million worth of loans for Texas college students attending state colleges and universities.

Parmer County followed the same trend as the rest of the state: narrowly passing Proposition 1 and narrowly defeating Proposition 2.

"As usual on an amendment election, the turnout was bad," said Parmer County Clerk Bonnie Warren. She noted that there is not normally a good turnout for elections to amend the Texas State Constitution. On this election only about 12% of the Parmer voters turned out.

"In some counties I've talked to they had only 9% turn out," said Mrs. Warren.

Not only was the election turn out low, some voters did not seem confident about the issues in this election. "It's one of the most confusing issues we've come across," she noted.

### Proposition 1 - Exemptions to Taxes

In Parmer County, the residents narrowly favored Proposition 1, 215-210. In Farwell they voted 37 for and 36 against. In Lazbuddie, 20 voted for it and 12 against. In Oklahoma Lane, 4 voted for it, and 12 voted against.

### Proposition 2 - Bonds for College Loans

Countywide, Proposition 2 was defeated 256-170. In Farwell, 31 voters voted for it and 42 voted against it. In Lazbuddie, 13 voted for the bonds, and 19 voted against. In Oklahoma Lane, 4 voted in favor, and 12 voted against it.

### County Education District Special Ballot

The special ballot for the Parmer County Education District had just about the same number of respondents as the state wide election - a very small percentage of the possible voters. The first two propositions, exemptions of property from the tax rolls, passed in Parmer County. The third proposition, which would allow for the taxation of personal property other than manufactured homes, failed.

### Proposition 1 - 20 % Property Tax Exemption

In Parmer County, 245 voters favored Proposition 1, which would exclude up to 20% of the market value of a residence homestead, and 179 were against it. In Farwell 42 favored it, and 27 opposed. In Lazbuddie 24 favored it, and 9 opposed.

### Proposition 2 - Tax Exemption for Disabled or Elderly

In Parmer County, 239 voters favored Proposition 2 which would exempt up to \$10,000 of the market value of a home of an elderly person or a handicapped person, and 163 voters opposed it. In Farwell, 44 favored Proposition 2, and 25 opposed. In Lazbuddie, 26 favored it, and 7 opposed it.

### Proposition 3 - Taxation of Personal Property

In Parmer County 232 voters opposed Proposition 3 which would tax personal property other than manufactured homes, and 167 favored it. In Farwell, voters opposed this measure 46-22. In Lazbuddie, voters opposed Proposition 3 19-13.

The surgery seemed to go just the way it should, but he needed two additional surgeries to relieve pressure due to swelling.

He is listed in stable condition.

"We're hanging in there," commented his mother, Leandra Byrd. "I can feel the prayers from the people back home."

After the last surgery Tuesday, Tanya Chadwick said the boy looked much better.

## Water mains topic

Water mains were a major topic at Tuesday's Farwell City Council meeting.

Water Supt. Dee Hammit reported that the No. 3 well, on the loop, is on its last legs.

The council authorized him to pick a company to pull the pump from the well and sell it. And bids will be sought for a new pump there later this year.

Also, the council discussed the low water pressure that several 1st Street residents have. The city is seeking state funds to help fund a larger water main but it appears unlikely those funds will be available to Farwell since not enough residents qualify as "low to moderate income."

Instead, Hammit was told to talk with Harry Sheets, of Sheets and Sheets, and also to the property owners involved to see what kind of project would be feasible and to ascertain the cost.

The council received a request for a variance to place a mobile home behind 500 1st St. by Judy Skinner. She already takes care of an elderly resident there and wants to move her mother from Clovis; her mother also needs care.

The council agreed to have a variance hearing on the request if she still wants it after Hammit informs her of the low water pressure problem in that area.

In other business, the council:

- Noted that city clerk Cynthia Thigpen now handles the scheduling of events at the Farwell Community Center.

- Noted that the sesquicentennial mural has been taken off the wall at City Hall and delivered to artist Cherokee for repainting.

- Approved four building permits: a fence at 103 Manana for Richard Mullen; a garage at 500 4th for Joe Walker; a garage at 900 7th for Fred Chandler; and a home addition at 905 2nd for Lena Ashton.

- Received an update on the citywide survey for a community development grant from mayor Wendol Christian. "We don't qualify," he summed up.

- Noted that Hammit's assistant, Royce Menning, has gone to San Antonio for a year's training to be a nurse in the Army Reserve. He will be replaced during that time by Michael Robinson, who has been working in the street department.

- Received a request from Bill Pennington, who wishes to sell his property. But the fence around it is on city property. Pennington said he received a verbal okay from the city council years ago to

**Farwell School budget presented**

The Farwell School Board Tuesday was presented a projected revenue budget of \$2,413,329 and a projected expenditure budget of \$2,381,886.42 for the 1991-92 school year. But they did not set a tax rate at the budget hearing.  
 The board decided not to act until the County Education District acts on its portion of the school budget.  
 In other business, the board:  
 - Accepted the resignations of cafeteria workers Bea Howard and Patsy Lonsdale.  
 - Hired three staffers: Larry Smith was hired as the Farwell High School chemistry and physics teacher. Monty Sartain was hired as the junior high science teacher and coach, and Nancy Miller was hired as an aide in music and drama.  
 - Accepted the bid of Robotech for \$13,108 to purchase new I.B.M. computers for the high school. The school system will also purchase Apple McIntosh computers for the junior high school through a statewide bidding system.  
 - Accepted the bid of Bell Milk for the school milk contract.  
 - Voted to pay for the new fencing and gates out of the capital projects fund. The bid for the fencing was \$6,560.40.  
 - Canvassed the results of last Saturday's election. In Farwell's school district, the results included: Proposition 1, 42 for and 27 against; Proposition 2, 44 for and 25 against; Proposition 3, 22 for and 46 against.

- Discussed the parking plan near the elementary school.  
 - Heard Gwen Corn report that the student handbooks had been sent to a firm in Amarillo for printing. She hopes that they will be ready for the students by the time school starts.  
 - Maintenance Supt. Joe Stanton showed the board members one of the two new 53 passenger school buses that had arrived. He also reported on the installation of fencing around the building; the high school air conditioner's air compressor; computer labs have been constructed and air conditioning was added to the elementary school.  
 - High School Principal David Reynolds said he expects more students this year than last year.  
 - Jerry Dee Owen talked to the board about the progress of the work done in the computer labs. He also discussed the fact that Farwell Junior High will have a new pre-algebra class in the fall and that Nancy Miller will help with a drama class.  
 - Mrs. Corn talked about some of the meetings that teachers have attended this summer to prepare for the school year. She talked about the 18 students in the new Head Start program; the progress of the work on the computer lab in the elementary building; and her concern about the possibility of a very high fourth grade enrollment.

 The group plans to hold 4 hearings on Aug. 28 to review the plans for redistricting with the voters. They will meet at the Lazbuddie School Auditorium at 9 a.m., at the County Courtroom in Farwell at 11 a.m., at the EMS ambulance center in Bovina at 2 p.m., and at the Friona Community Center at 5 p.m.  
 The plans call for little or no change in the voting districts for Lazbuddie and Farwell. There are some minor changes proposed to make voting more convenient for voters in Bovina and Friona.  
 No final decisions were made at this meeting. The input of the voters will be sought before county commissioners submit their final proposal to the state. Once a proposal has been accepted, the voting districts will probably remain the same until after the next census in 10 years.

# Texico School Board plans more classrooms

The Texico School Board Tuesday took steps to expand its school facility to meet state mandates.

The board is looking at adding 3 or 4 classrooms to the junior high school.

The firm of Simmons, Cuddy and Friedman was named bond counsel, since a bond issue will be sought to pay for the construction.

The board received building plans from five architects. A board committee will be appointed to review them and pick one.

The board also established its goals for 1991-92:

1. To emphasize and determine the student needs for the building program of Texico Schools.
2. To continue long range plans for Texico Schools that is congruent with student numbers and student needs.
3. To review all board policies.
4. To develop a tobacco free campus and evaluate the success of the policy at the end of the 1991-92 school year.
5. To determine the growth of the Texico Schools to and from bus routes for future route decisions and road improvements.
6. To evaluate the emergency leave pool at the end of the 1992 school year.

These are the superintendent's goals for 1991-92:

1. To keep the cash balance for Texico Schools \$ 180,000 to \$210,000.
2. To develop a kindergarten through 12th English/writing program.
3. To promote, review and facilitate a Texico Schools' building program such that it is in the best interest of the Texico School District and Texico School students.
4. To determine the legal process of governmental gross receipts tax.
5. To sequence the high school math program in such that it is parallel with the development of student learning.
6. To establish consistent procedures on activity accounting, and structure the decision making processes of Texico Schools.
7. To coordinate the accountability study with the parental needs assessment and program needs assessment program of the school.
8. To have the computer committee review, analyze and give recommendations on the instructional computer program and a new computer system for fiscal accounting.
9. To review and control the fiscal inventory process.
10. To fully comply with concerns and citations listed in the 1990-91 SDE monitoring report during the 1991-92 school year.

Also, in September, the school board will put out a survey to the community to get parents' input. The survey will include 5 questions from teachers, 5 from the school board and 10 from the state. In each case, residents will mark one of the following: strongly agree, agree, disagree, strongly disagree, don't know.

The school board's questions will be:

1. Parents, teachers and students would rise to the defense of this school's program if it were challenged.
2. Students would rather attend this school than transfer to another.
3. Many opportunities are provided for learning in individual and small group settings, as well as in classroom sized groups.
4. Most students get positive feedback from faculty and staff.
5. Students and staff are proud of their school plant and help to keep it attractive.

The state's questions will be:

1. My child communicates effectively in the areas of reading, writing, speaking and listening.
2. My child is acquiring the skills to do math confidently and accurately.

3. My child is acquiring the knowledge and skills to participate in the social, political and economic life of our nation and the world.

4. My child is gaining knowledge of various cultures and languages.

5. My child is demonstrating the ability to think critically and solve problems.

6. My child demonstrates the interest and knowledge necessary to continue the learning process throughout his/her life.

7. New Mexico school personnel are well trained to educate my child.

8. Public education in New Mexico approved over the last five years.

9. My child should be given more homework.

10. My child has a sufficient choice of school sponsored extra-curricular activities.

The 5 questions from the teachers are yet to be picked.

In other business, the board:  
- Heard Supt. J.L. Richards report that, depending on how many students show up when school starts, three classes of 1st grade may be needed.

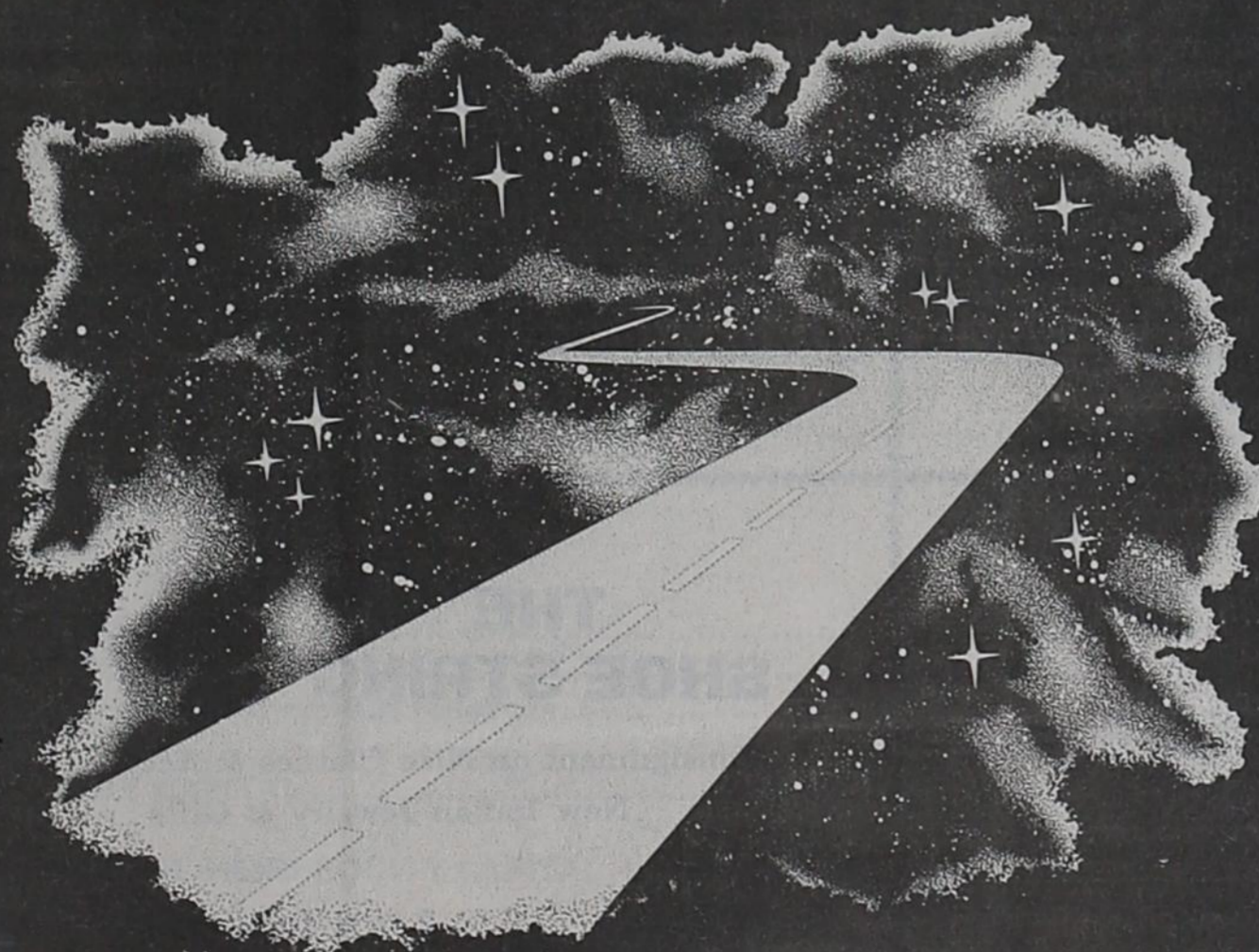

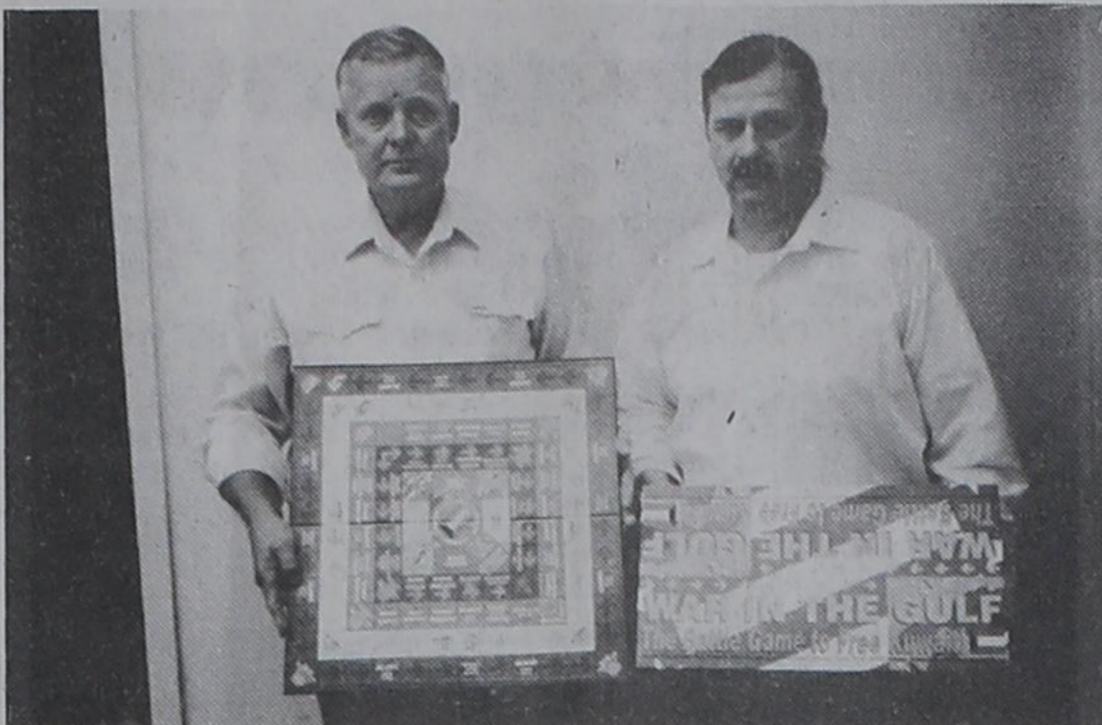
