

## THE football contest is only two weeks away!

## Border Banter

### We must be concerned

The most important article in last week's Tribune dealt with the regional task force to view the problem of depletion of the Ogallala aquifer, which feeds states ranging from Kansas to Wyoming to Texas and New Mexico.

The importance of water, to everyone, goes without saying.

We are not about to run out of water tomorrow. And if we practice good conservation methods, we will always have a decent water supply.

But if we just stick our heads in the sand and hope that the problem goes away ... well, we all know that story.

The point is, we need to be concerned about the Ogallala now. For example, stories in the Tribune the past few weeks noted that Lazbuddie Schools and the cities of Farwell and Texico are all discussing building more wells.

What I believe to be the necessary solution to this problem is the federalization of water in the U.S.

I realize that "state's rights" are important to many of us, but water is rapidly falling into areas like Social Security and Medicare.

The time when New Mexico and Texas, for example, could fight over various water usage has to belong to the past.

We already have seen how the trash problem has been federalized -- EPA rules supercede state's rules.

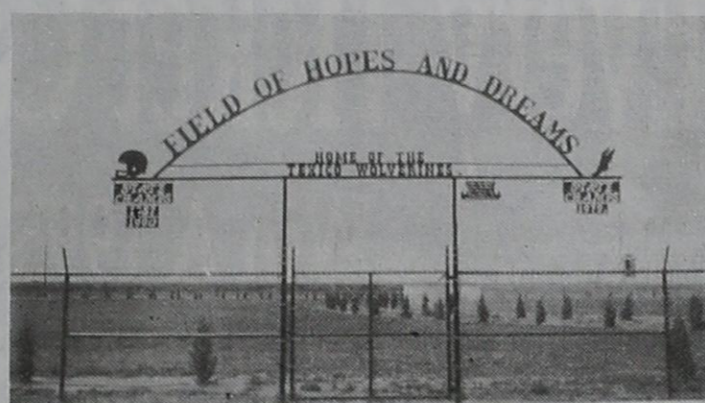
Another reason why federal intervention is needed is that, all too often, local governments cannot work together on a large-scale problem. Note the recent mess in eastern New Mexico over the handling of a sanitation landfill and on using Ute Lake water.

## Three ag offices to be located in one building

*Editor's note: Rumors are always prevalent, especially so in a rural community. In an effort to put to rest some rumors involving an upcoming decision that affects three government agricultural offices in Parmer County, the Tribune presents this account.*

There are three government ag offices in Parmer County which are due to be placed in one building. The question is where -- Farwell, Bovina or Friona?

In one building in Farwell are the Farmers Home Administration (FmHA) and Agriculture Stabilization & Conservation Service (ASCS) offices, with a total of 13 employees. In Friona is the Soil Conservation Service (SCS), with 3 employees.

On Oct. 1, the FmHA will be dissolved, merging with the ASCS to become the Consolidated Farm Service Agency (CFSA). And the CFSA and SCS offices have been given by the state a target date of Sept. 30, 1997, to find one building to be in.

Officials in Friona and Farwell both want that building to be in their communities because of the number of jobs they represent (16). And Bovina folks also have become involved, noting their central location. Here's how a site will be picked:

The first decision is up to the Parmer County Food & Agriculture Committee (FAC). But -- and this is important -- it appears that any county decision MUST be approved by the state FAC.

Currently on the county FAC are Tom Taylor, FmHA head; Tom Reed, SCS head; and chairman Curt Miller, ASCS head.

A question has arisen as to whether Gary Patterson, Parmer County extension service agent, is on the FAC. He has been part of the meetings but Miller says he is unable to find infor-

## City structures to be addressed

Farwell Fire Marshal Lee Hutchins presented a list to the City Council Tuesday of structures that may be substandard and dilapidated.

The mayor and council will inspect the structures next week. If they decide to do so, they can order citations to be given the property owners, who could have to appear before the city judge.

Several months ago, the city council passed a structure condemnation ordinance. The council is about to take the first step on it.

Hutchins and the council discussed how to remove the building materials after structures are torn down.

On Hutchins' list were:

In other business, the council:

-- Rejected a variance request by Linda Padilla to put a mobile home at 306 Seventh St. After neighbors objected.

-- Tabled a request for Dickie Sosa to move a house from Friona to 207 First St. The house needs work and the council wants guarantees that the needed work -- roof, walls, windows -- can be

## Revised request for county annex in Friona presented

Officials of the Friona Chamber of Commerce brought in a revised request for a county annex in their community before the Parmer County Commissioners on Monday.

Speaking were Bill McCoy, chamber president, and Teresa Buske, chamber executive secretary. Also present were B.K. Buske, Ricky Barnett and Becky Riethmayer.

The commissioners took no action on the request, pending full discussions on next year's budget. A workshop on that budget was held later on Monday (see story elsewhere in today's Tribune).

The Friona request, first made last year, then again last month, hasn't been met with a positive response from the commissioners due to the county's financial situation.

In a nutshell, here's the situation:

-- The cost of adding an annex, which basically would allow Friona area residents to register their vehicles there (several other county services already area provided in Friona) is estimated to cost an additional \$18,000 a year.

This is the cost of adding a full-time employee to the county tax assessor's office who would be stationed in Friona. County Tax Assessor Doris Herington said a full-time employee would have to be added.

Friona chamber officials, though, believe that one of the two full-time employees now in the courthouse in Farwell could be transferred to Friona, thus voiding the cost. If that were true, then the increase in costs would be negligible to the county.

-- As the Tribune began pointing out in articles starting last year, the county's receipts have been less than expenditures the past few years by large amounts. It appears that the commissioners have gotten to the point where they will be making cutbacks in order to stop these shortfalls.

For example, county treasurer Anne Norton said the shortfall in 1994 is about \$104,000 -- "and we didn't spend all we budgeted." She anticipated a projected shortfall for 1995 of about \$177,000.

The county commissioners have been drawing on their reserves to handle these shortfalls the past few years. The

He wanted to show the Burford's his daughter and to let them know that without the gift of Adam's heart, his father would have never seen his new grandchild. ## Sugar program supported

Area beet growers and processors are counting on U.S. Reps. Mac Thornberry and Larry Combest to encourage their colleagues to vote in favor of a good U.S. sugar program, says Bill Cleavinger, TSBGA president.

"We ask everyone to contact Larry, a senior member of the House Ag Committee, or Mac, who represents many regional farmers," he says. "Their help and work in maintaining the program is crucial. They were elected to represent the best interests of their districts. These districts and the

entire state depend heavily on the sweetener industry."

Sen. Phil Gramm and Kay Bailey Hutchison are members of the Senate Sweetener Caucus, and support a sound sugar program. "We remind the senators and congressmen that the sweetener industry creates 13,000 Texas jobs," says Cleavinger. "Beet farmers spend \$28.4 million in producing Texas beets, beet and can companies annually purchase \$173 million in goods and services from Texas businesses, and over \$45 million is added to the Texas corn crop value from corn purchases by corn sweetener refineries."

The proverbial "he could do it all" applied to the fleet slugger from Oklahoma.

He had the power to smash 400-ft. home runs, the speed to beat out bunts, the defensive ability to make sparkling catches in spacious center field, the confidence to bunt with two strikes, and the instinct only a truly-great player has.

Mantle never coached or managed after his career. He couldn't teach instinct. But he sure had it.

He was simply beautiful to watch in the early 1950s, especially before he hurt his leg in the center field drainpipe. A triple crown winner. A leader of those great New York teams, filled with names like Berra, Bauer, Martin, McDougald, Raschi, Lopat, Byrne, Ford, Rizzuto, Howard, and, of course, Casey Stengel.

I was sorry to read in the past few months of his drug addictions. But I will always remember the pure talent he exuded on the field of play.

In his time, New York kids would argue as to who was the best center fielder in the world -- Willie Mays of the Giants, Duke Snider of the Dodgers or Mantle of the Yankees.

All three were superb, and I would side with Mays as being the best.

But No. 7 of the Yankees was really special.

county's reserves are now under \$1 million. Regardless of whether an annex is approved, the commissioners could raise taxes by 3 percent, the number they have been using the past several years.

Thus, the problem: the commissioners are asked to expand a program while cutting back in other areas.

At the beginning of the meeting, the Friona chamber officials presented an estimated budget for an annex -- 3 offices at the Cattle Finance Building, 601 E. 11th St. The expenses involved the rent, \$7,200; a salary, \$17,500; and initial office supply set-up, \$2,000; for a total of \$26,707.

They said this would offset current expenses that the county pays for office space in Friona: \$2,260 paid to the

credit union for rent; \$2,400 for rent for the DPS and judge; \$764 for utilities; \$1,000 for supplies and telephone; and \$17,500 to transfer an employee from the courthouse to the annex. Total cost: \$25,932.

But the sticking point was the full-time employee. Mrs. Herington stressed that she needed two full-time employees in the courthouse, and couldn't transfer one. She noted that although a goodly part of the county's business is with Friona area folks, all the record keeping must be done on the computers in the courthouse. County Judge Bonnie Clayton said that it was the general consensus that, if an annex were okayed, an extra employee would have to be hired to better service the people.

When the Friona chamber officials appeared, they presented the estimated budget as shown a few paragraphs above. It also contained an important correction from statistics given the commissioners last month.

At their July discussion, the Friona presentation indicated that about 71 percent of the registration fees collected in Parmer County came from the Friona area. This has been corrected to about 26 percent.

Here's the complete clarification: "Friona Motors had submitted a figure of \$310,275 that had been collected by the tax office last year. Sales tax had not been deducted from this figure. The corrected figure stands at \$29,610. This amount was collected in title transfer and registration fees

from Friona Motors. This combined with the amount of \$125,988 collected through the Credit Union represents approximately 26% of the total registration fees collected in Parmer County. Accurate numbers could not be obtained through the tax office of the total registered in Friona and eastern Parmer County."

It also was pointed out by Friona representatives that the county would get an extra \$3,000 a year through vehicle registrations from Friona Motors if an annex was set up.

Mrs. Buske summed up her chamber's position by saying that they have identified a need and a way to service that need should be found.

Judge Clayton asked the Friona folks if Friona groups, such as the city or chamber, could help finance an annex. The response was negative due to funding problems.

Unfortunately, each commissioner has Farm to Market Road funds available for use in their individual precincts. But such funds can only be used on the repair, maintenance and upkeep of county roadways -- not for an annex. And the general fund, where the money would have to come from, has the shortfalls.

The county's tax rate for 1995 is .3246 cents -- .2488 cents for the general fund and .0758 cents for FM Road account. The FM Road account is divided up among the commissioners according to the percent of road miles in each precinct: Pct. 1, 23.85%; Pct. 2, 22.03%; Pct. 3, 30.08%; Pct. 4, 24.04%.

## Recipe of Week

### Herb Crusted Fish Fingers

1 pound firm fish fillets about 3/4 inch thick  
 3 tablespoons soy sauce, divided  
 2 tablespoons vegetable oil  
 1 egg, beaten  
 3/4 cup yellow cornmeal  
 1 teaspoon thyme, crumbled  
 1 teaspoon basil, crumbled  
 1 teaspoon onion powder  
 1/2 teaspoon coarse-ground black pepper  
 all purpose flour  
 lemon-garlic aioli (blend 1/2 cup mayo, 3/4 teaspoon grated fresh lemon peel; 1 tbsp. lemon juice and 1 small clove garlic: pressed. Cover and refrigerate until ready to use.

Cut fish into 3 x 3/4 inch strips. Coat with 1 tablespoon light soy sauce. Let stand 10 minutes. Meanwhile, oil bottom of 13x9 inch baking pan. Blend egg with remaining soy sauce in pie pan and mix cornmeal, thyme, basil, onion powder and pepper in shallow dish. Coat fish with flour, then dip into egg mixture and finally coat with cornmeal mixture; place in single layer in oiled pan. Bake in 425 degree oven 8 minutes. Meanwhile, prepare aioli. Turn fish over; bake 5 to 6 minutes longer, or until fish flakes easily with fork. Serve with aioli. Makes 4 servings.

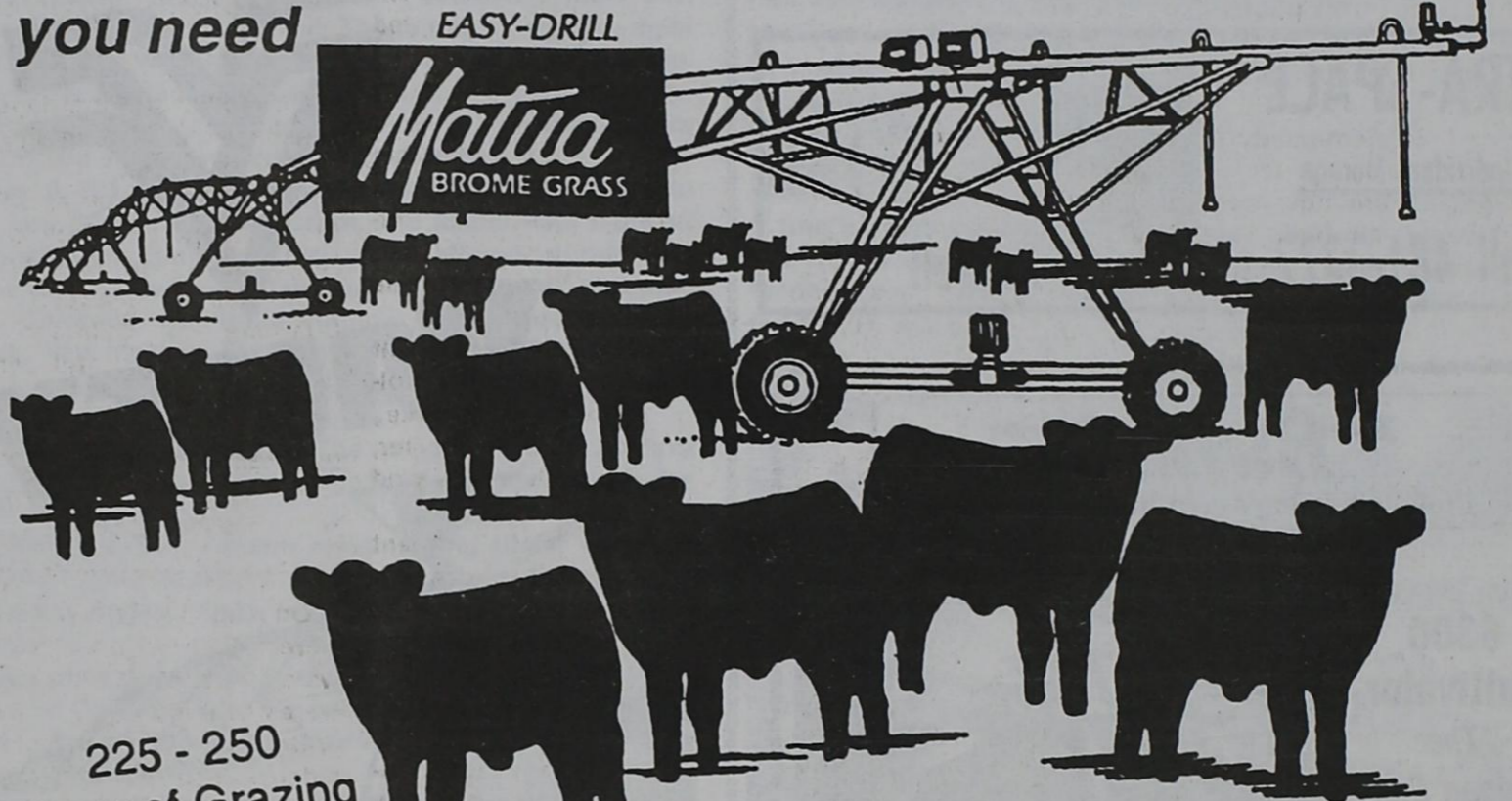

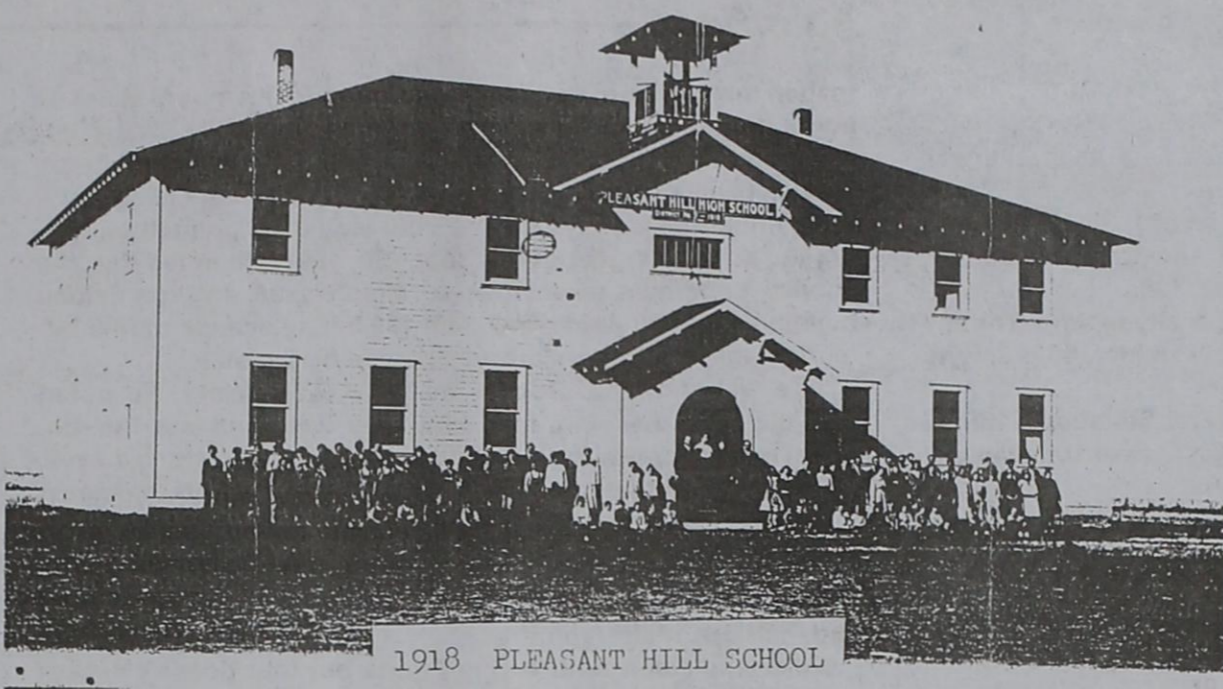

 -- Will look into raising the city's water rates. Mayor Jimmie Mace showed statistics noting that Farwell's water rates are very inexpensive.  
 -- Will look at various sites around town for a new water well. It had been planned to put a well at the southwest corner of the city but due to other wells in the area and a low water table there, this won't be done.  
 -- A question arose over whether Farwell's part-time police officer, who is unpaid for that work, can issue traffic tickets.

The council was told that he can.  
 -- Denied a request by Farwell Police Chief Roy McGaa to attend a medical legal death investigation seminar in Lubbock.  
 -- Received a letter from the owners of the building housing the FmHA and ASCS offices in Farwell, noting the question of where these offices will be in the future (see story on Page 1).  
 Charlene Halley asked the council to help keep the offices in her building.

mation authorizing Patterson as a voting member. Miller is continuing to check on it.  
 If a county FAC vote were taken today (with 4 members), Farwell likely would win on a 3-1 vote. But that isn't likely.  
 Chairman Miller says such a vote would be premature, noting the state's target date of Sept. 30, 1997. He notes that the Farwell building's lease runs to March 1996 and the Friona building's lease runs to Sept. 30, 1997. It's because of this later date that the target date was named by the state.  
 "We will start the process in 1996," said Miller. He noted that the state has informed him they will send out instructional letters for leasing procedures -- but haven't done so yet. This means that the status of the county FAC changes. FmHA merges with ASCS on Oct. 1, 1995. That removes Taylor from the FAC.  
 Thus, the county FAC in 1996 will consist of Miller and Reed and, perhaps, Patterson.  
 Miller and Reed both live in Friona but that doesn't necessarily indicate how they will vote. Miller said he will follow the wishes of his county committee, which is believed favorable to staying in Farwell.  
 But the key to where the ag offices end up lies with the building that is offered. There is a question of space in the Farwell building if the SCS' 3 employees were to be moved from Friona. However, the Farwell building can be enlarged.  
 What is likely is that bids will be asked. This is according to state FAC guidelines given Miller. The county FAC is authorized to delineate the boundaries in which offers for space will be considered. For example, Farwell can make a bid for a building at a certain location; the same is true for Friona and Bovina.

The CFSA (merged ASCS and FmHA) has been authorized to take the lead in leasing office space by the state FAC. The county FAC is authorized to make all decisions but if a dispute occurs, then the final decision is up to the state FAC. Forty-nine Texas counties will have agencies having to move.  
 The state FAC is composed of Harold Bennett, acting state director for CFSA; Harry Oneth, state conservationist with NRCS; and George Ellis, acting state director for FmHA.  
 Ellis, from Southland, Texas, is a cousin to Byron Boyd, a Friona attorney who is often retained by Friona State Bank. The bank will back a bid in Friona for the combined ag agencies but nothing has been formalized yet, said bank president Robert Neelley.  
 Because of the Ellis-Boyd kinship, rumors have been flying. But Ellis told the Tribune that he will not be part of the decision-making process because, as of Oct. 1, as noted above, FmHA merges with ASCS -- and Ellis will not be on the state FAC.  
 Ellis also stressed that anytime he sees a conflict of interest involving his job, he recuses (removes) himself. "I do it all the time on farm loans," he noted. Ellis said he has a large number of relatives in the Panhandle.  
 Instead, the state FAC, if they are faced with a decision, will turn to their business manager for a recommendation. Not only will the cost of the move involving a building be factored in, but also factored in will be the "cost" in people.  
 In other words, for example, if the two offices in Farwell, with its 13 employees, were moved to Friona, would those valuable employees agree to stay in those jobs?  
 It's still a long time before the state's target date for a decision. But you can be sure that officials in Bovina, Friona and Farwell will be putting together bid presentations.
