

DEATH COMES TO J. W. BARR ON JULY 30TH

The Wheeler community was saddened Tuesday to learn of the death of a prominent and respected citizen, Joseph Walter Barr, who had been a resident of this county for 34 years.

Mr. Barr passed away at 2:40 o'clock on July 30, at the age of 87 years, 2 months and 27 days. Funeral services were held at the Wheeler Methodist church Wednesday afternoon with Rev. Hugh H. Hunt, pastor, in charge. Mrs. R. H. Forrester read a poem, "The Builder," and Frank Wolford sang "Sunrise Tomorrow."

The Wheeler Masonic Lodge conducted its ritual and Hunt Funeral Home was in charge of interment.

Ever thoughtful of others, Mr. Barr was a beloved character. He was Chairman of the Methodist Board of Stewards here for several years and since his inactivity was Steward Emeritus of the Wheeler church.

He was born May 3, 1859 in Bask County, Texas, and when a child moved with his mother to Alabama where he grew to manhood. He joined the Methodist church at an early age. Mr. Barr returned to Texas in 1895, locating near Waxahachie, in Ellis county. Later he moved to Jones county where he resided until he moved to Wheeler county in 1912.

He was married to Bertha Clara Duan December 23, 1918. To this union two daughters were born, Ruth and Lula.

Surviving are the widow and daughters, Mrs. Ruth Bulee and Mrs. Lula McCasland, two grandchildren, Elaine and Kenneth McCasland of Wheeler, and one half-brother, E. T. Cosper of Wheeler.

Mr. Barr was a member of the Wheeler Masonic Lodge.

MRS. FLANAGAN LAID TO REST

Funeral services were held at the Wheeler Methodist church Tuesday afternoon for Mrs. H. Flanagan, 84-year-old Wheeler county resident who passed away last Sunday after an extended illness. Mrs. Flanagan was a Christian woman of whom Rev. Hugh H. Hunt, Wheeler Methodist pastor, said, "Few voyagers ever knew their Pilot better or had greater ability to inspire others to have confidence in Him; not by what she said but by how she lived."

Rev. A. C. Wood made an address at the service and Rev. Hugh Hunt preached the funeral sermon. Henderson Coffman sang, "Crossing the Bar," and other songs were "Abide With Me," and "Lead Kindly Light."

On October 17, 1932, at the invitation of her daughters, many of the friends of Mrs. H. Flanagan gathered in her home to help celebrate her birthday and wish her bon voyage on the sea of borrowed time. On July 28, 1946, some of those same friends saw her bark safely reach harbor on the eternal shore.

Mrs. Flanagan was born in Anamosa, Iowa, Oct. 17, 1862. In 1885 she was married to H. Flanagan who preceded her in death on Dec. 10, 1937. They lost three sons in infancy and youth. Four daughters and two sons survive. They are: Mrs. Rupert Foust and Miss Delpha Flanagan of Wheeler; Mrs. Steve Hanafin of Roswell, N. M.; Miss Lura Flanagan of Santa Fe, N. M.; Henry of Mobeetie and Paul of San Antonio.

She leaves thirteen grandchildren and four great grandchildren. Four of the grandchildren are well known by her Wheeler friends: Ruth Foust Kendrick of Lubbock; Joyce Foust Hallen of Philadelphia; Edwina Flanagan Greenhouse of Wheeler and Larue Flanagan of Mobeetie.

The Flanagans came to Texas in 1910 and moved onto the place three miles southwest of Wheeler where they have since made their home.

The secret of Mrs. Flanagan's wonderful life was partly revealed in a remark she once made, that it never had occurred to her that there was anyone who did not like her. She gave double measure of friendship to her friends. Even the children and young people came to know this and were always glad to go to her home, assured of her welcome. She suffered much in those last weeks but her welcome to callers was genuine even to her last day.

Tax Raise Is Needed If Wheeler School Is Kept At High Standard

"Out of sight, out of mind" is an old adage we realize applies to us. Since we have no children or grandchildren in the Wheeler public school we have thought little about its condition. Then we read about the possibility of the special school tax being raised to \$1.50 and later of an election being called to vote on an increase to \$1.35.

A loosed horse sleeps much of its time but touch the end of its nose and it rears up. Most of us taxpayers are like that. So long as someone else is wrestling with the problems of our community it is very well but just let them suggest raising taxes as a solution to a problem, and we rear straight up.

We had a talk the other day with our School Superintendent and here are some of the things we learned. There should be more courses offered on which no state aid is available. Everyone knows about the teacher shortage. Under the present setup, the only way a school board can pay more than the STATE SCHEDULED SALARY is to have a local fund to add to the state salary. These low salaries have been responsible for most of the teacher shortage.

This local fund can be used in any way the board sees fit but it is the only means trustees have of operating and improving the school system. All aid coming

from the state goes to help pay teachers salaries.

There are other needs. New furniture throughout; more visual aid for teachers, maps and other material from first grade to the twelfth. All buildings are in need of repair and \$500.00 should be set aside annually to maintain and improve the school library.

Here are some statistics that interested us.

The bonded indebtedness is ----- 66,000.00
The principal on some of these bonds will increase with the years, requiring more annual payment on interest and principal which at present is ----- 4,654.50
Other annual expenditures have been as follows:

Janitor's salary ----- 1,200.00
Janitor's supplies ----- 500.00
Fuel, lights and telephone ----- 1,280.00
Insurance ----- 500.00
Administrative supplies ----- 100.00
Teaching material and supplies ----- 160.00
Library ----- 240.00
Transportation ----- 6,000.00
When we fail our children we fail ourselves. We must not let our school run down. If we do, some day we will need to vote more bonds. So let's go to the polls Saturday, Aug. 3 and vote for the \$1.35 special school tax.

Swink, Daughtry, Sivage And Chris McClain Are Winners County Races

Three Wheeler county officials, two of whom were running for their second elective terms, were voted out of office in Saturday's Democratic Primary election.

They are: County Treasurer Lillie McClain who was defeated by Palmer Sivage; District Clerk Ollie W. Beene who was unseated by Chris McClain, war veteran; and T. L. Gunter who lost to T. J. Daughtry, a newcomer in county politics.

Sheriff Jess Swink who was re-elected to a third term without a run-off in a three-cornered contest, was the only public official to survive Saturday's balloting. Swink polled 1,336 to 1,108 for W. Z. Baker and 120 for J. D. Frye. There will be a run-off between Roy Gossett and A. C. Wood who led the list of write-in candidates for county surveyor.

Lewis Goodrich, Wheeler county attorney and veteran of two World Wars, carried three of the four counties comprising the Thirty-first judicial district to win the Judgeship over District Attorney Walter Rogers of Pampa by a 401 vote margin in Saturday's Democratic Primary.

Goodrich received a 10-to-1 majority in the two Shamrock boxes, an unprecedented vote, to emerge a 5-to-1 winner in Wheeler county's 21 voting precincts.

The Wheeler County war veteran also carried both Lipscomb and Roberts counties where the vote had not been completely tabulated when the above totals were compiled, and led his Gray county opponent in the McLean area where there were some 40 votes not yet tabulated.

Rogers, popular district attorney who conducted the most intensive campaign of any Panhandle candidate seeking election in Saturday's primary, carried Gray county 3,061 to Goodrich's 1,344.

Figures furnished Goodrich by supporters in the four counties gave him an overall lead of 401 while tabulations compiled by the Pampa News, Rogers' hometown newspaper, showed less than 250 votes separating the two men.

In a statement expressing his appreciation to neighbors who went to bat in his behalf, Goodrich credited his election to the amazing lead given him in his home county, and to friends who actively supported his candidacy from the start in Gray, Lipscomb and Roberts counties.

Goodrich, a former Thirty-first district attorney for six years, and a former City attorney of Shamrock, received strong backing from ex-service men in the four counties. He has been employed as Wheeler county Service Officer following his discharge from the navy several months ago. He saw action in World War II as a petty officer, being awarded a Presidential Citation.

Goodrich has announced he will resign his post as Service Officer before assuming his judicial duties next January.

W. E. Mason, seeking a third term as County commissioner in precinct 2, will run it off in the August Primary with S. B. Davis, high in the three-man race with 188 votes. Mason polled 139 and Jess Crowder, 112.

Albert Williams and Charley Wells will go into a run-off in the County commissioner's race in precinct 3. Williams polled 171, Wells 156 and Robert Terry 134.

Justice of the Peace T. E. Burkhalter of precincts 3 and 4, was another victim of the "vote 'em out" trend, losing to John H. Templeton, 584 to 943. Constable John Cox who did not have an opponent on the printed ballot was victorious over Write-In-Candidate Art Godwin by a majority of 216 votes.

Elected without a contest Saturday were: County Clerk Harry Wofford who led the county ticket with 2,717 votes, County Judge G. W. Hefley, County Attorney Homer Moss, County School Superintendent Allen Kavanaugh, County Commissioners Lloyd Anglin of Precinct 1 and H. S. Sims of Precinct 4, Justice of Peace A. C. Wood of Precinct 1 and Constable Bill Eisenmenger of Precinct 5.

A. B. Crump was named Democratic County Chairman without opposition, as was R. H. Forrester, committeeman of precinct 3.

A highlight of Saturday's election was the unprecedented majority given Lewis Goodrich in his race for district judge by his home county electors. Goodrich paced his opponent, Walter Rogers of Pampa, 5 to 1 going out of the county with 2,079 votes to Rogers' 403.

Congressman Eugene Worley of Shamrock, and R. L. Templeton of Wellington, candidate for state representative, were unopposed and polled 2,605 and 2,606 votes, respectively.

Beauford Jester carried this county in the governor's race, polling 1,148 votes to Homer P. Rainey's 695. Jerry Sadler received 162 votes and Grover Sellers 155.

U. S. Senator Tom Connally was given 1,604 votes to 459 for his four opponents combined. Boyce House led Allen Shivers by 244 votes for Lieutenant Governor. George Sheppard, controller of public accounts, and Jessie James, state treasurer, carried this county. Pat Neff, Jr., polled 1142 to Price Daniel's 1015 in the attorney general's race. Railroad Commissioner Olin Culberson carried the county by a landslide.

Future of Wheeler Is At Stake When You Vote Saturday

Wheeler County Wins An Election

(AN EDITORIAL)

The effectiveness of unity in backing a home candidate in a district political race was demonstrated last Saturday when Wheeler county voters gave Lewis M. Goodrich a 5-to-1 majority over his Pampa opponent. Our home county man was elected by a margin of 400 votes and it was the Wheeler County landslide that turned the trick, no doubt about it.

Wheeler County voters gave their home candidate 2,079 votes to Walter Rogers' 403, a majority of 1,676 votes out of 2,482 ballots cast. It was unprecedented in a contest where two equally per-

sonable and qualified candidates were on the ballot.

As Wheeler county voters have done too many times in the past, Gray county citizens did not give their candidate solid backing. The count there was Rogers 3,061 and Goodrich 1,344. Had Wheeler County given Goodrich the same 70 per cent majority, Rogers would have been elected by almost 300 votes.

The "ifs" of an election post-mortem are almost numberless. Statistics can be made to prove anything a writer desires. For instance if Goodrich had not carried Lipscomb and Roberts counties by such large majorities he would not have been elected in

spite of the Wheeler County landslide. The Wheeler county man received a majority of 321 in Lipscomb and 221 in Roberts. Goodrich had numerous staunch friends of many years standing in those counties, and his majority there while certainly not to be discredited, was not unexpected.

A majority of 1,676 votes out of 2,482 votes cast in Wheeler county in a hotly contested election, has never been achieved before. And so Wheeler county supporters of the new District Judge may well take pride in the significance of their solid backing of the home man. Wheeler county elected Judge Goodrich. Truly, "In Union There Is Strength."

THE CREDIT AND THE BLAME

Whatever happens in the next
 year with respect to production
 and prices, the question of who is
 to blame if things go wrong and
 of who should be praised if all
 goes well, will be difficult to answer.
 There will, of course, be many
 attempts to answer it. If prices
 move on upward, if inflationary
 trends assert themselves, if new
 wage increases are demanded to
 meet higher living costs, Mr. Truman
 can say that such conditions are
 due to the passage of an unsatisfactory
 bill by congress. If a happier state
 of affairs prevails, the president can
 say that by vetoing the first bill
 that passed and insisting on a more
 workable one, he contributed to
 such a result. Conversely, congress
 will undertake to claim the credit
 if the situation adjusts itself and
 to blame the administration if it
 does not.

If the average individual presently
 becomes confused by the two sets
 of claims, it will not be

surprising. But if he studies the
 record closely enough to realize
 that much that congress did was
 due to the activities of pressure
 groups, and that the president did
 the best he could to offset the
 power of the lobbies, the picture
 may be clearer. The congressman
 who brought about the passage of
 a bill which the president says
 was not satisfactory are probably
 hoping earnestly that it works,
 that it stimulates production with-
 out bringing inflation. We do not
 believe that the country will be
 deceived, as to where the blame
 rests, if inflationary conditions develop.

Veterans' News

A month from now thousands
 of veterans in this area will con-
 verge on colleges, universities and
 trade and professional schools, to
 take advantage of the educational
 benefits offered them under the
 G. I. Bill. Many others may not
 be able to attend the school of
 their choice, because of current
 overcrowding at almost every
 large school in the country.

The Veterans Administration recently
 completed a survey which showed
 that the most vacancies for veter-
 an-students will be found in
 smaller schools. State teachers'
 colleges, for example, listed com-
 paratively large numbers of open-
 ings, while state universities al-
 most without exception were al-
 ready at the saturation point.

Of the veterans who enter
 school this fall, a large percentage
 will be entitled to monthly sub-
 sistence allowances. In the past
 payments of these allowances has
 sometimes been delayed, because
 of a backlog of work in Veterans
 Administration offices, or incom-
 plete reports from schools or the
 veterans themselves. The Veterans
 Administration is anxious to pre-
 vent any such delays, and has
 taken steps to eliminate them
 completely. If you enter school
 this fall, and your first subsis-
 tence check does not arrive within
 30 days after your schooling be-
 gins, get in touch immediately
 with the school's veterans adviser,
 or go to a Veterans Administration
 office if there is one nearby. If
 you are not near a VA office,
 write to the VA regional office
 having jurisdiction over the area
 in which the school is located.
 Give full information, so that VA
 may give you speedy service.

Here are the VA regional offices
 in this area, and the territories
 they serve: St. Louis, Mo., serves
 eastern half of Missouri; Kansas
 City, Mo., serves western Missouri

and 10 counties in Northeast Kan-
 sas; Wichita, Kan., serves the re-
 mainder of Kansas; Little Rock,
 Ark., serves Arkansas; Muskogee,
 Okla., serves Oklahoma; Lubbock
 serves Panhandle counties.

Veterans Administration repre-
 sentatives are stationed at or near
 a number of the larger schools in
 the area, to provide assistance to
 veterans attending schools under
 the G. I. plan. They, and all other
 VA representatives, are always at
 your service.

Questions and Answers

Q. May a veteran pay off a
 guaranteed loan before it becomes
 due?
 A. Yes, the regulations give the
 veteran that right.
 Q. Can a guaranty be obtained
 if the proceeds are to be used by
 a minor or a person under legal
 disability?
 A. This can be done only if the
 loan and liens are valid under the
 state law governing the transac-
 tion. Many states have enacted
 statutes removing disability of vet-
 erans and for the wives of veter-
 ans who are minors to enable them
 to make such loans.

Q. May widows or children of
 deceased veterans obtain guaranty
 of loan?

A. No. The privilege is limited
 to veterans. A guaranty on a loan
 may continue, however, after the
 veteran's death.

Q. Are veterans of World War
 I eligible for benefits under the
 Act?

A. No. Its benefits are for
 World War II veterans only.

Q. If a loan is for farming pur-
 poses, must the veteran live on
 the farm?

A. No, but the Act requires that
 he actually conduct the farming
 operations.

Q. Is there any limit on the size
 of the loan?

A. No. The limit is on the
 amount which may be guaranteed
 or insured.

Q. May funds from a guaranteed
 loan be used to pay operating ex-
 penses on a farm?

A. Yes.
 Q. Must a veteran put any of
 his own money into a business, a
 home, or a farm in order to get
 the guaranty?

A. No. This is not a require-
 ment for guaranty or insurance.

It is a question which is settled
 with the lender. The only bearing
 it has on the guaranty or insur-
 ance of a loan is that in the case
 of a farm or a business it may ef-
 fect the likelihood of the veteran's

success in the venture.

Q. May a loan to buy an auto-
 mobile or truck be guaranteed or
 insured.

A. Yes, but only if the auto-
 mobile or truck is necessary to the
 conduct of the veteran's own busi-
 ness or farming operations, or the
 conditions of his employment re-
 quire that he have such a vehicle
 for use in carrying on his work
 but not merely for transportation.

H. J. R. No. 49
HOUSE JOINT RESOLUTION
 Proposing an amendment to Article VIII of the Constitution of the State of Texas by adding a new section to be known as "Section 7-a"; providing that subject to legislative appropriation, allocation and direction all revenues derived from taxes, gross production and ad valorem taxes, levied on motor vehicle registration fees shall be for the sole purposes of acquiring rights-of-way for and constructing and maintaining public roads; for the administration of laws pertaining to traffic and safety; and for the payment of principal and interest on county road district bonds and warrants voted or issued prior to January 2, 1939, and declared eligible for debt service prior to January 2, 1945; providing that one-fourth of such net revenue from the motor fuel tax shall be allocated

to the Available School Fund; providing and insuring that each county shall never derive less revenue from motor registration fees than the maximum amounts and percentages of such fees allowed under the laws in effect on January 1, 1945; negating any interpretation of this amendment as authorizing the pledging of the State's credit for any purpose; providing for the submission of this amendment to the voters of this State; prescribing the form of ballot; and providing for the proclamation of the election and the publication thereof.

BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF TEXAS:

Section 1. That Article VIII of the Constitution of the State of Texas be amended by adding thereto a new Section to be known as 7-a and to read as follows:

"Section 7-a. Subject to legislative appropriation, allocation and direction, all net revenues remaining after payment of all refunds allowed by law and expenses of collection derived from motor

vehicle registration fees, and all taxes, except gross production and ad valorem taxes, on motor fuels and lubricants used to propel motor vehicles over public roadways, shall be used for the sole purpose of acquiring rights-of-way, constructing, maintaining, and policing such public roadways, and for the administration of such laws pertaining to traffic and safety on such roads; and for the payment of the principal and interest on county and road district bonds or warrants voted or issued prior to January 2, 1939, and declared eligible prior to January 2, 1945, for payment out of the County and Road District Highway Fund under existing law; provided, however, that one-fourth (1/4) of such net revenue from the motor fuel tax shall be allocated to the Available School Fund; and, provided, however, that the net revenue derived by counties from motor vehicle registration fees shall never be less than the maximum amounts allowed to be retained by each County and the percentage allowed to be retained by each County under the laws in effect on January 1, 1945. Nothing contained herein shall be construed as authorizing the pledging of the State's credit for any purpose."

Sec. 2. The foregoing Amendment to the Constitution shall be submitted to a vote of the qualified electors of this State at the General Election to be held in November, 1946, at which election each ballot shall have printed thereon the following words:

"FOR the Amendment to the Constitution of the State providing that subject to legislative appropriation, allocation and direction all net revenues derived from taxes, except gross production and ad valorem taxes, levied on motor fuels and lubricants and motor vehicle registration fees shall be used for the sole purpose of acquiring rights-of-way for and constructing and maintaining public roadways; for the administration of laws pertaining to traffic and safety; and for the payment of principal and interest on county and road district bonds or warrants voted or issued prior to January 2, 1939, and declared eligible for debt service prior to January 2, 1945; providing that one-fourth

(1/4) of such net revenue from the motor fuel tax shall be allocated to the Available School Fund; providing and insuring that each county shall never derive less revenue from motor registration fees than the maximum amounts and percentages of such fees allowed to be retained by each county under the laws in effect January 1, 1945; and negating any interpretation of this amendment as authorizing the pledging of the State's credit for any purpose.

"AGAINST the Amendment to the Constitution of the State of Texas providing that subject to legislative appropriation, allocation and direction all net revenues derived from taxes, except gross production and ad valorem taxes, levied on motor fuels and lubricants and motor vehicle registration fees shall be used for the sole purposes of acquiring rights-of-way for and constructing and maintaining public roadways; for the administration of laws pertaining to traffic and safety; for the payment of principal and interest on county and road district bonds or warrants voted or issued prior to January 2, 1939, and declared eligible for debt service prior to January 2, 1945; providing that one-fourth (1/4) of such net revenue from the motor fuel tax shall be allocated to the Available School Fund; providing and insuring that each county shall never derive less revenue from motor registration fees than the maximum amounts and percentages of such fees allowed to be retained by each county under the laws in effect on January 1, 1945; and negating any interpretation of this amendment as authorizing the pledging of the State's credit for any purpose.

"Each voter shall strike out with pen or pencil the clause which he desires to vote against so as to indicate whether he is voting FOR or AGAINST said proposed amendment."

Sec. 3. The Governor of the State of Texas is hereby directed to issue the necessary proclama-

tion for said election and to have same published as required by the Constitution for Amendments thereto. 33-4tc.

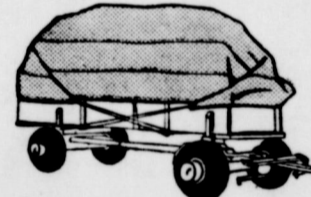

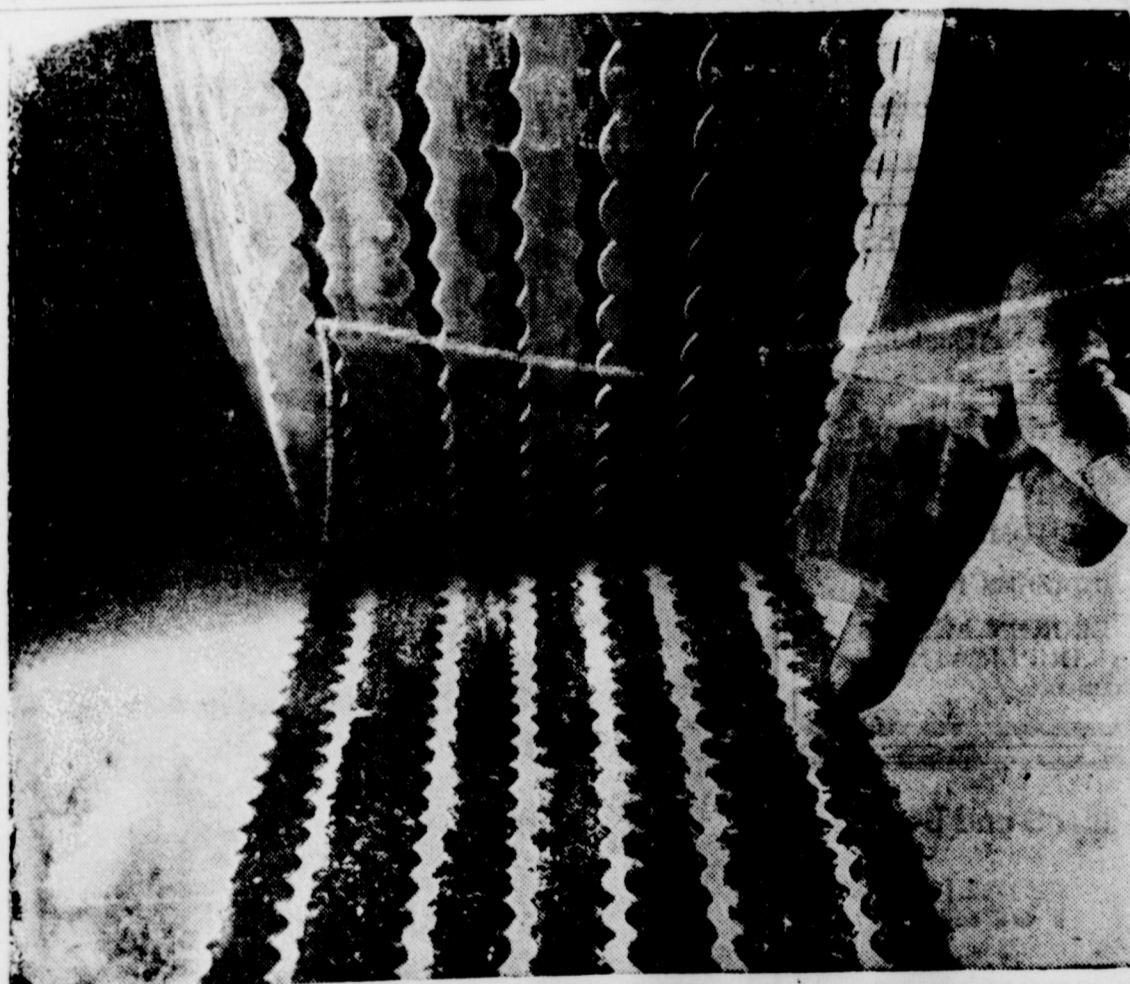
