Treasury Has \$52,292,255 Surplus

WASHINGTON, Oct. 3.—Income tax collections in September totaled \$498,520,385, enabling the treasury to end the first quarter of the new fiscal year with surplus of \$52,292,255.
Collections for the corresponding period a year ago were \$542,279,987, and the treasury at that time had a surplus of more than \$55,000,000.
Customs receipts in September dropped approximately \$16,000,000 under those of September, last year, totaling \$36,654,823. Customs revenues have dropped \$67,000,000 since July 1, below those of the same period last year. This decrease has taken place since the new tariff law became effective.

Darrow Takes Case of Robbery Of Chicago Bank

CHICAGO, Oct. 2.—Clarence Darrow, noted attorney who emerged from retirement to defend two gangsters from varnancy charges, has undertaken the defense of another case—this time that of a poor man accused of robbing the bank he worked for.
The man is bank clerk, Nicholas Price, 25, who admitted he took \$1,024 from the bank but said he needed the money to support his widowed mother.
Darrow was drawn into the case by chance while in Judge John H. Lyles' court defending two notorious gangsters charged with being rackets under a strict old law of 1874 which Lyle invoked in his drive to "rid Chicago of crime."

"Now, Mr. Darrow, what would you do in a case like this?" Judge Lyle asked of the attorney as Darrow sat in the rear of the courtroom waiting for the case to be concluded and his own clients called to the stand.
"You know my tendency to leniency, but I don't believe Price should go to jail," Darrow replied after considering the evidence.
"Give me the case and a little time and I think we can straighten this out."
The trial was continued until Oct. 8. Darrow's other clients were granted changes of venue.

Suit To Recover \$58,377.47 Taxes Is Dismissed

DALLAS, Tex., Oct. 2.—Suit to recover \$58,377.47 of the 1918 income tax paid by the estate of the late S. B. Burnett, multimillionaire Texas oil operator, was decided in favor of the government by Judge W. H. Atwell in federal district court here Wednesday.
The decision was based on the grounds that a claim for refund filed by prior counsel for the plaintiff failed to set out specifically that the recovery sought was based on the grounds of tax paid after the statute of limitations.
Attorneys announced an appeal will be filed.

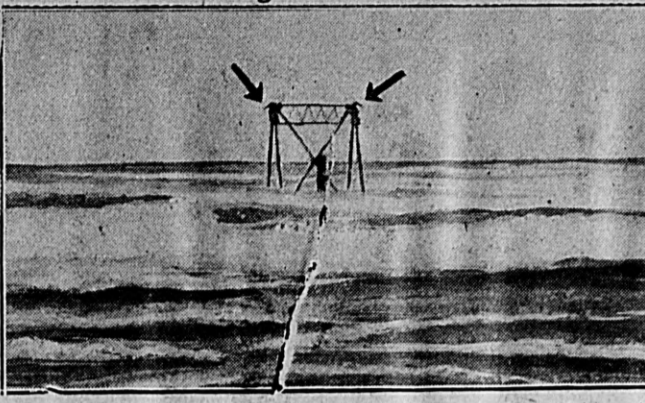

Detroit "Tonic" Party Held In Law's Limits

Prohibition Department Is Unable to Find Breach of Dry Statutes.

DETROIT, Oct. 2.—It would seem there is no clause in the prohibition law governing consumption of tonics, containing 22 percent alcohol, on drinking of such beverages.
At least that is the finding of the local prohibition department. It all started when a pre-election dinner was given in honor of Seymour H. Person, congressman-elect here.
During the course of the dinner a tonic of 22 per cent alcoholic content was served. The testimonial was given by Robert D. Wardell, president of the Michigan Moderation League and state representative, who pointed out that the tonic could be procured legally in spite of its high alcoholic content. Wardell also contended it showed the hypocrisy of the prohibition law.
A lengthy probe, conducted by Thomas H. Brennan, acting deputy administrator, during which samples of the tonic were purchased and examined, bore out Wardell's contention.

After "examining" the tonic, which was purchased in local drug stores, the probing agents admitted it resembled wine, rather than medicine, in taste.
The investigation revealed "no criminal intent" according to Brennan, which precluded any stringent measures on his part.

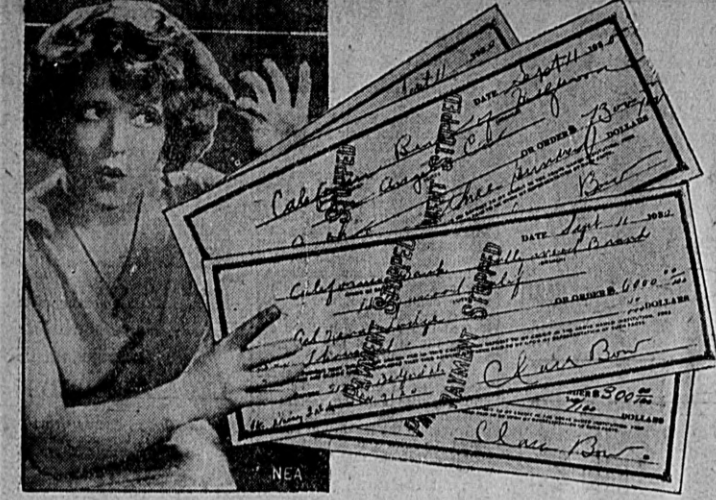

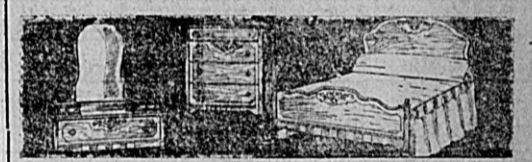

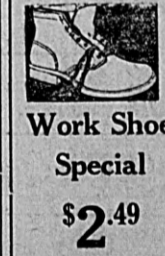

Coffee Tasters Choose Old Golds In Test

NEW YORK, Oct. 3.—Twenty-one leading coffee tasters gathered last week in a sampling room, at the invitation of Robert Ripley, the "Believe it or not" cartoonist. Among them were four official tasters for the New York Coffee Exchange, and other experts, said to be the most highly paid tasters in the world. For the first time, a representative group of coffee tasters met officially to judge the merits of a product outside of their own specialty. The occasion was "concealed name" test of Old Gold cigarettes and three leading competitors.

Mr. Ripley seated his subjects at two sampling tables, equipped with trays of coffee in the center, a steaming kettle, and scores of cups around the edge. The cigarettes were laid down in a certain order on the table. More sips of coffee to clear the taste—further rapid puffs on each cigarette, and their first judgment was checked.

The result was announced by Mr. Ripley and a certified public accountant as follows: ten of the

and he comes to his task unspooled and unhampered by a slack and easy-going father or mother. The whole situation was, in fact, very much in contrast with what often happens in the world. It has become almost a byword that childless homes into which a child comes late are often marked by tragedy.

Discipline Needed, Too
The parents in their joy are under great temptation to assume an indulgent attitude. The child is not subjected to the discipline necessary for his own good, and too often the child of hope and promise has brought his grey-haired parents in sorrow to the grave. Sincere religion is strong as well as kindly. It has regard for discipline as well as for gentleness. It considers the genuine welfare of the child and not merely his ease of his pleasure, and the child trained under such conditions develops the strength and ruggedness of his surroundings.

We can see quite plainly in these parents and in this home the natural qualities and the factors of spirituality and common sense that went to the making of such a figure as John the Baptist. The simple directness that marked his character, was about him from the days of his babyhood, and the rugged strength which his very food and environment suggested were the natural heritage of his daily environment.

Moreover, he had that individuality which it is the part of all good parents to foster in their children. He was not simply the product of the minds of his parents. They influenced him, but they developed in him a mind and a will of his own. Here are the ideal ends of the good home life and the factors that make for child training to produce strong manhood.

When one contemplates this home and thinks in contrast of the innumerable homes where children grow up with no such love or guidance or control, one does not wonder that the world is still so far from the kingdom of which Jesus typifies in the children. What we are should take of those of whom is the kingdom of heaven!
