As the time nears for the start of construction on a second Alaska pipeline--this one for gas-advertisements have begun to appear in numerous magazines and newspapers offering employment on the project at high salaries. The Bureau has learned that many of these offers provide job seekers--for a fee of \$10 to \$20--useless job applications or only vague on information employment.



You have surely noticed the proliferation of pieces under this byline about the excise tax on the oil and gas industry (mis-named windfall profits tax). Up until a couple of weeks ago, our reason for informing you about this bad piece of legislation was merely a vent for our frustrations. But now that we are heady with our influential impact and with the assumption that the Borden Star's readership surpasses our imagination, we are hopeful that these pieces will turn the tide and this legislation will be defeated. It will be an uphill fight tho because it is common knowledge that cattle producers are smarter than members of Congress.

And it is Congress that aroused members of the oil. and gas industry are taking on thisweek in Washington. Caravans of men and women from oil producing states are in Washington focusing attention on their plight. Not just the big producers and drillers, but the little guys and gals too--the small royalty owners are more effected by this legislation than the major oil companies. As a matter of fact, what government defines as obscene profits made by the majors won't be taxed at all. In most cases the majors have made by their profits on oil produced in OPEC nations---not domestic production (because of controls). And imported oil won't be taxed.

That is what this anti-windfall profits tax protest hopes to accomplish---to educate those members of Congress who could be a swing vote. The task force will tell all who will give them an audience that, 1. this is the first time in the history of US that one industry has been singled out to be destroyed, 2. that the consumer will be the loser, 3. that an excise tax will make US more dependent upon imported oil and gas; HEALTH FOOD CEN

4. that the OPEC nations would rather leave their oil in the ground than accept U.S. dollars; 5. that there is nothing wrong with profits as long as they are re-invested in THIS country. With this education, the task force hopes at the least to restore the 1,000 barrel per day exclusion and at the most to


kill the bill in its entirety. But one thing bothered I have always me. supported not only the oil industry but the agriculture industry too. Yet I disagreed in principal with the Farmers' Movement and their march on Washington. So I asked, "How can I support this task force descending upon D.C.?" The answer was simple and logical. The farmers were asking





government to leave them alone--let them produce. Therein lies a big difference. A subsidy is government--a tax is government. The oilers want less government and more energy.

Not all are convinced even so that this move on Washington is prudent. There is a feeling that the whole thing could boomerang-that it will be equated with the ill fated farmers protest. Some will accuse the industry of using those "obscene" profits to buy off Congress, when they would be better spent finding energy. - True, true-but the point is, if this tax passes, there won't be anything left to find more energy. So we better use whatever influence we have while we can still afford to go to Washington.

#### EMERGENCY FEED PROGRAM

Applicants under the **Emergency Feed Program** are reminded to submit sales documents for feed cost. The sales documents must include signature of the seller, date of purchase, amount, kind, and price of feed purchased.

If you have not filed for assistance under the Emergency Feed Program and are feeding quantities above normal and suffered at least a 40 percent loss in feed normally produced, including grazing, you could be eligible under the program. Please come by the office for more information.

1980 FARM PROGRAM SIGN-UP

No details have been received as to any type of sign-up for 1980 program participation. However, we are ready to accept your report of acreage planted to small grain (wheat, oats, rye, barley). This acreage must be certified timely on all farms with any acreage devoted to a small grain crop. If you fail to certify, then all farms in which you have an interest will be ineligible for program benefits. Any small grain standing on May 1, 1980, must be certified. This includes acreage planted for cover, grazing, or harvest. **REMEMBER** - May 1,


1980, is the final date to certify all wheat, oats,

barley, and rye acreage for harvest, grazing, or cover. 1980 DISASTER CREDIT

With the possibility of congressional action to extend the disaster program 1980, through before + destroying any acreage planted to a program crop be sure to come by the ASCS Office and file a Report of Acreage and Application for Disaster Credit.






