





Krenek Named President of

Snyder--Dr. Harry Krenek has been named the third president of Western Texas College.

Krenek replaces Dr. Don Newbury, who resigned in December to become president of Howard Payne University in Brownwood.

Krenek joined the faculty of WTC as an assistant professor of history in 1972, a year after the college opened. He was named Dean of Instruction in December, 1982, and has been acting chief executive officer of the college since Newbury's resignation.

A native of Elgin, Krenek was graduated from Howard Payne University with the bachelor of science degree in 1963. He received the master's degree from Southwest Texas State University in 1967. He began his college teaching career at Sul Ross State University in 1966 after teaching at Aransas County High School.

Krenek was awarded the Ph.D. from Texas Tech University in 1979. He was a part-time instructor at Tech as a graduate student from 1969-71. He returned to Sul Ross as an instructor for the 1971-72 school year before becoming a faculty member at WTC.

COUNTY AG-AGENT REPORT

Borden County Breakfast

Producers

On June 10, 1986 at the 4-H Exhibit Building in Gail, a breakfast will be held for producers of Borden County at Dr. Jackie 7:00 a.m. Smith-Economist and Mr. J.F. Cadenhead-Range & Brush Specialist will be on hand to discuss leasing of land for hunting, and habitat's required for dear, turkey, quail and antelope. Dr. Simith will have a computer on hand for demonstrate software programs concerning leasing of land and

contracts. This will be our first early morning meeting and all producers are encouraeged to attend.

This event is made possible through efforts of the Borden County Livestock and Range and Crops program area committees.

The Upper Colorado sSoil and Water Conservation District will sponsor the breakfast and we certainly appreciate their continued support.

Time To Treat For Cattle Grubs

Cattle grubs are internal parasites and their damage is largely unseen, yet they cause greater economic losses to the U.S. beef cattle industry than any other insect pest.

While grubs are usually found on the backs of infested animals during the winter months, that's not the time for control measures since the pests have already done their damage.

Grubs are the larvae or worm stage of heel flies, and adult heel flies are active over most of the state from March through May.

The time to control grubs is during the period of May through August when grubs are small and before infested animals suffer stress, weight loss and decreased feed efficiency.

Helel fries cannot sting, have no functional mouth parts and cause no pain to cattle. Yet, they frighten animals, making them difficult to mahage.

Heel flies lay their eggs on an animal's hairs in the lower leg region, glued in position. Tiny larvae hatch in a few days, crawl down to the base of the hair and burrow into the animal's skiln. Then they begin a migratory



A pencil equipped with an eraser, the first of its kind, was patented by Hyman L. Lipman of Philadelphia in 1858. course through the animal's body, congretgating in the throat after a few months, and after six to eight months, appear in the grub stage in the animal's back.

If a producer has a history of grubs in his cattle herd, we recommend treating each animal over three months of age with one application of an approved systemic insecticide or injectable treatment during the May through August period.

Systemic insecticides are absorbed directly through the animal's skin, circulate throughout the body, and kill grubs while they are small. Injectable treatments are circulated in the animal's body fluids to klill the invading pests. These insecticides come in various forms--dips, sprays, pour-ons, injections and spot-on treatments. A listing of approved insecticides and methods for controlling cattle grubs is available at the county

Extension office.

Sodium Label Regulations Take

Consumers should find it a little easier to cut back on sodium in their diests, thanks to new Food and Drug Administration (FDA) regulation.

Effect In July

Beginning July 1, 1986, the FDA will require that the sodium content be shown on any food that provides nutrition information on the label.

The regulation should be of real help to peopele who are concerned about the hidden sources of sodium in processed foods. Sodium content will be listed in milligrams per serving. Consumers can use that information to see if they are staying within recommended sodium intake of 1,100 to 3,300 milligrams per day.

In addition, the FDA hhas defined the various terms that manufacturers may use to describe the sodium content of their products. These terms include:

Preserving Food At Home

A five part letter series entitled "Preserving Food at Home" will be mailed during June and July. The topics are freezing; canning; pickles and relishes; jams, jellies and preserves; and drying. If you would like to receive this

---"Sodium Free"..less than 45

milligrams or less in a serving. ---''Low Sodium''...140 milligrams or less per serving. ---: "Reduced Sodium"...the usual level of sodium for this product has been reduced by at least 75 percent.

Sodium-conscious consumers should keep in mind that a product with little or no salt is not necessarily sodium free, since at least 70 sodium compounds, such as monsdodsodium glutamate and sodium bicarbonate, are used in processed foods.

An FDA survey shows about half the food products available would already qualify as being "low-sodium" products. products.





AGRICULTURAL CONSERVATION, PROGRAM (ACP)

Request for cost-share assistance on needed conservation proctices, to be completed by September 30, 1986, are now being accepted. Practices approved in-clude SL2, improving permanent vegetative cover through the control of mesquite, cedar and other associated species through root plowing or tree grubbing, SL4 constructing terrace systems both standard and parrallel, SL5 constructing diver-sion terraces to controll erasion and conserve water, SL6 constructing wells and installing pipelines for livestock water or constructing concrete water storage facilities. Also practice WC-1, constructing water impoundment reservoirs(earthen tanks

ASCS will pay up to 50% of the cost for establishing the conservation prac-tice. However remember that request must be filed and approved by the Committee before the practice is started to be eligible for cost-share assistance. Request filed by June 16 will be considered by the Committee on June 17, 1986.

LONG TERM AGREEMENTS (LTA)

Request for cost-share assistance under the LTA contract are also being accepted. Cost-share under the LTA contract are based on 65% of the cost of performing the practice. Contracts will cover a period of 3 to 5 years. The Soil Conservation Service will have total responsibility in the technical design of the conservation work to be performed. For additional information on the LTA program please contact this office. Request for assistance and cost-share approvals should be filed by June 16, 1986. All request will be considered by a priority of conservation needs and the first come first served consept will not be used.

ADVANCE PAYMENTS

Advance Payments under the 1986 Cotton, Wheat & Feed Grain program are being computed and released as quick as possible. Thanks for you patience.

MEASUREMENT SERVICE

Producers in the county will have until July 15, 1986 to request Measurement Service for spring seeded crops and Acreage Conservation Reserve (ACR). The cost for this service will be \$20.00 per farm plus 2¢ per acre in excess of 25.0 acres.

FAILED ACRES

Crops that fail due to natural disasters must be reported to this office to be gligible for program payments or to receive hsitory credit. Remember the crop must be certified and a request for disaster credit filed before the acreage is mechanically destroyed or put to another use.

Producers will be asked if they favor imposition of mandatory limits on production of wheat which will result in wheat prices that are not lower than 125 percent of the cost of production. Fertilization A Key To Successful **Home Gardens**

Lubbock-- A successful home garden in West Texas requires a fertilizer management program, say two specialists with the Texas Agricultural Extension Service.

'All vegetables require relatively large amounts of plant nutrients," says Dr. Roland E. Roberts, Extension vegetable specialist. "Most home gardeners will have to provide additional nutrients by applying fertilizers or composts.

"If your soil is naturally rich in nutrients, you are lucky," adds Dr. Michael G. Hickey, soil chemist and director of the **Extension Soil Testing** Laboratory here. "However, you may find it necessary to give your garden a nutritional boost through the use of fertilizers.

West Texas soils generally contain an adequate supply of essentilal plant nutrients, with the exception of nitrogen and phosphorous, the Extension specialists noted. In some soils and situations, iron and zinc may be needed in small quantities.

The amounts and types of nutrients require for your garden can be determined from a soil test by a qualified laboratory, such as the Texas Agricultural **Extension Service laboratory at** Lubbock, Robetrts saisd. Local county Extension agents can explain the simple procedure for collecting and submitting a soil sample, he added.

Over-fertilization, especially with the " complete" fertilizers, not only wastes your money, but can cause gardening problems, Hickey said. "On many older gardening sites in our region, we find that excessive fertilization with phosphorous has induced zinc and iron deficiency," he said.

If you use a "complete" fertilizer, be careful, because it may contain nutrients you don't need, the soil chemist cautioned. Some "complete" fertilizers will contain trace elements or micronutrients which may be of limited usefulness for soil application, he added.

The contesnt of most fertilizers is designated with three numbers on the label that indicate the percentage of total nitroegen, available phosphoric acid, and water soluble potash in the fertilizer. As an example, a "complete" fertilizer such as 10-10-5 contains 10 percent nitrogen, 10 percent abailable phosphorous, and 5 percent water soluble potassium. A nitrogen source, such as 21-0-0, contains 21 percent nitrogen, but no phosphorous or potassium.

Choice of a fertilizer material will depend on the type and amounts of nutrients needed, and the cost of the material. For example, Hickey said, if you are purchasing a fertilizer strictly for its nitrogen content and plan to apply it to the soil and till it in, you should buy the one in which the proper nitrogen amount is the least expensive.

Additional organic matter, such as compost, peat moss or manure, can benefit the home garden, Roberts said, Organic matter helps improve drainage and aeration in clay soils, and

increases the water holding capacity in sandy soils. It will likely improve the general soil fertility of any soil, the specialists agreed.

Care must be taken with manure application, they cautioned.

phosphorous--will be added, but so will salts, which can be harmful. Don't exceed a rate of 10 pounds of dried manure or 50 pounds of feedlot or stable manure for each 100 square feet, they advised.

Compost is refuse that has been converted into a 'synthetic manure,'' the Extension specialists said. Leaves, grass clippings, small

prunings, weeds, and vegetable matter from the kitchen can all be used. "In our region, grass clippings will predominate,' Hickey said. Depending on your lawn fertilization practices, compost from grass clippings

will be high in nitrogen.

To utilize compost or peat moss, spread about five bushels of the material over 1,000 square feet and mix it thoroughly into the soil, Hickey said.
