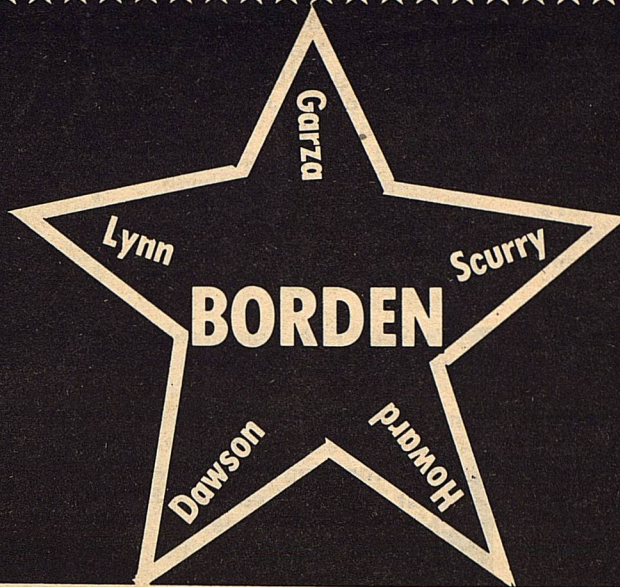

## Special grand jury called to hear vote fraud charges

Pecos-A special session of the grand jury convened here Saturday to collect evidence of vote fraud.

People with "first-hand knowledge" of any type of election fraud surrounding Tuesday's election were asked to come before the grand jury Saturday.

"There are no allegations against Larry Don Shaw or John Anderson's campaign workers. This involves internal county politics," McGowen said.

"We're trying to clear up some monkey business on certain local precinct races," McGowen said.

The possibility of election fraud in Reeves County was first raised in October when Brewer told news correspondents that the district attorney's office began receiving complaints from mail ballot applicants.

Those persons said they were harassed when they received their ballots, Brewer reported. Some ballots were hand-delivered.

Many of those voters were reported to be elderly Hispanics who said they were signing ballots without knowing for whom they had voted, Brewer said.

McGowen is asking for first-hand reports of voter intimidation and other illegal activities by elected officials and campaign and election workers.

"Some examples might be, in the mail order absentee, if you had unsolicited people appear at your door and intimidate you to vote when you're not ready or try to get you to vote for their candidate," McGowen said.

"Or if you were approached inside the polling place by any poll watcher or election worker politicking for a candidate or political

party.

"Or any irregularity you see in the performing of duties of any election official.

"Or illegal aliens voting..."

Though abuse of the fairly "liberal" policies for mail-out voting has been growing worse, other problems potentially more affectual to the election have now been reported, he said.

"The worse problem is the need for election workers, campaign workers and elected officials to be more schooled in what their duties are and in what they can and can't do," McGowen said.

McGowen noted that numerous reports of fraud have been made during various elections, but that investigations are now focusing on alleged fraud in Tuesday's election.

"Allegations were continually made in the two or three weeks preceding the election, then on election day against workers, poll watchers and elected officials."

District attorney investigator Jack Brewer has been working with secretary of state officials, the FBI and federal postal inspectors.

McGowen said the federal agents became involved because of the congressional candidates on the ballot and also because the postal service was involved in some allegations.

"There are several investigations going on-state and federal. In other words, there have been both federal and state laws broken," McGowen said.

"How can the United States complain about the elections in the Philippines when we have practices here in Reeves County that are

## John Anderson sweeps vote in Borden County

In a heavy Borden County vote, 72 percent of the registered voters went to polls, and three-quarters of them supported their home-county candidate, John "Rich" Anderson, in his unsuccessful bid to unseat District 69 Representative Larry Don Shaw of Big Spring.

Shaw won his county precinct by 1 vote.

County Clerk Dorothy Browne called the turnout "pretty normal" as she reported 404 voters cast ballots out of the 560 registered in the county.

They voted overwhelmingly in favor of Anderson, giving him 301 votes to 95 for Shaw.

In the governor's race, Borden County sided with the winner, voting 283 for challenger Bill Clements and

105 for Governor Mark White.

Because there were no Republican candidates in Borden County, all local elections were uncontested. Van L. York was re-elected county judge; Browne was re-elected district and county clerk; Melissa Ludecke was re-elected county treasurer; and Carolyn Stone was re-elected justice of the peace.

In the county commissioner's races, Hurston Lemons won in Precinct 4 and Larry D. Smith was re-elected in Precinct 2. Borden County voters went against the tide on two of the four state constitutional amendments.

Although all four amendments were passed statewide, Borden County voters expressed their disapproval on Propositions

1 and 3. The vote was 129 for to 163 against Amendment 1 - the railroad rolling stock measure; and 129 for to 152 against Amendment 3- the mutual insurance amendment.

Borden County voted 155 for to 134 against Amendment 2 - the legislative titles measure; and 168 voted for to 149 against Amendment 4- to allow branch banking.

### ANDERSON TALLY BY COUNTY

Shaw carried Crane County 837 to 787 for Anderson, Culberson 483 to 312 for Anderson, Hudspeth 421 to 157 for Anderson, Jeff Davis 287 to 246 for Anderson, and Winkler 1101 to 1007 for Anderson.

Anderson won Borden County 301 to 95 for Shaw, Glasscock County went 295 for Anderson and 132 for Shaw, Howard County went 4383 to 4193 for Anderson, Loving County went 48 to 35 for Anderson, Ward County went 1944 to 1382 for Anderson, and Upton County Reagan County went 644 to 328 for Anderson.

Reeves County voters cast the winning votes for Larry Don Shaw when they went 3,012 for Shaw and 1,329 for Anderson, a difference of 1,683 votes in Reeves County for Shaw.

Indications are that Anderson's losses came from the highly hispanic counties.

## Lady Coyotes Open Roundball Season

The Borden County Lady Coyote Basketball season officially opened last Tuesday night as they traveled to Coahoma for a two team scrimmage. In the J.V. scrimmage, Borden easily won the first three quarters before dropping the last. In the Varsity scrimmage, Coahoma won the first and third quarter with Borden winning the second and the teams tying the last.

Turnovers and cold shooting from the floor hampered the Lady Coyotes in the first half as they had 11 turnovers and hit a low 7 of 23 from the field. But then the nerves settled and Borden committed only 3 turnovers in the third and fourth quarters. Although the field goal percentage never did come up much, the free throw percentage was a respectable 65 percent for the game. Leading scorer in the varsity scrimmage was Kelli Williams with 24 points. Also in double figures was Elvira Balague with 12. Rounding out the scoring was Elana Himes with 8, Kate Phinizy and Lynn Herridge with 4 each, and Ralynn Key with 2. Leading in field goal percentage was Elvira with 57 percent and Lynn with 50 percent. Leading free throw shooters were Elvira with 100 percent hitting 4 of 4 and Kelli with 76 percent making 16 of 21. Ralynn led in assists with 3. Leading in

rebounds was Elana with 10 followed by Lynn with 9. Elana also led in steals with 3. Also playing in the varsity scrimmage were Kristi Stone and Linda Sternadel.

In the J. V. game, Borden completely dominated the first three quarters. Leading scorers for Borden were Lisha Sternadel, Shelly Lewis, and Kristi Adcock. Also playing on the J.V. were Felicia Romero, Cindy Lewis, D'Lyn Lloyd, Amy Lewis, Rachel Romero, Kandy Belaw, and Randi Woodward.

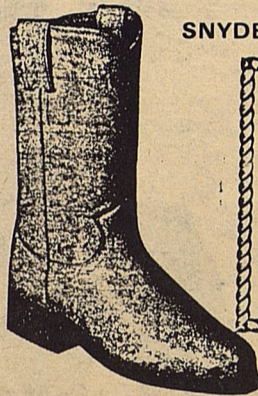

## Coyotes Loose Heartbreaker 44-41

The Borden County Coyotes traveled to Wellman last Friday night to play the top rated six man team in the South Plains. Wellman entered the game with an 8-0 record this year, and they were averaging well over 400 yards per game on offense. The Coyotes gave the host team more excitement than they bargained for.

The first Coyote score was set up by a Shannon Bond 23 yard kickoff return and a 10 yard run by Rockie Harber. Then Brice Key raced 37 yards for a touchdown with only 46 seconds ticked off of the clock. Shannon kicked the PAT for a quick 8-0 lead. The highly talented Wildcats were also quick to respond to the challenge as they also scored on their second play from scrimmage. J. Rowden took the handoff from Tony Timmons and raced 49 yards around end for the score. Timmons also kicked the PAT to even the score at 8:31 in the first quarter.

Each team stalled on their next possessions, but the Coyotes scored again with 3:38 remaining in the first quarter. After an impressive defensive stand in which Brice Key sacked Timmons on a 4th and 8 on the Wildcats on 38 yard line. The loss was all the way back to their own 26 yard line. It took the Coyotes 7 plays, but on 4th and goal from the 4 yard line, Rockie Harber raced into the endzone behind some good blocking by Mickie Burkett, Brice Key, Gerry Smith, Shannon Bond and John Stephens. After taking a bad snap for PAT, Shannon passed to Rockie Harber for a one point conversion for a 15-8 score.

The Wildcats stalled after gaining two first downs. Again the Coyote defense stopped the Wildcats of a 4th and 1 at the Coyotes 39 yard line. The Coyotes dropped the Wildcats for a none yard loss, but turned the ball over

from Shannon Bond to Michael Murphy. The PAT failed and the score was 27-22 with 58 seconds left in the half.

The Wildcats moved the ball to the Coyotes, where on 4th down they tried a field goal. The kick was short and the Coyotes had the ball with 8 seconds left in the half. Brice Key took a screen pass from Shannon Bond and raced 24 yards before being knocked out of bounds.

After the half the Coyotes had to kickoff to the Wildcats, and on a 4th and 17 from the Coyotes 30 yard line Timmons passed to J. Rowden who had slipped behind the Coyote defenders for a touchdown. Their PAT was good, and it made the score 30 to 27 with 6:47 left in the 3rd quarter.

After a 13 yard return the Coyotes drive stalled on the Wildcats 30 yard line. The Wildcats took over and the J. Rowden show began as he carried 6 times for a 60 yard drive. The PAT was good and the Coyotes were behind 38-27 with 1:46 left in the 3rd quarter.

Again the Wildcat defense forced the Coyotes to punt, but the Coyote defense stiffened. Shannon Bond made a diving fingertip interception on the Coyote 32 yard line. Three plays later Shannon passed to Rockie Harber who raced 43 yards for his 3rd score. Shannon passed to John Stephens for the one point conversion to narrow the lead only 4 points (38-34).

The Wildcats turned again to Rowden who 6 out of 7 plays to cap a 72 yard drive. The PAT failed, but their lead increased by 6, (44-34).

With things looking bleak for the Coyotes with only 5:18 left in the game, the Coyotes once again demonstrated their desire and willingness to do the necessary things to win. Michael Murphy put things into motion with a 36 yard

kickoff return to the Wildcats 36 yard line. After a 9 yard pass to Brice, a 7 yard run by Rockie, Shannon passed 20 yards to Mickey Burkett for a touchdown. Shannon passed to Michael Murphy for the one point conversion to make the score 44-41 with 3:56 left in the game.

One play after the kickoff, Harold Barnes recovered a fumble on the Wildcats 39 yard line. The Coyotes made a good run, but it was wiped out by a 15 yard holding call. Now facing 1st and 40 yards for a first down on our own 26 yard line, Shannon passed 35 yards to Brice. Rockie then ran for a first down with the ball on the Wildcat 19 yard line. On the next play the Coyotes appeared to score a go ahead touchdown pass from Shannon to Michael, but another holding call wiped it out. The Wildcats were then able to hold the Coyotes out of the endzone and run out the remaining few seconds.

This was a very hard loss for the Coyotes, but the school, coaches, parents and friends all know that they gave their best. We're all proud of our Coyotes and the hard work and good sportsmanship that was displayed all year.

The Coyotes displayed an over-all team effort, but

several individuals had excellent efforts. Brice Key led offensively with 85 yards on 12 carries and 126 yards on 5 catches. Rockie Harber gained 64 yards on 14 carries and 43 yards on 2 catches. John Stephens had 19 yards on 2 catches. Mickey Burkett had 20 yards on 1 catch. Michael Murphy had 2 catches for 21 yards. Michael also had 136 yards on 5 kickoffs and punt returns. Shannon Bond had 38 yards on 2 kickoff returns.

Shannon completed 13 out of 19 passes for 228 yards. He also had 2 interceptions and 12 tackles. Mickey Burkett led all tacklers with 15 while playing, after being out of school 2½ days with the flu. Mickey came back to school on Friday while still running a little fever. Ray Martinez, starting nose guard missed the game because of sickness. Kerry Fryar had 8 tackles. Brice Key had 5 tackles. Michael Murphy had 6 tackles. Harold Barnes had 5 tackles and 1 fumble recovery. John Stephens had 5 tackles and Rockie made 2.

Good job Coyotes, everyone is proud of you for your determined effort to be winners. You are winners and don't forget it!

## COUNTY AG-AGENT REPORT By DENNIS POOLE

DETERMINE 1987  
 FERTILIZER NEEDS NOW

Make plans now to collect soil samples from those fields which will be planted to spring crops.

Early assessment of fertilizer needs will help crop producers take advantage of purchasing fertilizers in the fall or winter when prices are generally lower than during the high-demand period in early spring. Also soil samples can be collected after warm-season crops have been harvested, and problem areas in the fields can be identified more easily for specific sampling.

Traditionally, soil testing laboratories have a lighter work load during the fall and early winter so that samples can be processed and results reported more quickly to the sender.

A soil test may indicate that fertilizer is needed to attain a desired yield goal. Not to fertilize may result in only average yields which don't generate enough income to cover basic production costs. However, fertilizing at recommended rates will often increase

yields enough to more than pay for the fertilizer and also provide some profit margin.

To help crop producers monitor the carryover or residual nitrogen levels in their soil, the extension service soil testing laboratories at College Station and Lubbock routinely analyze soils for nitrate nitrogen. This analysis determines the amount of available nitrogen present in the soil and is subtracted from the amount of nitrogen required to reach a desired yield goal. The reduced nitrogen recommendation results in a direct savings to the producer without sacrificing yield.

There is no substitute for knowing what your soil's nutrient balance is as you start planning next year's cropping program. Soil testing can provide an economical means of determining your soil's nutrient status and can help you make those major economic decisions with greater confidence.

Miss Williams is a general business major at WTC and plans to continue her studies at Texas Tech or Angelo State University.

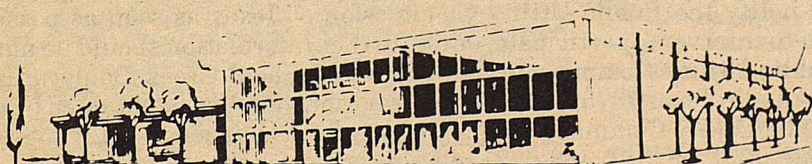

### NOTICE OF PROPOSED REDUCTION IN AT&T's TEXAS RATES

The Public Utility Commission of the state of Texas has entered orders in two recent cases that would substantially reduce the charges which AT&T pays to the state's local telephone companies and which could allow AT&T to reduce prices for most of AT&T's customers on calls placed within the state of Texas.

The total amount of the reduction to AT&T's customers is expected to be between \$115.3 million and \$120.6 million. This is in addition to the \$19.8 million reduction in AT&T's Texas basic long distance prices that went into effect on March 1, 1986 and is in addition to the approximately \$2 billion in AT&T interstate price reductions that took effect earlier this year.

If the changes are approved, all of AT&T's direct dialed long distance, directory assistance, WATS and 800 service customers would be affected, and would experience a decrease in their prices for these services when calling within the state of Texas. The following tables show the anticipated impact of the changes on AT&T customers by service category:

The rate reductions are presently anticipated to occur in two phases on or about October 22, 1986 and November 12, 1986. The matter has been assigned as Docket Nos. 6926 and 7113. 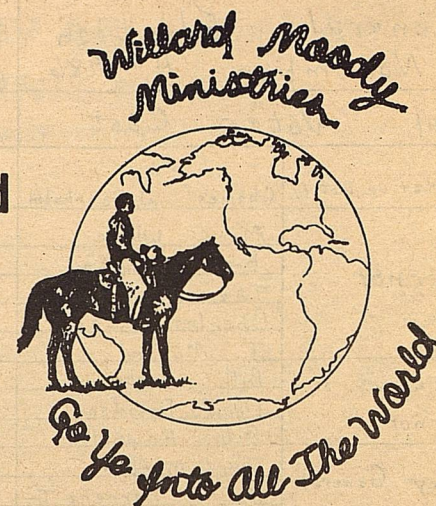
