
Rotarian/Teacher Meet




The Christie Committee, formed recently by supporters of a Christie bid for the Senate, has been assessing citizen support and evaluating his potential as a sentorial candidate.

"We have closed the loopholes and eliminated the fine print in accident and health insurance policies, making the board a truly consumer-oriented agency."

In addition to deciding whether to make the Senate race, Christie said he plans to "get more active in the oil business and continue in my law practice."




SOUTHWEST TEXAS AGRICULTURAL OUTLOOK

UVALDE--Light scattered rains in some counties of Southwest Texas last week have brought needed relief to many ranchers, but dry conditions still prevail in many areas with low forage quality and danger to range fires.

In their weekly report on agricultural conditions, Texas Agriculture Extension Servie County Agents report cotton harvesting is wounding down in the Wintergarden area. Harvest of Florunner peanuts in the southern past of the area is in full swing, and most areas are reporting that the fall commerical vegetable crops under irrigation are doing well.

Lnad preparation for small grains is underway in most area and shearing activities for Angora goat producing areas are continuing with the clip 95 percent complete at some locations.

Shahan Preps Longhorn Group



James T. "Happy" Shahan, Texas Longhorn and Aberdeen-Angus cattle rancher, owner of Alamo Village, and enterpreneur of country and western mus cial talent, was elected president of Texas Longhorn Breeders Association of America at the annual membership meeting held in San Antonio recently.

Frank Doherty, distinguished citizen and rancher of Fort Scott, Kansas was named Vice-President; and James Caleb Stanfield, rancher and attorney of Paris, Illinois was re-,elected treasurer.

About 150 members and guests representing nine states attended the annual three day convention which offered seminars on cattle promotion and bull evaluation, slide presentations of the U.S. Wildlife Refuge at CAche, Oklahoma and breed research by Dr. Davis Crenshaw of Texas A&I University, and an evenings entertainment by the San Antonio Charro Association.

The Texas Longhorn Breeders Association, organized in April, 1964 under the leadership of Charles Schreiner III, currently has a member ship in excess of 500 with representation in 46 of the United States and in Canada, Mexico and Norway.

The first board of directors meeting of the new tenure will be held January 18-20 in Denver, Colorado in conjunction with the National Western Livestock show and the fourth Texas Longhorn Steer Show.

During the first quarter of this century, the Texas Longhorn was considered to be closer to extinction that the American Bison. The Texas Longhorn Breeders Association has registered about 15,000 head of cattle of which 12,000 are believed to be


in 1976 when the college had an all-time high of 2,150 students.

Dell City is truly an oasis in the des-

It's a small town — not much bigger than a roadrunner's stride. Sitting on the desert floor with the sheer walls of the Guadalupe Mountains towering to the north and wide open spaces in every other direction, driving into Dell City is a lush surprise.

A seemingly inexhaustable underground water supply turned Dell City's desert into rich farm land. Tomatoes, cotton, barley, alfalfa, hay—just about anything that begins as a seed and can withstand desert heat is grown there.

A hearty breed of people also grow there. They are ranchers and farmers whose life staple is hard work. Virtually isolated from the rest of civilization, the people of Dell City have learned to make do with what they have.

Situated virtually in the center of a triangle, Dell City is about 100 miles from Carlsbad, Van Horn and El Paso. It's no big deal to drive two hours one way just to buy groceries. There is nothing right around the corner in Dell City — including a doctor.

Like many other small towns in West Texas, Dell City has no full-time doctor. There is not even a veterinarian or a dentist to answer emergency calls. When children there come down with a cold they are usually packed into the cab of a pickup truck and driven to El Paso for treat-

Dell City has been without a doctor for 15 years. It hasn't been by choice. Recruiting efforts have been made at nearly every medical school in the United States. At one time the city thought it had struck a bargain with a medical student in Mexico. But, as usual, the net came up doctorless.

"We have been in contact with just everyone you can think of in hopes of coming up with a doctor" said Sid Templeton, a Dell City farmer and president of the town's Chamber of Commerce. "But so far we have not found one. But we are still looking."

Templeton looks at Dell City's doctor situation realistically. He said the last doctor left town 15 years ago because he could not make money. "I

Yesterday as I came out of Del Rio I saw a rather respectable looking young man hitch-hiking near Laughlin. I almost never pick up a hitch hiker but on a hunch (or maybe it was prompting from the Lord) I picked him up. His wife had gone off to San Antonio, where they lived, with his car keys in her purse. He didn't want to catch a bus for fear she would notice them and come back to Del Rio and he'd pass her on the highway and be unable to stop her. It turned out he had been in Mississippi State when my oldest son was doing graduate work there and lived only a short distance from where Joe now lives.

He had bought a car in Del Rio and had a 90 day warranty. The warranty was written and signed by the automobile dealer in Del Rio. When he took the car in the dealer refused to honor the warranty. The young man went to the Justice of the Peace who went

to the dealer. The dealer admitted he gave the warranty but said frankly he would not honor it. The J.P. told the young man he'd just have to sue the dealer. I asked him if he planned to sue him. He said "no" I believe in universal justice. I believe God will deal with the man and I believe God will compensate me if I just turn it over to him. He recounted a former experience that had worked that way and said, "I felt God told me to let Him handle it so I will." This revealed to me wisdom far beyond the years of the young man. It revealed a faith in God seldom seen. It is one of the most difficult things in life to follow this young man's example. Where a person mistreats you, pathologically lies about you, slanders you or seeks to degrade you, it is not easy to let the Lord handle it. When you have evidence which could mean thousands of dollars toyou and send a person to the pententiary it's no easy thing to let God work his justice out. But He can do for better and be more effective than we can and He will.

CONSTITUTIONAL AMENDMENTS **GENERAL ELECTION NOV. 8, 1977**

NUMBER ONE ON THE BALLOT (S.J.R. 18)

S.J.R. 18 proposes an mendment to the Texas Constitution to provide for xpanding the Court of criminal Appeals from its current membership of five udges to nine judges and o permit the court to sit n panels of three judges.

The wording of the proosed amendment as it will ppear on the ballot is as

"The constitutional amendment increasing the size of the Court of Criminal Appeals to nine judges, and permitting the court to sit in panels of three judges."

NUMBER TWO ON THE BALLOT (S.J.R. 13)

S.J.R. 13 proposes a contitutional amendment to provide for an additional \$200 million in bonds or obligations of the State of Texas for the Veterans' Land Fund and to allow surviving widows of veterans to purchase tracts under certain circumstances.

The wording of the proposed amendment as it will appear on the ballot is as

"The constitutional amendment to provide for an additional \$200 million in bonds or obligations of the State of Texas for the Veterans' Land Fund and to allow surviving widows of veterans to purchase tracts under certain circumstances."

NUMBER THREE ON THE BALLOT (S.J.R. 3)

Under current Texas law a person charged with a felony offense who has previously been convicted of two felony offenses may be denied bail. S.J.R. 3 proposes an amendment to the Texas Constitution which would also result in the denial of bail, for a limited time and subject to appeal, to a person accused of committing a felony while on bail for a prior felony for which the person has been indicted, or accused of a felony involving the use of

a deadly weapon after being convicted of a prior

The wording of the proposed amendment as it will appear on the ballot is as

"The constitutional amendment permitting denial of bail to a person charged with a felony offense who has been theretofore twice convicted of a felony offense, or charged with a felony offense committed while that person was admitted to bail on a prior felony indictment, or charged with a crime involving the use of a deadly weapon where there is evidence such person has been convicted of a prior felony offense: providing for a 60-day limit to that person's incarceration without trial; and providing for that person's right of appeal."

NUMBER FOUR ON THE BALLOT (S.J.R. 5)

S.J.R. 5 proposes an amendment to the Texas Constitution authorizing the legislature to grant exemptions or other relief from ad valorem taxes on property designated for the preservation of cultural, historical or natural history resources.

The wording of the proposed amendment as it will appear on the ballot is as follows:

"The constitutional amendment authorizing tax relief to preserve certain cultural, historical, or natural history resources.'

NUMBER FIVE ON THE BALLOT (S.J.R. 19)

S.J.R. 19 proposes an amendment to the Texas Constitution authorizing the formation of associations authorized to collect certain refundable assessments from producers of poultry, livestock, and other raw agricultural or marine products and validating the 1967 law regarding the formation of such associations.

The wording of the proposed amendment as it will appear on the ballot is as "The constitutional amendment authorizing the formation of agricultural or marine associations which may mandate the collection of refundable assessments for improvement of production, marketing, or use of their products.'

NUMBER SIX ON THE BALLOT (S.J.R. 49)

don't know if a doctor can get rich here. This is not a rich community. But we have a lot os things to give a doctor, it we can find one willing to come here."

Templeton said the population of Dell City is about 450. But a doctor's practice area could swell to well over 2,000 people "when you count all the farms, ranches, and other samll communities in the area."

A medical clinic built in Dell City 20 years ago by the Sears-Roebuck Foundation now stands empty. Its' doors open three, maybe four times a month when two doctors travel to town for one-day out patient clinics. One doctor drives from VanHorn, is sponsored by Family Services and handles most of the welfare cases. The other is a Carlsbad physician who flies in on his days off a couple times a month.

"These doctors are a lot of help to us," said Roy Rascoe, a Dell City farmer. "But unless you are sick on the day they come they cannot help you.

Suffering with a head cold he said he had had for several days, Rascoe siad he could use a doctor. The doctor from Carlsbad was scheduled to be in that day, but decided to go elk hunting instead.

"I guess I'll just suffer with this cold for a while. If it starts getting worse, I might have to go to El Paso to see a doctor," he said.

"The people hare have become acclimated to it," Virginia Brownfield, Dell City's school nurse and No. 1 health adviser. "When people get sick here they don't think anything about driving in to El Paso to see a doctor. It has become part of the way of life."

Better known to the townsfolk as Jennie, she is a registered nurse and had been school nurse for 19 years. But her nursing goes far beyond the school. "There is just no way of measuring how valuable she has been to Dell City," Templeton said. "In emergency cases she is the first person we

"I can only do so much, thought," she said. "Whin I see a case should be handled by a doctor I say so. But I won't turn my back on anyone. I never know when I may need help myself."

Surrounded by greenery in the heart of a desert, Dell City is an attractive place. But, so far, no doctor has found it to be an oasis.

Bullock Report

COMPTROLLER OF PUBLIC ACCOUNTS

AUSTIN-- State Comptroller Bob Bullock said Thrusday that some 880 Texas cities have been mailed checks totaling \$57.6 million as their share of the one percent city sales tax for Spetember.

The September checks raise to \$263.6 million the total that has bee rebated to the cities to date this year, up from \$229.7 million for the same period last year. This is a 14.7 percent increase.

Bullock said the increase in sales tax collections in Texas is outpacing that of most other states, signaling the continuing vigor of the state's economy.


"This has got to be a good sign for everyone -- the consumer, the merchant and the taxpayers," Bullock said.

Houston, Texas's most populous city, was sent a check for \$11.2 million, raising its year-to-date total to \$53 million. This is a 10 percent increases over last year.

Rebates to the City of Dallas are up to a whopping 20 percent for the year, outpacing Texas' other major urban centers. Dallas was sent a check for \$6.9 million, bringing its total for the year \$32.3 million.

Fort Worth has received \$11.1 million for the year, a 17 percent increase over the same period last year, and sales tack rebates in San Antonio are running 10 percent over last year for a total of \$16 million.

* Brackettville had a net payment this period of\$3,435.65, with the net for the same period prior year of \$2,379.33, 1977 payments to date \$15,853.69; 1976 payments to date \$9,526.84; and percent change to date is 66.00%.



Q: I've got a cyclone fence along the back of my property, which adjoins an apartment house parking lot. The fence is being pushed down by cars in the apartment complex, and I've written the owner several times. However, the apartment is owned by a large corporation in another city and I can't get them to communicate with me. Can I take steps to get them to repair or replace my fence?

A: If a fence constructed on a homeowner's property is being damaged by an adjoining property owner, the homeowner may sue the neighbor to recover for damages to the property.

Q: If I mail a traffic ticket with a check or money order sufficient to pay the fine for a traffic offense, is this an admission of guilt?

A: Most traffic tickets have a blank where you must sign to enter a plea of guilty. If you desire not to plead guilty, you can mail the ticket without your signature along with the payment of the fine, and a plea of nolo contendere will be entered for you. A plea of nolo contendere, commonly called a "no contest" plea, should a lawsuit be filed as a result of the traffic offense. In a personal injury suit, a plea of guilty in a traffic offense is admissable as evidence to be used in determining who was legally at fault in an accident.

Q: My husband and I are retired and have a 175-acre farm. All of our eight children are married. Neither one of us has a will. When we die, will our children receive all of our property?

A: A surviving spouse would share ownership of the couple's community property with the couple's children after the death of one spouse who left no will. This shared ownership would result because the one-half share of the community property owned by the spouse who died would pass to the children. If the surviving spouse does not remarry or dispose of the land by sale or gift, the remaining one-half ownership would pass to the children at the death of the surviving spouse if no will was left.

Q: We're planning on buying five acres in the country with a house. But we discovered this property is subject to outstanding mineral rights. Because we're buying the property to use as a residence rather than for mineral exploration, we're not concerned that someone else owns this interest. However, we're not sure whether this mineral interest will affect our rights to the property.

A: An outstanding minercould become important al interest may seriously affect the use of property as a residence. The owner of a mineral interest may have the right to enter the property and remové the minerals from around your house in a reasonable manner.

It will soon be time to think of planting trees and shrubs. You should even now be choosing sites and deciding what to plant.

Trees should be ready to plant by mid-December. It is safer to order before that time. If trees are planted early-- (December instead of April) they will be far ahead. Some fruit trees planted in December may actually bear fruit the first year. Trees should be selected on the basis of whether they will grow in this area. It's great to have exotic trees or ones that grow in the North or in the mountains but it makes more sense to plant those which grow and do well in this area.


