Odd as it may seem those who criticize the loudest are usually the ones who never show up at the polls. I would say that they have forgotten what their Forefathers sacrificed in order that they might have the privilege of living in a free country.

One cannot discuss voting without eventually arriving at party affilation My next remark might offend some sensitive souls but, it is a reality we must face. At one time our two parties migh have stood for something but, that must have been before my time. Personally, fail to see any delineation. Learn how to "Decorate for Energy Efficiency" at an upcoming program in Del Rio. It will be held on Tuesday, November 7 th, at $7: 00 \mathrm{pm}$ at the Dink Wardlaw Agri-
cultural Complex at 300 E. 17th Street Mrs. Patricia Seaman, Housing and Home Furnishings Specialist and Becky Rogers, County Extension Agent-at-1arge will present the program. Energy efficient decorating factors to be con-
sidered include: color selection, floo coverings, wall and ceiling coverings, glass area treatments, furniture select ion and arrangement, lighting and accessories.

This program is being sponsored by the Extension Home Economics Advisory Committee for Val Verde County.

All extension programs are open to all people regardless of race, color sex, national origin, creed, religion or socio-economic levels.

Harvesting at the peak of quality handling properly, and storing under the best conditions possible are factors which will help insure a superior product at the dinner table.

These are important points to consider whether canning, pickling, freezing or preparing the product for eating fresh.

Determining the point at which fruits and vegetables reach peak quality is no easy task. Keeping a record of what varieties were used and when they were planted, along with the guide lines which follow, will be helpful in determining maturity

Some fruits and vegetables are more prone to damage during harvesting than others, but care in handling in order to avoid bruises and cuts is important with all commodities.

Any product which possesses decay and rot should be discarded so it will not infect the good fruits. Washing vegetables in cold water immediately
after harvesting is important for two reason: (1) to remove adhering soil, dust and other contaminants and (2) to help lower the temperature as quickly as possible.

In order to store any fruit or vegetable successfully there are requirements which must receive careful consideration.

Temperature. The conversion of sugar to starch is very critical in products such as sweet corn and peas. It is necessary to cool these products immediately in order to minimize this change.

Moisture. Proper humidity will vary with commodities. Leafy type vegetables require a high humidity (95\%) whereas onions should be stored in a dry atmosphere $(70-75 \%$ relative humidity

Ventilation. Wilting and Tissue break $\overline{d o w n ~ c a n ~ b e ~ a v o i d e d ~ b y ~ p r o p e r ~ a i r ~}$ circulation. A discussion on harvesting, handling and storing the more common home-raised vegetables follows along with a chart about optimum storage condition:

BEANS, LIMA - Harvest when pods are about full grown but have not begun to yellow. Wash pods immediately and transfer to refrigerator

BEANS, SNAP - Harvest before maturity when pods are not completely full for maximum tenderness. Wash immediately and refrigerate.

BEETS - Early beets should be pulled from the row when about 2 inch es in diameter. If they are allowed to get much larger, they become woody, especially in warm, dry weather. Remove all but about $1-1 \frac{1}{2}$ inches of the tops Wash and refrigerate immediately.

BROCCOLI - Look for tight, blue green buds, free of protruding leaves when harvesting. Cut the head with some 8-10 inches of stem and attached leaves. Chill immediately.
stem when they are solid, firm, and stem when they are solid, firm, and
fully developed. Chill immediately.

CARROTS - Pick when roots get to be $3 / 4$ to $l^{\frac{1}{2}}$ inches in diameter. Remove tops and wash before transferring to refrigerator.

CAULIFLOWER - Pick when curd is white and compact, free from protruding leaves. Heads should be 4-6 inches in diameter. Slightly yellowed heads will be acceptable, but dark cream to yellow will have a strong flavor. Chill immediately.

CUCUMBERS - Harvest when fruits are bright, firm and green, before they get too large; $1 \frac{1}{2}-2$ inches diameter is about right with the smaller size best for pickling. All nubbins, poorly shaped or light-colored, fruits should be picked and discarded. If possible, do not store in refrigerato for more than two days. It is best to pickle cucumbers the same day pick GREENS - Harvest before leaves start turning yellow or brown, while they are young and tender. Slight bronze tints are normal on mustard greens. Avoid wilted or flabby leaves. Wash and chill immediately.

LETTUCE - Select compact young heads which vary from 5-9 inches in diameter, depending on variety. Ro maine lettuce does not form a tight head, but good heads are compact, $9-12$
inches long. Wash and chill immediate ly.

OKRA - Three (3) to four (4) inches optimum length. After bloom has set, they will be ready to pick in two more days. Avoid pods which are dull, mp and yellowish. Chill immediately PEAS - Pods should be harvested when they are shiny and well filled. Overmature peas are of poor quality. high temperatures. Wash and chill immediately.

PEPERS - Harvest when peppers are
$4-5$ inches long with full, well-formed $4-5$ inches long with full, well-formed
lobes. Immature peppers will be soft pliable, thin-fleshed, and pale in color. Wash and chill immediately. POTATOES, IRISH - A good tuber size is a 2-3 inch diameter. Individual preferences are the keynote here. Let potatoes dry several hours in the garden after digging. . Remove adhering dirt, but it is not recommended to wash before storing. Store in cool, dry and dark area.

RADISHES - Harvest when diameter reaches approximately one (1) inch. Wash and chill immediately.

SPINACH - Harvest when six (6) or more leaves have formed that are crisp and dark green. Wash gently and chill immediately.

SQUASH - Harvest when fruit is $4-6$ inches long for yellow crook neck squash, 6-9 inches for yellow straight neck, and 3-4 inches diameter for white scallop. Glossy color indicates tenderness. Wash, dry, and store in warm area of refrigerator. Squash, like cucumbers, is susceptible to chilling injury and should not be stored for more than two (2) days.

TOMATOES - Harvest at pink stage and ripen in warm area of house. This will not affect flavor and may save loss due to insect and bird damage.

## ATAXPAYER'S BIL OF RIGHTS IS PAST DUE

Bill Clements believes we still have a chance to preserve our future by establishing constitutional protection against excessive taxation and runaway government spending

## John Hill calls for state tax freeze

"Our state taxes in Texas are among the lowest in the nation, and I want to keep them there. As I've said many times, I'll veto a tax increase before the ink dries on the bill."
As Attorney General, John Hill proved he could increase the efficiency of his office without any unnecessary budget increases. He absorbed a three-fold increase in his office caseload by hiring top legal talent capable of higher productivity. The result: his staff lawyers doubled their average workload, and the increased court judgments and enforcement of civil penalty laws returned $\$ 25$ for civil penalty laws returned $\$ 25$ for
every $\$ 1$ of state funds spent on his office.


As Governor, John Hill will insist on this same type of increased productivity for all state agencies. He will institute new controls over federal funds, demand that we follow our "pay-as-you-go" budget policy, and use zero-base budgeting to eliminate unneeded programs before any new programs are added. And he'll block any state tax increase - there won't be any new taxes under John Hill.

Also Kinney County $4-\mathrm{H}$ was awarded the champion herdsman award in the market lamb division. This award is given to the group who has and maintains the cleanest and neatest exhibit during the entire show.

WHAT IS A SALVATION ARMY SERVICE UNIT?

When the Salvation Army was start ed in 1865, it was known---and loved-for a slogan:
'A MAN MAY BE DOWN, BUT HE'S NEVER OUT.
The Salvation Army took men who had reached the end of the line gave them a hand and tried to give the the hope that could turn their lives around.

The Salvation Army was founded in 1865 in England by William Booth, a Methodist minister who was shocked by the poverty and degradation in the slums of London. His small group of followers grew into an army and spread rapidly to 71 counties around the world. Over 85 years ago the Army came to Texas. Today full-time corps with their uniformed officers and personnel operate in 40 of the larger cities of Texas. Some have separate facilities for welfare, rehabilitation ters, and lodging for homeless women and children as well as men. Over 250 officers and personnel work in these programs; approximately 1,200 voluntary advisory board members contribute their time, talents, and money.

Another 3,000 voidunteers make up the Service Unit Committee in 350 cities of Texas. In the absence of full time officers, these committees conduct the Army's welfare program for those having needs in their area.

In Brackettville, the officers elected by the Service Unit Committee are Rev. Joe Townsend, Chairman; Mrs Orlean Riley, Treasurer; and Mrs. Marty Miears, Welfare Secretary. Other members are Happy Shahan, Alvin Hall, and Dolores Raney

## SHEEP \& GOAT

 RAISERS NEWSGood-neighbor stock hauling deals can get a fellow in trouble. Out of necessity, many gooseneck trailer owners have been hauling stock part-time for pay. The necessity is often that of helping neighbors whose loads can't attract a bigger rig, combined with the necessity of getting enough service out of the gooseneck to justify its cost.

Whatever the reason, a lot of
these good-neighbor haulers have re-
cently found themselves paying out con-
siderable premiums to their local peace justices because the man who patrols
the highways discovered that they had no legal permit to haul for hire

These permits, known as Specialized Motor Carrier Certificates, are issued by the Texas Railroad Commission and are not to be had on a whim. Many would-be haulers who've tried to get them have given up on the often difficult and expensive endeavor and either quit haviing or resigned themselves to paying fines.

It's not that the permits themselves cost so much -.-- a total of $\$ 25$ for
filing fees and $\$ 11$ per vehicle for

registration -- in fact, that expense is as little as a tenth or twentieth of what some fines have reportedly cost The real expense comes in, apparently, when an application is protest ed by already established haulers. An swering a protest means appearing before a hearing examiner in Austin, proving the public necessity of the desired permit, etc. A certificated hauler must also carry RRC-approved insurance maintain certain records and follow established rate tariffs.

These last three items in themselves are not overly unreasonable or prohibitive, but added to the hassles and expense of battling a protest, the re enough to convince many part-time small-load haulers that fines are friendly by comparison. The end result? A lot of extralegal hauling.

Cooperative efforts by the Texas Sheep \& Goat Raisers, the Texas Farm Bureau and the Texas and Southwestern Cattle Raisers Assn. may be shedding a little different color of light on the subject, however. Representatives of the three groups met recently with RRC officials to seek a solution to what's come to be called the "gooseneck situation"

The outcome may not be apparent right away, because it involves no regulatory, legislative or interpretative change by the RRC. What the commission did offer was a suggestion and it's one of those pleasant cases where a simple suggestion may eliminate e need for a difficult change.

What the RRC suggested was that prospective applicants voluntarily re strict their own hauling authority. A standard permit might allow a hauler the right to use any size of equipment, move unlimited loads and serve a broad territory when all he really intends to do is pull an occasional gooseneck load to the local auction. Tt's aenercan when the price is the same anyway, but such a broad request is sure to generate protest from established competition.

The RRC suggests instead that applicants specify that their authority be limited to such vehicles as gooseneck trailers and that their operating range be limited to their own local area. Other restrictions might include prohibitions against hauling to or from commercial feedlots or packing houses limits on the number of head of stock hauled in one load and limits on the number of loads to be hauled in one day

These limitations, again, are not mandatory, but may be handpicked by an applicant at his own choosing. In fact he himself must request that they be
applied against him. The RRC simply applied against him. The RRC simply says that the more restrictions, the less chance of a protest; larger volume truckers know all too well that they can't service the small loads and have no logical reason to protest competition from a fellow who's been obviously restricted out of competition at his own choosing.

There are no reported plans to lower minimum insurance requirements or alter tariff compliance. The insurance coverage required, however, does not appear out of line anyway,
and one RRC spokesman says special low-volume rate tariffs could be considered upon request

In short, the situation is not perfect, but the outlook is rosier. Th
Texas Sheep $\&$ Goat Raisers' application forms available and would be willing and eager to assist lowvolume livestock haulers who wish to volume livestock apply for permits.
