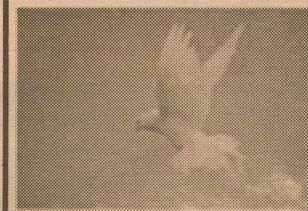

got Borden County on the board first sprinting 65 yards to the endzone and then following a Helio Rosales kick the Coyotes would have a quick 8-0 lead.

After another quick defensive stop, Richey would take off on another 34 yard run to pay dirt and a 14-0 lead and another Rosales kick made the score 16-0. The Coyote defense would hold again and this time trying to pass Richey was forced to take off and as he did he found the endzone a third time in three carries and a commanding 22-0 lead in the first quarter. Matthew Ham recovered a fumble at the Eagle one and TJ Basquez capped the Coyotes third one play drive with the one yard plunge to give Borden County a 28-0 lead. After another defensive stop, Richey finally took to the air hitting Basquez with a 30 yard strike. Rosales got back on track to push the first quarter lead to 36 to 0. On the Coyotes first play of the 2nd quarter, a fifth one play drive was accomplished as Richey hit Kurt Shafer on a 54 yard pass and run. Rosales added the point after kick to extend the lead to 44-0. The Coyote

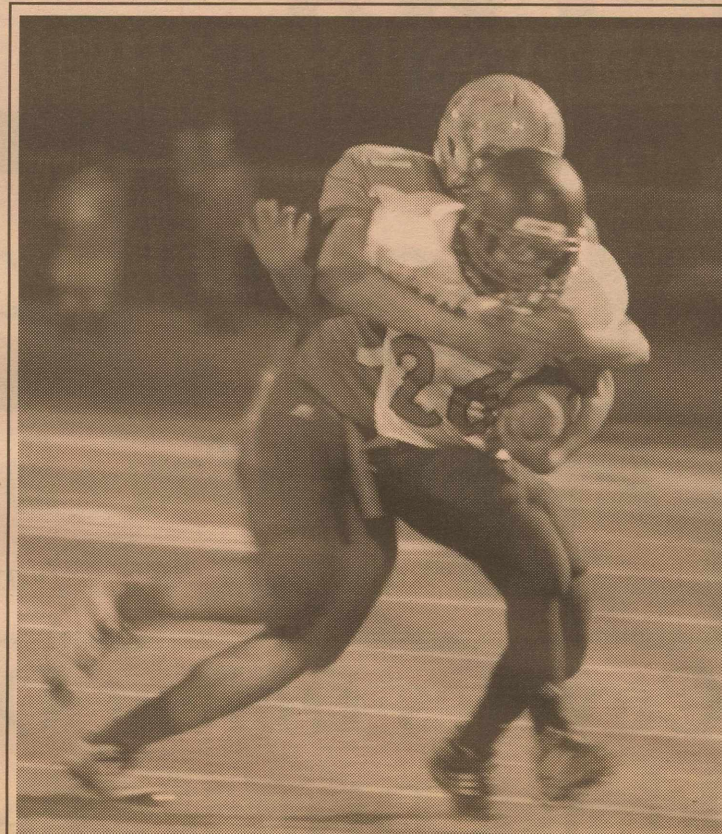
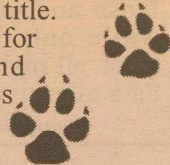
defense forced another turnover, this time an interception by Frank Banman. They used two plays to convert on this drive as Richey hit Tristen Benavidez on a 28 yard pass play followed by a 15 yard strike to Banman for the score and a 50 to 0 lead in the 2nd quarter. With the bench emptied of all Coyote players, the defense continued their dominate play forcing another fumble, this one recovered by Matt Proulx. One play later Steven Howard would find the endzone from 42 yards out and make for a convincing ending to the evening at 56 to 0.

Richey lead the Coyotes with 3 carries for 132 yards and 3 scores and was 4 of 6 passing for 121 yards and 3 more scores, while being in on 11 tackles with 2 for loss. TJ Basquez had a carry for 1 yard and a score and a catch of 30 yards for a score while making 9 tackles with 2 for loss. Kurt Shafer had a 54 yard touchdown catch and was in on 7 tackles, 1 for loss. Steven Howard had the touchdown run and was in on 4 tackles. Frank Banman had the 15 yard touchdown catch, the interception and 6 tackles. Korbin

Martinez had a 28 yard run and 4 tackles. Helio Rosales was 4 of 7 on extra points and 6 tackles, 2 for loss. Jared Smith had 5 tackles, Luis Andrade had a tackle, Tristen Benavidez had the 28 yard catch and was in on 4 tackles. Matt Proulx and Matt Ham each had a fumble recovery and 4 tackles. Matt Roberson had a tackle and several nice blocks.

The Coyotes will next start phase three of the season and work toward their second goal of the season as they will play the Meadow Broncos, Friday at 7:30 in O'Donnell.

Lady Coyotes Start 2012 Season Off With Two Heart Stomping Games

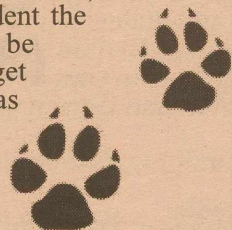

The Lady Coyotes started the ranked Pre-Season #20 in TABC poll and traveled to Spur to open up there season last Tuesday. The Lady Coyotes find themselves down at the end of the first quarter 12-10, but Coach Skelton points out that it was actually worse than it looked. "We started the game down 9-0 and I remember thinking this is not how I imagine this night going." "Then one of our groups got in and then sophomore Tye (Basquez Sophomore) got things going by hitting a 3 and we righted the ship for a moment." The first half ended with the Lady Coyotes tied 16-16 all. Then after the third quarter the Lady Coyotes were down three points 26-23. As the game ticked on the late in the fourth around the 35 second mark the Lady Coyotes were still down three. "I remember seeing Kylie (Voss Senior) trailing after we had stolen a ball and I hollered at Taylor (Gass Junior) to hit Kylie for a wide open three." "The place exploded when she knocked it down, and then we pressured the ball, and Kylie stepped in front of a pass at half court, and made the game winning lay-up with 2.2 seconds left in the ball game." "It was unreal to say the least."

The second contest played on Saturday was against the #9 team in the State Roby Lady Lions. Once again the crowd got its money's worth. The Lady Coyotes once again found themselves down two points 13-11 after the end of the first quarter, and at the end of the first half the Lady Lions of Roby had built a six point lead 27-21. The Lady Coyotes stormed backed in the third quarter winning it 13-6 taking a one point lead into the fourth quarter. "In the winding seconds down 4 Dean-O (Kaylyn Dean Senior) tipped a ball that

was picked up by Clair (Shafer Soph), and started the fast break. "We missed a 3 pt. and Dean-O keeps the ball alive, we took another 3 from the top of the key and missed and Dean-O got the rebound and put this one in." Then Tye stole the inbound pass, and was tied up giving us the ball under the basket." "I think everyone can see we have some issues we need to work on before district rolls around, and I am confident the girls will be ready to get those areas fixed."

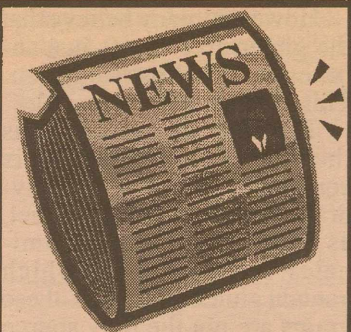



Gluten-Free is Not the Same as Low Carbohydrate

Those with celiac disease cannot tolerate the protein gluten that is found in wheat, rye, and barley. (Gluten can also be found in oats if they are processed in the same plants that process wheat.) Although it is sometimes simply called *gluten intolerance*, celiac disease is an intestinal disorder. For people with celiac disease, gluten damages the lining of the small intestine. The damaged intestine cannot absorb nutrients very well, which can lead to malnutrition and other symptoms such as abdominal pain. Because those with this lifelong disease cannot tolerate the gluten in wheat, they require a gluten-free eating plan.

However, many believe that the gluten-free diet is just another weight loss regimen. This is not true.

The first misconception is that the gluten-free diet is equivalent to a low carbohydrate diet. A gluten-free diet, as mentioned before, eliminates certain grains, which contain gluten. However, these grains are not the only source for carbohydrates. Other carbohydrate sources include gluten-free grains (such as corn, quinoa, and rice), vegetables, fruits, milk, and other items that contain sugar or starch. The gluten-free diet allows carbohydrates as long as they do not contain gluten. (If you have celiac disease, gluten intolerance, or a wheat allergy, be sure to read the ingredient list and check the allergy warnings on food labels to ensure that the product does not contain items with gluten or wheat.)

Another misconception is that carbohydrates, grains and wheat in particular, are the villains. There are different reasons for this belief; but, the truth is that there is no evidence to support this idea. Carbohydrates are the only energy source for your brain and your

red blood cells. Without consumption of carbohydrates, ketones produced from the breakdown of fat can cause the body to go into a dangerous condition called metabolic ketoacidosis. On the other hand, diets without wheat *can be* nutritious; however, these diets must be managed very carefully. The average gluten-free diet only contains 6 g of dietary fiber, which is significantly lower than the recommended 25-38 g/day. Therefore, a major drawback and difficulty to eliminating wheat from the diet is meeting fiber requirements. Additionally, many people who follow a gluten-free diet do not receive adequate amounts of some other vital nutrients, such as iron, B vitamins, antioxidants, and folic acid.

A final misconception is that gluten-free diets promote weight loss. In reality, any weight loss seen with a gluten-free diet is likely due to the overall limitation of food options and thus calories in the diet and not due to gluten or wheat being harmful or fattening. In fact, diets such as a low carbohydrate diet may result in more weight loss initially but eventually have a higher drop-out rate compared to a more balanced diet that does not eliminate entire food groups.

Gluten-free diets are medically necessary for those with celiac disease or a gluten intolerance but not indicated for the general public. Eating more whole-grain foods remains an important health recommendation.

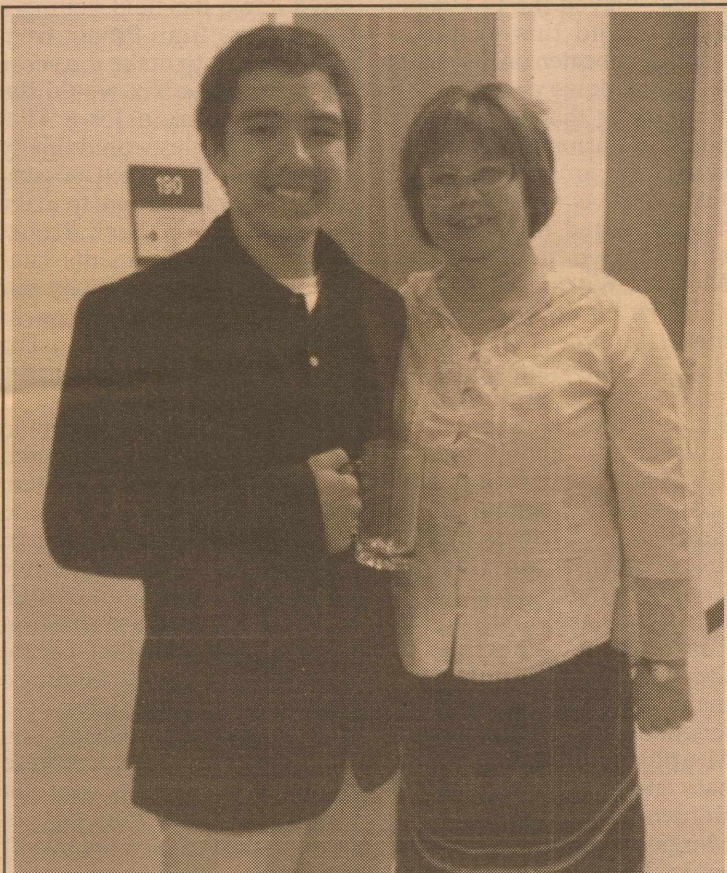
Freshman Debater Wins Novice Division at WTAMU Tournament

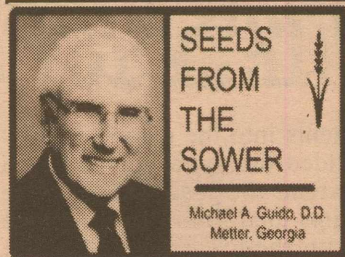
Debating the current issue

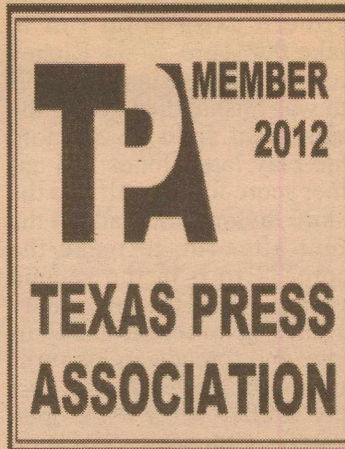

ments into the game. Richey added the extra point kick to extend the lead to 8-0. The Pups then followed that score with their 2nd nice defensive possession not allowing a first down. In fact the defense did not give up a first down the entire game. After forcing another Eagle punt, Hunter Jones hooked up with Corbin Sumners on a perfectly executed 62 yard screen pass. Richey connected with his second PAT kick to make the score 16-0.

On the first offensive possession of the second quarter for the Pups, Jones sprinted in from 32 yards out, then Jones connected with Yarbrow for the point after to push the lead to 23-0. The only negative play of the evening happened on the ensuing kick-off as the Pups failed to tackle the Eagle sprinter and he raced 72 yards for the kick-off return and their only points of the contest to cut the lead to 23-6. Borden County wasted very little time getting those points back as Richey raced 35 yards to paydirt followed by a Ryan Wilborn extra point run to make the score 30-6. Richey recovered the ensuing kick-off but was mishandled giving the Pups great field possession. One play later, Jones had another score for himself and the team. Jayton Lewis added the point after run to make the score 37 to 6 in the second quarter. The Borden County defense again rose to the challenge and forced a quick turnover on downs. On the first play Richey hit a wide open Braxton Coor for a big gain before Richey scampered the final 13 yards on the next play to extend the first half lead to 43-6. On the point after Jones hit Kace Lott on a nice pass play to make the score 44 to 6 at intermission.

The second negative play happened to the Pups on their first offensive play of the second half as they fumbled the ball away deep in their own territory. Then following another defensive stop the error was quickly exonerated as they scored on the same play that the mishap occurred as Corbin Sumners out raced the Eagles on he set sail on a nice 75 yard run, giving the Pups an insurmountable 50-6 lead. 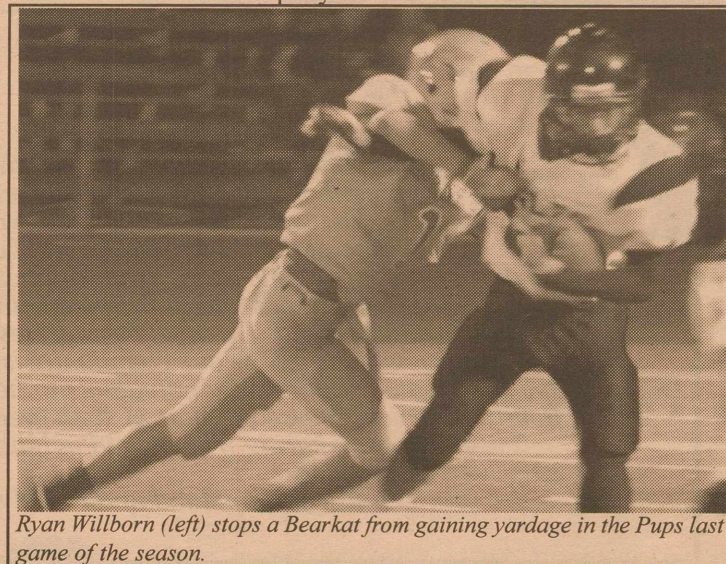
County got yet another defensive stop on the next Eagle possession and then on the first play Jayton Lewis sprinted around the edge on a trap play from 38 yards out to end the game by the mercy rule at 56-6 and cap off the perfect season.

Earlier in the day, the group of 8th graders Dylan Murphy and Hunter Huse and 7th graders Brian Torres, Nick Proulx, Braxton Barnes, Thadd Basquez, Clayton Addison, Morgan Wilson and Kable Kleck played the O'Donnell B team and this group remained unbeaten on the season as well winning every game or scrimmage that they participated in during the 2012 season. This group got off to a fast start as well as Brian Torres scored from 30 yards out to take a quick 6-0 lead. Morgan Wilson hit Clayton Addison for the extra point to make the score 7-0. Wilson then found Dylan Murphy 22 yard scoring pass after the Pups forced a turnover on downs by the Eagles to take a 13-0 lead. Nick Proulx tackled an Eagle runner in the endzone for a safety and two more points for Borden County to make the score 15-0 to close the first quarter. Torres added another score for the Pups from 17 yards out to make the score 21 to 0, this touchdown was set up by a big Murphy to Braxton Barnes pass and catch. After another Borden County defensive stop Morgan Wilson, shrugging off an ankle injury, found classmate Proulx on a nice 3 yard scoring pass and catch. This touchdown was set up by a

nice Wilson to Kable Kleck 18 yard pass play. Wilson would leave the game for the remainder of the evening with his ankle injury, but Murphy would step into the quarterbacking role and the Pups would continue to role. With a 27-0 lead, Torres would extend that lead with a 38 yard run, followed by a Murphy to Addison extra point pass the Pups would take a commanding 34 to 0 lead into the locker room.

The Pups would take the opening kick of the 2nd half and drive down the field getting a quick score from Proulx from 56 yards out to make the score 40-0. Thomas Nix would run the extra point in for a 41-0 lead. The Eagles would finally respond on their next possession driving for a score to make the game 41-7. Nick Proulx would answer moments later for the Pups reaching pay dirt from 39 yards out. The touchdown made the score 47-7. The Eagles would add a score in the 4th quarter to make the score 47 to 14, but Thomas Nix would get into the action as he scored from 25 yards out on a nice run, then Murphy would hit Thadd Basquez for the point after to make the final score at 54 to 14.

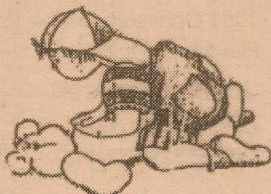

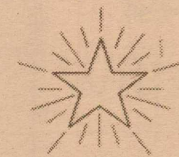
