

Coyotes Claim 6th Straight District Title

Borden County Coyotes may have not taken on the appearance early of what was first thought they would look like with all but two players having little to no varsity experience heading into the 2013 campaign. However, that did not stop this group from having the same goal when the season began, with that goal being a 6th straight district championship. In order for the Coyotes to accomplish this goal, the Coyotes would have to travel to play the teams that were projected to finish 1-2 in the district. In fact, after only beating the Cougars a week earlier by the score of 28-26 the Coyotes were a 24 point underdog according to several dif-ferent polls. That however did not discourage this young group of Borden County Coy-

With the district championship on the line the home town Wildcats got on the board first taking an early 8-0 lead with 7:51 left in the first. That would be the only lead the Wildcats would have during the course of this title tilt. The Coyotes as they did most of the evening scored very quickly as Corbin Sumners, following the superb blocking of end/full-

Nathan Ham, End Colby Pennell, Center Frank Banman, fullback Korbin Martinez, Quarterback Riley Herridge, sprinted 51 yards on the Coyotes first play from scrimmage. Herridge added the point after as Michael Taylor snapped to the holder Mason Coor making the score 8-8 with 7:42 left in the first. The Coyote defense of Banman, Benavidez, Jayton Lewis,

The 2013 version of the back Tristen Benavidez, Guard Hunter Jones, Sumners, Pennell, and Korbin Martinez forced a turnover on downs. Taylor will be running this Saturday November 9th 2013 in Round Rock at Old Settlers park at 9 am.







With a slow cooker you can cook larger quantities and as round, chuck, freeze the extra for future meals. Meal preparation varies by the meats, vegetables, and seasonings you choose. 


