9,300 Foot Project Will Be Drilled Northwest of Here

Intex Oil Company of Midland and Universal Consolidated Oil Company of Dallas No. 1-37 Bedford Heirs is to be a 9,300 foot operation in West Yoakum, five miles northwest of Plains.

It is 1,980 feet from north and east lines of section 307, block D, John H. Gibson survey.

Honolulu Oil Corporation No. 9 Paul Cobb and others is a new project 66 miles northwest of Tokio in the Prentice field.

Location is 1,980 feet from west lines and 660 feet from north lines of section 381, block D, J. H. Gibson survey.

Leland Fikes of Dallas No. 1-A Ed S. Smith Heirs, West Yoakum County operation has been abandoned at 6,824 feet. It was seven miles southwest of Plains and 660 feet from north and east lines of section 640, block D, John H. Gibson survey.

The project was an old dry wildcat to total depth of 5,300 feet which Fikes originally planned to drill to 13,600 feet to test the Devonian.

It is one location southwest of the opener of the West (Devonian) pool.

The Texas Company No. 2 W. F. Walker, is a new location in the Wasson (Wolfcamp) field of Yoakum County.

Drillsite is 1,980 feet south section 794, block D, John H. and 660 feet from west lines of Gibson survey, 7 miles northwest Denver City. It originally had been the Texas Company No. 1 W. F. Walker. Total depth will be 8,650 feet.

J. G. Brown and Associates No. 1 E. W. Jones has been completed as a discovery in Yoakum County.

Operator reported a 24 hour pumping potential of 124.39 barrels of 30.9 gravity oil through perforations from 5,232 to 5,269 feet, after 3,000 gallons of acid had been used. Gas-oil ratio was reported as 380-1.

Location is 1980 feet from west and south lines of section 391, block D, J. H. Gibson survey.

Monsanti Chemical Company has completed No. 4 Ken with a pumping potential of 12.71 barrels of 22 gravity oil from perforations of 5,185 to 5,283 feet.

The well is located 2,130 feet from south and 660 feet from west lines of section 269, block D, John H. Gibson survey.

Attend District Baptist Convention

New Streets to Be Opened, City Council Decides

At a meeting of the Plains City Council last Thursday night the Council voted to assist in opening some new streets to serve the north and northwest parts of town.

The streets that have been taken into consideration are Ave. G from the light plant to the north city limit, and Second and Fourth streets from the northwest addition to Ave. E, which is the street on the east side of the park.

Several citizens living in the northwest part of town have asked that the streets be opened to allow traffic to reach the area around the park without having to travel back to town.

County commissioners have offered to open the streets after the city has staked the lines. Lowering of a water main will be required on Ave. G north of the light plant.

In other business transacted by the City Council, application was made for workmen's compensation and public liability insurance for the city.

Hobbs Man Killed In Wreck Tuesday

Yoakum County's traffic toll for this year climbed to five Tuesday morning when a 57-year-old Negro from Hobbs was killed when the car in which he was riding collided with a highway department bulldozer. The accident occurred about two miles northwest of Plains on Highway 380.

Killed was Hallie Green, with another passenger, Eloise King, 33, also of Hobbs, seriously injured in the crash. Green was taken to the Denver City Funeral Home and later taken to a funeral home in Hobbs. The King woman is in Yoakum County Hospital.

Officers are still searching for a third person believed to have been riding in the vehicle, and thought to have left the scene

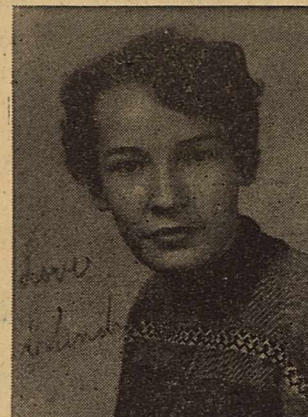

Postal Receipts Up This Quarter

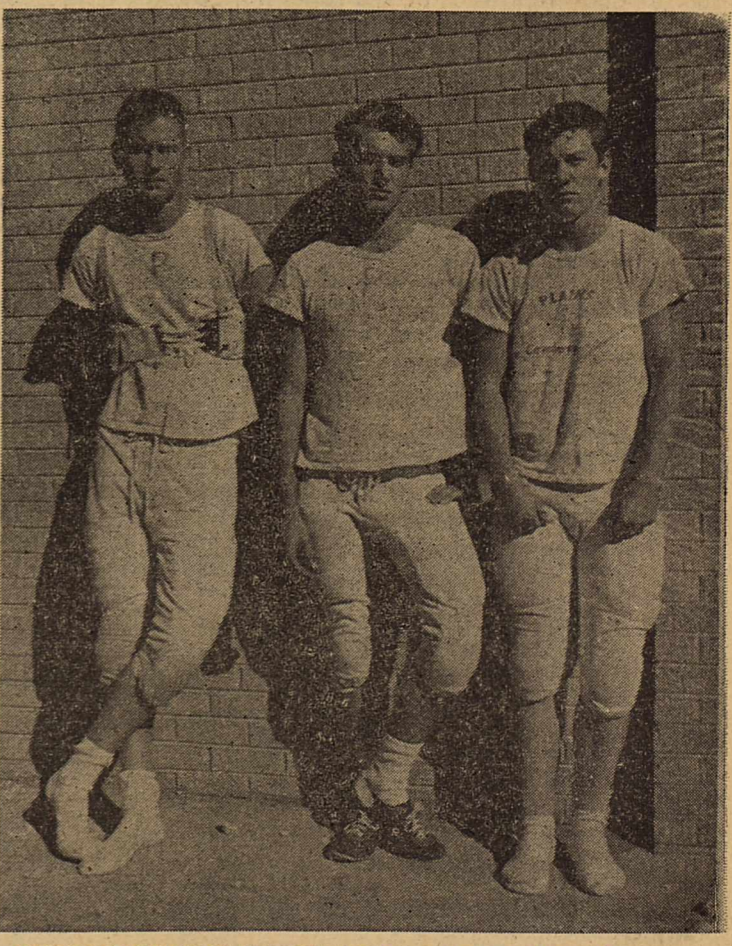
An increase in postal receipts for the third quarter of this year was reported this week by the local post office.

SHOP IN PLAINS!

ACROSS THE CATTLE GUARD

The delegation of Yoakum County folk who attended the State Fair at Dallas last week came home in good spirits and in good health. One of the things that we were afraid of before we left was that someone would get sick but everyone came through in good shape. There was a great deal of sickness among the exhibitors from over the state. Some of them sent their animals and had other boys handle them while others had to be taken home about the middle of the week.

Our reason for going to the Fair was to take four steers entered in the Junior Livestock Show by Margaret Henard, Marsha K. White, Kenneth McCinty and Harold Lee Swann. Going along with these four 4-H Club members were Mr. and Mrs. Robert Henard, Mr. and Mrs. Garland Swann and Mr. and Mrs. Leo White. This is the fifth year that Yoakum County 4-H members have entered livestock in the Dallas show and we came out this year with the highest placing of any of the five years. Margaret Henard placed fifth in the light weight Hereford class. Her calf sold for 35c a pound in the sale last Friday. Kenneth and Harold Lee each had calves in the Market Steer Show and were choice. Kenneth's calf sold for 25c a pound and Harold Lee sold his calf for 24c. The State Fair will add to the price of these calves and all animals that graded choice will receive 26c a pound.

Marsha was the one who had hard luck. Her calf was in the medium weight Angus class in the Fat Steer Show and there were fourteen calves in the class. Her calf placed 12th and they only give ten ribbons. She was all lined up to sell her calf with the group of non-placing calves when the Assistant County Agent from Hale County offered her \$237.50 to lead him out and let him take him back to Plainview. That figured about 26c a pound for her calf and the others sold just minutes later for \$23.90 cwt.

This year there were more calves at the State Fair than we have ever seen there before. About 200 more calves were entered this year than last year. Most of the increase was in the Market Steer Show where the animals were graded into either prime or choice group. They had a sifting committee that took out about 125 of the more undesirable calves and we felt good last Tuesday afternoon when all four of our calves stayed in the show. Within the next few weeks we will be looking for calves to take to the Fair next year. We would like to have weaning age calves that weigh about 400 pounds. After they have been on feed for 10 or 11 months they will weigh about 1,000 pounds and they will be fat enough to stay in the Show. In order for them to place very high, we will need to start with a calf that is deep, thick and heavy set. If we can find calves of the right type we can enter the best ones in the Fat Steer Show again and the others in the Market Steer Show. The little calf that was Reserve Champion Angus was a dry lot fed animal. Many of the other calves in that division were also fed without the aid of a nurse cow.

Homespun Hints By Myrna Marshall County H. D. Agent

On September the 26th and 27th, seventeen home demonstration agents met in Plainview for a meeting on household equipment. Purchasing and repairing household equipment was discussed by the group. Several things are important to consider before you purchase equipment for your house.

"The first point to consider is 'What does my family need?'" The appliance will need to be worth the money invested in it. Consider also, "How often will my family use the appliance?" An expensive waffle iron may not be used enough to justify the money spent on it. Remember to check the wiring of the house to be sure that the circuit will not be overloaded by the new appliance.

"Notice if the appliance will be expensive to operate. An example would be an inadequate water supply for an automatic washer which uses several gallons more per load than the wringer-type machine.

When buying electrical appliances, buy those which have the "UL", Underwriter's Laboratories seal of approval. Such appliances have been tested for electrical and mechanical safety.

Be sure to read the instruction book which comes with the appliance. It will give the hints on the way to obtain the best service from the appliance.

It is almost time to get out the electric blanket. It may be a problem of how to wash the electric blanket. The Good Housekeeping, March 1954, has some good suggestions for the housewife.

"Automatic electric blankets, like regular blankets, should be fresh and clean when they are put away for the season. But they should always be washed, never dry-cleaned, because dry-cleaning fluids may injure the wiring system. Good Housekeeping research workers have washed many automatic blankets, and they recommend two machine-washing methods that are gentle enough to use on any electric blanket. One is for agitator-type washers, the other for tumbler types. (Incidentally both methods were developed by washer manufacturers.) But don't let a blanket get too soiled. Wash just one blanket at a time, and follow exactly the procedure given as right for your washer. The gentle washing will be kind to the blanket and will protect it against shrinkage, an important point, since automatic blankets contain wool.

AGITATOR - TYPE AUTO-

MATIC WASHER. This method is called nonagitated washing because the agitator is removed from the washer after the suds are prepared, and it is not used during the washer procedure. Fill the washer with warm water — about 100 degrees F. Add 1 cup of mild synthetic detergent, and agitate until dissolved. Stop washer. Remove agitator. Immerse blanket in washer, and close cover. Set control dial for 10-minute wash. Allow washer to proceed through all cycles and stop. Remove blanket, shape over two clotheslines a few inches apart, and let dry. Press bindings with steam iron or dry iron set at low heat.

TUMBLER - TYPE AUTOMATIC WASHER. This method combines a soaking with carefully-timed washing and spinning. You can't leave the washer unattended. Place blanket in washer, fill washer with warm water, adding ½ cup of low-sudsing detergent. Then stop washer. Soak blanket for 5 minutes; then tumble it 1 minute. Advance dial so water drains out. Then advance dial a second time, and let washer fill for deep rinse; run for 1 minute. Finally, turn dial to give final drain, for 2 minutes, or until drain hose stops ejecting. Remove blanket; dry and press as directed for agitator-type washer.

"The Freshmen are looking good," Coach Dahl said.

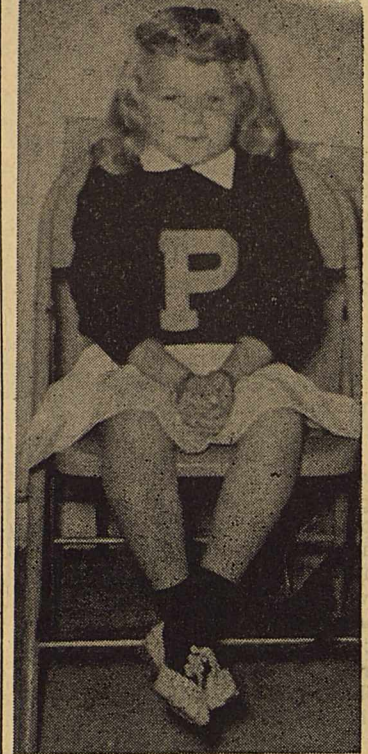
Denver City's score was made on a pass from Burt to Bill Gravitt.

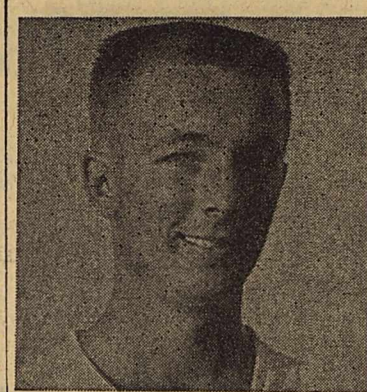

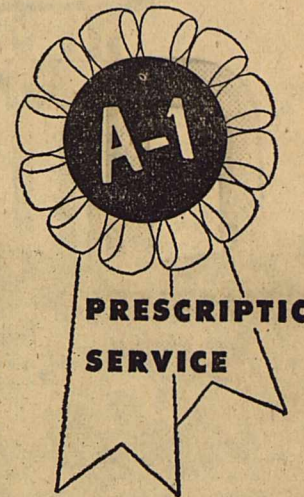

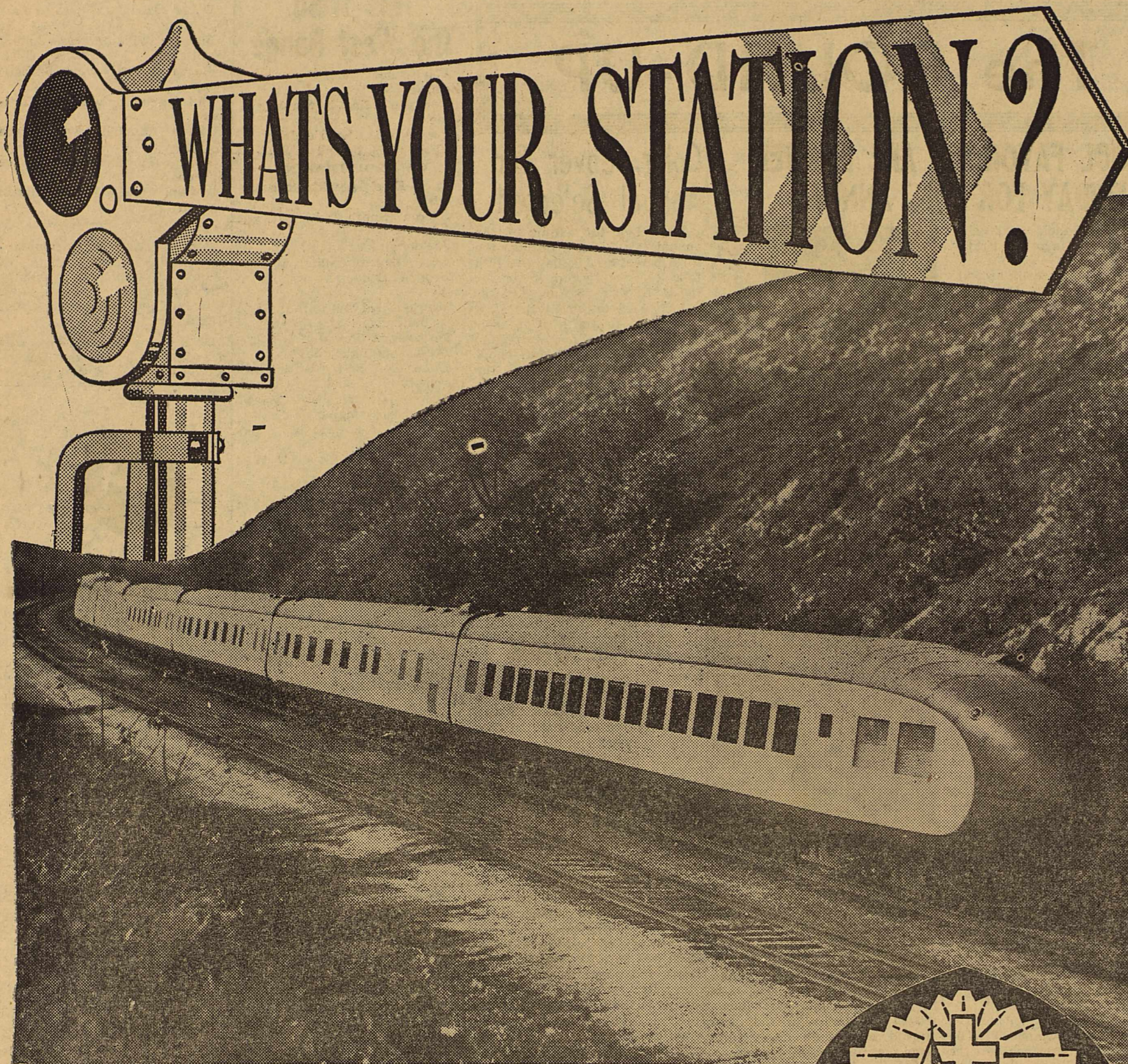

Sunshine Boosts Hopes of Farmers For Cotton Crop

Oh! Man Sun, conspicuous by its absence for almost the past week was greeted Wednesday with thanks by county farmers who had been faced with steadily mounting crop damage due to the rainy weather which had buffeted the area for several days, especially since Saturday.

The sun, coupled with a good wind, was drying out the fields enough to allow a few hands to be put in the cotton fields by Thursday.

With less than 10 per cent of the cotton out of the fields, most of the farmers felt this week that with a little luck and continued good weather, plus a sufficient supply of help, they would be able to go over the fields before frost.

Estimates are now placing the cotton crop in the county at 17,000 bales, some below the 19,000 bales made last year. There are a total of 31,000 acres in the county planted to cotton, it was reported.

Although accurate gauging of the rainfall over the weekend was not available, local reports placed it at about three inches.

THIS WEEK IN AUSTIN

By Preston Smith

One of the main targets of the special session is a better lobby control bill which would, among other things, better define ways a trade association or interest group could have its voice in state government.

Mainly, though, new lobby control measures will prevent bribery situations which in the past have cost Texas plenty. Just exactly how much it has cost the state would be impossible to find out.

One measure introduced in the Senate has to do with "direct communication." This bill would allow a lobbyist to spend any amount of money on a lawmaker for entertainment without reporting it, as long as he didn't mention legislation during the entertainment.

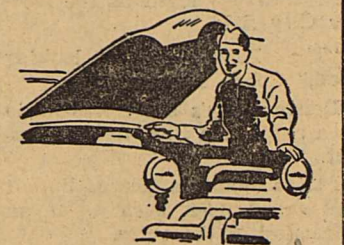
"Direct communication" has been defined as "any personal appearance before a legislative committee, or any personal contact or communication with any member of the Legislature for the purpose of explaining, discussing, or arguing for or against pending or proposed legislation or any action thereon by the Legislature, the Governor, or the Lieutenant Governor."

Under this bill, by Sen Crawford Martin, only those persons who make total expenditures of more than \$50 during any one calendar year through "direct communication" would be required to file an accounting of the money spent.

The effect of entertainment on legislation is a subject that can be debated in the Legislature from now on.

Even when trade associations, civic groups, private industry and other sponsors entertain groups of legislators through their Austin contacts, legislation is seldom if ever mentioned.

With discussions underway in the Senate, action is underway toward lobby control measures. Just what the final outcome of this work will be, we can only wait and see. At any rate, it is a subject well overdue for consideration.

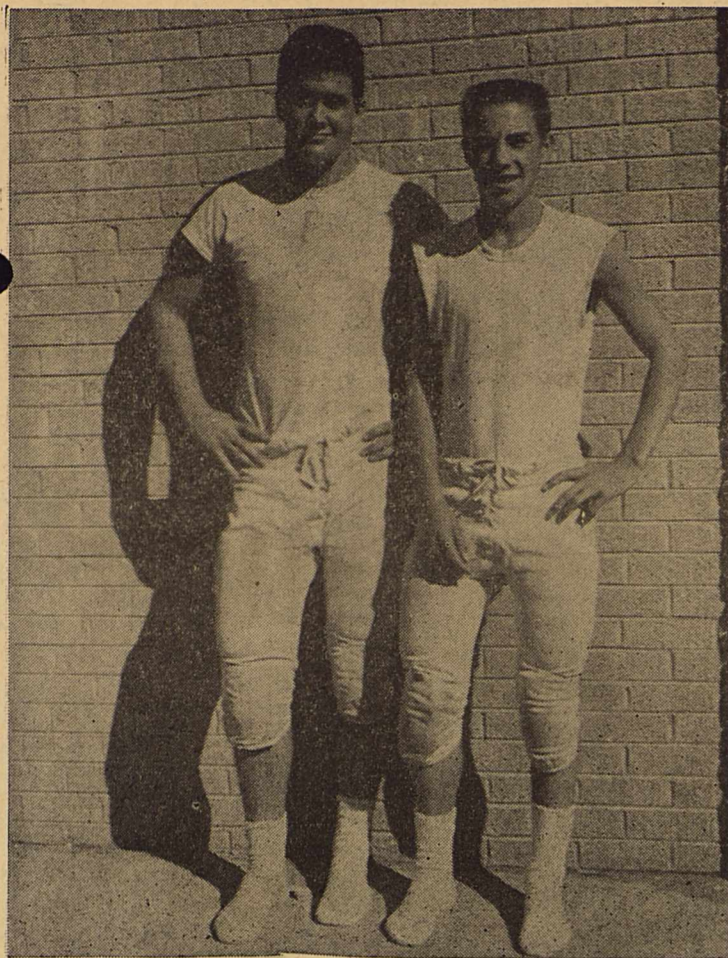

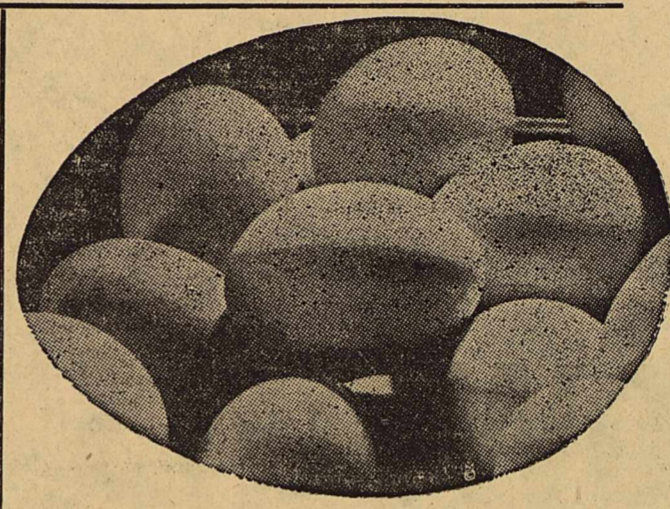

OUTDOORS IN TEXAS

Literally, the weather is great for ducks.

A lot of Texans, you may be sure, have been thinking it over, inasmuch as the duck season opens November 1 and extends to December 30.

Big rains this year have broken the drouth along the Gulf Coast, providing plenty of surface water for the birds. Conditions in the marsh areas of the upper coast are the best in 10 years.

There will be an excellent crop of such native waterfowl food as wild duck millet, smartweeds, duck potato, and pondweeds.

Along the lower coast, the duck prospects are also very good. October rain caused habitat conditions to improve rapidly.

Add to all this the fact that the duck breeding season in the North was a successful one, and you have every indication of good duck hunting in Texas during the coming season.

Many varieties of ducks come to Texas with the cool winds of Fall.

Of the various kinds, the mallard predominates. A graineater, the mallard's flesh has a mild flavor. Fish-eating ducks have a stronger taste.

Biggest of the ducks available to Texans is the American Merganser, which may go to four pounds. Smallest is the green-winged teal, averaging three-quarters of a pound.

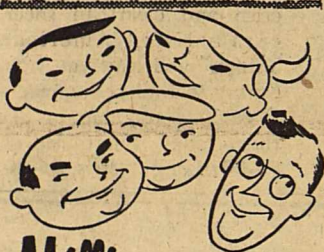

1960 Census to be Taken on Different Basis in County

In a joint program with the state and each of its counties, the U. S. Census Bureau is establishing areas, known as "Census County Divisions" for use in statistical reporting. Similar areas were established in Washington prior to the 1950 census, and since then have been put into effect in 11 other states.

Jack Burkhardt, member of U. S. Census Staff, spent the latter part of last week here consulting with officials and seeking their advice in regard to the proposed areas for Yoakum County.

"The proposed Census County Divisions should be of much use for local administrative purposes," explained Burkhardt. "The Census County Divisions generally are larger in area and population than the justices or commissioner's precincts. They have clear-cut boundaries which can be identified easily, and they are intended to remain as permanent areas."

The staff member went on to say that the Census County Divisions—of which there will be two in Yoakum—are based on the communities which serve as the focal point of each area.

Burkhardt continued: "The statistical data for these divisions will serve as a yardstick with which to measure the sphere of influence exercised by such communities. It is believed that the divisions will be a hand tool for the use of county officials, local newspapers and business and civic organizations."

For the 1960 census purposes, Yoakum County has been divided into two census county divisions, Denver City and Plains.

Urge Caution by Motorists During Hallowe'en Time

Now that the haunting season is here again, little make-believe ghosts and witches are advised to see and be seen on Hallowe'en. J. O. Musick, General Manager of the Texas Safety Association, asked parents, today, to help Back the Attack on Traffic Accidents by cooperating with TSA through following a few simple rules to protect their own little spooks.

"We want our youngsters to be a treat and not a trick to drivers," Musick said. "In the first place, they must see, and see well. Many false faces limit the vision of anyone wearing one—makes it hard to see approaching cars. I strongly advise parents to help the kids disguise their faces by using makeup. Rouge, lipstick and eyebrow pencil can do an amazing job of painting weird and funny faces on freckle-faced and rosy-cheeked boys and girls."

Musick also stressed the importance of being seen. He appealed to parents to see to it that the youngsters wear costumes made of light-colored or reflectorized material. These precautions aid drivers in seeing the trick-or-treaters, should they dart into the street. "Actually, the best Hallowe'en traffic accident prevention is to keep children off the street at night," Musick said. "Of course, this is not an easy thing to do. But parents can get together and arrange indoor parties at Community centers or in their homes. Those parties will keep our make-believe spooks from taking the chance of becoming honest-to-goodness ghosts."
