Acrospirits Earn "Ticket" To World Competition In Paris

South Plains Acrospirits competed July 1-7 in the United States Acrogymnastic Federation National Championships in Mobile, Ala. Twenty-six members of the group competed in power tumbling, trampoline, double mini and synchronized trampoline. Their coach is Sherry Lowrey.

Thirty-one individual awards were won by the youngsters. In addition, they were named the National Trampoline Champions for 1986. The team placed fourth in tumbling against teams from all over the United States. Some 625 competitors entered the competition.

Competitors from Plains were Ladd Winn, second double mini, second synchronized trampoline, fifth in tumbling and fifth in trampoline; Ashlee Winn, sixth in synchronized trampoline and fifteenth of 72 persons in tumbling; Will Green, second in synchronized trampoline, seventh in trampoline and eighth in double mini and Penny Green, eighth in synchronized trampoline.

Shyloh Winn and J'Lyn Green competed in the meet in the eight and under division and did a "real good job" said Coach Lowrey.

Traveling to Paris, France Oct. 11, Ladd, Ashlee, Shyloh, Will and Penny will compete in the World Championship Meet.

Commissioners Court

Special session of Yoakum County Commissioners Court was held July 10 so that members of the court could attend NACO Conference on the regular meeting date, July 14.

The monthly report of taxes collected for June was approved as presented by Tax Assessor-Collector Wanda Smith.

A partial payment of \$5,000 to Mickey Kennedy for roofing at Yoakum County Park was approved. Also approved was a motion to re-hire Luis Villareal at his previous salary of \$2,013.59 per month effective July 14. He replaces Wilson Edwards.

Commissioners okayed a motion to pay \$253.08 for the County's part of expenses of Court Reporter Sandy Vining to attend National Reporters' Convention in Boston Aug. 6-9.

An order appointing election judges and alternate judges was approved with election precinct boundaries remaining the same as set by a Sept. 15, 1981 order.

A maximum number of clerks that may be appointed to serve at each election precinct for one year was set at five.

A branch office for absentee voting in Denver City's community building and appointment of deputy clerks for absentee voting was established. Temporary deputies at the branch office will be Pearl Prewitt and Sheron Smith. Full time deputies in the County Clerk's office will serve the main office.

Under estimated expenses when the budget was prepared led to budget amendments which were approved.

June bills were approved for payment.





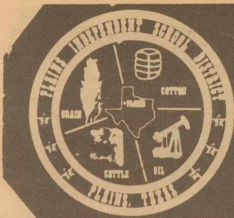
