Events will include team roping,

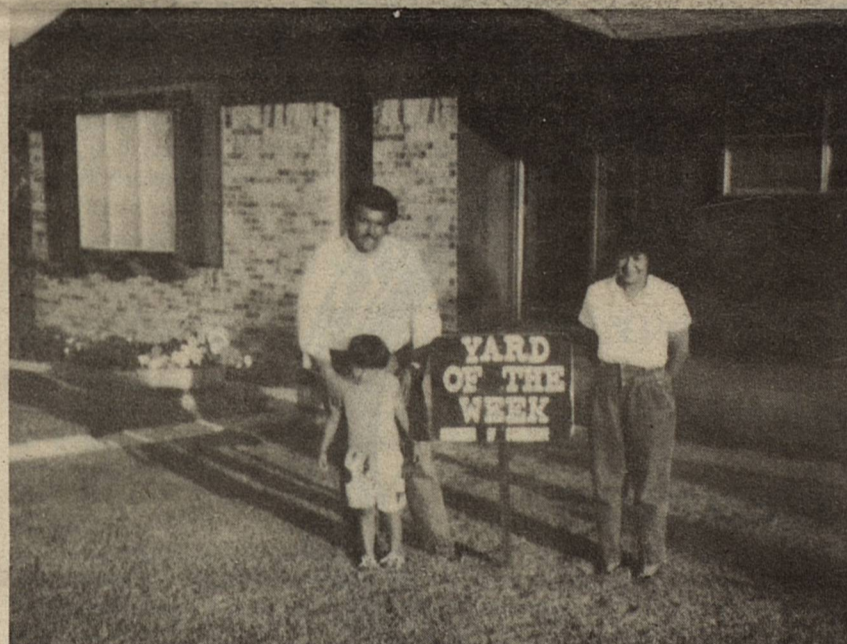

County Extension Service To Conduct Pest Clinic

Yoakum County Extension Service will be conducting a pest management clinic on July 31, from 9 a.m. to 4:30 p.m. at various locations throughout the county.

Topics covered at the clinic will be 1) Pest identification for cotton, peanut and maize; 2) How to know when to spray for best economic potential 3) Economic benefits of pest management 4) Lawn and garden pests and how to control them. (This particular session will

only be available at McPherson's Farm and Chemical in Denver City.)

The time schedule is 9 a.m. - Anderson Grain, Plains; 10:15 a.m. - New Tex Gin; 1:00 p.m. - Denver City Farm and Chemical (lawn and garden pest advice, as well as field crops will be given here); and at 3:15 p.m. - Anderson Grain, Tokio.

Dr. Jim Leser and Dr. Pat Morrison will be conducting the clinics. They are regional Entomologists with the Agricultural Extension Service.

Oil Overcharge Refunds Sought For Farmers, Ranchers

Between Aug. 19, 1973 and Jan. 27, 1981, a number of oil companies illegally charged excessive prices for crude oil. These overcharges were passed on to consumers of petroleum products. Texas Farm Bureau is working to help farmers and ranchers receive their portion of these oil overcharge refunds.

Farmers and ranchers are eligible for a refund for all gasoline, diesel fuel, heating oil, propane, motor oil and lubricants used on or off the farm purchased between August

1973 and January 1981. Refund amounts will vary, but will be between \$0.0008 and \$0.0015 per gallon.

Texas Farm Bureau recognizes that this is a time when "every dollar counts" for many operations. It is their hope the rebate offer will be worthwhile.

A Department of Energy form is available to persons through the local Farm Bureau office; Plains Yoakum County Farm Bureau at 902 Ave E, across the street from Yoakum County Library.

From The Superintendent's Desk



DEAN ANDREWS

This week the special session of the Legislature adjourned with the news of additional taxes to support our state government. There are several bills that directly affect our school district.

1. \$5.7 billion tax bill which is the largest in Texas history. Six percent sales tax and levies on previously non-taxable items.
2. Taxes on the services of doctors, lawyers, dentists, accountants and real estate brokers.
3. Making the State Board of Education an appointed board permanently.
4. Delaying the implementation of Career Ladder Level III and IV until the 1989-90 school year.

The things that we did not see during this Legislative session are those changes in House Bill 72 that Governor Clements had called for during his bid for election. We hardly heard of the six weeks suspension period called for in the "No Pass, No Play" clause, nor did we hear about making the State Board an elected board by 1988. I am amazed at the power of the Speaker, Lieutenant Governor, and H. Ross Perot, and so are many of our elected officials.

Many good things come out of each Legislative session and we sometimes overlook the good by focusing on areas where we were disappointed.

In spite of all the problems we face, this country still provides a head-and-shoulders above all, good life.

Kennedy Introduces Bill To Mandate Employee Aid

Senator Edward M. Kennedy (D-Mass), chairman of the Senate Committee on Labor and Human Resources, has introduced a bill to mandate universal employee health insurance. The proposal has caused alarm among many small business owners across the country.

According to an article in the July issue of "Nation's Business", the Kennedy plan would require employers to buy health insurance for 24 million uncovered employees and dependents at an average cost of \$1,186 for each worker. The employer would pay at least 80 percent of premiums and 100 percent for low-wage employees.

According to the legislation, low-wage employees are those earning up to 125 percent of the federal minimum wage. Total cost of the mandated health care plan would be \$25 billion a year for all businesses but small companies would bear the brunt. Nearly half of all uninsured workers are in firms with fewer than 25 employees.

Granddaughters of Mr. and Mrs. A.B. Chitwood, Donna Reed and Cindy Vannatta, are quoted in the article. The sisters opened a day care center last year in Waco.

Their company, "New Horizons Learning Center", employs 22. "We're already regulated to death and our money is tied up in loans we took to start this business. We can't pay any more," says Ms. Reed.

Patricia Albers, secretary-treasurer of Beckman and Gast Canning Company in St. Henry, Ohio is also quoted. She worries about the "astronomical" costs the plan would be for her company which has 15 full time employees and hires another 185 people for six weeks during canning season. "The entire scheme is mind-boggling to an employer of our size and type," she says.

All 50 states have rules about how health insurance is written but a growing number of those states have begun ordering cost-benefit studies of their own mandates.

Quoting the Nation's Business article, "Congress, going further, has been getting into the area of specifying which groups and individuals should be covered. In addition to the cost, regulatory and paperwork burdens involved in this approach, business is concerned about a larger question -- the growing tendency of Congress to force employers to underwrite costs of social programs that would be politically troublesome to the lawmakers if the bills were presented to the taxpayers.

"Mandatory health insurance is viewed as a major example of that trend. The idea that the government might impose a comprehensive health care mandate is 'especially disturbing to small business' says William Byers of National Steel Erectors Corporation. 'We have enough problems as it is without Congress sneaking more of these things through the way they did with COBRA' -- the Consolidated Omnibus Budget Reconciliation Act of 1985.

"That budget act carried a provision - added with no hearings and little debate - requiring employers

with no more than 20 workers to extend health coverage to workers who leave or are laid off, widows and divorced spouses and some dependents. While the covered individual must pay the premiums, the employer bears the administrative costs, which are considerable.

"The new proposals would go much further. They would require every employer to provide a wide range of minimum health care benefits to all employees who work more than 17½ hours a week."

Kennedy is quoted as saying "The time has come to require all

businesses in America to offer health insurance to all their workers and their dependents as a condition of doing business."

The Kennedy bill would require employers to provide insurance covering all "medically necessary" hospital care.
