





Plains High School Math and Science Team competed in the Andrews Pre-UIL meet on Jan. 30, and walked away with the first place sweepstakes trophy, for the third year in a row. They were competing against 19 other schools from Class A to AAA.

In Calculator, Micah Stowe placed first and Shane McMinn placed second in the senior division. Stowe scored 299 and McMinn, 290, which was the highest two scores in both divisions, large and small schools. Chad Guetersloh placed first in the junior division. Lance Morrow placed first and Nieves Garcia earned a third in the sophomore division. Layne Morrow managed a first in the freshman division. The Calculator Team won the first place team trophy. 





- ½ t salt
- 1 c Wesson oil
- 1 c chopped nuts (optional)
- t vanilla

County Agent Informs Citizens About Tax Changes

Agricultural producers need to keep in mind the more significant changes of the Tax Reform Act of 1986 as they prepare to file their federal income tax returns, points out David Kight, county agent with the Texas Agricultural Extension Service.

These changes include the follow-

*Tax rates have been reduced and tax brackets have been expanded. For example, the marginal income tax rate for a married couple filing a joint return is 15 percent on taxable income between \$3,000 and \$28,000.

*Personal exemptions have been increased from \$1,080 to \$1,900.

*The standard deduction for a married couple filing a joint return has increased by \$90 to \$3,760, but is scheduled to increase to \$5,000 in 1988.

*A self-employed individual is allowed to deduct 25 percent of what he or she pays under an insured or self-insured family health plan. This is not available if the self-employed person participates in a health plan furnished by his or her spouse's employer.

*Capital purchases of up to \$10,000 on eligible property may be deducted in the year of purchase.

*Limits have been placed on the amount of prepaid farming expenses that can currently be deducted if you use the cash-basis method of accounting. The limitation applies to prepaid expenses in excess of 50 percent of the non-prepaid farming expenses.

*Deductions for IRA contributions are phased out for middle to high income individuals who are covered under another qualified pension plan.

Items that have been eliminated by tax reform legislation include the

following:

Two-earner deduction for married couples; income averaging; capital gains exclusion, (There are special rules for participants in the dairy herd buy-out program.); land clearing expense, (Conservation expenses must be part of an approved plan.); dividend exclusion; charitable contributions, (These must now be included with other itemized deductions.)

State Line Club Gets Together






