



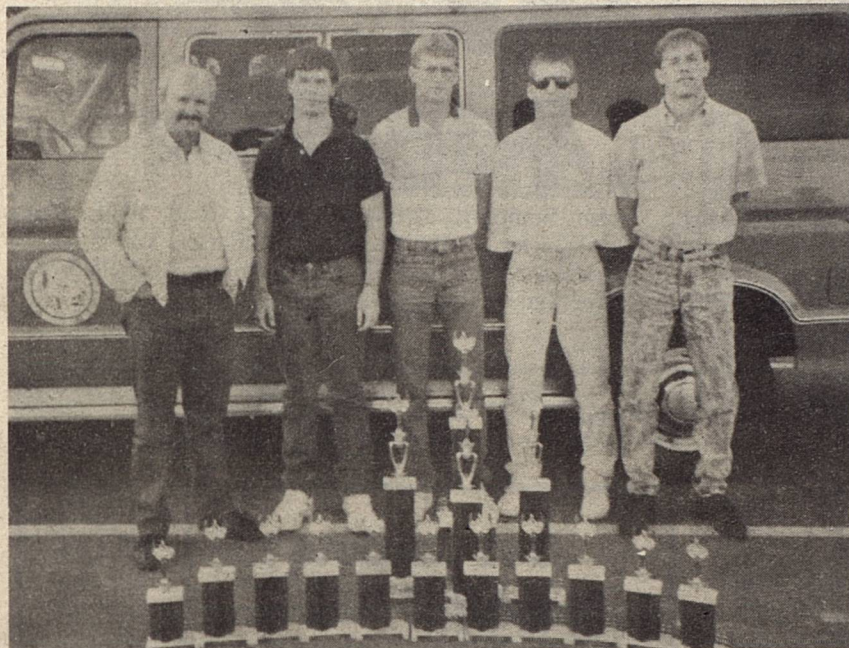

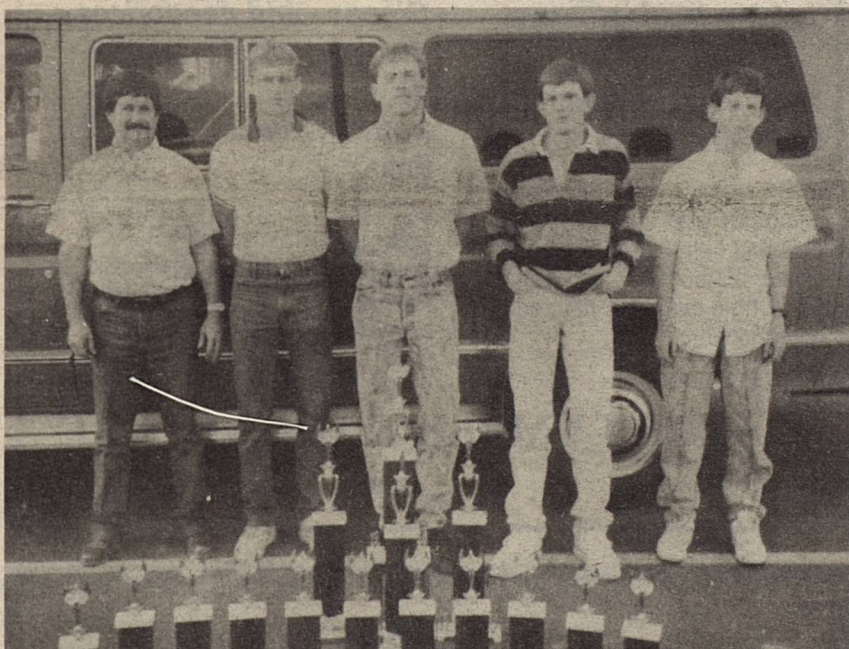

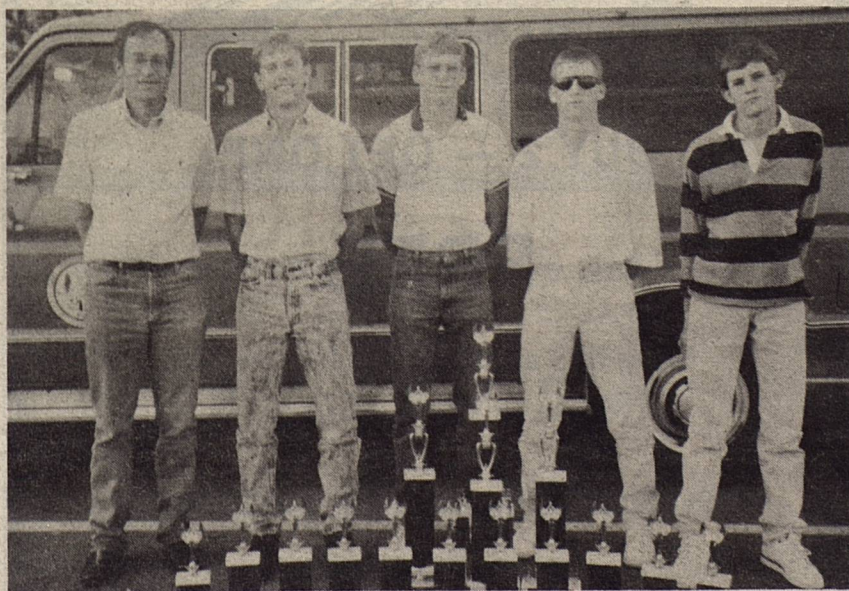

## Math/Science Team Wins

"Same ol' song and dance"...for Plains Math and Science Teams as they once again bring home the State Sweepstakes Title for Class A schools. This year's title is the third one in a row for Plains. Competing among 12 other Class A schools in the TMSCA State Meet last weekend in San Antonio, the PHS team garnered the third highest team points total of the 85 schools representing classes A through AAAAA, finishing back of a 5A and a 4A school.

Participating in the meet were seniors Micah Stowe and Shane McMinn; juniors Chad Guetersloh, Brian Livengood and Jesse Ramirez; sophomores Lance Morrow and Nieves Garcia and freshman Layne Morrow. Sponsors were Larry Devitt, calculator; Richie Cullins, number sense and Macky McWhirter, science.

In calculator competition, McMinn and Stowe were first and second in the senior division with scores of 326 and 315; Guetersloh was first in the junior division with 272 points. Lance Morrow and Garcia were third and fifth in the sophomore division with scores of 254 and 218, respectively. Layne Morrow scored 200 to win first in

the freshman division. The calculator team won the first place team trophy for Class A with 1167 points. Only McAllen and Port Arthur, 5A teams, scored higher team totals in the meet.

McMinn also won first in number sense with 328 points. Guetersloh was second in the junior division with 201; Lance Morrow, first with 273 points and Garcia fourth with 115 in the sophomore division; and Layne Morrow first with 185 points in the freshman division. The team won the first place team trophy for Class A with 987 points. Second place Class A team was Grady with 524. Only McAllen and 4A Hirschi scored higher team totals in the number sense competition.

Science competition found McMinn taking his third first place win. He scored 65 points. Stowe was fourth with 40. Guetersloh was first with 89 in the junior division with Livengood and Ramirez placing fifth and sixth with scores of 40 and 34, respectively.

McMinn scored first place in the chemistry test; Guetersloh, first in physics.

The science team won the first place Class A team trophy with a total of 312 points. Second place team, Rotan, scored 163.

## Delegates Chosen At Caucus

On Super Tuesday, March 8, 1988, at 7:15 p.m. Democrats in Precinct-4 met at the Youth Center in Plains for their Precinct Caucus. Democratic Chairman, Melvin Lowrey, expressed disappointment in the fact that only one precinct had voters who showed up for a caucus. (One interested voter in Denver City did show up to observe his precinct caucus. Since he was the only one to show for the caucus, none was held.) Lowrey speculates that voters who have never attended a precinct caucus may think that it is a complicated procedure, when it is really very simple. He also stated that this is an area where our economy is dependent on oil and agriculture, and the policies for oil and agriculture are developed almost entirely in Washington. Consequently, he was surprised at the low number of voters in Yoakum County in a presidential election year.

In Precinct 4-4, the following Democrats were elected to attend the County Convention as *Delegates*: Pat Curtis, Louise Goehry, Sylvia Martinez, Linda S. Lowrey, Melvin C. Lowrey and Edith Tuggle. The *Alternates* are: Joyce Ann Moore, Tracy Lowrey,

Ken Peterson and Sonnie Stephens. Of the six delegates, four signed in for Dick Gephardt as their choice for the Democratic nominee for President, and two signed in as "Uncommitted".

The caucus participants voted to send two resolutions to the County Convention. The first resolution states: *We urge the United States Congress and the President to halt military aid to the Contras in Nicaragua.* The second resolution states: *We urge the United States Congress to repeal the new requirement that agriculture producers pay the diesel fuel tax of 15.1 cent per gallon. We urge a return to the policy under which farmers are exempt from paying taxes on the purchase of wholesale diesel used strictly for on-farm and off-highway purposes.*

The County Convention will be held on Saturday, March 19, 1988, at 11 a.m. in Linda Lowrey's law office in Plains. For further information, interested persons are urged to call 456-7404 or 456-7474. Two delegates and two alternates will be elected to represent Yoakum County at the State Democratic Convention in Houston on June 18.

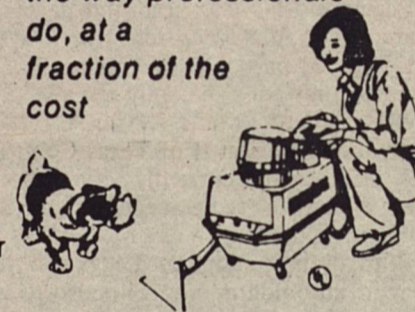

### MY GRANDMOTHER'S

#### PECAN PIE

[for one (1) pie]

3 eggs  
 2/3 c sugar  
 1/2 t salt  
 1/3 c melted butter  
 1 c Karo syrup  
 1 c pecans

[for six (6) pies]

18 eggs  
 4 c sugar  
 3 t salt  
 2 c butter  
 6 c Karo syrup  
 6 c pecans

Add pecans last; pour into unbaked pie shell. Bake at 375° for 40-50 mins.

#### BAKED BEANS

2 c pork 'n beans  
 1 chopped onion  
 3/4-1 c brown sugar  
 1 1/2 t mustard  
 1 T worcestershire sauce  
 1 t liquid smoke  
 bacon strips or grease

Bake in moderate oven 1-1 1/2 hrs.

#### CORNBREAD

1 c sifted flour  
 1 T sugar

4 t baking powder

3/4 t salt

1 c cornmeal

2 eggs

1 c buttermilk (or milk)

1/4 c soft bacon grease (or oil)

Combine dry ingredients; blend in others. Bake in 400° oven until brown.

#### MAYONNAISE CAKE

2 c flour

1/2 c cocoa

1 c mayonnaise

1 1/2 c sugar

1 T soda

1 c boiling water

salt

1 T vanilla

Sift dry ingredients together. Mix liquid. Combine thoroughly and bake at about 350°. (45 mins. for tube pan - very moist)

## From The Superintendent's Desk

DEAN ANDREWS



As we begin our last eleven weeks of the 1987-88 school year, we begin our Spring competition in literary contest, one-act-play, golf, tennis, and track. I am concerned that we exhibit the same quality of sportsmanship as we exhibit skills in the various contests. I want our school and community to be recognized not only as excellent competitors, but also as being very sportsman-like.

I read an article from the University Interscholastic League which said that the biggest problem schools have in improving sportsmanship and conduct at athletic events, appears to be with adult fans. Enthusiasm from adult spectators is desirable, but unguided enthusiasm can be detrimental to the most worthwhile values of the contest. Fans who show disrespect to opposing players or to officials are a liability rather than an asset to a school's academic/athletic program.

Good sportsmanship is easy to understand but difficult to exhibit. If we would practice the following U.I.L. code, we would improve relations with everyone:

- (1) Participate in contests in the spirit of fairness and sportsmanship observing all rules - both in letter and in spirit.
- (2) Sponsor and advise individuals and teams without resorting to unethical tactics, trickery which attempts to skirt the rules, or any other unfair tactic which detracts from sound educational principles.
- (3) Accept decisions of officials and judges without protest and extend protection and courtesy to officials.
- (4) Regard opponents as guests or hosts while placing personal and/or team integrity above victory at any cost. Maintain grace and poise in victory or defeat.
- (5) Provide information or evidence regarding eligibility of any contestant or school to local school administrators or to the appropriate judicial bodies upon request.
- (6) Understand and appreciate the educational values of competition.
- (7) At all times, ensure that competition is relative to a more important overall educational effort, using competition as a tool in the preparation of students for citizenship and successful adulthood.

I think we all need to be reminded that our actions always speak louder than our words. Sportsmanship is as important as the competition in any contest. I want us - our school and our community - to be recognized as highly for our sportsmanship traits as we are for our competitive spirit, in all our contests.

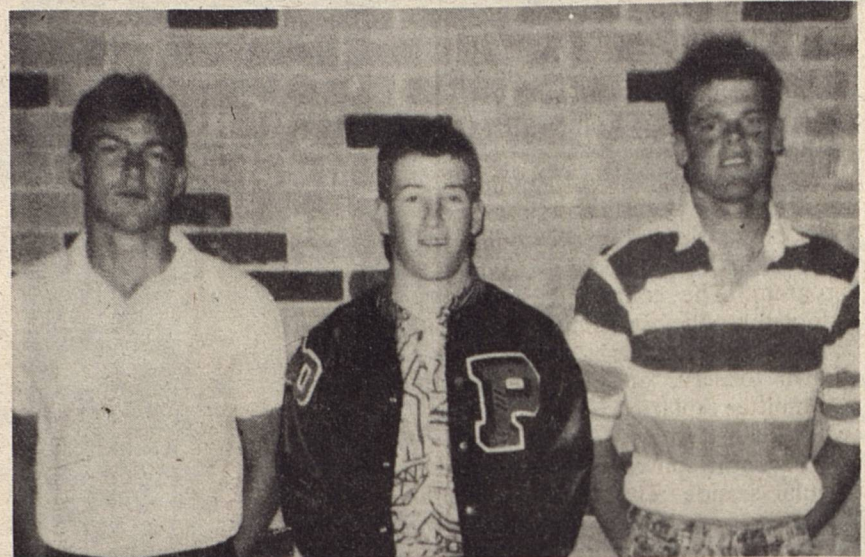

## Commissioners' Court

Yoakum County Commissioners met in special session March 7 with all members present.

Extra hire and disbursements according to the list on file were approved for payment. Approval was also given for the release of the pledge on securities held by First City Bank of Dallas.

Johnny Jones, newly appointed Loss Control Coordinator, discussed Texas Association of Counties suggestions for the county's safety program. The court unanimously adopted a policy statement.

Esmeralda Salas' name was drawn to serve on the Grievance Committee replacing Edward Smith who declined to serve.

The Court convened March 14 in regular session. The Tax Assessor-Collector's report of taxes collected in February was approved.

A motion was approved to advertise for bids to be received by April 4 for the purchase of a fire truck for Plains. Also approved was a motion to amend the budget to bring Revenue Sharing Funds from the 1987 budget into the 1988 budget in the amount of \$92,000 to be used for the purchase. Bids were rejected in 1987.

Child Welfare Board members, whose terms were expiring, were re-appointed for three year terms including L.J. Sanders, Anna Gonzales, Jenny Coston and H.K. Henniger. Debbie Rushing was appointed to replace Rev. Filpin who resigned to become an associate member. Beth Clanahan was appointed to replace Wayne House for a term expiring in March 1989 and Mavis Sessions and Diana Patterson were appointed to succeed Cathy Minchew and Dorothy Anderson, respectively, with terms expiring in March 1990.

Approval was also given for Bill Gravitt who resigned to become an associate member and Armida Ybarra and Peggy Thurston who resigned and were not replaced.

Barbara Wright was approved as an additional member of the Denver City Youth Center Board for a term expiring February 1991.

Extra hire and disbursements were approved for payment.

Unanimous approval was also given a motion to advertise for total cost bids for one new diesel tandem drive motor grader. Precinct One will offer in trade one 1972 Caterpillar 12F motor grader. The motion included receiving total cost bids on one new dozer, to offer in trade a 1976 Caterpillar D5 dozer. Bids will be received April 4.

Also approved was a motion to advertise for asphalt with prices both at the plant and delivered for

all four precincts for the remainder of 1988. Bids will be received April 4.

Commissioners also approved endorsement on blanket position bond adding Vicki Abercrombie, Deputy District Clerk, and deleting Barbara Thrash.

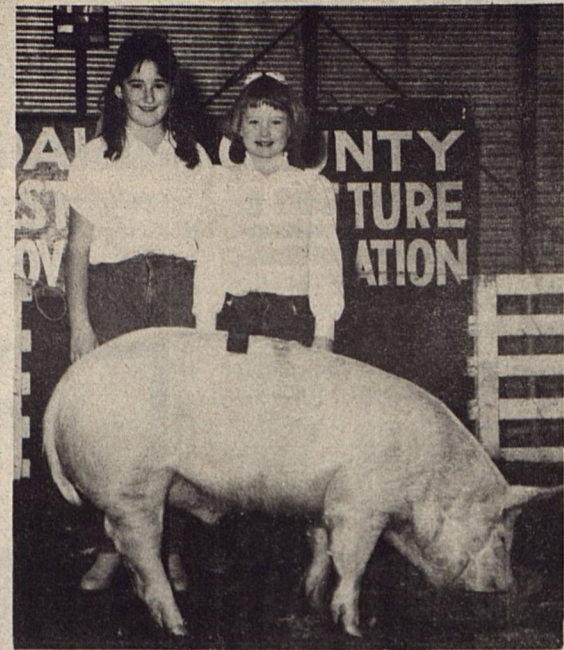

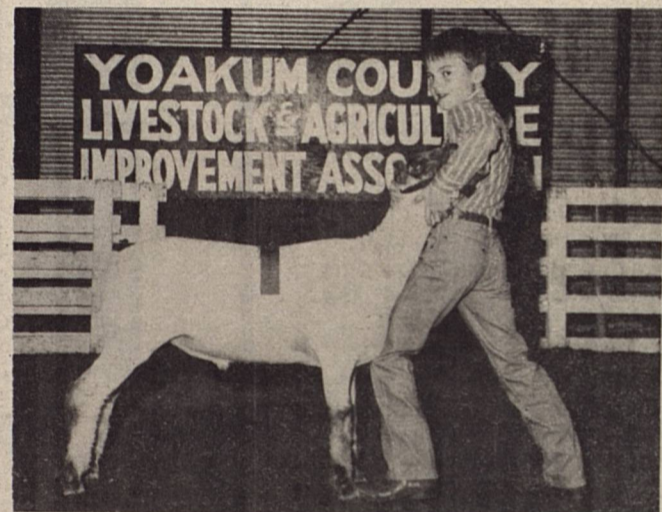

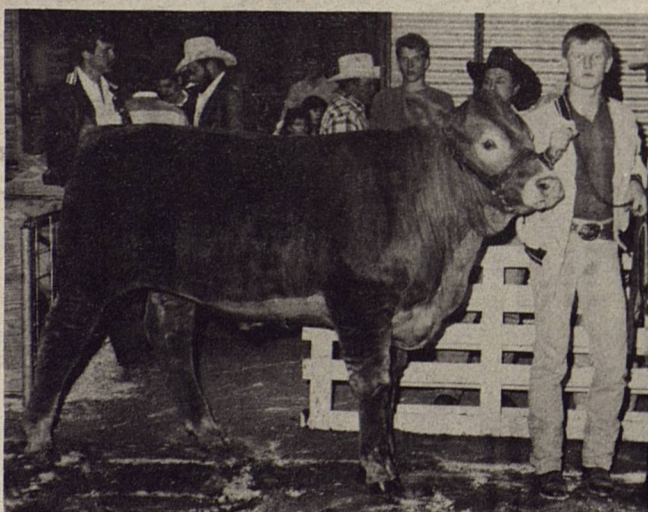
