Plains Cowgirls and Cowboys participated recently in the District 6 1-A Cross Country Meet in Lamesa and the Cowboys captured the team title with 37 points over second place team, Klondike's 44 points.

# Cowgirls Beat Bronte

The Cowgirls booted the Bronte Longhorns 16-14, 15-6 Tuesday night in area competition at the Howard County College Coliseum in Big Spring. They will return to Big Spring Saturday, Nov. 12 for regional competition, squaring off against Fort Hancock at 8 a.m. Dell City will take on Miles at 7:30 a.m. with the winners advancing to the Region 1-A finals at 2 p.m.

The Cowgirls got off to a slow start but managed a 9-7 lead. Momentum went back and forth with Bronte holding the Cowgirls at nine points through eight rotations while boosting their score to 10. The Cowgirls picked up the tempo and tied the game at 10-10 and the Longhorns held their last lead of game one at 13-12. Both squads earned an additional time out at 14-14 and the Cowgirls rallied to win the game 16-14 after two

Getting off to a good start in the second game, the Cowgirl offense jumped to an early nine point lead and held the Bronte offense to six points for a 15-6 win and a Class A area championship.

# **Majority Of County Voters** Choose Bush/Quayle Ticket

in Yoakum County cast ballots in the General Election held Tuesday and voted much like the entire state.

George Bush and Dan Quayle received 1762 votes while Michael Dukakis and Lloyd Bentsen only garnered 727 votes. Sixteen votes went to the Libertarian candidates and two to the New Alliance candidates.

In the race for the United States Senator, Beau Boulter carried the county with 1429 compared to 1171 for Lloyd Bentsen. Libertarian Jeff Daiell got 18 votes. Combest easily won the congressional race with 1843 votes. McCathern received 759. In the Railroad Commissioner's race, Rep. Ed Emmett received 1092, Demo. Jim Nugent, 1363; Lib. Draheim, 25; and N.A Lozano, 38. Kent Hance, Rep., got 1958 votes compared to Clint Hackney, Demo., 658.

PLEASE read this letter if you have sold - you will pay for it in the end! mortgaged livestock or you intend to take out a loan for livestock...your personal financial business may soon be spread all over the State of Texas by your Legislature!!!

The "Big Banks" of Texas did you a great injustice when they helped push through legislation that requires livestock commissions to issue "joint payee checks" when you sell mortgaged cattle. That means your check for your cattle has to be endorsed by your bank. This was only the "foot-in-the-door" for what is to come in the 1989 Texas legislative session.

Once again, the "Big Banks" find it necessary for the livestock commissions to be used as their collection agencies.

This time they want a law that requires banks to send all information on mortgaged livestock to a costly computer system in Austin. Not only will four or five livestock commissions have your personal financial data -everyone in the State of Texas will have access to it - this system is called "Central Filing"! It will violate your privacy!!

On May 14, the Texas Bankers Association told their state-wide convention in Dallas that the new law will pass in 1989...there were two key Senators and two key Representatives there that said the same thing. TBA is writing the legislation and it is being sold to Representatives and Senators as a "no- cost-to-Government" piece of legislation...have you ever heard of that before?

Every livestock commission will be forced to purchase a computer and to hire a computer operator. The "granddaddy" system in Austin will be very expensive to operate. These costs will be passed on to the farmer and rancher through higher commissions on cattle

#### Crude Oil Averaged 1,869,788 Barrels **Daily In August**

Texas crude oil production averaged 1,869,788 barrels daily in August, according to preliminary figures released by Railroad Commission Chairman James E. "Jim" Nugent.

This figure compares with preliminary July production of 1,879,744 barrels daily. Final production reports for July indicated average production at 1,893,019 barrels daily.

The preliminary Texas oil roduction figure for August is 57,963,418 barrels, down from 58,272,074 barrels in July.

According to Nugent, the state's top production counties, rank ordered by preliminary August production were:

Gaines, 3,501,414 barrels; Andrews, 3,399,328 barrels; Ector, 3,340,559 barrels; Pecos, 3,060,072 barrels; Yoakum, 2,898,021 barrels; Hockley, 2,739,999 barrels; Gregg, 2,613,076 barrels; Crane, 1,644,287 barrels; Scurry, 1,425,970 barrels; and Wood, 1,125,051 barrels.

Banks seldom notify livestock commissions when loans are paid off under the current system. It will be even worse under the new system and livestock commissions will be forced to issue "joint payee" checks by mistake if the system is not current. Livestock commissions are liable for these loans if they fail to issue the check to the seller and the bank involved.

Even more serious, farmers and ranchers may not receive a check for their livestock on the date of sale if the "granddaddy" system in Austin is broke...Can you imagine everyone calling Austin by phone to get the information on sale day? The new law may also require a Social Security number on the livestock check-in so the system is perfect - Then you will have the Internal Revenue Service interested in the same system and more data will be needed in the

Livestock commissions in Texas do not want to know your personal financial business. They do not want to be a collection agency for banks. They want to sell your livestock for a good price and a reasonable commission. They need your help to fight the "Big Bank" lobby! The smoke-filled rooms have the power but you have the vote...you need to contact your Senator and Representa-

tive TODAY!! Send them this letter with a hand-written note that tells them how you feel...Call or send a note to the Farm Bureau and ICA - get them involved! The bankers in Dallas were told that Farm Bureau has reluctantly come around to support this new law in 1989 - can you believe they would sell out the farmers and ranchers on this one?

Let's work together on this problem...reproduce this letter and get it into the hands of every farmer and rancher in Texas...we can kill this legislation if we work together...We may even kill the stupid Federal law that caused this to happen in the first place. Send a copy to your U.S. Senator and Representative too! Ask him how he voted in 1985 on the Food Security Act?
