

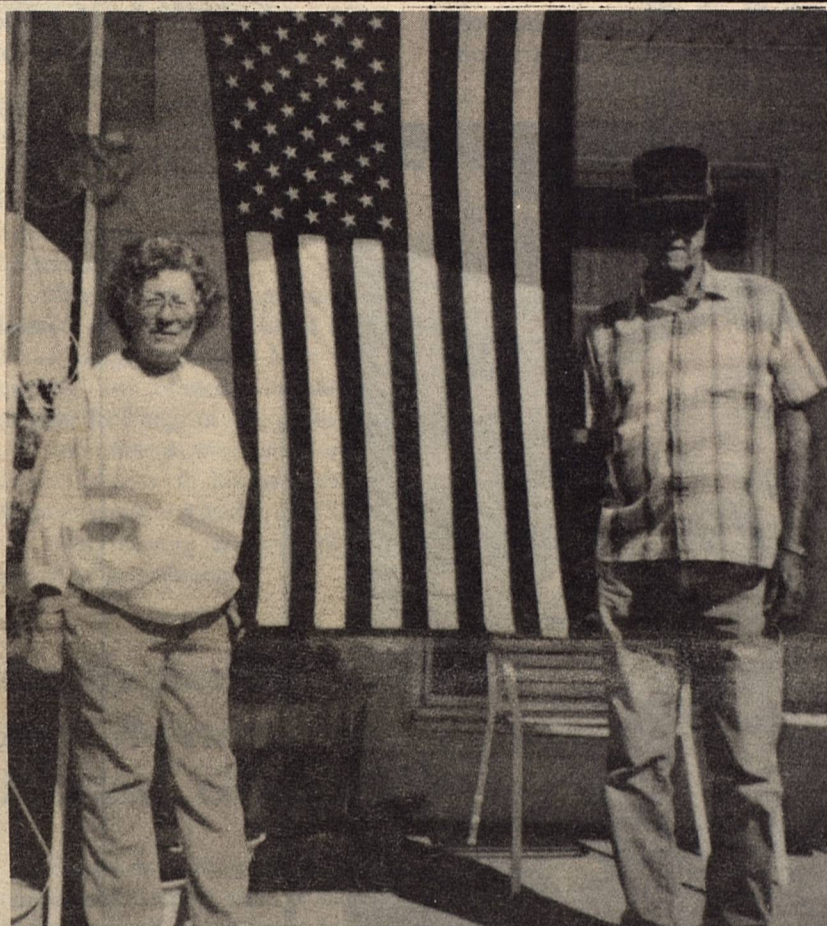

## Toll-Free Number Available For Election-Related Questions

With "extended" absentee voting under way, Secretary of State George Bayoud reminded Texans that his agency's toll-free, hotline is available during extended hours for election-related questions or problems.

Bayoud, the state's chief elections officer, said the hotline 1-800-252-VOTE (8683) - is available from 8 a.m. until 8 p.m. on Saturday, Oct. 27; noon until 6 p.m. on Sunday, Oct. 28; and from 7:30 a.m. until 8 p.m. on Monday, Oct. 29 through Friday, Nov. 2.

"Voter participation is among the highest priorities of my administration," Bayoud said. "To encourage full participation, integrity of the electoral process must be absolute. That can only occur when voters have total confidence in the fairness and openness of our voting system."

To that end, Bayoud encouraged Texas voters to use the election hotline if they have any questions or concerns about the election or the voting process.

During the "extended" absentee voting period, which runs through Fri-

day, Nov. 2, registered voters can appear at county courthouses and other absentee polling places across Texas to cast ballots for the Nov. 6 election. The deadline to register to vote in the Nov. 6 election was Oct. 7 in person and Oct. 9 by mail.

This year Texans will elect a U.S. senator, governor, lieutenant governor and hundreds of other statewide and local office-holders.

For information on local absentee voting hours and locations, call your county clerk or county elections administrator.

# Sky Divers Deliver Game Ball

Plains Homecoming was an exciting evening right from the beginning. The Plains Athletic Booster Club presented a high flying pre-game surprise, as five sky divers dropped from 6,000 feet to a pinpoint landing on the football field. They delivered the game ball to the officials.

The excitement did not diminish as the Cowboys and Anton Bulldogs took to the field.

Providing the large enthusiastic crowd with many memorable moments, the Cowboys lit up the scoreboard first. The score came on a 47 yard pass from Monte Pierce to Shane Lowrey. The PAT was no good.

Anton's Artemio Tarango scored on the Bulldogs next possession on a six yard run. The kick was good. Anton lead the Cowboys by one, the only time during the game they would lead.

With one minute gone in the second quarter, Pierce again found Lowrey for a 27 yard TD. He connected with Dain Guetersloh for the two point conversion.

Halfway through the second quarter, Mario Medina ran five yards for pay dirt. The kick was no good.

Twenty-eight seconds before half-time, Tarango scored on a one yard run. The two point PAT was no good.

Not letting the crowd down seemed to be the Cowboys goal as they scored four unanswered TD's in the second half.

Medina had carries of six and seven yards on the first drive of the third quarter. Pierce tossed a nine yard pass to Guetersloh, and ran five and three yards before Medina covered 31 yards for the TD. Pierce's toss to Lowrey was good for two.

Medina carried for 49 yards and four yards before scoring his third straight TD on a ten yard run. The kick was blocked.

Jose Ramirez scored his first touchdown of the season on a three yard run. Guetersloh's kick was good.

Medina lit up the scoreboard at the 10:53 mark of the fourth quarter on a 13 yard carry. Chris Chavez' kick was good.

Anton came to life at this point and gave a good try at a comeback. The Bulldogs scored three straight TDs in less than four minutes. Steven Garcia scored on a one yard run. PAT failed.

Scott Redden intercepted a lateral toss at the Cowboy 47 yard line and ran it in for the touchdown. Tarango ran over the two point PAT.

With four minutes, five seconds left in the game when Tarango carried over from the two for the Bulldogs third TD of the quarter. The two point try failed.

There was only 15 ticks of the clock left when Pierce ran in from the six yard line for the Cowboys final touchdown. The kick was no good.

Medina had an outstanding night with 29 carries for 255 yards and four TDs. Pierce had 13 carries for 49 yards

and one TD. Ramirez carried once for three yards and one TD. Wade Redman carried once for one yard.

Pierce had 22 throws with 10 completions for 154 yards, two TDs and one interception.

Jason Smith caught two passes for 46 yards, Lowrey three for 77 yards and two TDs, also one two point conversion. Guetersloh caught four for 26 yards and one two point conversion. Redman was one for five yards.

The Cowboys had a total offensive effort of 462 yards.

The defense was lead by Ramirez with 12 tackles and one interception. Redman had 10 tackles and caused a fumble. Pierce had 10, Guetersloh had nine, Stoney Garland had seven and a fumble recovery. Dwane Talley had

five tackles and Dusty Rafferty had four and blocked a punt.

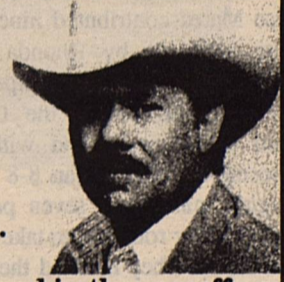

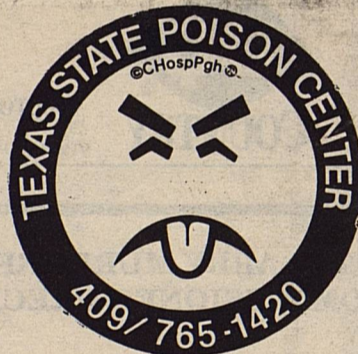

MICHAEL P. STEVENS, Ed. D.

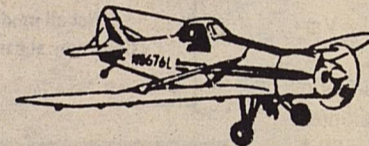
