

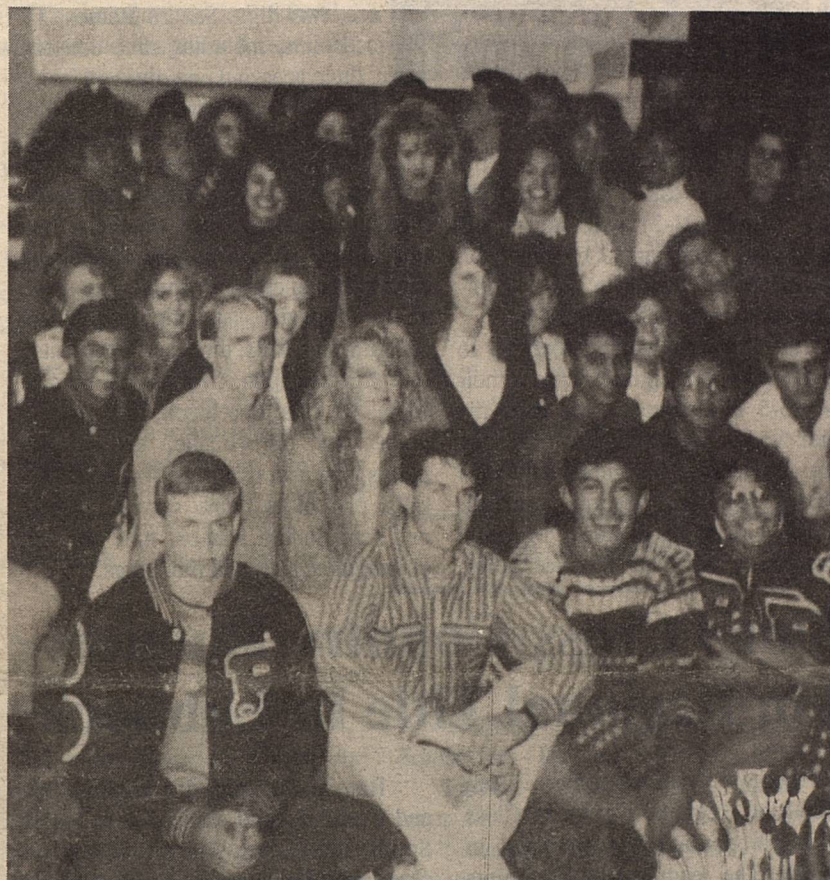

Plains High School's FHA-Student Council has adopted a project to collect items to be mailed to service men and women in Saudi Arabia. The collection period will conclude Nov. 16.

Items may be brought to the home economics department. Items will be picked up by calling the high school at 456-7445 or 456-7490.

Suggestions of items that might be sent include:

CANDIES/FOOD ITEMS - all prepackaged hard candies, with no soft centers; instant drink mixes (individual packets); beef jerkey type items; tuna, chicken or turkey with pop tops; beef-a-roni microwave containers; canned fruits with pop tops; small packages of fruits or nuts; pop tarts; homemade cookies (sturdy type, no chocolate or meltable items).

STATIONARY/ENTERTAINMENT ITEMS - pencils and small pencil sharpeners; erasers; blank prepackaged audio cassette tapes; crossword puzzle books; lightweight paperback books; lightweight writing tablets and en-

velopes; plastic dominoes, cards, travel games; paint by number kits.

EVERYDAY ITEMS - travel size hand lotions, pocket combs for men, hairbrushes for women; nail clippers and emery boards; travel size toothpaste and toothbrushes; eye drops; petroleum jelly; lip balm; sun block SPF 15 or higher, without paba); perfume, cologne or aftershave; disposable razors (desperately needed); toilet paper; tampons; deodorant; sunglasses; sewing kits.

Winns Compete In Germany At Power Tumbling Event

Dillenburg, Germany was the site of the 1990 World Power Tumbling Championships. Over one thousand competitors from 21 countries gathered there in hopes of bringing home a medal.

Ashlee, Ladd and Shyloh Winn left Saturday, Oct. 13 along with 77 other United States team members arriving in Frankfurt and then traveling 80 miles to Dillenburg. This would be the third World Championship contest for all three Winns.

Fourteen year old Ladd came close to winning a third world title by taking the silver medal. He sat less than a point from first place after being scored only eight out of a possible 10 skills in his long pass. He also came in 5th in double-mini trampoline.

Ashlee, who became an Elite competitor last spring, came in 8th in the 15-17 year old division. Her competition was held Saturday, Oct. 20.

Shyloh, now 11 years old, competed in the 11-12 year old division

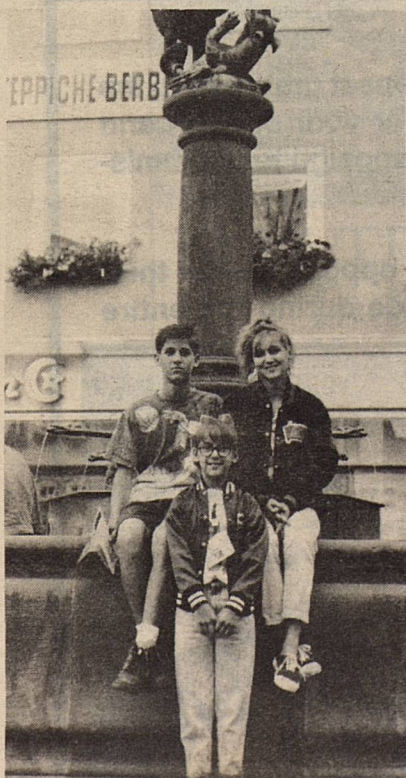
placing 7th in the world. She competed on Oct. 18.

They each qualified for the World Championships after competing in the ATTA (American Trampoline and Tumbling Associations National Championships in Rockford, Ill. held in July.

The trip included tours to the famous Wartburg and Marburg Castles. The Wartburg Castle was the home of Johann Sebastian Bach and was also resided by Martin Luther. It was there that he translated the Bible into German.

The Marburg Castle dates back to the 800s and was rebuilt and finished in the 1180s by King Ludwig. Also on the tour was the oldest church in Germany - Saint Elizabeth's Cathedral.

All three athletes are members of the South Plains AcroSpirits Tumbling Team coached by Sherry Arnwine of Levelland; and they are the children of Tony and Lynne Winn.

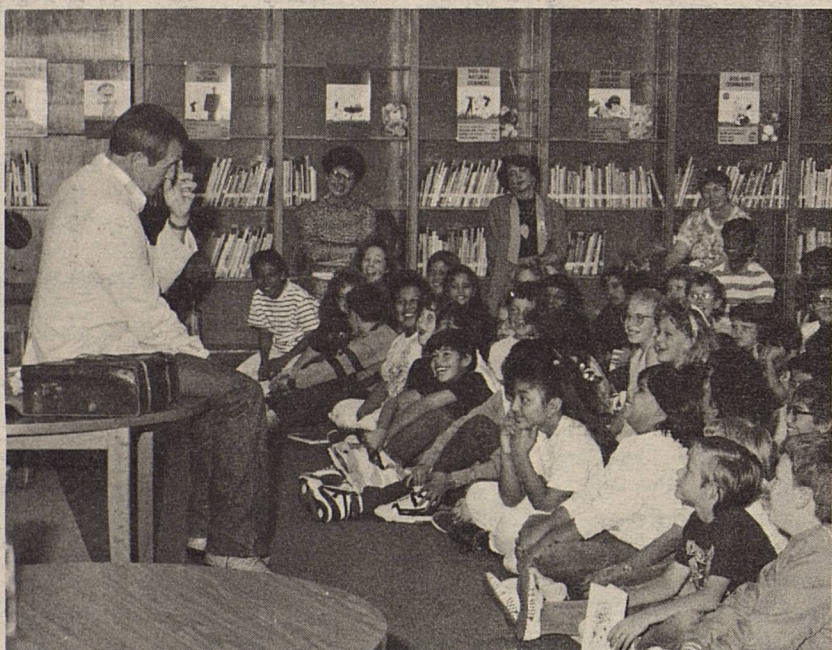

Cowgirls Eliminate Contenders In Bi-District & Area Matches

The Cowgirls moved two steps closer to their quest for a third consecutive Class A State Volleyball Championship by eliminating Water Valley and Chillicothe at the bi-district and area levels.

Advancing to regional competition, the Cowgirls (33-2) will take on Fort Hancock (16-10) at 9 a.m. Saturday, Nov. 10 in the semi-finals of the Region IA volleyball tournament at the Texas Tech Recreation Center in Lubbock. Bronte (21-3) will square off against Fort Davis at 10:15 a.m. with the winners advancing to the championship match scheduled for 3 p.m.

The Cowgirls worked together to post 23 kills and eight blocks in their 15-4 15-5 bi-district victory over the Water Valley Wildcats last Saturday night in Odessa. Individual statistics included Vee Ann Fitzgerald, one kill; Melissa Green, five kills; Michelle Lowe, three kills, one service point;

Rena McElroy, eight kills, five blocks, eight service points, one dig; Leslie Patton, two kills, three blocks, four service points, four aces; Jo Lena Powell, four kills, two service points, one ace, two digs; Sandra Ramos, 15 service points, including nine consecutive, three aces and one dig.

The Cowgirl offense jumped on Chillicothe early in game one of their area match Tuesday night in Aspermont. Recording a kill on their first possession, the Cowgirls combined their skills to clobber Chillicothe 15-0 15-1. Cowgirl statistics included Melissa, five kills, three service points, one dig; Michelle, two service points; Rena, 10 kills, one block, one service point, one dig; Leslie, six service points, one ace, two digs; Jo Lena, two kills, one block, nine service points, one ace; Sandra Ramos, nine service points, three aces and three digs.

Plains Cross Country Runners Win Regional Title In Lubbock

Cowboy Cross Country Team grabbed the Regional Crown in Class 1-A in competition last weekend in Lubbock. The team scored 59 points with Armando Ramirez, Michael Sainz and David Corrales qualifying for state.

State competition will be Saturday, Nov. 10 in Georgetown.

Ramirez scored 4th; Sainz, 7th and Corrales, 10th. Others were Jason Smith, 17th; Lenny Morrow, 27th; Junior Lira, 31st; and Lacy McAdams, 41st.

Cowgirls running in regional competition were Oglia Ramirez, 45th; and Amy Crutcher, 66th.

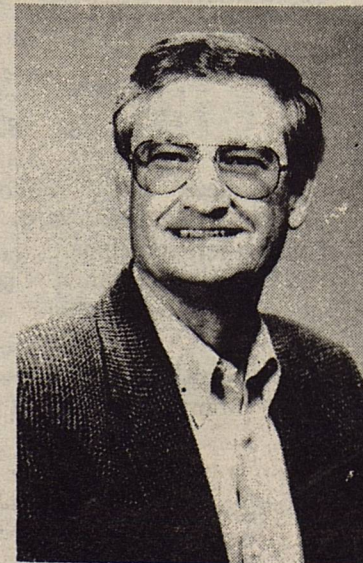

Residential Treatment Center Holds Dedication Ceremonies

Dedication ceremonies were held Tuesday, Oct. 30 in Brownfield for the Regional Court Residential Treatment Center. A project of the 121st Judicial Court, the center will serve Terry and Yoakum counties.

District Judge Ray Anderson introduced several speakers and attributed the success of acquiring the facility to chief probation officer Mary Guetersloh and the City of Brownfield.

Jim McDonough, executive director of Texas Board of Criminal Justice, spoke to the audience on crime in Texas and what must be done to control it. "The solution lies in the family, the work of the church and especially the school," he said.

"This facility is a move in solving this problem. These people (residents) will not only be given a second chance, they will be able to function in society."

McDonough said this is the only center in the state of Texas that is owned and operated by a city.

State Representative Jim Rudd was keynote speaker. He noted that the state prison system is asking for an additional 36,000 beds within the next two years and added, "If the request is honored, it means we will have 100,000 people in state prisons by that time."

Rudd said that in order to solve such a problem, education is the most important tool in lowering crime.

"The more education you get, the less chance of you going to prison," he said. "How do you get a person involved in criminal activity, especially a young person, back in society?" he

asked. "The answer is with the concept of community support."

Rudd also expressed gratitude towards Ms. Guetersloh in her effort to secure the facility. "Mary has dedicated the last three or four years to getting this here," he said. "Through the work of the city council, the commissioners court and two cities, the facility has come into being."

"Most people here (residents) would be in prison if the facility wasn't here, but there's still a lot of work to be done," he said.

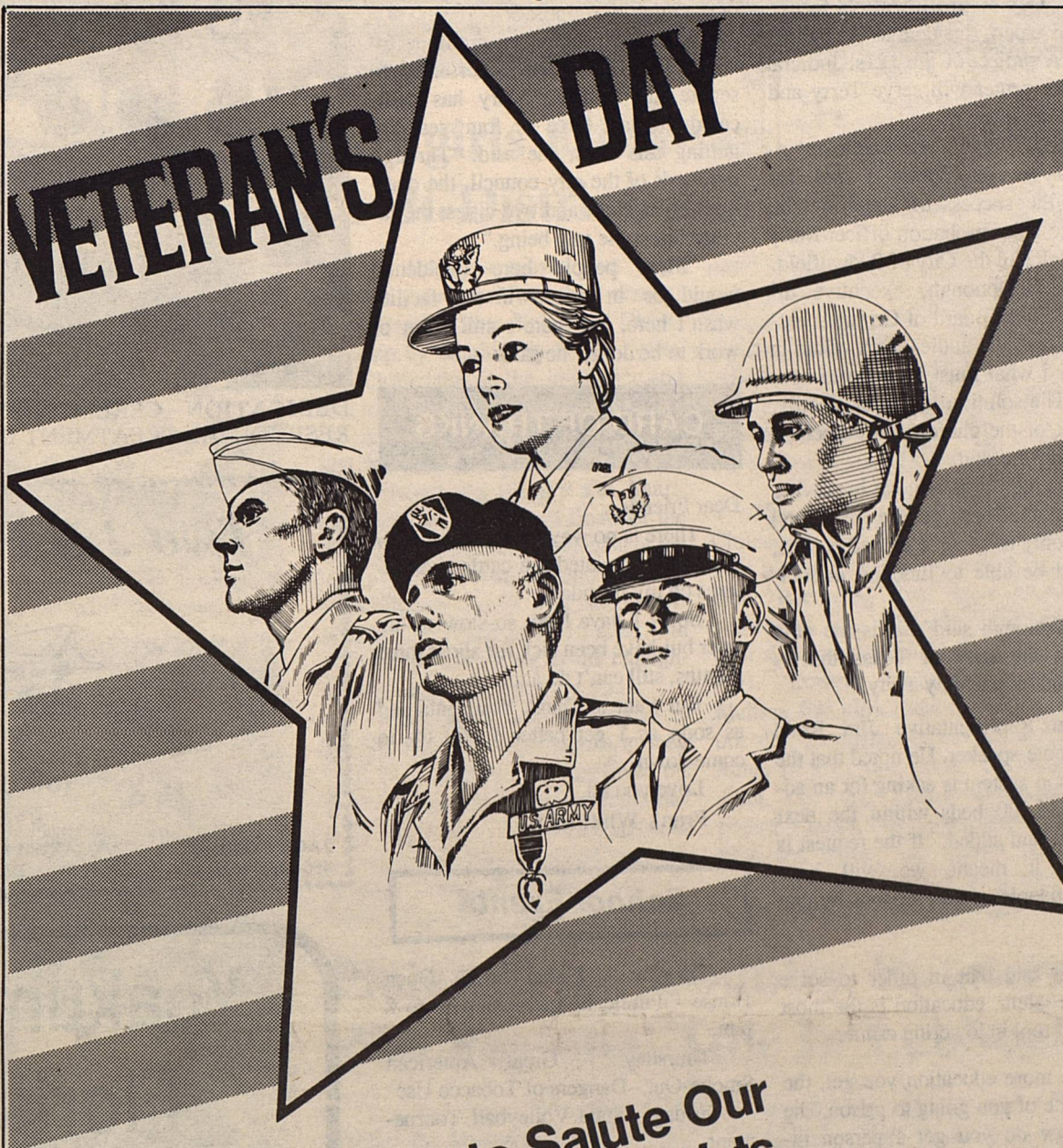
