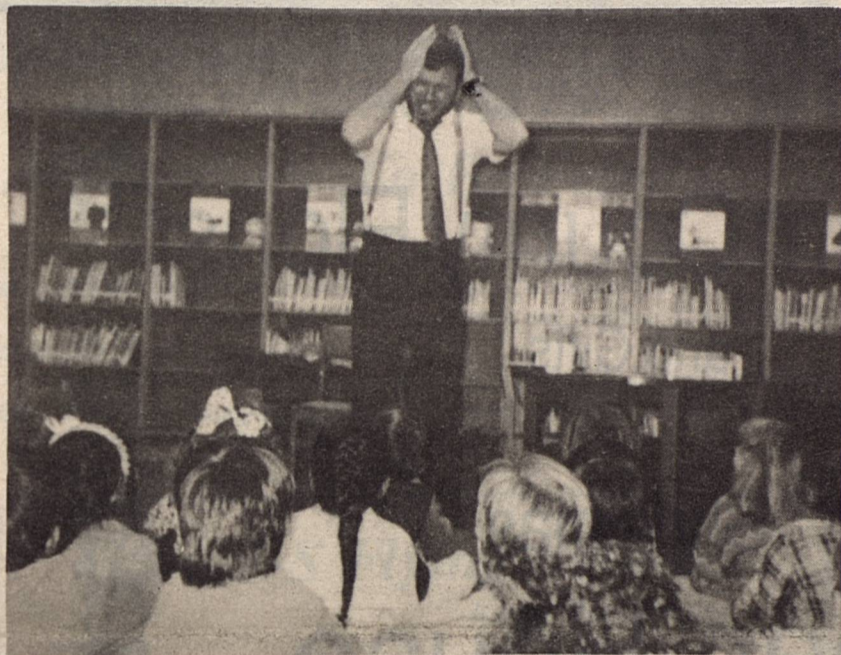

Water District Slates Contest

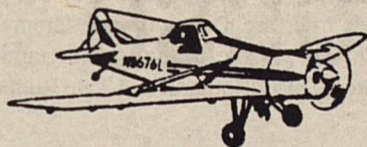

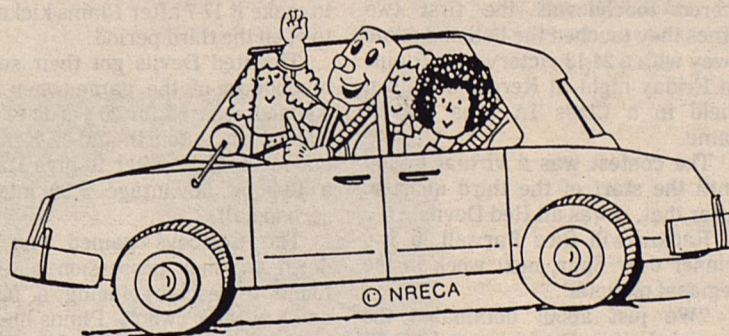

Rankin grounds Cowboys, 24-13

KERMIT - Rankin's Red Devils scored touchdowns the first two times they touched the ball and came away with a 24-13 victory over Plains on Friday night at Kermit's Walden Field in a Class 1A area playoff game.

The contest was a virtual tossup until the start of the third quarter. After that, it was all Red Devils.

Rankin will face Farwell, a 34-6 winner over Spur, next week in the regional playoffs.

"We just about dominated the second half," Rankin coach Troy Kennedy said. "(Plains) about spent all night out there on the field in the first half. We didn't break, but we bent about like a horseshoe.

"I don't know how far we can go in these playoffs. Plains was tough tonight, but from here on out they get awfully tough. I don't know if we can line up one or two more weeks, but whatever happens, I'm very proud of these kid."

"In the second half, they controlled the ball game," Plains coach Larry McMinn said. "That was probably the key; that and the turnovers we made early in the game. Those things happen. We thought turnovers would probably be the difference and that's the way it worked out."

Plains, the runnerup in District 6-1A, finished the season 6-5. District 8-1A champion Rankin improved its ledger to 9-2.

After a close first half, Rankin dominated the second half. The Red Devils marched 67 yards in 10 plays to make it 17-7 after Plains kicked off to open the third period.

The Red Devils got their second touchdown of the game when Kirk Kennedy passed for 20 yards to Joey Valera on a fourth-and-4. Kennedy added the point-after to give Rankin a 10-point advantage 5:35 into the second half.

The Cowboys gained one first down on their possession but soon found themselves facing a fourth-and-6 at their own 46. Plains lined up in punt formation, but McMinn elected to go for the fake. Shane Lowrey was tackled for a 3-yard loss and the Red Devils took over at the Plains 43.

Rankin then took 13 plays to get its third touchdown, a 9-yard pass from Kennedy to Valera. Kennedy's point-after gave the Red Devils a 24-7 margin with 10:06 to go in the final stanza.

A few minutes later, Kennedy fumbled after being sacked by Dain Guetersloh and Stoney Garland recovered for the Cowboys. Plains then drove to the Rankin 2, but tailback Mario Medina was stopped after gaining just a yard on fourth-and-goal from the 2 and the Red Devils took over.

A fumble by Rankin moments later was recovered by Plains' Ramirez and set up the game's final score, a 1-yard run by Medina. The Cowboys went for two on the extra point, but

Monte Pierce's pass was knocked away, leaving the score 24-13.

Neither club was able to gain much of an advantage in a hard-fought first half.

Plains took the opening kickoff and gained one first down before Medina fumbled and Clint Templeton recovered for Rankin on the Cowboys' 40-yard line.

Red Devil quarterback Kennedy was dropped for a 4-yard loss on first down, but then he faked left and broke loose for 26 yards over right guard and a first down at the 18.

Two carries by Kevin Braden set up a third-and-1, and Gabe Hyatt swept around right end for 8 yards and a first and goal at the Cowboys' 1. Kennedy kept over right guard on the next play for the touchdown and Rankin had a 6-0 lead with 8:40 left in the first period. Kennedy kicked the point-after to give the Red Devils a 7-0 lead.

Neither team was able to gain a first down on its next possession and Plains eventually took over on its own 17 after Kennedy's 53-yard punt.

Buoyed by the running of Medina, the Cowboys smartly moved deep into Rankin territory.

Pierce carried for 10 yards and a first-and-goal at the Rankin 4 before disaster struck. Pierce carried around left end and was hit near the line of scrimmage. He lost control of the ball after being hit, and Templeton recovered for the Red Devils on the 14-yard line.

Plains held the Red Devils without a first down and took over at its own 45 after Kennedy's 34-yard punt.

The Cowboys again moved into Rankin territory, and this time Plains made no mistake, tying the score after Pierce threw a 2-yard touchdown pass to Shane Lowrey.

Pierce kept the 13-play drive alive with a 2-yard keeper on fourth-and-1 at the Rankin 4 and hit Lowrey for the score on the next play. Jose Ramirez booted the extra point to tie the score with 4:09 left in the half.

Rankin took over at its own 31 after the ensuing kickoff. The Red Devils used 11 plays, including Kennedy's 30-yard pass to Francisco Gonzales, moving to the Plains 17 with :25 left in the half.

At that point, Kennedy kicked a 35-yard field goal.

YOAKUM COUNTY Commissioners' Court



Yoakum County Commissioners Court met in special session Nov. 5. All members were present.

A raise for Deputy County Clerk Faye Nelms of \$50 per month after a six month probationary period ending Nov. 1 was approved. Line items transfers to cover anticipated expenditures through Dec. 31 were approved.

Also okayed was a motion to advertise for bids for two new vehicles for the Sheriff's Department to be paid from 1991 budgeted funds with trade-in of two used vehicles. Bids were to be received by Nov. 23 with action Nov. 26.

A motion was approved to include in the minutes a letter to McCreary, Veselka, Bragg and Allen terminating former contract for handling delinquent tax suits and include the contract with Rafe Foreman which was authorized Oct. 22.

Sheriff's Reserve Deputies were approved for coverage of workers compensation. Extra hire and disbursements were approved for payment.

The court voted to amend the Professional Services Agreement with Dr. James Chudleigh to provide that "medical supplies" would include all reasonable operating supplies and expenses normally and reasonably associated with the operation of a medical practice including medical and office supplies and approved equipment with the exception of normal telephone expense after the system has been installed. Physician may assign money due him to a third party.

The court convened Nov. 9 in special session to canvass the returns of the General Election.
