Simmons' wife, Linda, was raised in Santa Anna. She attended Howard Payne University in 1965-66 and earned a bachelor of science degree in elementary education with English specialization, early childhood and kindergarten in 1976 from Angelo State University.

She taught second grade in Coleman, Santa Anna and Littlefield and kindergarten in Howe.

Judging of swine was held at 8 a.m. Friday with lamb classes to be judged at 1 p.m. Judging of rabbits was to follow. Saturday's competition called for the judging of heifer classes at 9 a.m. followed by steer competition.

The annual buyers luncheon is slated from 11:30 a.m. to 12:30 p.m. Saturday in the school cafeteria. The closing program will begin with invocation at 1 p.m. followed by the presentation of queen contestants.

Awards will be presented following the revelation of the 1991 Stock Show Queen.

This year a show is being dedicated to the memory of the late A.E. "Dick" McGinty who was a tireless supporter of youth and their projects. He was a dedicated supporter, leader and helper in youth endeavors from athletics to Scouting to 4-H and FFA.

## On The Hard Court

### VARSITY COWBOYS

Cowboy roundballers opened district play Jan. 8 with an easy 81-58 victory over Three Way.

Scoring was by Mario Medina, 20; Brad Ashburn, 17; Dan Rushing, 13; Brian Wilson, 9; Layne Morrow, 8; Justin Stowe, 4; and Monte Pierce and Joe Martinez, 2 each.

Whiteface overcame the Cowboys Jan. 15 with a 63-47 win. Scoring for the Cowboys were Rushing, 17; Ashburn, 10; Pierce, 4; and Wilson, 3.

Battling the Hornets of Sudan to a 62-56 victory Jan. 18, the Cowboys were paced by Medina, 19; Morrow, 16; Pierce and Rushing, 8 each; Ashburn, 6 and Wilson, 5.

The Cowboys tromped Amherst 90-66 Jan. 22 back of Rushing's 31 points. Other scoring included Morrow, 26; Jason Smith, 15; Medina, 8; Ashburn and Pierce, 4 each and Wilson, 2.

Action on the hardcourt Jan. 25 found the Cowboys in an overwhelming 95-59 win over Three Way. Scoring were Morrow, 25; Rushing, 23; Ashburn, 18; Wilson, 10; Smith, 9; Stowe, 4; Lacy McAdams, 3 and Michael Sainz, 1.

Continuing their winning ways, the Cowboys took a 56-39 win over Lubbock Christian High School Jan. 29. Scoring in the non-district tilt were Rushing, 18; Morrow, 14; Medina, 8; Ashburn and Smith, 4 each; Stowe and Wilson, 3 each and Sainz, 2.

Leading the district, the varsity Cowboys whipped Whiteface 80-59 Friday evening. Scoring were Wilson, 30; Morrow, 16; Smith, 15; Medina, 9; Pierce, 7; Stowe, 2; and Sainz, 1.

### Cowgirls

In a tense, all important game at Amherst Tuesday night, the Plains Cowgirls made a big second half comeback to force a District 9A game into overtime, and then dominated the extra three minutes for a 42-36 win over the Bulldogs. Cold shooting in the first three quarters kept the Cowgirls

trailing until the last eight minutes, where Plains hit some at half, Plains held the Bulldogs to one point in the third quarter, but could only manage to score six of their own. Still, it narrowed the gap to 24-20 setting up the exciting finish. In the overtime, Jenifer Fillingim hit a basket and made two free throws as did Melissa Green for the Cowgirl's six points. The defense held tough, denying Amherst an opportunity to score.

Melissa and Daphne Lowe led the Cowgirls in scoring with 10 points apiece. They were followed by Leslie Patton with 8, Jenifer had 6, and Ashlee Winn and Shannon Squyres each had 4 to round out the total. Daphne led in field goal percentage with 45%. Jenifer and Shannon tied for honors in free throw percentage hitting 2 of 2 for 100%. Melissa followed with 75%, making 6-of 8. Ashlee led in rebounds with 11 followed by Leslie with 10 and Jenifer with 7. Leslie led in assists with 5 and Melissa had 3.

This moved the Cowgirls into second place in the district, behind leader Sudan. Plains must win 3 of their remaining 4 games to earn an outright spot in the playoffs. Two wins would force a district playoff for the playoff spot. Plains still has Three Way and Sudan on the road and Whiteface and Amherst at home.

### Cowgirls Slip By Three Way

For the second time this year, the Plains Cowgirls defeated the Three Way Eaglelettes, this time by a score of 50-35. In a game marred by numerous fouls, the Cowgirls had to gradually slip away from their host as the game went on. Jumping out to a quick lead, Plains saw their lead begin to vanish as Three Way began to make good on many of their 35 trips to the free throw line. But a big final quarter where Leslie Patton and Melissa Green combined for 14 of Plains' 16 points, pushed the lead out of reach and gave the Cowgirls' their third district win.

### YOAKUM COUNTY APPRAISAL DISTRICT AD VALOREM TAX EXEMPTIONS PROPERTY REPORTS AND RENDITIONS

#### EXEMPTIONS:

1. Texas school districts offer a \$5,000.00 residence homestead exemption off of appraised value and additional exemptions to persons who are over 65 or disabled.
2. A mobile home owner must now provide a copy of a title issued by the Texas Department of Labor and Standards together with the residence homestead exemption in order to qualify for a residence homestead exemption.
3. Yoakum County offers a \$3,000.00 homestead exemption off of appraised value on the Farm to Market and Lateral Road Fund and a \$25,000.00 exemption off of appraised value to persons who are over 65.
4. The City of Denver City and City of Plains both offer exemptions to persons who are over 65.
5. Sandy Land Underground Water Conservation District offers a \$25,000.00 exemption off of appraised value to persons who are over 65.
6. All taxing units offer an exemption for certain service connected disabled veterans on one designated property. Surviving unmarried spouses are also entitled to these exemptions of a deceased veteran or a surviving minor child.
7. If you received a residence homestead or disabled veterans exemption on your present property in 1990, it will not be necessary to make a new application for 1991 unless you receive a written request in the mail from the appraisal office. If you were at least 65 years of age or disabled on January 1, 1991 and have not previously filed for the over 65 disability homestead exemption, you will need to make application by April 1, 1991. Or if you have never received a residence homestead exemption on your present homestead, an application must be filed with the appraisal office on or before April 1, 1991. All exemptions not previously granted must be filed on or before April 1, 1991.

#### LAND PRODUCTIVITY VALUATION:

If your acreage was appraised based on productivity for 1990, it will not be necessary to file a new application for 1991 unless you receive written request in the mail from the appraisal district office.

#### RENDITIONS:

Business Personal Property renditions are mandatory according to State Law. Real Property renditions are an option available to owners of real property.
