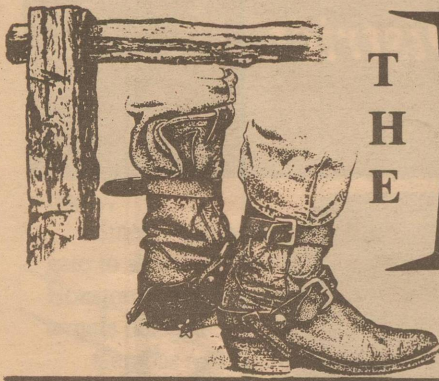

Mrs. Williams died April 28 in Yoakum County Hospital in Denver City.

Born Oct. 13, 1912 in Jones County, she attended school in Hodges. She married Ray Stephenson in 1928. They moved to Anton in 1937. He died Nov. 6, 1950. She married Sammie E. Williams Dec. 22, 1951 in Clovis, N.M. They moved to Morton in 1952 and were engaged in farming. He died in March 1981.

Mrs. Williams moved to Plains in 1983. She was a member of First Baptist Church, Order of the Eastern Star, Stateline Extension Homemakers, ABWA, Tsa Mo Ga Study Club and 1936 Study Club of Morton. She was a past member of Morton Garden Club. She was a life member of GFWC Caprock District and was chosen Outstanding Clubwoman of Caprock District in 1982.

A daughter, Karen Nell Stephenson, preceded her in death Sept. 30, 1946.

Survivors include one daughter, Dolores Davis; grandchildren, Wayne Lee and Cindy Davis; Raynee Davis of Waco and Michael Davis; and one great-granddaughter, Lauren Davis.

Pallbearers were Dean Andrews, Jim Barron, Vaughn Culwell, Terry Davis, Lethel Jones, Larry Murphree, Kent Welch and Wilson Neely III.

Army Tank Mechanic Visits Plains Fourth Grade Students

Rob Warren, 21-year-old grandson of James and Jerri Warren, visited Friday with fourth grade students in Plains Elementary School. The U.S. Army tank mechanic had received letters from the class early this year while stationed in Saudi Arabia.

Recently returning to the U.S. after seven months in the Persian Gulf, Warren spent a three weeks leave visiting in Phoenix, Az. and Plains. He returned to Georgia May 5.

Warren spoke to the students about his experiences before and during the Desert Storm conflict. He

stated the soldiers slept in their tanks or tank repair vehicles. He said that his job with tank repair placed him within 100 yards of actual combat near Basara, Iraq.

He said surrendering Iraqi soldiers, who had been forced to fight, had been cut on the backs of their legs by their commanders so that they could not run away.

Warren has served two and a half years with the U.S. Army and has one and a half more years to serve before his enlistment is complete. He plans to enroll in college after his discharge.

School Board Reorganizes, Jerry Parrish Is President

School Board members met in regular session Monday evening. The board was reorganized with Jerry Parrish elected president; Eddie Earnest, vice president; and Linda Powell, secretary.

Stanley Ashburn was elected delegate to the 1991 TASB Convention in Houston. Jerry Parrish was elected alternate delegate.

Campus and District Improvement Committees, presented by the administration, were approved.

Construction bids for elementary were rejected and the board voted to enter contract with media services of the Education Service Center.

A resolution was adopted providing a twenty thousand dollar (\$20,000) homestead exemption for persons over 65 as well as twenty percent (20%) exemption of appraised value for all other homestead exemptions.

Approval was given for summer maintenance projects to proceed and for the disposal of the white school duplex. Purchase of a duplex was tabled.

The board voted to seek bids for a pick-up, superintendent's car, van and route bus with wheel chair lift. Transfer students for 1991-92 were accepted.

In other action, the board voted to enter into litigation of SB 351 with Budget Balanced Schools Association with Plains ISD paying its pro-rata share of expenses. A one month trial period for a check signing machine was approved.

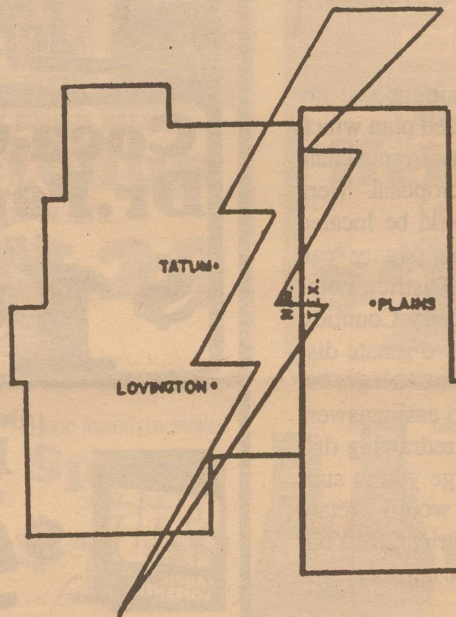
Wanda Ashburn gave financial reports for general operating, cafeteria and tax areas. Principal J.B. Wilson reported that the Cowboy Band was the only 1-A band at state competition to receive all ones. Elementary principal Larry Devitt announced that elementary students will have Roper Fun Day on May 22. Arlon Alexander gave information on TASS testing.

Following executive session, the board voted to pay teachers \$50 per day for weekend sponsoring of UIL contests, industrial arts contests and other events where the employee is not compensated for extra-duty. Payment will be at the discretion of the superintendent.

Resignation of Linda Devitt was accepted and Linda Simmons employed as elementary teacher.

In final action, the board voted to add a professional position of instructional programs co-ordinator with the position to be open to present school staff members first and then if needed to go outside the system.



On or about June 10, 1991, the above named City of Plains will request the Texas Department of Commerce to release Federal funds under Title I of the Housing and Community Development Act of 1974 as amended, to be used for the following project:

Project to be located in the city limits of Plains, Yoakum County, Texas. A more detailed description of the project and a map showing the specific locations of the proposed improvements is available for public examination at City Hall, 601 East Eleventh Street.

Finding of No Significant Impact

It has been determined that such request for release of funds will not constitute an action significantly affecting the quality of the human environment and accordingly the above named City of Plains has decided not to prepare an Environmental Impact Statement under the National Environmental Policy Act of 1969.

The reasons for such decision not to prepare such Statement are as follows:

1. There will be no negative impacts on the environment as a result of the proposed project.
2. Temporary increase in noise, dust, or other nuisance that will occur during construction will be of short duration and low intensity and will cease on the completion of the construction.
3. The project to be undertaken will not affect any known local, state or national historic, architectural or archeological resource presently listed or potentially eligible for listing in the national register of historical places or in any state or local registry.
4. The project will not be affected by nor will it affect the 100 year flood plain.
5. No effect is expected on protected or endangered wildlife or vegetation.

An Environmental Assessment respecting the within project has been made by the above named City of Plains which documents the environmental review of the project and more fully sets forth the reasons why such Statement is not required. This Environmental Assessment is on file at the above address and is available for public examination and copying upon request in the office of the City Secretary between the hours of 8:00 a.m. and 5:00 p.m., Monday through Friday.

Public Comments on Finding

All interested agencies, groups and persons disagreeing with this decision are invited to submit written comments for consideration by the City of Plains, to the office of the undersigned. Such written comments should be received at City Hall on or before June 7, 1991. All such comments so received will be considered and the City of Plains will not request the release of Federal funds or take any administrative action on the within project prior to the date specified in the preceding sentence.

Release of Funds

The City of Plains will undertake the project described above with Community Development funds from the Texas Department of Commerce under Title I of the Housing and Community Development Act of 1974. The City of Plains is certifying to TDOC that the City of Plains and T. J. Miller, in his official capacity as Mayor, consent to accept the jurisdiction of the Federal courts if an action is brought to enforce responsibilities in relation to environmental assessments, decision making and action; and that these responsibilities have been satisfied. The legal effect of the certification is that upon its approval, the City of Plains may use the Texas Community Development Program funds and TDOC will have satisfied its responsibilities under the National Environmental Policy Act of 1969.

Objections to State Release of Funds

Texas Department of Commerce will accept an objection to its approval only if it is on one of the following bases: (a) that the certification was not in fact executed by the certifying officer or other officer of applicant approved by TDOC; or (b) that applicant's environmental review record for the project indicates omission of a required decision finding or step applicable to the project in the environmental review process. Objections must be prepared and submitted in accordance with the required procedure (24 CFR Part 58.75) and may be addressed to Texas Community Development Program, Texas Department of Commerce, P.O. Box 12728, Capitol Station, Austin, Texas 78711.

Objections to the release of funds on a basis other than those stated above will not be considered by TDOC. No objection received after June 27, 1991 will be considered by TDOC. The Chief Executive Officer of the City of Plains is T. J. Miller, Mayor.

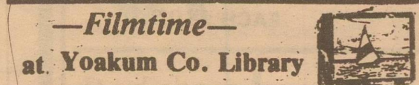

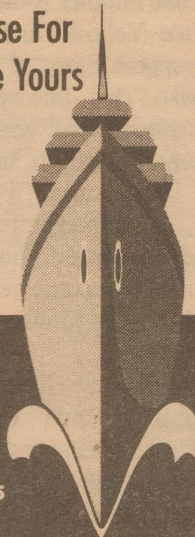
