## Cyclists Visit, Support Cause

A 48-year-old deaf man, Manny Valencia, his two sons and two friends, cycled through Plains last week as a part of their trip across America to promote public awareness of the needs of the hearing impaired.

From Tucson, Az., the southwestern regional coordinator of U.S. Deaf Cycling Association and his group left San Diego, Ca. June 5 and hope to arrive in Virginia Beach, Va. July 17. From there, he will go to Gallaudet University, a college for the deaf in Washington, D.C.

Traveling with Valencia and his sons, ages 10 and 11, are two friends who alternately drive a Volkswagen camper alongside the cyclists. During their visit in Plains Friday morning, the group visited in Yoakum County Library with Heather Bowlin and Lynn Day through pencil and paper.

Valencia said the trip will take him a total of 2,810 miles.

## U2 Pilot Captain Dan Sanders Presents Plaque To County

Capt. Dan Sanders, U2 pilot during the Persian Gulf War, appeared before Yoakum County Commissioners Court June 24 to present a plaque of

appreciation to the citizens of Yoakum County for hometown support shown him during Operation Desert Storm. The plaque contains a small U.S. Flag.

The inscription reads: "I flew the day the ground war kicked off. I was thrilled to see us on the move. The flags enclosed were flown over Kuwait above 60,000 on the first day of the invasion to liberate Kuwait. One is for you and one is for the people of Plains."

Son of L.J. Sanders, the pilot said he placed the small flag in his boot before each mission and felt it brought him luck. The plaque will hang in the hall of Yoakum County Courthouse.

Judge Dallas Brewer accepted the plaque in behalf of the citizens of Plains and expressed his deep appreciation to Capt. Sanders for serving his country as a U2 pilot. He also instructed the Court to pass a resolution of appreciation to Capt. Sanders and all men and women of Yoakum County who served in the Persian Gulf.

## Basketball Camp Slated July 8-12

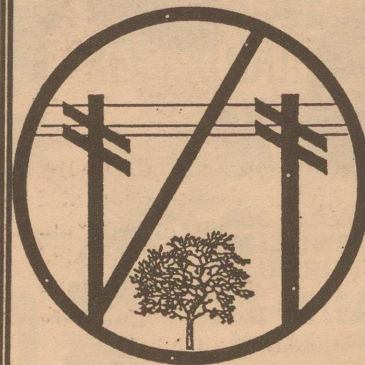

Plains 4-H Club members and their families met May 28 in the park for their annual family night picnic. Youth council members elected officers for the 1991-1992 year.

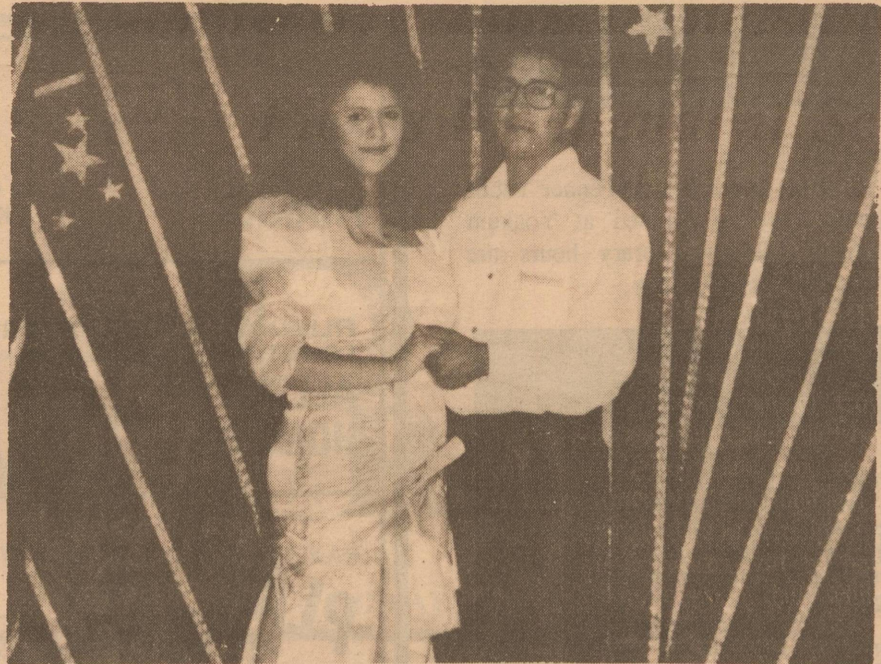

Friends and relatives are invited. Gift selections may be found locally.

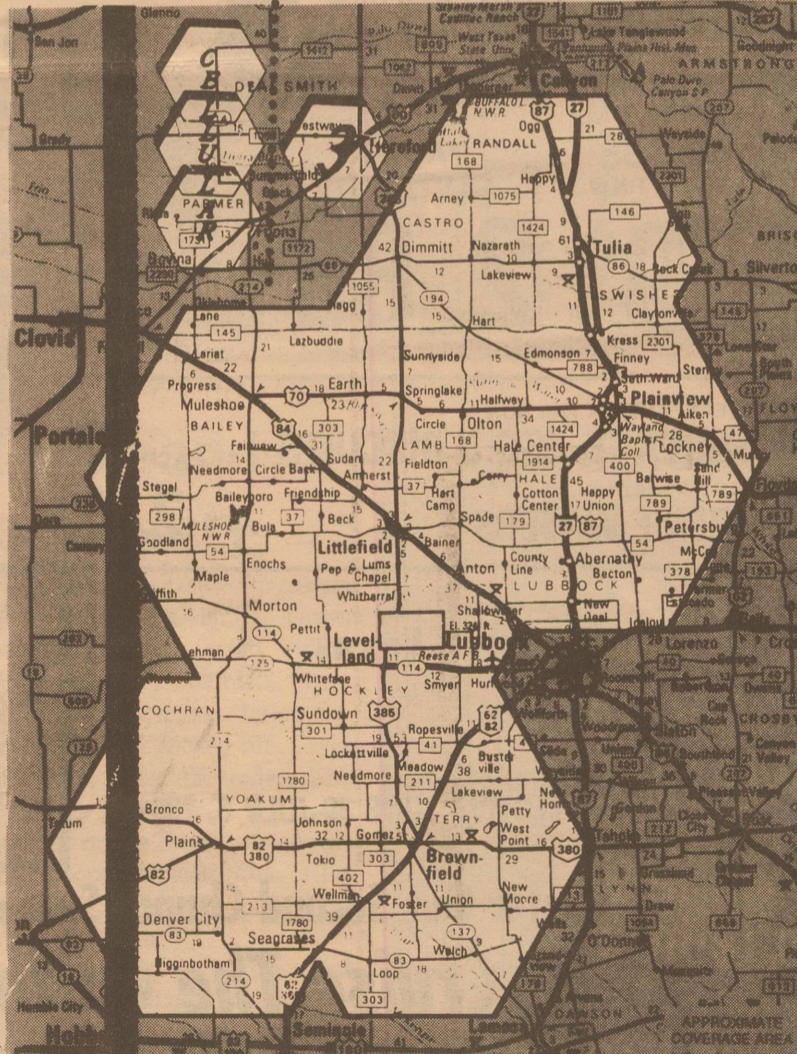
## Jenkins Services Held In Hamlin

ARCO OIL AND GAS COMPANY is applying to the Railroad Commission of Texas for permit to inject fluid into a formation which is productive of oil and gas.

The applicant proposes to inject fluid into the San Andres formation, Sable San Andres Unit, Well Number 68H. The proposed injection well is located five miles northwest of Plains in the Sable (San Andres) Field in Yoakum County. This well has been proposed as a horizontal injector with an injection interval of 3000' from 4750' TVD to 6000' TVD. Injection fluids will consist of water and carbon dioxide.

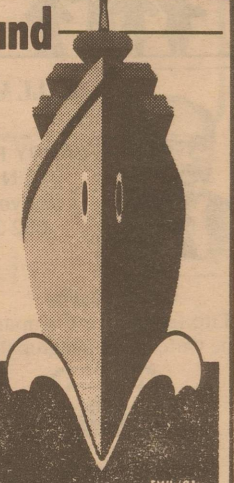
